## Barona celebrates 40th annual Powwow

vour decades have passed since the first Barona Powwow took place in 1970. On Labor Day weekend, Friday through Sunday, Sept. 3-5, the 40th Annual Barona Powwow will showcase traditional tribal dancers, singing and music from across the country. Native American food, handcrafted arts and jewelry will be on display.

The idea for a Powwow began in the late 1950s when a handful of Barona tribal members belonged to a group called Pacific Coast Indian Club. Tribal members who were interested in bringing this event to San Diego presented the idea to the Barona Tribal leadership. The first Powwow was held at the traditional gathering grounds, which is now the site of today's Barona Cultural Center and Museum, located at 1095 Barona Rd. in Lakeside.

The gathering has grown to a three-day event drawing more than 300 dancers and 10,000 in attendance. The word "Powwow" is an anglicized word derived from the Algonquian "Pau-Wau" or "pauau" (meaning, one who dreams) which

## San Diego's Highway 94 receives historic designation

here's is nothing more exciting than watching a piece of history get its due. That's what happens on August 28, when County Supervisor Dianne Jacob, California Assemblyman Joel Anderson and representatives from the San Diego Convention & Visitors Bureau celebrate the historical designation of Highway 94. The ribbon cutting takes place at 9 a.m. followed

by a news conference, at Simpson's Nursery in Jamul.

"Highway 94 is a wonderful historic route filled with many hidden treasures," said Joe Terzi, President and CEO of the San Diego Convention & Visitors Bureau. "Recognizing the historical significance of Highway 94 will help improve visitor demand to the San Diego region, which in turn, will benefit surrounding businesses in East County."

The resolution to designate Highway 94 as a state historic route was approval on June 2, 2010. It's the third highway – along with Highways 80 and 101 – in San Diego County to receive historic designation as routes that preserve local history and renew interest in the communities surrounding the highways.

To coincide with the celebration businesses along Highway 94 from Jamul to the back-country town of Boulevard will offer discounts and giveaways throughout the weekend to customers who attend the ribbon cutting ceremony. Free sodas and free walking tours are some of the deals that will be offered.

The declaration project was spearheaded by Historic Highway 94 steering committee chair and Larry Johnson – member of the Old Highway 94 Club, the Historic Highway 80 organization and the San Diego Convention & Visitors Bureau. California Assemblyman Joel Anderson authored the resolution, introducing the

historic designation to the state legislature.

The declaration's content came from East County resident Shirley Bowman Reider who wrote a book on the history of Highway 94 in 2001. The declaration highlighted several key historical sites and events that happened along Highway 94 such as the establishment of Camp Lockett in 1941, a military facility that was home to the U.S. Army's 10th Cavalry

Regiment, made up of mostly African American soldiers and better known as the Buffalo Soldiers; and how Highway 94 served as the main artery road from San Diego to Yuma, Arizona until 1918.

In addition to its historical significance, the highway that winds like a snake hugging open and mountainous areas offers some of East County's most scenic views. The Sweetwater River Bridge stands tall

and full of grace; if only it could speak, surely treasured stories would be unveiled.

Two markers noting Highway 94's historic status will be posted at the beginning of the historical route at Steele Canyon Bridge in Rancho San Diego and at the end of the route in Boulevard. The markers are expected to be up by the end of 2010.

## A monumental dedication to KCBQ

A monumental dedication ceremony to a legendary radio station and the 20-year era it produced (1958-1978) will be held at "1170 AM" - 12:10 p.m. Saturday, Aug. 28. in Santee.

The unveiling will take place on the exact location where a building and towers once stood and the history that was made there will be remembered. The station changed the lives of those involved with it, and an endless number of those affected by it as well. Captivating those who were fortunate to hear and share its trend-setting music, original "Top 40" radio personalities, news, and staff - KCBQ provided entertainment and information, and I believe, second to none in the community. Often copied but never duplicated, KCBQ was one of the most listened to radio stations in San Diego, and was known world-wide for its programming excellence.

On the Santee property at 9416 Mission Gorge Road that

is now occupied by Lowe's and Kohl's, Santee Mayor Randy Voepel along with original KCBQ surviving "Hit Parader" the night mid-watch show discjockey/engineer "Jolly" Jack Vincent will unveil the impressive commemorative monument. It will feature photographs of the building formally housing the KCBQ studios, offices, and powerful transmitters, along with pictures of the station's six 200-foot transmitter towers that once broadcast an impressive 50,000 watt A.M. signal, the first of its kind for many years in San Diego. In 1958 Vincent helped move the facility from downtown at 7th and Ash to

the then rural Santee location. Also scribed into the monument are the names of more than 100 talented disc-jockeys and newscasters employed by the radio station in those glory years.

Supported by private contributors, designed and built by Seaman-Poe Monument Company and installed by Charco Construction Co, the monument's unveiling ceremony will commence Saturday at 12:10 p.m. and is open to the public. This finely forged monument in Santee will forever reflect the pioneering attitude of KCBQ as a leader in the radio industry.

#### Pets and heat

The County's Health and Human Services Cool Zone program offers more than 100 locations for anyone to beat the heat. Call toll free 1-800-510-2020 or 2-1-1 for information. An important reminder – NEVER leave your child or pet unattended in a parked car for any period of time. On a warm day, the temperature in a car can reach 120°F in a matter of minutes – even with the windows partially open. A child, the elderly or your pet can quickly suffer brain damage or die from heatstroke or suffocation when trapped in high temperatures. If you see a child, a senior or pet left unattended in a car - and exhibiting any signs of heat stress - call 9-1-1 immediately!

Reminders: Heat exhaustion is marked by weakness, nausea, vomiting, headache and muscle aches. To treat heat exhaustion, cool the victim off quickly, and provide water or diluted sports drinks like Gatorade. Signs of heat stroke include: Lack of sweating, rapid pulse, headache, nausea, confusion, and even unconsciousness. If someone is suffering from heat stroke, call 9-1-1, loosen or remove the victim's clothing, and spray or pour cool water on his or her skin.

If your pet has become overheated, you must lower his body temperature immediately by taking the following steps: Move your pet into the shade and apply cool (not cold) water all over his body to gradually lower his body temperature. Apply ice packs or cold towels to your pet's head, neck, and chest only. Let your pet drink small amounts of cool water or lick ice cubes. Finally, take your pet directly to a veterinarian - it could save your pet's life.

## Health...Just Common

The ethics in today's traditional medical approaches have again sunk to a new level. Too many seniors have called in confusion and fear as to whether they should have a quick pertussis vaccination to prevent the pandemic. Pandemic? The staff have written down their concerns well and all are ashamed of the "medicine by fear" style observed in news broadcasting and pharmacy signs. "People who scare old people are going to have rough time at the Pearly Gate." That comment was delivered by an 80 year old retired teacher who lives alone and her family has already left us. However, she can still fire her 12 guage!

The number one side effect of the pertussis (whooping cough) vaccination is death. This must be reported to parents when they consider immunizations for their children. Pertussis responds to the proper erythromycin delivery rapidly and efficiently. It is a disease of the young. Recently a mother and daughter established as new patients and their debilitating fibromyalgia symptoms have been linked to their pertussis vaccination as a young child. 





anny McPhee is back and just as magical as the first movie five years ago. In Nanny McPhee Returns, set in the English countryside and London, statues come alive, elephants sleep in beds, and pigs fly.

Mrs. Isabel Green (Maggie Gyllenhaal), an over stressed mom, juggles three argumentative children, Norman (Asa Butterfield), Megsie (Lil Woods) and Vincent (Oscar Steer). They run a wheat farm, and work for the elder, odd and funny Mrs. Docherty (Maggie Smith) while her husband is away at war. To make matters worse, her persistent, creepy brother-in-law Phil (Rhys Ifans) is trying to get her to sell the farm because he owns half and wants his part of the money.

Arriving from London to stay with the Greens are two spoiled cousins. They are coming to the country to get away from the bombing in London. Cyril (Eros Vlahos) and Celia (Rosie Taylor-Ritson) Gray are rich, spoiled brats that don't want to leave the city. When the they arrive a day early and make insulting comments about the Green's farm, the trouble begins. The mayhem turns mean, muddy, hurtful and cruel. All this happens while Mrs. Green is away at work and is magically told by kettles and drawers that "the person she needs is Nanny McPhee."

That night in the middle of a rainstorm the unattractive female stranger Nanny McPhee (Emma Thompson) knocks at the Green's door. Once invited in her magic begins. Nanny McPhee uses bombs, pigs, cows, motorcycles and her magical stick to teach the children lessons which transform the children and also transforms Nanny McPhee.

Seeing pigs fly, pigs climb trees and pigs doing synchronized swimming are just some of the cool special effects. All of the magical special effects look real and are fun

Emma Thompson and the other actors appeared to have so much more fun making this film. Vlahos and Taylor-Ritson are so funny fighting with themselves and chasing the pigs. Vlahos is exceptional in staying in character all the way through the movie.

## Jason Bateman and Thomas Robinson excel in this tired plot

"m really on the fence about The Switch. I think there are two movies inside this romantic comedy. There's one plot I dislike for being cliché, boring, ridiculous and helping to spur even more tabloid stories about poor Jennifer Aniston (thank you very much). But there's also a tender story about a man who loves a woman so much he'll wait vears for her – and, after falling instantly in love with a little boy

- will do anything to make the lad's world complete.

First I'll tackle the plot I didn't like. Kassie (Aniston), tired of waiting to meet Mr. Right, goes on the hunt for a sperm donor so she can have a baby. She confides this to her pessimistic friend Wally (Jason Bateman), who when first hearing this announcement is so self-absorbed with his own lackluster life, barely understands what she's saying. As it slowly sinks in, Wally tries to dissuade Kassie from the ludicrous idea. Spurred on by her empty life and her crazy friend Debbie (Juliette Lewis), Kassie moves on, finding Roland (Patrick Wilson), a charming, suave and good-looking married man as her target.

Things get zany when Debbie throws an extravagant party for the actual filling of the cup by Roland. Were they actually going to plop Kassie on the bed and turkey baste her right there? Before that can happen, a drunken Wally - realizing his best friend is slipping away -switches the sperm to his own.

Seven vears later. Kassie. who had moved away from New York City, returns. She not only renews her friendship with Wally, but strikes up one with Roland who is now divorced, lost all his charm and appears plainly idiotic. This story would have been far more interesting if

he was a smart, savvy guy and a "real" contender for Kassie.

What I like about *The Switch* begins at this point. We know Bateman can be funny and charming as evidenced in Arrested Development and other comedies. And while he again shows his ability to be creatively amusing, there's a depth to his character here I've not seen before. Wally falls for Kassie's son Sebastian (Thomas Robinson) even though he believes Roland is his dad (he didn't remember the switch-a-roo). And the more he sees Kassie warming up to Roland and Sebastian obviously not wanting anything to do with his soon-to-be father, Wally becomes frozen with regret, fear and longing. Bateman brings out these feelings so effortlessly it definitely raises his game as a performer.

And who wouldn't fall in love with the smart-beyond-hisyears Sebastian? Although Robinson made a TV appearance in Heroes, this is his debut role on the big screen, and he's set big shoes to fill for himself. He's adorable in every scene while playing each emotional arc to perfection. His agent's phone must be ringing nonstop.

Aniston comes across as one-note in this movie. Her character is lamely blind to the "real" Roland in front of her, a guy who doesn't like her kid. Aniston could have done this

role in her sleep. Lewis is her usual zany character but likable. Jeff Goldblum has a small but believable part as Wally's co-worker and buddy. Wilson unfortunately got stuck with the cliché "wrong guy" part -- not much you can do with that.

While The Switch will probably not please many viewers who enjoy romantic comedies. Bateman's fans should not miss his performance in this film.







## **Walking in faith**

Thile freedom of religion continues to be challenged, millions of Americans walk in faith everyday. Each person has his own mission and goal – most selfless, wanting only to obey God's word. This column hopes to share some incredible journeys by passionate people that make every day living a little better.

Dr. Douglas Bray is a pastor at Sonrise Community


Church in Santee, CA, Director of Global Outreach International, and leader of the Prime Time class at Sonrise that has an average attendance of more than 100 every Sunday. Pastor Bray and his wife Sydney have spent the majority of their life serving God both in America and abroad. There's barely a country they haven't visited to spread God's messages and have faced eminent danger more than once.

Pastor Bray always felt a calling to Christian leadership. He held Christian gatherings in his back yard during high school, became a youth pastor in a large church in Long Beach, and graduated from Long Beach State University, and Talbot Theological Seminary. Pastor Bray believes in divine destiny, particularly in how he met his wife. "We were just friends at first with other romantic interests, but then God wanted us together and eventually in 1960 we were married." he said.

The Brays served with Intervarsity Christian Fellowship for two years – he as president and she as vice president for a year. In 1961 he was called to pastor a church in Pasadena. The Brays made a trip to Europe and Russia, bought a car at the Volkswagen factory in Germany and lived on \$10 a day for four months. The trip – a combination of journey and missions – resulted in many incidents one would only see in movies. When they crossed into Poland from Berlin, and stopped at a check point for directions, the guard ripped up their map. They eventually made it to Russia – in the middle of the "Cold-War." In one incident Pastor Bray dropped off Syd in Moscow to run into a store. When she wasn't on the curb to be picked up, he parked and searched for her, only to be told by someone that she had been arrested. At the police station he was informed the Russians believed they were spies. A few harrowing days later they were allowed to leave.

The Brays were then asked to visit Biola University missionaries around the world as ambassadors. Back in the states, Pastor Bray was called to pastor a church in Westminster. After nine years there, and now with children, the couple came to San Diego where he became associate pastor of Scott Memorial Baptist Church. It was there Pastor Bray worked with Dr. Tim LaHaye (Co-author of Left Behind series). Pastor Bray next entered into International Evangelism and Pastor Training.

By this time a big calling was awaiting the Brays. Dr. Paul Gupta, a graduate of Biola, visited America from India, and

asked the Brays to get involved in Global Outreach International. Feeling a burden to save souls and God's plan to reach out in the world, once again they answered his call to spread the Gospel. Since 1998 the Brays have made endless trips to India helping set up orphanages, speaking at Christian gatherings and teaching in training centers. They have often worked with renowned Hopegivers International's Dr. M.A. Thomas – who is still being persecuted today for his teaching of Christianity in India.

"Our goal with Global Outreach International was to help, not just financially, but also in ministering and building churches," Syd Bray said. "We began working with graduates over there to plan churches and the ministries we support all have something in common."

While continuing to work with world missions, the Brays were called to Sonrise Community Church in Sonrise, where he serves as one of their pastors, and oversees the Prime Time ministry. This includes teaching the Sunday morning class, giving a devotional every Tuesday to the class who attend the Home Town breakfast in Santee, visiting the ill and both he and Syd nurturing all in the class no matter their needs.

Whether officiating over a beloved one at a funeral to bravely risking jail time for taking Bibles across a forbidden border, Doug and Syd Bray's Walk in Faith has saved thousands of lost souls and been a shinning inspiration to all who know them.

## Sycuan tribal police approved for grant funding

he Sycuan Band of the The Sycuan Band of Line Kumeyaay Nation's Department of Public Safety will receive \$107.000 in funds from the U.S. Department of Homeland Security.

The Sycuan tribe, owners of Sycuan Casino and Resort, applied to the U.S. Department of Homeland Security (DHS) to be considered an eligible recipient for a piece of the \$10,000,000 set aside for the Tribal Homeland Security Grant Program (THSGP). The funding will be used for the purchase of new communication equipment by the Sycuan Tribal Police Department in an effort to better serve and protect its members and the surrounding community.

"Communication is a fundamental aspect of any effective law enforcement program," says Bill Denke, Chief of Police for the Sycuan Tribe. Not having the ability to communicate with other jurisdictions puts the lives of the people we serve in

'Sycuan has experienced a number of disastrous wild fires around the reservation over the last several years. We found with cell service and land lines down we were completely cut off from communicating with all outside agencies.'

Chief Denke goes on to say that, "With the grant funding Sycuan will be able to deploy dual-band radios (both handhelds and vehicle), enabling Sucuan's police officers to communicate within San Diego County's Regional Communication System and at the same time continue to communicate with all other departments/agencies on the Sycuan Reservation."

In order to be considered eligible, every tribe must meet the criteria defined by the DHS in conjunction with the THSGP Determinations are made by a peer review process. For further information please visit (www. fema.gov/government/grant)

Other tribes who have received similar funding in California are Yurok, Agua Caliente and Blue Lake.



## Padres refuse to lose

The San Diego Padres continue to flourish in these dog days of August.

In a season where most thought they would contend for last place in the N.L. West, the Padres in August have expanded their lead and are beginning to run away with division. Granted there is a lot of season left, but there no longer lingers the doubt of whether or not this team is for real.

Amazing is the word. They have the best record in the National League and have had just one three-game losing streak all season. That's simply amazing.

Concluding their longest road tour of the season, 10 games in 10 days, San Diego returned home after an excellent (7-3) trip that began August 11 in San Francisco, then to Chicago, ending in Milwaukee. When the Padres took to the road they held a slim  $2\frac{1}{2}$  game lead in the N.L.West. Upon their return to Petco Park, they had extended that lead to 6 games.

Taking 2-of-3 from San Francisco was satisfying after hearing the prophetic comments of pitcher Jonathan Sanchez predicting his Giants would sweep the series, take over first place in the division, and never look back. Obviously that didn't happen.

The Friars did sweep the Cubs in four games. The first time ever, a four game sweep for them in the windy city.

San Diego did hit a bump in the road at Milwaukee. Losing the first two of three to the talent laden under achievers, the Brewers looked more like the Padres than the Padres did themselves. San Diego did bounce back in the third game averting a sweep behind excellent pitching from Jon Garland in a 7-3 Padres victory.

Refusing to lose, the San Diego Padres have now won a remarkable... 10 in a row, 15-1 overall on Sunday games this season.

David Eckstein returned to the lineup over the weekend against the Brewers after being shelved by a hamstring injury on July 21. The scrappy veteran second baseman contributed immediately with 2 hits. He also brings invaluable intangibles to the team.

"He's terrific. We love his leadership, his management, his skills around that. We love the consistency he offers," said Padres Vice Chairman and Chief Executive Officer Jeff Moorad.

'Eck' glad to be back said, "It was tough to sit out that month and just watch the guy's play. You want to be helping them. Once I came back I just wanted to go out there and help them win again."

"What makes this club is they can cut down a losing streak quickly. We've been able to do that all year long. It starts with our pitching. Jonnie (Garland) went out there and did another fantastic job for us getting us a chance to score some runs and get the lead. Our pitching staff and our bullpen has been outstanding. I don't know if there's anyone in the league that can compare to that."

The Padres hitters have hit for power in August. This is no more clearly evident than first baseman Adrian Gonzales. After his home run Sunday, Gonzales took over third place on the Padres All-time Home Run record book (surpassing Dave Winfield) with 155. Only Phil Nevin (156) and Nate Colbert (163) are above Adrian.

Look for outfielder Luis Durango (recently called up from Portland) to start more games for the Padres against left handed pitching. The blazing speedster may be the fastest player to ever wear a Padres uniform.

After a well deserved day off Monday, the Padres entertained the Arizona Diamondbacks for three games this week. They take on the world-champion Philadelphia Phillies in a three-game weekend home series beginning Friday at Petco Park.

Saturday and Sunday are day games both starting after 1 p.m.





## BLM conducts rescue mission for stranded burros

Thirteen wild burros stranded in a remote area of San Bernardino County are the focus of an unusual rescue mission coordinated by the Bureau of Land Management (BLM). The burros are the last of a herd of 69 wild burros found stranded without water and outside their normal herd management area.

BLM Needles Field Office Manager Rusty Lee said BLM was notified Thursday afternoon by a local rancher that he had come across a number of burros that apparently had died of dehydration, but there were also others that were still alive at Fenner Spring, in the Piute Mountain Wilderness Area, about 35 miles west of Needles, Calif. The herd was about 40 miles from the Chemehuevi Herd Management Area, the nearest BLM herd management area.

The rancher, who grazes livestock in an allotment covering the area, said the dead animals had clogged the spring in the pursuit of water in the 110-degree heat, preventing other burros from getting to the spring. He attempted to pull out as many as he could with his horse, but wasn't able to reopen access to the spring. The nearest alternative source of water is 12 miles away; Fenner Spring, an abandoned mine adit, is the only reliable source of water in the Piute Mountains.

Lee said BLM immediately mobilized a helicopter, a county water tender, folding water tanks, and other equipment needed to rescue the remaining burros. Although the site is in a federal wilderness area, BLM has authority to use "minimum tool" equipment in the case of emergencies, he said. A BLM fire crew was dispatched to the area and deployed portable water troughs. Corral staff from the BLM Ridgecrest Wild Horse and Burro Facility were also dispatched.

A contract fire helicopter reached the scene later that afternoon and began moving water from large portable troughs by the highway to a smaller water "pumpkin" near the spring. Thirteen live burros watched a helicopter deliver 750 gallons of water. BLM personnel then backed off at

sunset to allow the burros to approach the water.

Upon returning in the morning, 13 live burros were seen in the area and the water trough was empty. Corral staff then ordered another 1,000 gallons delivery by helicopter and also set up secondary troughs for more water. The county water tender delivered another 3,000 gallons to the helicopter drop point to be readily available as needed. Corral crews have been on-site to stabilize the surviving burros for further recovery and later transport to the Ridgecrest Corrals.

Lee said the rancher's discovery and rapid reporting of the situation "saved the lives of the remaining burros." He said range specialists were unsure how the animals wandered into this area although

burros are adept at finding water sources in the desert. "BLM also took special precautions to minimize impacts to the wilderness and to rehabilitate the area, which was already disturbed due to the previous mining operation.

BLM California Deputy Director Tom Pogacnik said BLM will conduct an inquiry into the incident and credits Lee and all others involved with "a fast response and plan that undoubtedly saved the lives of the remaining animals." The preliminary findings from the veterinarian brought to the site to check both living and dead burros were that the animals died from dehydration. The remaining animals are in fair condition and with an adequate supply of water on hand are expected to
