

A grateful East County says thank you and happy birthday to Stoney Stone

his past week nearly 200 East County residents celebrated the 85th birthday of B. W. "Stoney" Stone. Most people recognize him as the name behind the nonprofit Stoney's Kids. In 1991 Stoney had an aspiration to build an organization to help kids, make a positive impact on them through positive works and find a group of volunteers that could work with businesses and community leaders to bring his goal to fruition.

Stoney grew up in a large family, the youngest of 11 children. His daughter Bonnie, a board member of Stoney's Kids, said her father has always had a giving back spirit. "We owned a grocery store in El Cajon when we were kids, and would help out there. I remember my father kept a little black book and if a customer couldn't pay for something, he would write the amount in the book until they came in and took care of it. He always got his money back. We also did

things like take clothes to kids in Tijuana."

Coincidently, it was also in 1991 that the police department was looking for funding for its new DARE program. A Board of Directors for Stoney's Kids was selected, and this mission statement created: "Stoney's Kids is dedicated to improving the health and welfare of the children of East County by supporting the programs, activities, and means for young people to develop essential life skills and make healthy choices for a successful future."

In the almost 20 years of the organization, Stoney's Kids has far exceeded its goals. "Our family is proud of my dad, what he has done is a real gift. But he would be the first one not to take any credit. He's very humble and acknowledges all of the good works of the community for what they do," said Bonnie Stone-Davis, who took her father's examples to heart. She is the Salvation Army's Director of Social Services in the back country.

Stoney's Kids has funded education and activities that promote drug use prevention; provided scholarships for afterschool activities for underprivileged kids; sponsored activities and met needs within East County schools, and worked with local police departments, government bodies and school districts to define, develop and fund future projects that bring the right people, programs and resources together to benefit the kids

Current programs include:

- East County Youth Symphony: Provided funds to assist the organization purchase music equipment and music books. East County Youth Symphony provides free, high quality orchestral education and performance opportunities to young musicians ages 8-25.
- Destination: Imagination: Helped with providing funds for the students of Granite Hills High School attend the National

Contest when families did not have enough monies to send their children after they won the State Competition.


- CVUSD F.A.M.E. **Program:** F.A.M.E. is the only fine arts magnet public school in East County.
- CVUSD 6th Grade Camp Scholarships: Making sure that kids do not have the money can attend 6th grade camp.
- **Granite Hills High School Tennis Team:** Provided funding to refinish the tennis courts to prevent injuries to the children.
- **Scholarships:** Funding to engage underprivileged and at-risk youth in recreational after-school programs that develop life skills, such as Youth Sports League at Cajon Valley Middle School.
- Juvenile Diversion Program: In conjunction with Harmonium (harmonium-inc. org) and the East County police departments, this is San Diego County's only program designed to keep kids in school, off the streets, and making the right choices.
- School Attendance and Anti-Truancy Campaign: A public awareness campaign coordinated with the local school district, created to get kids in school and keep them
- **READ 180:** A special assistance reading program to improve the reading skills of those kids who need it most.

- Holiday Toy Drive: A joint effort with the Salvation Army to provide toys to underprivileged children at the holidays. Over two thousand families are helped each year.
- Local High School Athletic and Music Programs: Providing materials and equipment to the local high schools on an as-needed basis to ensure access to valuable activities and resources for the kids.

Stoney's Kids has already

invested more that half a million dollars in East County programs, and 98 percvent of donations go into the programs. Health willing, Stone-Davis knows her dad will keep showing up wherever he's needed. "He's grateful for all of the programs we support, but is especially fond of the 6th Grade Camp Scholarships. He loves seeing kids who might not otherwise get to be like all the others, go to camp. For him it's always been - all about the kids." Special help from San Diego Gas & Electric

San Diego Gas & Electric (SDG&E) encourages customers experiencing financial hardship to apply for assistance through a new state program called Temporary Energy Assistance for Families (TEAF). The program, facilitated by the Salvation Army, provides eligible families the opportunity to receive a one-time emergency energy grant of up to \$1,500 to pay off past-due utility bills and avoid service shut-off. Community Emergency Response Team holds open house

A CERT (Community Emergency Response Team) was recently held at the Lakefront Mobile Home Community, at 9395 Harritt Rd. in Lakeside. The Open House had disaster preparedness demonstrations, fire department and CERT team demonstrations and information booths. For the one day event, open to the public, the park was divided into zones able to be evacuated within 45 minutes. In a disaster, the park would have a 30 day supply of water from the two community pools using special chlorine drops to purify the water.

There are more than 500 mobile home parks in the county and only two have emergency preparedness in force, said Lakefront manager Rich Hubert. Nearly 100 people attended the event which included a CERT demonstration with Chuck Palmore, CERT Certified teacher from the Lakeside Fire Department. Lakefront Mobile Home Park started with seven CERT trained residents; they now have 13. After the event, 11 people volunteered to be CERT trained. \$240 was donated for emergency equipment and supplies. September 6 is the next CERT class. The class is already full. Kumeyaay / Diegueno females between the ages of 13-20 participated in this annual event. A panel of judges representing all areas of the Kumeyaay Nation decided the winner of the Miss Kumeyaay pageant. Judges evaluate contestants on their cultural knowledge, community involvement, educational/career standing, overall appearance, dance and singing presentation.

Vasquez is planning on attending Cal State San Marcos in the fall and has selected to pursue a business degree. She will represent the 12 Tribes of the Kumeyaay Nation and make public appearances at parades, conferences, ceremonies, and educational events.

The legacy of KCBQ remains solid

n Saturday, August 24, an enormous crowd gathered at the Lowe's and Kohl's parking lot in Santee for a dedication ceremony of the radio station KCBQ A.M. 1170. Longtime KCBQ newsman,

Lee Marshall (the voice of Tony the Tiger) began the ceremony in his unmistakable deep voice by describing the people who made KCBQ a legendary radio station not only to the rural community of Santee that eventually became a city, all of San Diego County.

Marshall recounted some sentiments about his years at the station before introducing whom he called, "San Diego's native son," Shotgun Tom Kelly.

Kelly acknowledged the challenges of getting the monument constructed. He thanked Chuck Swimmer, Charco Construction Co. and Seaman-Poe Monument Co. and said, "They did a marvelous job with the name and pictures that will last forever."

Santee Mayor Randy Voepel then took the stand. "KCBQ has been a part of Santee for many years," he said. "Shotgun Tom thought this idea up, raised the money and put it all together."

Shotgun then read the inscription at the top of the monument commemorating Lee Bartell who built the KCBQ AM 1170 broadcast facility. He then introduced Lee's son, the president of Bartell Hotels, Richard Bartell.

Bartell recalled working with his dad on the project when he was only 11. "For my dad,

KCBQ was such an important part of his life," he said. "Then it was known as KCBQ family radio because he wanted it to appeal to the entire family. It was the on-air personalities who were so important to my dad. He took such pride in each of them and their accomplishments."

Kelly next introduced another legend, KCBQ disc jockey Neil Ross, the former voice of the Academy Awards, the voice of the drunken mouse on An American Tale and narrator on The Nova Series on KPBS.

Ross spoke about early memories of the area and how Santee has changed. "KCBQ Radio 1170's programming excellence was known and respected by broadcasters throughout the United States

and Canada. This stations sound was envied and quite frequently imitated. I am so proud to have been a part of the history of KCBQ AM 1170."

Kelly read the names of KCBQ employees on the plaque of the monument before the monument was unveiled. It marks a significant history in Santee that will represent all of those who were part of it and everyone who invited those voices into their homes.

How to spot the red flags of an investment seminar scam

Falling victim to fraudulent investment schemes could mean losing anywhere from a few hundred dollars to your life savings. While most people might not see any harm in sitting through a slick investment seminar featuring promises of big returns, the San Diego Better Business Bureau (BBB) recommends researching the investment company first rather than run the risk of falling for a financial scam drawn in by a free lunch.

In one recent case, the Securities and Exchange Commission shut down a Ponzi scheme which stole \$20 million from retirees in California and Illinois. The scammers invited senior citizens to estate planning seminars and later coaxed their victims into buying promissory notes for purported Turkish investments.

According to Sheryl Bilbrey, San Diego BBB president/ CEO, "Unscrupulous seminars often use the promise of a free lunch to lure in leisurely senior citizens who have time plus exploitable retirement accounts and real estate." When listening to an investment pitch, the BBB advises to look for the following red flags:

• Requires a large up-front investment.

Untrustworthy schemers might try to convince investors to pay a lot of money upfront so they can get out of town with a large haul, rather than waiting for the funds to trickle in.

 Promises high returns for low risk.

The reality is that every investment comes with a level of risk and, typically, the amount of risk increases in line with the potential return on the investment. So, if the seminar is trying to sell an investment scheme that claims a high return with little or no risk, then

beware, even if it comes with the promise of a money-back guarantee.

• Employs high pressure sales tactics.

Seminar leaders often use high pressure sales tactics to get people to sign up without thinking it through, or they might claim that there are only a few spots left or that you need to get in on the ground floor today to see the largest earnings. However, any reputable investment company will let you take your time and do your research and will not pressure you into signing a check.

• Relies on off-shore investments.

Many hucksters will try to give their scheme an air of sophistication by relying on overseas investments such as foreign currency, property, stocks and bonds, or they also might claim – incorrectly - that



'The American' is solemn, slow and confusing

he American opens with George Clooney staring into a fireplace as he sits on the floor of a remote cabin in a Swedish snow-covered mountainside. The naked woman lying on a bed with her arms around his neck paints a vivid picture of what just took place. Yet Clooney's blank stare is only the first of many in a film that is solemn, terribly slow, and visually vapid. Director Anton Corbiin believes moviegoers will enjoy watching a film about a character we know practically nothing about and who does things that are never explained. My guess is they won't.

Clooney fans are used to seeing him portray one displaced American character after another. He's played a psychic warrior in Iraq (The Men Who Stare at Goats), an American military journalist in Berlin (The Good German), a CIA undercover operative in Beirut (Syriana) and more. Because fans acknowledge Clooney's talent, we're willing to wait for an explanation at of the bizarre outcome of this opening scene. Unfortunately, there's little clarification of anything that happens in this film during its slightly under two-hour running time.

The American is loosely based on the 1991 novel, A Very Private Gentleman, by British author Martin Booth. The idea to turn the book into a film began 10 years ago and would go through many hands before screenwriter Rowan Joffe produced a final draft.

Fleeing from Sweden, Jack

or Edward (Clooney) - depending on which name he gives out - stops to make a call and is given a direction to drive towards. Apparently he's not sure who he can trust, and even the mysterious caller seems to be a pawn in a much bigger game. So Jack finds the car he's to secretly pick up, but then throws the cell phone left for him in the seat out the window and heads to a different town. It's a bleak city in Italy where he takes a room in a multi-stepped villa - perfect for chase scenes.

Jack takes a few days to suspiciously survey the town and its residents. He barely lets his guard down to spend a rather forceful tumble with a local prostitute, Clara (Violante Placido). He finds a phone booth and checks in to get his assignment, which the audience does not hear. More days of canvassing and running from shadows take place until Jack befriends the local priest, Father Benedetto (Paolo Bonacelli), who seems to have a lot of questions as well as insight about Jack. He tells Jack - who claims to be a photographer of architecture, but as of yet has not even been seen with a camera - that his hands are those of a mechanic of machines not of an artist. "Architecture has a history; but you live in the present," the priest says.

Finally, Jack meets a woman (Thekla Reuten) in a public outdoor café which we can only assume is his next assignment, for they discuss gun parts. So maybe Jack is a specialist at building guns – which he does for more days to come, followed by little interaction with anyone but Clara.

(It surprised me how well she spoke English for a small town Italian prostitute.) She's beginning to think of Jack more as a date than a "john." She wants Jack to take her to America, and with little more than a few nights spent in hot sexual encounters, Jack decides he loves her and wants to spend "forever" with her.

Corbijn's only previous feature film credit was the 2007 *Control* about British Punk band lead Ian Curtis. His idea was to fashion *The American* like a contemporary Western built around a simple character, with sparse dialogue and a wild Italian landscape.

However, Jack is anything but a simple character. He's so complex we know nothing about him except he likes guns and hot girls. Corbijn sees Jack as going through a metamorphosis, but we can't understand what he wants to become if we don't know what he was or is. The lack of dialogue in the movie only adds more mystery to Jack's glum stares and hesitant decisions about turning left or right. Regarding the location chosen as a wild Italian landscape, Corbijn

calls Italy's Abruzzo's mountain region "a raw environment, an honest landscape of a type that is rarely seen in movies." I think there's a reason for that – it's unexciting and boring, just like *The American*. Also, Clooney is the only recognizable actor, so we feel no connection to anyone in this film.

Fans of 70s style European films with little dialogue might enjoy *The American*; others will be taking a risk.

Harsh realities unveiled in 'The Tillman Story'

mericans were surprised when Patrick Tillman, the NFL's Arizona Cardinal's linebacker, gave up a lucrative career to join the Army Rangers along with his brother Kevin in 2002. In a post- 9/11 interview, Tillman said the patriotism of his grandfather and other family members inspired him to do the right thing. That decision would become a lifelong heartache for his family when Tillman was killed in Afghanistan in 2004. Although Amir Bar-Lev's documentary, The Tillman Story, may make viewers sorrowful, angry and confused, it's a compelling story that needs to be told.

The first news hitting the airwaves reported that Tillman was a war hero who saved men during an ambush in the Afghanistan Mountains. Buddies who were there received orders from higher ups not to talk to the family or reveal what really happened. From the early hours of notice -- which caused Pat's mother, Dannie Tillman, to collapse upon seeing two uniformed officers approaching their home -- through the following days, the family tried to deal with the heart-wrench-

Tillman had clearly checked

the box "no military funeral" on the form when he enlisted, and he left a copy with his wife Marie. He never wanted any recognition for joining the military, even declining interviews before going in. Yet because of news reports swirling around about Tillman's heroic acts as well as proclamations from the President and other officers, a military funeral was inevitable.

While high brass attended in numbers, and comrades who ached to tell the truth sat quietly in the breeze at that news-covered funeral, Tillman's younger brother, Richard, had the guts to get up and tell the truth about what he knew his brother would have wanted – and to call it exactly how he saw it.

And then, a mere five weeks later, more news would deepen the wounds of the Tillman family. After an official investigation it was determined that Tillman had been killed by friendly fire - shot by one of his own. Dannie would not take this news lying down. She pushed, researched, prodded, called congressman after congressman and spent years in getting nowhere. No one seemed to know exactly what happened on that mountain but it was obvious the coverup had begun immediately.

Tillman's brother Kevin. who was in his outfit, was told his brother was shot by the enemy, and accompanied the body home to the States. The Department of Defense didn't order an official investigation until August of 2005, but it would go through another three years of cover-ups and irresponsible actions by many military officials and people in the government. At one point. hoping Dannie would tire of her campaign, the officials delivered to her a box of large notebooks packed with 1000s of pages about the investigation. However, every name of a real person or actual place was blacked out in the reports. But family members – along with buddies from Tillman's outfit were able to fill in most of them. This gave Dannie the ammunition to finally go after specific people and to demand a true account of what happened to her son.

At a second congressional hearing in August of 2007, the focus was on a P4 memo and its recipients, including Secretary Donald Rumsfeld, General John Abizaid, General Bryan Brown and General Richard Myers, all who were called to testify. At a final congressional hearing in July of 2008, nothing went as the family had been led to believe. A House and Oversight Committee report stated the investigation was "frustrated by a near universal lack of recall" from Bush administration officials, and that the White House withheld drafts of a speech in which the President discussed Corporal Tillman, claiming the speech would "implicate Executive Branch confidentiality

interests."

Screenwriter Mark Monroe had his challenges cut out for him in gathering years of facts or those missing, to put this story together. Monroe was also the writer of the shocking and intense documentary *The Cove.*

No matter how the situations unfold in this documentary narrated by Josh Brolin, direc-

tor Bar-Lev maintains there are no simple answers. "I hope that whatever conclusions anyone takes from this film, they'll also prod and question those same conclusions," he said. "If audiences walk away wondering how such a thing could have happened, they're in good company. It remains a mystery to anyone who really looks into it. The life and death of Pat Tillman challenges us to see the world differently."

For Health's Sake

Going fruity with the top five

n apple a day just doesn't cut it anymore, and too many apples could make you fat.

That's the advice of Iva Young, a nutritional expert who warns that the wrong kinds of fruits can actually do more harm than good.

"We really should be smart about the fruits we consume, said Young, author of Healthy Mom (<u>www.ivayoung.com</u>). "After all, remember that fruits are very similar to breads, pastas, rice, and other high carbohydrate-rich foods in that fruits are high in carbs. That is one reason why we should only consume a certain amount, and choose the fruits that are lower in sugar. If you pick the right fruits and eat the proper portions, then you will give your body what it needs and it will benefit greatly from your efforts."

So, which fruits offer the biggest health boost? Young named the following fruits, all of which are comparatively low in sugar, as her top five:

- Raspberries Raspberries are an excellent source of fiber, offering 30 percent of our recommended daily value, 8 grams per serving. Raspberries are also a rich source of vitamin C, with about 50 percent of our daily value. In addition, they are a rich source of manganese, delivering 60 percent of what we should have each day. Raspberries rank near the top of all fruits for antioxidant strength and contain many anti-disease properties if consumed regularly, helping to fight against inflammation, chronic pain, cancer, cardiovascular disease, diabetes, allergies, age-related cognitive decline and eyesight degeneration associated with aging.
- Blackberries Blackberries are notable for their high

nutritional contents of dietary fiber, vitamin C, vitamin K, folic acid, and manganese. Blackberries are well-ranked for having strong antioxidant levels, and they also contain copious amounts of omega-3 and omega-6 fatty acids.

- Kiwi Kiwi is a rich source of vitamin C and vitamin K, which is a natural blood thinner. It's also a good source of potassium, just slightly less than that of a banana. Potassium is one of those nutrients that's absolutely essential for heart health, yet many people don't get nearly enough. Kiwi also delivers a mild laxative effect, possibly because of the high level of dietary fiber.
- Strawberries Strawberries are low in calories compared to many other fruits, and are a good source of fiber. They are also an excellent source of vitamin C and flavonoids, promoting lots of antioxidant activity in the body.
- Oranges Oranges are an excellent source of vitamin A and C, along with powerful antioxidants. Oranges also provide a good source of fiber when the pulp is consumed. The white pith of the orange also contains flavonoids, and some doctors are even using extracts from the pith to help fight certain types of cancer.

"Sugar is also something that you should keep your eye on, because it affects the health of your teeth and the functioning of your hormones, specifically leptin," she added. "Leptin is the important hormone responsible for telling the body that you should stop eating. With excess amounts of sugar in your body, the amount of leptin is diminished, which causes you to overeat. Excess sugar also has been known to cause intestinal issues increasing the chances of bloating, which causes your stomach to stick out and look like you have extra fat. That's how consuming too many sugar-rich fruits can actually make you look fat, and make you feel less healthy than if you didn't eat any fruits at all."

Iva Young was born in Munich, Germany, and her family moved to Toronto, Canada, when she was two

years old. Her parents grew up in Croatia, so she grew up eating traditional high-fat Croatian and German meals. That upbringing helped spark her passion for nutrition and natural health. She holds a bachelor's degree in Kinesiology and health promotion from California Polytechnic University.



2011 Mitsubishi iMEV

drove the EV-1 by GM back in the 90s then the Nissan Leaf a couple of months ago, and now the Mitsubishi iMEV - their introduction vehicle in the electric car game. Interestingly, the iMEV I tested was a pre-production four door, four passenger electric vehicle. The iMEV is not new; the body has been used in Japan for many years sporting a gas engine. Mitsubishi felt the iMEV layout would be a perfect electric vehicle for the US. There will be a few changes to the Japanese version of the car, for example the US model will be wider and heavier once all the U.S. mandated safety equipment has been installed. But for this test I had the Japanese version with right hand steering and all the gauges in metric.

The body style is very round and cute. I fit in the iMEV fine, and it drove better than I expected. There is no engine in the iMEV, but the one speed transmission will get you down the road in a jiffy. Top speed is around 80 MPH, all from a Permanent Magnet Synchronous motor that produces a maximum power of 47 KW and a maximum torque of 180N. The batteries in the iMEV are Lithium-Ion with a total voltage of 330V and a total energy of 16KWH. This may seem like Greek, but I bet this is what the future has in store for us.

The transmission is a one speed but it has three modes with a choice of driving style. First is D for drive, which is your normal position, then E, for economy, that limits excessive power going to the motor. Lastly B, for brake range which applies the regenerative brake more aggressively during

incline descent. I drove the iMEV in all modes and found the economy mode more driver-friendly until I noticed the power source dropping. Then I had to drop it into B for more regenerative braking which helps boost the batteries for a longer trip.

One might ask how far can I go and what happens if I run out of electricity. That won't happen if the car is driven correctly. Driving any electric car is like flying an airplane; you need a flight plan so you can make it from point A to point B without running out of fuel. The same goes for the electric car. Using the iMEV for commuting is a good reason to own one. Recharge the car early in the morning during off peak hours and there's no need for fuel.

Will there be charging stations in and around San Diego? Mitsubishi say's yes, but be careful; SDG&E may put a premium on mid-day juice. Start off with a full charge, plug in at work with the 110 cable, and it's good to go. If I commuted to work, I would be looking at an electric car, but which one, I'm not sure. Stay tuned!

The iMEV will price in the \$20,000 range with the help of the state and federal discounts for buying an electric vehicle. No final price has been set yet. Visit www.mitsubishiusa.com for more information


