

What You Need:

2 halves roasted butternut squash

2 cups vegetable broth

1 teaspoon garlic powder

1 teaspoon onion powder 1 teaspoon curry powder

Salt and ground black pepper

How to Make It:

Scoop flesh out of butternut squash with a spoon. In a medium saucepan, combine broth, flesh of butternut squash, garlic powder, onion powder, curry powder, salt and pepper. Set pot over medium heat and bring to a simmer, about 10 minutes. Puree soup with an immersion blender until smooth. Ladle into bowls. Serve with a dollop of Lime Creme and garnish with extra lime zest, if desired.

2 15-oz cans of cannellini beans, rinsed and drained 1/2 cup pesto

3 teaspoons freshly squeezed lemon juice

Kosher salt Freshly ground black pepper

1 large acorn squash

Veggies for dipping:

Cut bell peppers

Carrot sticks

Celery sticks

Cucumber sticks

How to Make It:

Heat oven to 350°F. Line a baking dish with aluminum foil. Cut the top third of the squash off and remove the seeds with a spoon. Place the squash cut-side down on the baking dish and bake for approximately 30 minutes. Remove from the oven

and cool completely. Trim the bottom of the squash so it stands upright and place the dip inside of the cool squash. Arrange the veggies under the squash on a plate and serve.

Puree the beans in a food processor until smooth. Combine the beans with the pesto and the lemon juice. Season to taste with salt and pepper. Serves 6.

The San Diego County Taxpayers Association (SDCTA) gave top honors to the Heartland Fire & Rescue JPA with the "Grand Golden Watchdog" award-this award highlights smart, sensible practices in taxpayer-funded programs.

F.B.I. Statistics show that the City of El Cajon is among the top cities in crime rate reductions in the County of San Diego for 2009.

The downtown area has gone through a major face-lift- a distinctive City of El Cajon sign, new sidewalks, seating, streetlights and "way finding" signs. New businesses have arrived and more are coming!

We just completed a major renovation of the downtown Prescott Promenade. The refurbished park features a covered amphitheater area, plenty of informal seating, and walkways designed for pedestrians as well as classic cars, vendor booths or a host of other activities. We'll be able to host larger events in the downtown area.

El Cajon is one of the most successful cities in San Diego County regarding recycling and resource recovery. It is recognized as the only "Zero Waste City" in San Diego County and only one of a few in the State of California. Our Solid Waste Vehicles are operated by clean natural gas from a landfill.

The City of El Cajon is recognized by the Federal Government as a "Tree City USA" because of our efforts in promoting the value and benefits of tree planting. This "Urban Forest" maintains a natural environment for all our residents, now and in the future.

The City is looking forward to the new animal shelter being built next year with "Prop J" money for our four legged residents. The shelter has a "no kill policy"- every pet that can be saved will be saved. Each animal is checked, treated if necessary and micro chipped by a veterinarian before being placed for adoption.

onviction is a testament to the strong ties of a brother sentenced to prison for murder and his sister who sacrifices everything including years of her own life to prove his innocence. The film, adapted by Pamela Gray and directed by Tony Goldwyn, is based on a real-life story.

Kenny (Sam Rockwell) and Betty Anne Waters (Hilary Swank) were among nine children raised by their single mother. As seen through flashbacks -- in harsh times and devoid of true mentors, the two-siblings formed a close bond early on. Yet each chose a different path into adulthood.

Kenny is now disorderly and rebellious and his fits of anger erupt at all the wrong times keeping him under police radar all the time. Betty Anne has not had it easy either. She's balancing her marriage, kids and job as a bartender.

When Kenny is accused of

the murder of a young woman based only on circumstantial evidence, – before DNA was in use – Betty Anne's life takes a new focus. Time drags on before her brother is even brought to trial, and Betty Anne does everything in her power to find out the truth. When he's convicted, based mostly on biased witnesses' testimonies, Betty Anne knows she can't give up on him.

Years go by, and Betty Anne goes through a divorce, suffers alienation by her children and is forced to work even harder as she begins night school to get a law degree so she can better fight for her brother's appeal. That sounds totally Hollywood except it's a true fact.

When Kenny, depressed and with little hope, tries to commit suicide in prison, Betty Anne tells him, "You promise that you'll stay alive and I will go to law school."

The film is too long and misses some key opportunities to build on the real drama. We get a lot of what Betty Anne does over nearly 18 years, but a lot of it is too repetitive. The story is interesting and Swank and Rockwell's performances keep the intrigue building. Swank is great at intently focusing on a character as she did in her Oscar-winning roles for Million Dollar Baby and Boys Don't' Cry. But the overburden script dilutes some of her forte here.

Again, because the majority of Rockwell's scenes are in jail, there's little room for him to explore his strength as an actor but a few scenes do stand out revealing the emotional depths that Kenny suffers and can't abide. Melissa Leo does a good job as the suspicious cop who might have framed Kenny. Minnie Driver plays Betty Anne's best friend but has little screen time. Juliette Lewis, one of Kenny's former ex-girlfriends to testify, is quirky and relevant as usual

It's difficult to say who will like *Conviction*. It's not a great film, but not really bad either. Mostly it will appeal to Swank fans and those who like true crime dramas.



Pans of Bruce Willis, Morgan Freeman, Helen Mirren, John Malkovich, Richard Dreyfuss, Karl Urban, and Mary-Louise Parker won't go wrong with *Red*. Based on a 2003 three-issue cult classic D.C. comic book, the movie has plenty of action, comedy and a touch of romance.

Frank Moses (Willis) is living the quiet life as he flirts with his pension service worker, Sarah (Parker), over the phone. He plans a trip to meet her, and that night, an assassination team tries to take Frank out. His identity compromised and his conversations with Sarah now recorded, puts her in danger. Frank rushes their meeting ahead of schedule. The assassins are hot on their heels, and Frank is forced to assemble his retired black ops team (Freeman, Malkovich and Mirren) to help solve the mystery why RED (Retired Extremely Dangerous) agents are being assassinated.


Director Robert Schwentke (The Flight Plan, Time Travelers Wife), does an excellent job of working with the top-notch cast and action sequences that fit the big screen. However Red has nothing new to offer in terms of an action movie and is a little predictable in some respects but should be enjoyed due to a good mix of actors and actresses combined with a decent and funny script.

The impressive cast is the main reason to see this film. Willis does his typical style of acting which we are all familiar with, tough as nails and mostly emotionless, but has a soft side that appears every now and then. Malkovich plays an interesting role as a crazy conspiracy nut and one of the more interesting characters in the movie.





# **Bolts 'Rammed'**

n a dark afternoon there was no thunder-and-lightning. There was no pouring rain on a slippery field. No overwhelming deafening crowd noise. No spooky Halloween-clad fans in a hostile coliseum. There were no excuses period.

Last Sunday the Chargers lost their fourth consecutive road game to the St. Louis Rams 20-17.

It didn't seem possible after losing to the Raiders the week prior, it would get worse. Most thought the game against the Rams was a sure victory for San Diego, especially since the Detroit Lions throttled the Rams 44-6 a week earlier. The first six games were supposed to be the soft part of the schedule. The Bolts have now faced teams that drafted 1st, 5th, 6th, and 8th in the 2010 NFL Draft. Not quite the cream of the crop.

The Rams jumped on the Bolts early scoring 17 points in the first half to San Diego's 3. Two touchdowns came on long Rams drives of 80 and 67 yards.

The Chargers did valiantly attempt a comeback with 2 second half touchdowns of 68 and 76 yards but fell a field goal short in the end. Chargers kicker Nate Kaeding drove a long fourth quarter field goal attempt low into the pile that was blocked (possibly attributed to a pulled groin muscle).

True, the Rams played good enough to win, their defense played well and rookie quarterback Sam Bradford made the plays when they needed it. But again, the (2-4) Chargers helped beat themselves and did not deserve a victory.

They allowed seven sacks of their quarterback Philip Rivers. He was hit more than twice that. There were seven dropped passes by the Chargers, two on the defensive side of the ball for sure interceptions. One of them by linebacker Stephen Cooper (a pick six) that should have gone for a score, a six-point swing. One by a wide-open Antonio Gates. Three by wide-out Buster Davis.

The Chargers committed too many costly penalties The defense allowed too many drives and could not stop Rams power runner Stephen Jackson (29 rushes, 109-yards, 1 TD).

San Diego was plagued by injuries to their ball catching receivers. Antonio Gates left the game with an ankle injury in the first quarter. Malcolm Floyd pulled a hamstring in the fourth quarter and did not return. The Chargers were already without the services of receiver Legedu Nanee for the game due to a prior injury.

Without his top receivers Chargers quarterback Philip Rivers did complete 22-of-37 passes, 1 TD, 1 INT. Wide receiver Patrick Crayton (acquired from the Dallas Cowboys in a trade) did have a coming out game catching 7 balls for 117 yards.

"You are what you're record is," confided Chargers Head Coach Norv Turner. "We are a (2-4) team that has struggled to put together a complete game with all three phases. To win in this league, that's what you're going to have to do. We've got a lot of work to do to be able to do that," he continued.

It won't get any easier from here on. The Bolts in their next two home games play the Patriots and Titans.

Game time this Sunday is 1:15 p.m.



### Chocolate is no treat for pets

hocolate Halloween candy may be a treat for children Chocolate Halloween candy may be a first but poses a serious threat to pets, warns an expert. Pets who consume chocolate can experience vomiting, diarrhea, excessive thirst and urination, irregular heartbeat, tremors, seizures and even death, said Susan Nelson, a Kansas State University veterinarian. These problems are mainly caused by a substance in chocolate called theobromine.

Different types of chocolate have varying concentrations of theobromine. Baking chocolate contains the most, semisweet and milk chocolate sport a medium amount, and white chocolate has the least, Nelson explained in a university news

If your pet consumes a large quantity of chocolate, you should call a veterinarian or emergency clinic immediately, Nelson said.

"Chocolate consumption is a very common problem among pets, dogs especially," but it can also harm cats, birds, rats and ferrets, Nelson said in the news release. "It is important to recognize that individual reactions vary by pets, but it is best to assume your pet is one of the sensitive ones and not delay in seeking advice from your veterinarian. Be aware of the chocolate sources in your house, and tell any new dog owner about this potential threat to their pet.

In order to protect pets, she suggests keeping all foods out of their reach and confining pets during family gatherings and parties so that guests don't feed them
