The El Cajon Fire Department management staff is now Heartland Fire and Rescue. As of January 1, 2010, the Cities of El Cajon, La Mesa and Lemon Grove entered into a joint exercise of powers agreement (JPA) for management and delivery of fire protection and emergency medical services-this will save a combined \$560,000 annually.

The San Diego County Taxpayers Association (SDCTA) gave top honors to the Heartland Fire & Rescue JPA with the "Grand Golden Watchdog" award-this award highlights smart, sensible practices in taxpayer-funded programs.

Overall Crime is <u>DOWN 21 PERCENT.</u> Violent Crime is <u>DOWN 13 PERCENT.</u> Property Crime is <u>DOWN 23 PERCENT.</u> Domestic Crime is <u>DOWN 24 PERCENT.</u>

The downtown area has gone through a major face-lift- a distinctive City of El Cajon sign, new sidewalks, seating, streetlights and "way finding" signs. New businesses have arrived and more are coming! We just completed a major renovation of the downtown Prescott Promenade. The refurbished park features a covered amphitheater area, plenty of informal seating, and walkways designed for pedestrians as well as classic cars, vendor booths or a host of other activities. We'll be able to host larger events in the downtown area.

El Cajon is one of the most successful cities in San Diego County regarding recycling and resource recovery. It is recognized as the only "Zero Waste City" in San Diego County and only one of a few in the State of California. Our Solid Waste Vehicles are operated by clean natural gas from a landfill.

The City of El Cajon is recognized by the Federal Government as a "Tree City USA" because of our efforts in promoting the value and benefits of tree planting. This "Urban Forest" maintains a natural environment for all our residents, now and in the future.

The shelter has a "no kill policy"- every pet that can be saved will be saved. Each animal is checked, treated if necessary and micro chipped by a veterinarian before being placed for adoption.

New Tagger Hotline nets three just hours following news conference

Definition of the announcement of the new El Cajon Tagger Tip Line, an El Cajon resident saw a group of individuals using spray paint to vandalize the rear of a business. The reporting party kept watching the suspects as he called the police department. He directed officers to the location of the vandals and they were arrested. Three juveniles were taken into custody for this incident.

The City of El Cajon has seen an increase in graffiti over the last several months. During the last year, there have been approximately 4,000 incidents of graffiti reported to the City of El Cajon's graffiti removal hotline. This is an approximate 45 percent increase from the previous year. In an effort to reduce graffiti in El Cajon, the City of El Cajon, in partnership with the El Cajon Community Development Corporation and Crime Stoppers, unveiled the El Cajon Tagger Tip Line this week. As was done in this case, if people see a crime in progress, they should immediately contact the police department and direct officers to the location of the offenders. This was an excellent example of the important role community members play in helping to combat crime in their neighborhoods. People with information regarding the identity of graffiti vandals can reach the El Cajon Tagger Tip Line from the El Cajon Police Department website at www.elcajonpolice.org, or the Community Development Corporation website at www.downtownelcajon.com. Anyone with information that leads to an arrest could receive up to a \$2,000.00 reward and remain anonymous.

Mission Federal opens first-ever Credit Union at Junior Achievement BizTown

alling all fifth graders! ✓Mission Federal Credit Union today announced the opening of the first-ever credit union at San Diego's Junior Achievement BizTown. The Mission Federal BizTown Shop will serve more than 12,000 participating fifth-grade students each year, through financial education and real-world business experiences.

"This ideal matchup pairs the financial education missions of both Mission Federal and Junior Achievement into one powerful experiential learning environment for students,³ said Tricia Link, vice president of community relations and external affairs, Mission Federal Credit Union.

JA BizTown is a 10,000 square foot mini-version of the City of San Diego, in which kids discover how free enterprise really works. Its newest Mission Fed student shop will be joining 18 other life-size local businesses, the San Diego Foundation, and City Hall. Other community partners include such companies as Sony, Clear Channel, NBC, and Cox.

Each year, 12,000 fifth grade students complete a four-to-six week in-class business curriculum, including economics, good citizenship and money management, and then take to the streets of BizTown for

a full-day to put what they've learned into action. Students apply for jobs and work at the area businesses, and also run for elected offices. Students must develop their business operating budget, apply for business loans, create advertising and refine their marketing strategies in the classroom in preparation for their JA BizTown visit. Students also practice being consumers in the economy and are responsible for managing their personal checking and savings accounts

"JA BizTown affords these lucky students the unique opportunity to learn hands-on business skills, team work, leadership, money management, and corporate citizenship," continued Link. "Biz-Town is also an ideal venue to

'Beauty & The Beast' Lumiere ready to light up the stage

ince the story of Beauty & the Beast first hit The big screen and later video and DVD outlets, America has loved the story of a simple girl who longs for true love. Filled with fanciful characters, a wonderful Academy Award-winning score by Alan Menkin and lyrics by the late Howard Ashman and lots of humor, it's a tale fit for imagination. Fifteen years ago a creative team produced a Broadway show of the story that earned critical acclaim. Those same creators have returned to the stage with a new touring show

of Beauty & the Beast and it plays at the Civic Theatre October 26 - 31, 2010.

With a book written by Linda Woolverton, direction by Rob Roth, choreography by Matt West, costumes by Ann Hould-Ward (Tony Award- winner for her work on Disney's Beauty and the Beast), lighting design by Natasha Katz, scenic design by Stanley A. Meyer, sound design by John Petrafesa Jr. and music supervision by Michael Kosarin, there's magic that awaits audiences

Merritt David Janes, who plays Lumiere in the show, took time out of the show's

appearance in Arizona for an interview. He has a cornucopia of artistic talents and appearances including roles in Circle In The Square, The Wedding Singer (Robbie Hart), Sweeney Todd (Sweeney), Little Shop (The Dentist), Two Gentleman of Verona (The Duke), Grease (Danny), and Works of Shakespeare Abridged (Adam). He's performed at Carnegie Hall, Broadway's Beacon Theatre and Notre Dame Cathedral in Paris. Janes earned a Bachelor of Music at the University of Maine. He can perform in different dialects, plays the trumpet, piano and guitar.

Q. Did you specifically go after the role of Lumiere?

MJ: I went in to audition for the lead since I was lucky enough to get both leads in The Wedding Singer and Sweeny Todd. But the creative team thought Lumiere was a better fit for me, and I am glad because I'm having so much fun with this character.

The original story is about Belle, a young woman in a provincial town, and the Beast, who is really a young prince trapped in a spell placed by an

got together and have given it new life with new choreography, new costumes and set pieces, and they have done a fantastic job.

Q. Is there added pressure to perform a character from one of the most famous stories of all time that's been reproduced in so many mediums?

MJ: There's always pressure if you let it get to you. I had a similar situation when I played the Adam Sandler role in The

Wedding Singer and Sweeney Todd the year after Johnny Depp stared in the film. But while people get used to seeing something one way, it's important to remember what you have to offer and forget yourself in the process. I focus on bringing something unique to the role and offering a different portrayal that people get a chance to experience.

lint Eastwood is one of our most prolific and respected filmmakers. His movie awards are numerous, but he's had a few misses that didn't score well with the general public. Hereafter - based on an exploratory notion of connecting with those who have left us - may be one to add to that list.

Hereafter concerns what might happen after we pass and if it's possible to connect with a loved one through a medium/ psychic. Matt Damon portrays George Lonegan, a reluctant psychic who – after becoming famous for this ability - no longer wants any part of it, even though many want to search for the truth through him.

George tells his brother Billy (Jay Mohr) several times, "It's not a gift, it's a curse." However, Billy continues to leak his brother's fame and one by one people search George out a woman who lost her baby, a twin boy whose brother is killed, a man who lost his wife and eventually a woman who

endures a tsunami – which is detailed in the opening scenes of Hereafter and comes across as one of the best segments of the film.

While the idea of Hereafter and the months of buildup seemed intriguing, I found the movie dull and boring. There's a lot of unevenness in the story, including how George continually tells everyone "I don't even do this anymore," then backs down and holds their hands until he gets that bolt to his body which means he's in contact

with the person's deceased connection.

Because the film focuses on only a few main subjects and spends little time on each, we can't bond or care about the characters. Damon reaches some emotional peaks but seems detached by his stilted and repetitive dialogue. The only time he seems to come alive is when he's in a cooking class - a totally fish out of water for this story – with a young girl played by Bryce Dallas How-

MOTOR SPORTS Chargers fumble away another win

The San Diego Chargers were defeated by the New England Patriots 23-20 last Sunday in a tough, gut-wrenching loss. Continuing their mantra this season, the Bolts got behind early, made critical turnovers and mistakes, rallied in the second half, only to fall short on the scoreboard.

Chargers fans left Qualcomm Stadium stunned after watching their team give it away with four first-half turnovers. The Chargers stepped on their own feet with three lost fumbles and an interception before the intermission.

"We don't give ourselves a chance to win football games with the things we do early in games. This game was a totally different group of guys with the same type of plays," confessed Chargers head coach Norv Turner.

On the first play Bolts wide receiver Buster Davis lost the ball, luckily recovering his own fumble. A portend of what was next to occur.

Backup tight end Kris Wilson continued the malady fumbling after being hit by Patriot inside linebacker Brandon Spikes.

Then it got more strange... Wide receiver Richard Goodman starting his first game for San Diego caught a 25-yard Philip Rivers pass, then put the ball on the ground without being touched by a defender. New England recovered the fumble.

On the Chargers next possession, Rivers threw a lateral to Jacob Hester who let the ball go. Patriots linebacker Rob Ninkovich scooped up the ball and rambled 63-yards before being tackled by Rivers at the Chargers 8-yard line.

Totally bizarre... Chargers special teams had another meltdown allowing a 34-yard punt return. Cornerback Antoine Cason was flagged for a pass interference penalty allowing another New England scoring drive.

All of these mistakes led to three first half New England scores. A one-yard TD pass from Brady to TE Gronkowski and 2 Gostkowski field goals (40, 35).

The Patriots led at halftime 13-3. The third quarter wasn't any better.

A 15-yard Antonio Garay roughing the passer penalty on the second play after halftime was critical in allowing New England's longest drive of the game 17 plays, 79-yards. This culminated in a 1-yard Green-Ellis TD run making the score 20-3 Patriots.

Fourth quarter action saw the Chargers fighting back, first scoring on a Kris Brown 28-yard field goal. Brown was signed earlier in the week to replace the injured Nate Kaeding (groin).

After another Gostkowski field goal (35-yards), the Bolts trimmed the Patriots lead to just three points (23-20). Quarterback Philip Rivers again valiantly guided his team to two late touchdown drives (Gates 5yard pass, Tolbert 1-yard run).

The Chargers defense played well enough to win.

They stopped a signature Belichick decision to go for it on fourth down. Bolts linebacker Antwan Applewhite stuffed running back Green-Ellis for a 2-yard loss, turning the ball over to the Chargers with over a minute and change left in the game and renewed hope.

Rivers guided his team to the Patriots 27-yard line. After a false start penalty by Louis Vazquez put the team back 5yards, Kris Brown attempted a 50-yard game-tying field goal that bonked off the right goal post depicting the way the Chargers season has gone this far.

The Chargers out-gained the Patriots 363-yards to 179.

Next up: Tennessee Titans at Qualcomm Stadium. Kickoff 1:05 p.m.

undreds of youth bands start up every year – the kids' starry-eyed dreams hang in the balance that they will be something unique and find fame and fortune. This summer San Diego saw the emergence of vet another hopeful group when the Dannie Marie Band started playing in different arenas. Their mix of country rock, pop, some original tunes and Christian worship music made instant fans of their audiences, but their demeanor, influenced by band leader Dannie Marie Pupa, set the group solidly apart from their peers.

Along with the inclusion of a few worship songs, these young Christians are not afraid to let their listeners know how faith guides them and their music. But it's their uncontainable joy that speaks louder than their heartfelt words about who they are and what there mission in life is all about.

Dannie Marie started in Christian Community Theatre as a young child. She acquired her guitar when she was 16 and started writing songs. Her parents are very supportive of her musical passion, even allowing her to go to Los Angeles to attend music workshops. "I had written some original songs, but I thought it would be awesome to have the full sound of a band; so that was my next step towards a musical career," she said.

Six months ago she announced at her church – Foothills in El Cajon – that she was looking for band members. Shortly after at a church retreat she met Ryan Poole, a drummer who had other friends that played instruments. Adding members Coe Schneider (bass), Taylor Smith (back ground vocalist), Obediah Byrd (electric guitar) and Tim Amposta (acoustic guitar), the Dannie Marie Band was born.

Dannie Marie writes a lot of the original music and her mother who is also the band manager, writes some as well. Since she was young, Dannie Marie said she loved the imagery and energy of emotion created in her acting classes. She soon learned how to transform that creativity into writing songs. "I picture it as a music video, seeing the story in my head and then I start writing the lyrics," she said. "I get my guitar and start strumming chords together and pick out the melody for the chorus

then come back to the bridge. The band members write their own riffs and instrumental hooks to my melodies."

The process can take four or five hours, but to Dannie Marie this is now her main goal in life. She graduated from Steel Canyon high school and works with her mom in creating a business based on the band. Although someday she would like to attend Belmont University in Nashville, her focus is on reading about songwriting and industry, writing music and playing the guitar – she gets lessons from Byrd. And then there's marketing; booking performances, networking and follow up with people and radio stations. Guiding her every step of the way is her steadfast faith.

"It gives me a hope that never fades," Dannie Marie said. "I know that whatever I'm going through God has a purpose for my life. And I have an indescribable eternal happiness to know that when I die, I'll be in Heaven."

No one can deny that Dannie Marie and her band members don't uphold their convictions. They tell those listening to their band exactly how they feel about God, what he's done for them in their lives and invite them to their church. While some young musicians might see this as a hindrance to their career, Dannie Marie believes this is why she has a career.

"When I was little I felt God put this mission on my heart," she said. "It's not been easy. I've gone through a lot of

rejection and struggling pursuing different paths, and all the time God has been with me working behind the scenes. The strength and hope he has given me is something I want to share with other people, and I feel I cannot leave an audience without sharing this with them."

A few weeks ago Dannie Marie, her mother and band member Coe Schneider made a trip to Nashville to hand out demos of their latest CDs and enjoyed meeting industry professionals and performing at open mic nights. Performing at The Bluebird Café, a Nashville landmark where country stars Garth Brooks and Taylor Swift were discovered, is only one of the highlights of the trip.

This December the Dannie Marie Band will have a CD release party and they are focusing on more shows. Along every step of the way, Dannie Marie never forgets her main goal. "In the Bible there's a great commission that says; 'Go into all the world and preach the good news to all creation.' My main goal in life is to glorify God in all that I do. I hope that's to sell out an arena so I can let everyone in it know about God."

ome for the holidays can mean colorful decorations, sumptuous food and spirited cheer between friends and family. Unfortunately, it can also mean danger for the family pet.

Sweets, decorations and a multitude of guests can adversely affect your pet's health and behavior.

"There are lots of pet hazards during the holidays, but the right training can keep your dog safe," says Dawn Sylvia-Stasiewicz, trainer of Senator Ted Kennedy's dog Splash and Bo Obama, the First Family's dog, and author of the new book "The Love That Dog Training Program."

Common holiday decorations and treats that are toxic to dogs and other pets include mistletoe berries, poinsettia leaves, tinsel and water from a tree stand. In addition, your dog's appetite for unattended holiday chocolates, poultry bones or holiday decorations can result in emergency visits to the vet.

To keep pets safe, try keeping things out of reach or make them inaccessible, such as using a tree skirt to keep dogs from drinking water in a tree stand. But solid training based on positive reinforcement, especially for that new puppy you got for the holidays, is often the best prevention technique.

"Canine communication is usually visual, not verbal," says Sylvia-Stasiewicz. "Starting off with hand signals for 'sit,' 'down,' and 'stay,' encourages your dog to watch you closely, thereby making them more obedient once you add a verbal cue."

You should also positively reinforce good behavior in your dog instead of punishing bad behavior. That means your dog should come to understand that when he sits, he gets a reward -- either a toy or a treat.

"Dogs love making trades for something of equal or lesser value," Sylvia-Stasiewicz says. "If you teach your dog that bringing you a particular object will result in him receiving a more desirable alternative, such as a favorite toy or treat, then he'll be less likely to hold onto dangerous holiday decorations." For anxious dogs, incessant doorbell ringing and an abundance of guests may be unnerving, leading them to act out. In order to give dogs a sanctuary, Sylvia-Stasiewicz recommends rewarding dogs for spending time in their crate. That way, they begin to associate their crate as a safe haven from the party, not a jail from which to escape.

"The lessons learned from good parenting are also applicable in the dog world," says Sylvia-Stasiewicz. "Fortunately, it's never too late to teach an old dog new tricks."

Chocolate is no treat for pets

Chocolate Halloween candy may be a treat for children but poses a serious threat to pets, warns an expert. Pets who consume chocolate can experience vomiting, diarrhea, excessive thirst and urination, irregular heartbeat, tremors, seizures and even death, said Susan Nelson, a Kansas State University veterinarian. These problems are mainly caused by a substance in chocolate called theobromine.

Different types of chocolate have varying concentrations of theobromine. Baking chocolate contains the most, semisweet and milk chocolate sport a medium amount, and white chocolate has the least, Nelson explained in a university news release.

If your pet consumes a large quantity of chocolate, you should call a veterinarian or emergency clinic immediately, Nelson said.

"Chocolate consumption is a very common problem among pets, dogs especially," but it can also harm cats, birds, rats and ferrets, Nelson said in the news release. "It is important to recognize that individual reactions vary by pets, but it is best to assume your pet is one of the sensitive ones and not delay in seeking advice from your veterinarian. Be aware of the chocolate sources in your house, and tell any new dog owner about this potential threat to their pet."

In order to protect pets, she suggests keeping all foods out of their reach and confining pets during family gatherings and parties so that guests don't feed them
