## Groundbreaking of the Sunrise Powerlink

Picket signs lined the dirt road leading to the Old Charger Training Camp in McCain Valley, the Boulevard area of East San Diego County, at the site of the groundbreaking for the new Sunrise Powerlink. Signs reading “Prevent wildfires, Stop Sunrise Profit link underground” and different sayings greeted buses bringing in approximately 300 guests to the Dec. 9 event at Rough Acres Ranch.

Among those picketing the Powerlink was County Supervisor Dianne Jacob. Dignitaries who addressed the invitation only event included Governor Arnold Schwarzenegger, his brother-in-law and son of Robert Kennedy, Joe Kennedy, officials from Imperial Valley, El Centro and Sempra Energy.

The Sunrise Powerlink has a completion date of June 2012. When complete there will be cleaner more secure power with clean energy from the Imperial Valley to San Diego. The audience was informed the Sun Bird helicopter, which was present and purchased for the project, will also help the city, county and Cal-Fire during fires. The Sun Bird can

be reconfigured from a high lift cage to a fire fighting helicopter capable of carrying 2,500 gallons of water.

Governor Schwarzenegger told the audience, “I see a gold mine of clean energy.” He assured those present that wild life and the environment will be taken care of. Schwarzenegger said he felt it took “five years too long” and was too difficult to acquire permits for the project.

Joe Kennedy, with Citizens Energy, informed the group that Imperial Valley and El Centro are some of the poorest areas in the world. Imperial Valley has a 30 percent unemployment rate. He said this project will bring work to the area and benefit thousands of families. The Imperial Valley Board of Supervisors was the first to support renewable energy from the valley.

Following the speeches Governor Schwarzenegger, using a gold plated wrench, turned the first symbolic nut on the Sunrise Powerlink project. The Governor then signed the presentation board signifying the beginning of the project. Following the ceremony a lavish luncheon was served.

and Human Services Agency (HHS) has received from the California Office of Traffic Safety (OTS). 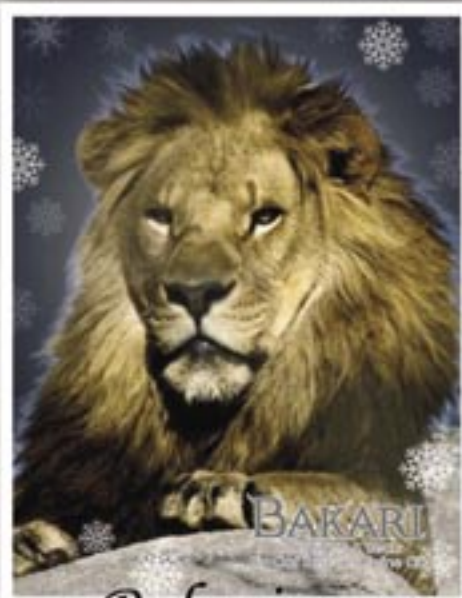

## Resolve to improve your finances

If you dread making New Year's resolutions because you're afraid you'll fall short, take heart: One minor setback doesn't mean having to write off the rest of the year. You'll probably have more success if you start out with small steps and gain momentum as you go, whether it's losing weight, lowering debt or boosting retirement savings.

If your goal is to improve your personal finances, here are a few ideas to get you started:

Most dieters know that the key to success using Weight Watchers is to monitor every

morsel you eat. You become more aware of and thus, more likely to change, behavioral patterns that caused you to overeat in the first place. You can use the same strategy when designing a livable budget.

For a month or two, write down every cent you spend: rent, food, gas, clothes, cable, insurance (health, auto, home), 401(k) contributions, entertainment – everything. The list will probably be eye-opening. Along with the usual suggestions like brown-bagging lunch more often and fewer to-go coffees, try these relatively painless ways to trim expenses:

Pay bills on time and send at least the minimum amount due. You'll avoid late fees and related interest rate increases, and it will improve your credit score.

Balance your checking account regularly and use in-network ATMs to avoid fees.

If your employer offers flexible spending accounts, use them to pay health and dependent care expenses with pretax dollars. If you're in the 25 percent tax bracket that means expenses you'd have paid for anyway will cost 25 percent less.

Reduce energy bills by turning down the thermostat, weatherproofing your home, turning off "energy vampire" appliances when not in use and buying energy-efficient appliances.

Raise insurance deductibles and shop around for better rates.

With the money you save, start paying down debts more quickly. One strategy that often works is to list all outstanding balances and their corresponding interest rates. Then each month pay the minimum amount due on each account – except pay as much as possible on the highest-rate account

or loan. Once it's paid off, move to the next-highest-rate account, and so on.

At the same time, start building an emergency fund. Although the ideal of having six to nine months' worth of expenses saved may sound insurmountable, don't be discouraged. Start slowly with a few dollars each month. It won't be missed and might just save you from needing an expensive short-term loan to cover emergency car repairs or another unexpected bill.

And finally, look to the future. Buying a home, paying for college and retirement are all big-ticket items that require sound budgeting and credit management skills. Here are several helpful resources:

# Easy ways to save money in the New Year

## What your eyes tell you

Everyone knows the eyes are the windows to the soul, but few people realize they are also windows to your overall health, allowing eye doctors to see signs of chronic conditions.

# 'True Grit' has it all

Having read Charles Portis' 1968 page-turning novel *True Grit* this summer, I was anxious to see Joel and Ethan Coen's version and to find out how different it might be from the original movie. The Coens claim their offering is based on the novel and not on the film starring John Wayne as Reuben J. "Rooster" Cogburn -- and they're right.

The movie begins with young heroine Mattie Ross (Hailee Steinfeld). She's journeyed from home to seek revenge on Tom Chaney (Josh Brolin), the man who killed her father. That's a tall order for a 14-year-old, but her boots are laced with pure iron will, and every step she takes makes her more determined to complete her mission.

Mattie's first task in Fort Smith, Arkansas, is to ID her father in the funeral home, a

run down shack where Mattie sleeps her first night in a wooden casket. That's because there's no room in the hotels as people have come to town to watching a hanging. After asking a few questions the next day, Mattie learns it's "Rooster" Cogburn (Jeff Bridges) she wants to hire to find Chaney. The one-eyed, hard-nosed U. S. Marshall has a reputation to get his man.

Before Mattie tracks down Cogburn, she has to deal with Col. Stonehill (Dakin Matthews), the auctioneer who underpaid her father for some horses. She bargains with the man like a 40-year-old pro and when he refuses to deal with her, threatens Stonehill with legal action. Newbie actress Steinfeld sets this scene so well, viewers immediately have no doubt she'll make men say "okay" and never whine when circumstances will be too tough for most young ladies.

After a courtroom scene (which unfolds word for word

from over 14 pages in the novel) in which Bridges displays his mettle as Cogburn, Mattie approaches him and explains her situation. When he somewhat agrees, she hands him fifty dollars to seal their deal to travel to Indiana Territory and find Chaney. After several drunken go-arounds with Mattie and teaching her how to shoot her father's pistol, Cogburn sets off with the teenager. They are soon joined by Texas Ranger LaBoeuf (Matt Damon), a man Mattie met at the boarding house and invited along.

Cogburn and LaBoeuf decide to dump the harebrained young girl at the first river crossing, but charging through the roaring river on horseback, she arrives on the other side soaked, but a notch closer toward earning "her spurs" from her doubting companions.

From this point on, there are long miles of hills, riverbeds and stretches of nothing, all made visually striking through

the lens of Roger Deakins (*No Country for Old Men*). Deakins' shots of running streams, and bright sunny days or the morning light etching its way through the Ft. Smith courthouse window ease the images of bloodshed and violence exchanged between Mattie's hired hands and the Ned Pepper (Barry Pepper) gang -- believed to be traveling with Chaney. Deakins captures the scenery and production as if it really were the 1870s western frontier.

Production designer Jess Gonchor (*Capote*) sizes up New Mexico wisely in scene after scene here, and stunt coordinator Jerry Hewitt keeps the stunts vividly exciting with the beautiful horses and gun-fights.

I re-watched the 1969 movie after seeing the Coen version. While that film followed the main plot of the book, it felt like a movie to me even though Wayne did win his first and only Academy Award for his performance. What the Coens have done is to expertly bring every visual from the book to life on the big screen. It was exactly what I imagined while reading the book, and like Jeff Bridges and Hailee Steinfeld were there on the pages telling me the story. The Coens' script is exceptional, putting percise emphasis on the right spots, letting the subtleties arrive in surprises, and using few words to tell a mammoth tale.

The Coens are known for their comedic spin on movies, and *True Grit* contains some

funny lines. However, I had a problem with the casting of Damon (*Invictus*) because too many of his lines are supposed to be the funny ones. Every time he spoke, it took me out of the story and reminded me it's Damon talking. Otherwise a well chosen cast raises these characters right off the page of the book. Bridges (*Crazy Heart*) is beyond excellent as the crotchety cowhand who would rather sell his mother than pass up a bottle of booze, and the chemistry between him and Steinfeld is river deep. Brolin scowls well as Chaney. But it's Steinfeld who mesmerizes in this film. Her resolve to master her character disappears beyond the camera as she becomes Mattie -- and we believe every hardship she endures, cowboy she outsmarts and businessmen she outtalks. She blends innocence and insolence as easily as putting an obnoxious man in his place. This girl (and this actress) has Grit!

Another surprise to this film is the musical score. Carter Burwell (*A Serious Man*) perfectly marries every tune with its scene perfectly. Opening song "Sleeping with the Devil" immediately alerts viewers this is a western. Strands of "Leaning on the Everlasting Arms" recall the blistering differences of gentle people in the Bible belt against violent gun slingers.

*True Grit* has it all -- an engaging tale, adventure, mysticism and a cast that makes it everything happen right before our eyes. Brilliantly done, Coen brothers!

# Inspirations

## Walking In Faith

**I**n Isaiah 6: 8 of the Bible, God said to Isaiah about spreading the WORD, "Whom shall I send, and who will go for us?" Isaiah accepted the Lord's commission and answered, "Here am I; send me."

Although he would go through some bad times before realizing his mission for God, Rick Ivko eventually had the same reaction to that Biblical request. A financial controller with an MBA in finance, Ivko owned and sold his own tax business and is now controller of a company. While easily tackling financial problems, it took Ivko a little longer to

conquer some troubles in his own life.

"After an unpleasant divorce and living alone in an apartment, I found myself crying out to God," he said. "I had gone to church growing up and thought I understood the gospel. But then I started to read the Bible and began to really understand it for the first time in my life."

A few years later he met Katherine. She took him to her church – the first time in 18 years that Rick had been back in church. Ivko said he wallowed in misery for six months and finally the Lord reached out to him. Ivko was baptized at age 35 and volunteered to do short-time mission work in Mexico, Argentina and Columbia.

"One Sunday, 13 years ago at church a few guys got up and said they needed some volunteers for prison ministry," Ivko recalled. "They quoted Isaiah 6:8 and asked, 'who will come with us?' I stood up and said, I will, send me."

His call to work in prison ministry began an entirely new road for Ivko's life. He married Katherine and later they begin to attend Sunrise Community Church. At the church he oversees a letter writing

ministry where men volunteer to exchange letters and guide prisoners. He also serves in various aspects of prison ministry at Central jail, George Bailey Detention Facility and the Donovan State Correctional Institution. He performs this service with a team, and each two-member team rotates to serve every other Sunday. All volunteers must undergo a background check.

"The different jails have different programs," Ivko said. "In the San Diego jails, run by the Sheriff's department, the jail ministry is about studying the word of God. Another volunteer and I go inside and are locked in with the inmates. We create a praise and worship service inside the jail sometimes bringing a boom box, CD or iPod."

It takes a passionate and dedicated servant of God to understand the situations these men are in and what they are really seeking. Some are seriously looking for spiritual guidance. Others, said Ivko, may want help with family problems, are just looking for a friend, or someone to listen to their story.

"At the end of our message we allow prayers requests for the inmates or family members and have an altar call. Some of the men are already Christians and might want to rededicate their lives; others just might want to have somewhere to go, so we try to fill all of their needs. Then we call the deputies, they remove those guys and bring in a new batch. We do two services each Sunday afternoon."

Things are very different at Donovan. The state prison uses the Kairos International Program for Incarcerated Men. Kairos is the Greek word for "time," used in the sense of a time set by God for a particular occurrence. Volunteers for this program must go through a six-week program before going into the prison.

"We work with the prison warden, chaplain, doctors and other educators and present a four-day program that focuses

on bringing the love and forgiveness of Jesus Christ into prison," Ivko said. "Through a series of talks we build upon the importance of us being open to the inmates, and them open to us, other inmates, and to Christ."

About 18 inmates participate in the classes but the volunteers can never forget some of these inmates are dangerous and hardened criminals. "This is a mix of men who are in the yard for five years to life," Ivko said. "Those who come into our program range from real believers to professed Satanists, and we must be ready for anything."

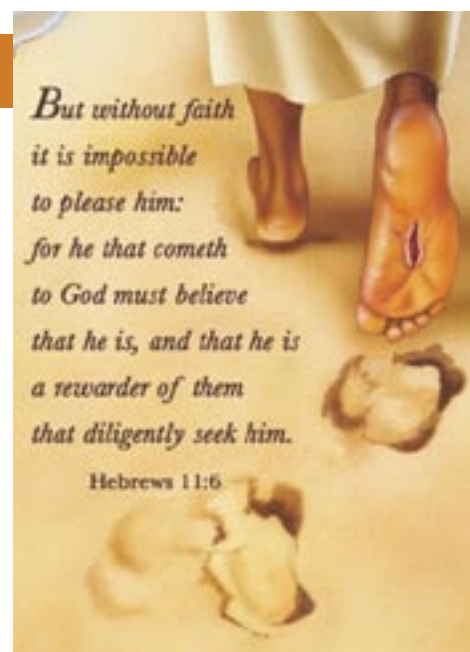
Ivko said his wife and children are very supportive of his ministry. He knows that studies have shown prisons that participate in the Kairos program experience a drop in recidivism of about one-third of inmates who would otherwise return to prison.

"It's an interesting culture, interesting institution, and very complicated," Ivko said. "The main focus is the security of the inmates they're watching, the guards and the folks that work there. We're in their house and have to play by their rules, but the staff and most of the inmates are all very nice. They're just human beings who made bad choices."

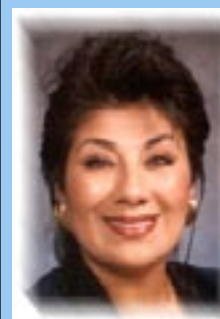
It's hard to measure the effectiveness of these volunteers as prisoners come and go with no follow through by the volunteers, but Ivko knows he and the other volunteers are changing lives.

"I think all of us feel the best ability is availability," he said. "All we have to do is show up and the Holy Spirit does the rest. It makes me feel good to know that I'm doing the work of my Father because that's what we're supposed to do. Evangelizing the lost whether on a mission field or in a prison is the work the Lord has given me."

Ivko heard that call, "Who will go for us," and is fulfilling his Walk In Faith with dedication and passion.

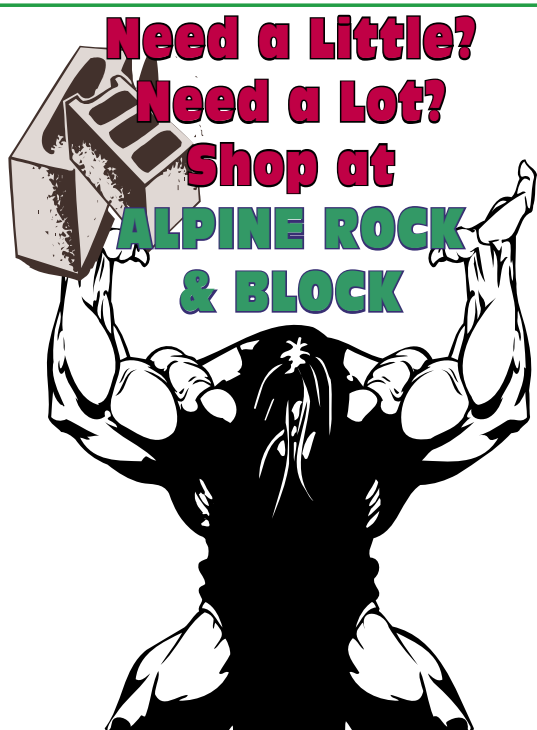

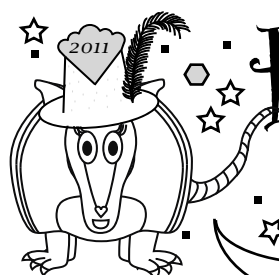

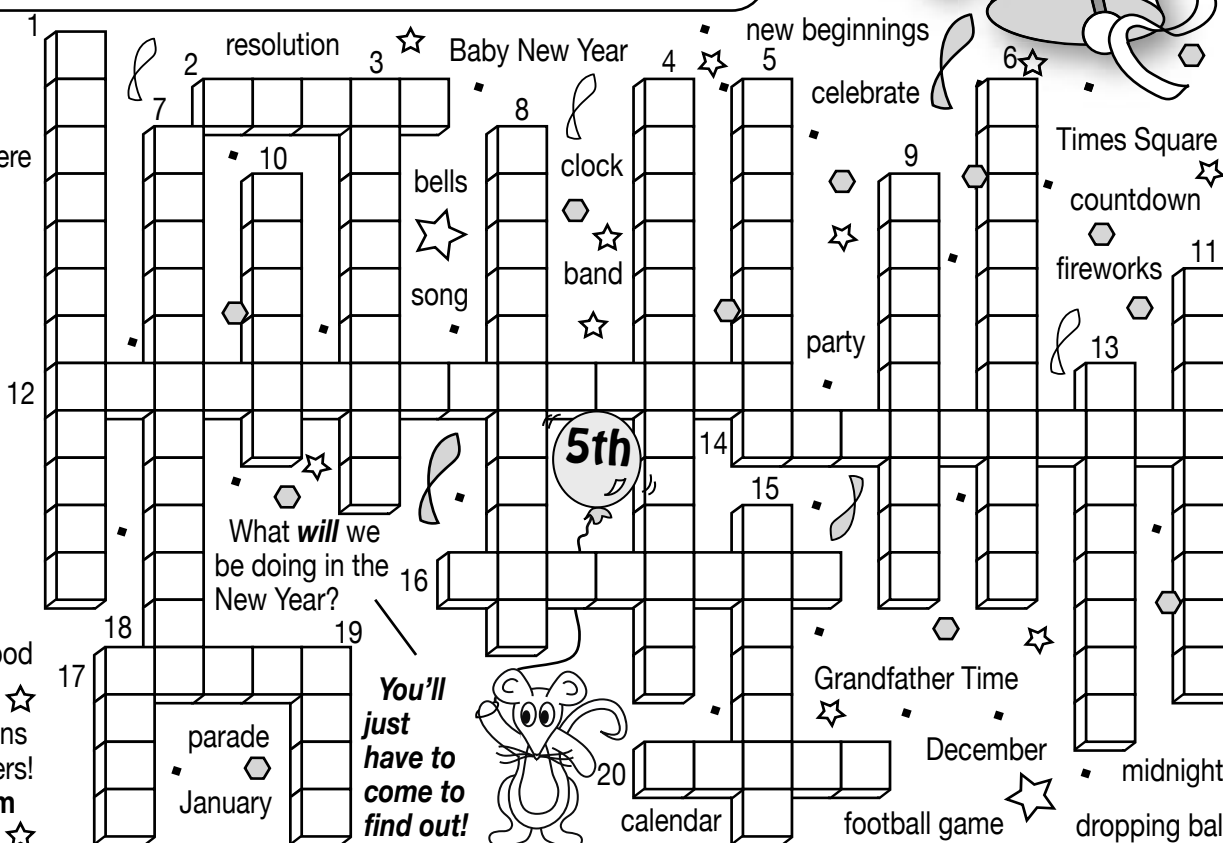

## Chargers pummeled in the cold

**I**t was a cold, snow flurried afternoon at Paul Brown Stadium in Cincinnati, Ohio. The Bengals playing the role of 'The Grinch' a day after Christmas pummeled the San Diego Chargers 34-20. Ending the Bolts season long hopes of reaching the playoffs and capturing the AFC West title.

There were a lot of ways to describe this game. Shocked, surprised, and devastated are the words that come to mind.

Shocked by a meaningful game, ending in a painful loss to a Bengals team that now own a (4-11) record.

Surprised in the way the Bengals offense riddled the

Chargers NFL #1 ranked defense. Led by former Pro-Bowl quarterback Carson Palmer. Passing for 269-yards, four touchdowns, no interception. He did this without top wide receiver's Chad Ochocinko, and Terrell Owens. Instead he utilized the club's new young receivers Jerome Simpson (6-124), Andre Caldwell (4-87), and Germaine Gresham (4-56). Palmer finished the game with a nearly perfect Q.B. rating of 157.2. Also shocking, was the way Cincinnati ran rampant through the Chargers D for 102-yards with Benson (52) and Scott (50). "I thought the Bengals played great. "We knew coming in they could run the ball. They got a Pro-Bowl quarterback who played like one today," confided Norv Turner.

Devastated are the (8-7) Chargers players, staff, and fans knowing that officially the 2010 season will soon be over with one more game left on the schedule. This loss and season is a tough one to swallow.

The Bengals are the kind of team, and Cincinnati is the kind of place, the Chargers did not want to fall behind early. But that is exactly what they did.

"It's obviously hard because our guy's put a lot of preparation in this game," explained Chargers Head Coach Norv Turner.

"They've put in a lot of preparation in everything they've done starting in March. To have it come out and end the way it did today and not play the way we like to play. We didn't take care of the ball the way we've been taking care of it. Obviously it gets you."

In the first quarter of play, on the very first play of the game. The Bolts botched a daring double reverse. Mike Tolbert after getting a handoff flipped the ball to Vincent Jackson at the 20-yard line. With no defenders around him, it appeared the play would go for an 80-yard touchdown. Fate

would have it, when Jackson fumbled the ball kicking it into his own end zone. Recovering it, he somehow managed to avoid a safety and was tackled at the 1-yard line.

On the ensuing change of possession play, Mike Sci-fres facing a gusty, freezing wind shanked the punt. This gave the Bengals offense a short field leading to their first touchdown, on a 3-yard Palmer to Gresham pass and reception.

To add injury onto insult, Mike Tolbert fumbled the ball on the Chargers third offensive series, suffering a neck and shoulder injury after being tackled. The game was halted with tension in the air not knowing the severity of his injury. He did give the thumbs up sign while he was being carried off the field strapped to a gurney and did not return to the game.

The second quarter saw a lethargic Chargers offense

kept out of the end zone. The team did manage to score 3-points from a 20-yard Nate Kaeding field goal. This after Cincinnati scored their second touchdown on a 10-yard Palmer to Simpson pass and catch.

In the third quarter, there was hope for San Diego. Down in the score 13-3. The Chargers offense came to life on an 8-play, 86-yard drive culminating with a career long 23-yard TD run from rookie Ryan Mathews. That score put the Bolts to within three points at 13-10.

The Blue and Gold offense however could not keep up with the orange and black striped Bengals in the fourth quarter. Cincinnati out scored San Diego 21-10 in the final period.

The Chargers will finish their season this Sunday in Denver with both teams left with nothing to play for except their pride.

# 2011 Ford Mustang V6

Anyone who remembers the sequential tail lights that was found on the 1965 Ford Thunderbird as pretty cool might be excited to know that Ford brought them back on the 2011 Ford Mustang. I really like that action, and I love this Mustang even though it's a V6. But it's also available with a six speed manual transmission that has about the closest shift-ratio of any other transmissions out there – short shifter, all about retro – and that is a great thing.

Looking at the Mustang from the front it is all about stance, and this car is moving while standing still. In fact all angles are pleasing to the eye. My tester was Race Red with the glass panorama roof and wow does it let in the sunshine; thank goodness for a pull shade cover. The seating is very supportive, comfortable and my tester came with leather seating, I could adjust my driver seat electrically six different ways, the passenger gets two adjustments. Dash is basic, well done for easy control operation, why they put a 12-volt receptacle in the middle of the dash between the top vents, strange but at least you won't have to hunt for a receptacle!

I mentioned the 3.7-liter V6 power plant, which is very impressive, 305 horsepower and 280 pound-foot of torque, and for a great launch the V6 comes with an optional V6 Performance Package that includes 255/40R19 tires, 3.31 Ratio Limited Slip Axle 19-inch Mach/ Painted Aluminum Wheels all for an additional \$1,495. Even though this package will make drivers some what of a Ricky-Racer, its still be able to get 19 MPG in the city and 29 MPG on the open road.

The scene from behind the wheel screams retro with a big fat leather wrapped steering wheel with controls for audio and cruise control all at a finger tip, plus Ford Sync, also operated either with voice or steering wheel.

Safety is all around those inside with front and side airbags, a crash alert system, tire pressure monitor, and the best back up camera system I have seen so far. Put the car in reverse and the top left corner of the inside rearview mirror illuminates a crystal clear view of what is in back of the car, plus guide lines for backing up. There is a real back seat that flips and folds flat

for longer items coming from the trunk or just a flat surface to load items.

Ford engineers did a fabulous job on the exhaust tones coming from dual stainless steel exhaust with chrome tips sticking out the back. My tester came from El Cajon Ford and

you can stop by and take it out for a spin if it hasn't sold by the time this goes to print.

A good thing to note for those V8 lovers, with a V6 insurance is cheaper and gas mileage is better with less maintenance. Those not convinced can buy a Mustang V8 for a base price

of \$25,845 (on this model) and have the time of their life. I say; if you're not smiling when you drive your car or truck, get a new vehicle!

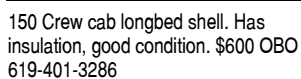
