## Alpine Veterans Wall of Honor moving forward

**P**lans for the Alpine Veterans Wall of Honor are moving forward. Three weeks ago the Alpine Community Center Board of Directors approved the start of the construction of the wall as soon as the funds were received and

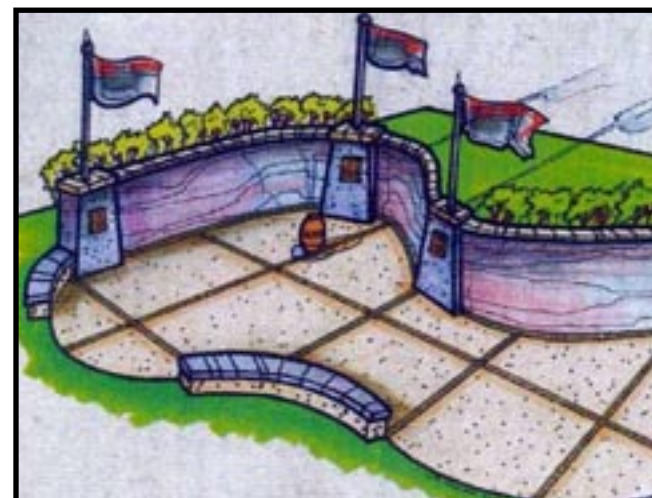
county permits issued. The wall is a partnership between the Alpine Community Center and the Kiwanis Club of Alpine.

Dan Foster, Chairman of the Veterans Wall of Honor Committee, picked up the permits from the county last week and is excited to proceed with the vision to create a space of thanks, peace and reflection to

immortalize the names of those from our community who have proudly served for all future generations to respect and admire. "This will be a source of pride for all members of the community," Foster said.

Several fundraisers were held last year to raise the needed funds to begin construction and many local community

members have also generously contributed to the project resulting in nearly \$80,000 being raised. San Diego County is providing \$41,500 to the project. To date approximately \$10,000 has been spent on drawings, plans and permits. The total cost of the wall will be approximately \$70,000, with money set aside for long-term maintenance.

"It is so wonderful to live in the United States of America and to have a dream that can turn into a reality," Foster said. "Without the help of the best committee ever and all of the caring giving people of this community, we could not have gotten this far."

At 9 a.m. on January 29 at the site next to the Alpine Community Center, there will be a Labor of Love – where community members can move ground in honor of the veterans who have served this country.

"It's a chance for everyone to have a hand in the construction of the Wall," said Veterans Wall

of Honor committee member Herb Cawthorne. "The Labor of Love begins the construction and the celebration of a proud moment for the community. Put on your work clothes and come help build the foundation of the Veterans Wall of Honor."

It is the hope of the committee to dedicate the wall on or before Memorial Day. Urgency has always been important to Foster as the WWII veterans yet alive are dwindling.

"It's vital that we congratulate and show our World War II heroes' names on this wall, which is a Wall of Honor not just a memorial," Foster said.

The "Vial of Life" is a special brochure that holds your vital health care information and speaks for you when paramedics, firefighters or law enforcement respond to your home for an emergency. It informs emergency crews of any health issues you may

have, and most important the "current" medications you are taking in the event you are unable to communicate due to a possible language barrier or if you are unconscious. It also comes with a DNR (Do Not Resuscitate) form and a health information card to carry in your wallet. These are "free" to the public and available at our Heartland Fire stations, weekdays, during regular business hours. They are available at the front office of the El Cajon Fire Station located at 100 E. Lexington Avenue, at La Mesa's Fire Station offices at 8054 Allison Avenue and at Lemon Grove Fire at 7853 Central Avenue. The Vial of Life was made possible through a grant provided by Grossmont Healthcare District. If you would like a large quantity for your senior group or senior living facility call (619) 441-1737.

**Dispose of that dry-combustible holiday tree**

In El Cajon, you can take your tree to the Waste Management Recycling Center located at 925 O'Conner Street to be recycled. For residential customers with curbside green waste collection services, Waste Management will collect and recycle trees from now until January 14. Trees taller than six feet must be cut in half. Please remove all decorations and tree stands and place the tree at the curb. Flocked trees will be collected but cannot be recycled.

**East County loses a friend**

**Robert Oren Conley**  
**August 25, 1923 to December 18, 2010**

Bob Conley was born in Los Angeles to Nellie Mae and Raymond (Slim) Conley. Because of his work in the heavy construction industry Slim's family moved often with Bob attending five high schools and finally graduating from George Washington High School in Los Angeles in 1941.

Bob was appointed to the Merchant Marine Academy in Kings Point, New York and graduated as an Ensign with the US Navy Reserve.

On June 3, 1944 Bob married Barbara Mae Goodman at the Lakeside Presbyterian Church in Lakeside (current site of Lakeside Historical Society). Barbara's parents, Harvey and Myrtle, were pioneers in the community of Lakeside.

During WWII Bob served in the South Pacific under General MacArthur. ## Contractors State License Board cautions to only deal directly with board for renewal or changes

The Contractors State License Board's (CSLB) Renewals Unit has been contacted by several licensees who attempted to renew their license through an outside business, rather than directly with CSLB. In some cases, doing so caused delays, which resulted in their licenses expiring. As a result, they must now pay late fees.

Earlier today, the Attorney General's Office announced a \$2.4 million settlement against the perpetrators of a similar scheme. CSLB has also learned that the Better Business Bureau (BBB) has received about 50 complaints over the past couple of years about companies that offer to file regulatory paperwork for people throughout the state. The companies have addresses

in the Sacramento and Los Angeles areas, and use business names that usually include the words "Renewal" or "Filing." The BBB complaints indicated that the companies charged a fee to register or change the names of corporations with the Secretary of State's Office or renew or change the names on city and county business licenses, but failed to do so.

CSLB reminds all 310,000 licensed contractors that it sends renewal notices approximately 60 days before a license will expire. The application and renewal fees, or fees to make any other changes to a license, should be addressed directly to:

Licensees should also be aware that credit card payments for renewals or exams are accepted in person at CSLB's Sacramento Headquarters office, located at 9821 Business Park Drive.

Applying for, renewing or changing a license or company name may be done through the appropriate government agency without additional cost. Those with any doubts should contact that government agency directly to assure the appropriate fees are sent to the correct address.

Anybody who has received suspicious mail soliciting fees to act on their behalf or as an intermediary for licensing or changing a business name should contact local police or sheriff's department and Better

Business Bureau to report the suspected fraud. Complaints can also be filed with the Attorney General's Office.

The Contractors State License Board operates under the umbrella of the California Department of Consumer Affairs. More information and publications about hiring contractors are available on the CSLB website or by calling 800-321-CSLB (2752). You can also sign up for [CSLB e-mail alerts](#) and follow us on [Facebook](#) and [Twitter](#). CSLB licenses and regulates California's more than 300,000 contractors, and is regarded as one of the leading consumer protection agencies in the United States. In fiscal year 2009-10, CSLB helped recover nearly \$42 million in ordered restitution for consumers.

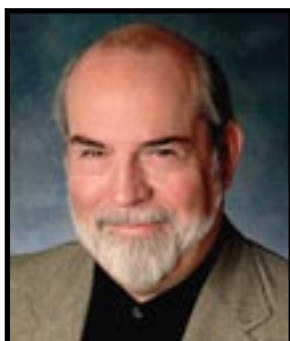

# For Health's Sake

## Don't use ovens or BBQs to stay warm

**S**outhern California Gas Company (The Gas Company) is urging customers not to use their ovens, ranges or outdoor barbecues to heat their homes because these appliances are not designed for such use and pose a severe and potentially fatal risk of carbon monoxide poisoning if used for space heating.

Carbon monoxide is a colorless, odorless, tasteless gas that is formed when carbon-based fuels, such as kerosene, gasoline, propane, natural gas, oil, charcoal or wood, are burned with inadequate amounts of oxygen, creating a condition known as incomplete combustion. When incomplete combustion occurs, carbon monoxide is produced, and this can potentially lead to carbon monoxide poisoning to a family.

The early stages of carbon monoxide poisoning produce unexplained flu-like symptoms, such as headaches, dizziness, nausea, vomiting, shortness of breath and mental confusion. Since carbon monoxide displaces the oxygen in the blood, prolonged exposure to carbon monoxide can lead to death.

Signs that may indicate the presence of carbon monoxide:

- A yellow, large and unsteady gas appliance burner flame.
- An unusual pungent odor when the appliance is operating. This may indicate the creation of aldehydes, a by-product of incomplete combustion.

- Unexplained nausea, drowsiness and flu-like symptoms.

What to do if someone suspects carbon monoxide is present in their home:

- If safe to do so, immediately turn off the suspected gas appliance.

- Evacuate the premises and call 911.

- Seek medical attention if anyone in the home experiences possible carbon monoxide poisoning symptoms.

- Contact The Gas Company or a licensed, qualified professional immediately to have the appliance inspected.

- Don't use the suspected appliance until it has been inspected, serviced and determined to be safe by The Gas Company or a licensed, qualified professional.

# Pharmacists encourage Americans to consider medicine cabinet cleanout among New Year's Resolutions

The American Pharmacists Association (APhA) encourages the public to make an annual medicine cabinet cleanout part of their New Year's resolutions. Pharmacists recommend patients use this time to properly dispose of all the unused and expired medications that accumulated over the previous year.

Because each season brings a host of new illnesses and conditions, it's easy for medicine cabinets to become cluttered with unused or expired prescriptions, over-the-counter medications, vitamins and herbals that can potentially be harmful to one's health. Hanging onto old, expired or unused medications can increase the chances of taking the wrong

one. Old, expired medications can lose their potency thus reducing or providing no value to the condition being treated and unused medications have the potential to be abused and misused.

"As you finalize your resolutions for a happier and healthier New Year, why not add this simple task to your list?" asked Thomas E. Menighan, APhA Executive Vice President and CEO. "A medicine cabinet cleanout is one of the smallest resolutions a person can make for their personal and family's health. To help protect yourselves and the environment, it just takes a few simple steps to properly store and dispose of medications. And if you have any questions about your medications' expiration date or potency, talk with your pharmacist."

Tips for Storing and Cleaning Out Your Medicine Cabinet or Other Medication Storage Areas:

- Medications should be

stored in a secured area that has low humidity, a stable temperature and adequate lighting.

- Check the date on everything in your medicine cabinet and dispose of anything that has passed the expiration date.

- Properly dispose of anything you have not used in the past 12 months.

- Properly dispose of any prescription medications you no longer need. Do not share prescription medications with others.

- Properly dispose of medicines no longer in their original container or that can no longer be identified.

- Properly dispose of medicines that have changed color, odor or taste.

- Do not flush unused or expired medications and do not pour them down a sink or drain.\* They should be

disposed of properly in the household trash or through your community's medication disposal program, when available. Follow these easy steps before disposing in the trash:

- Pour medication into a sealable plastic bag. If medication is a solid (pill, liquid capsule, etc.), add water to dissolve it.

- Add kitty litter, sawdust, coffee grounds (or any material that mixes with the medication and makes it less appealing for pets and children to eat) to the plastic bag.

- Seal the plastic bag and put it in the trash.

- Remove and destroy ALL identifying personal information (prescription label) from all medication containers before recycling them or throwing them away.

## January is National Cervical Health Awareness Month

California Medical Association (CMA) Foundation joins forces with other health advocates across the nation to promote "Cervical Health Awareness Month."

Cervical cancer is the second most common form of cancer worldwide and causes 250,000 deaths a year; 4,000 of those in the United States. Each year, nearly 1,400 California women are diagnosed with cervical cancer and 400 die from the disease.

Cervical cancer is one of the few preventable cancers that can easily be detected through an inexpensive screening and also prevented through a vaccine.

Most cases of cervical cancer are caused by the Human Papillomavirus, or HPV. Millions of American women are infected with HPV, but due to its often symptomless nature, a woman can be unaware of her risk of developing cervical cancer.

"By proclaiming January as

"Cervical Health Awareness Month," this is the perfect opportunity to remind women to schedule their annual screening and also schedule appointments for their children to receive the series of HPV vaccine shots," states CMA Foundation board member, Diana Ramos, MD, MPH.

While cervical cancer affects all races, Latina and African American women have the highest death rates.

In California, Latinas are diagnosed with cervical cancer twice as often as Caucasian women. Research shows that 10 percent of Latinas in California have never had a Pap test, and 30 percent have not had a test in three years.

Mortality from cervical cancer is associated with later stage of diagnosis, and thus poorer access to preventive services, including infrequent or no pap screening and lack of follow-up.

At a recent Cervical Cancer and HPV Vaccine Summit, the

CMA Foundation launched the California phase of a nationwide Cervical Cancer-Free campaign. The Campaign aims to reduce the prevalence of cervical cancer through increased screening and vaccination. California's campaign will focus on Latinas and other groups at greatest risk, those with continued high rates of cancer and low rates of screening and prevention. A comprehensive array of resources for physicians, other healthcare providers and consumers, including online clinical education resources and multilingual patient education materials has been developed and are available on the project's website, [www.thecmafoundation.org/projects/hpv](http://www.thecmafoundation.org/projects/hpv).

# Situations in 'The Company Men' feel very real

Although *The Company Men* takes place three years ago, it could have been any of the last few years as its premise mirrors daily headlines about the loss of jobs. When a Boston based shipbuilding and manufacturing conglomerate begins to suffer huge losses, downsizing is its answer to staying afloat.

Bobby Walker (Ben Affleck) has worked his way into a very comfortable lifestyle. He has a good position with the company, an upscale house in the suburbs and enjoys a regular round of golf with his buds. Faster than Bobby can hit a ball into the sand trap his idyllic life begins to fly away when he's fired.

At first he relies on tried and true friends – Phil Woodward

(Chris Cooper) and Gene McClary (Tommy Lee Jones) – in the company who are amazed at the firing to help him undo this wrong. But in a matter of days their heads, too, are on the chopping block.

Whether poor or well off, getting a pink slip can be one of the most devastating occurrences in one's life. While Bobby's wife Maggie (Rosemarie DeWitt) immediately starts to move into survival mode worried about the bills and their two kids, Bobby has mentally checked out. His priorities include continuing to play golf first, look for a job second, or third, or not at all. When he's literally asked to leave the golf club for lack of payment he finally gets it, and Bobby goes into overdrive to look for work.

Affleck is becoming one of Hollywood's most bankable stars and does not disappoint here. His emotional arc as Bobby who sees the world continuing on while he is drowning, keeps *The Company Men* trotting along.

Phil and Gene deal with their situations in different ways. Even though Phil thinks James (Craig T. Nelson), their boss and CEO of the company, will look out for him, he soon finds out that's a misconception. Phil is also older than Bobby so a new career feels out of reach for him. But more than the financial set back it's the psychological aspect of this action that Cooper delves deeply

into to excellently portray his character. Phil's days with an employment recruiter are painfully real-life in action.

Tommy Lee Jones also ups the intrigue of the film as Gene; a co-founder and close friend to James. He's instantly appalled at his colleague's unapologetic behavior in letting his workforce go while he maintains a luxurious lifestyle similar to many big firm's CEOs.

Kevin Costner plays Jack, a down to earth construction worker who has always seen Bobby as a snob but

tolerated him because he's Bobby's brother-in-law. Jack offers Bobby a job, and when Bobby at first turns it down, Jack filets him like a fish, constantly badgering Bobby with innuendos that his imagined "status" keeps him misguided and bordering on broke. But it's a narrowing of Jack and Bobby's differences that soon unites them.

*The Company Men* is not without its faults, mainly believably in some aspects. Bobby seems arrogant and selfish for too long, lessening the viewer's sympathy for him. There's little to feel bad about concerning Gene. He's very well off financially and should sail off happily into the sunset. The subplot about his overall concern for his fellow comrades could have been explored a little more to even out his arc. Maria Bello, though quite talented, can't make the 21-year difference in age between she and Jones disappear in her role as Gene's lover. There is no chemistry between them which

only adds to some of the film's problems.

Films about losing everything have filled the big screen for decades – *It's A Wonderful Life* (1946) is one of them. And while it's hard to feel sorry for people who seemed to have everything and weren't prepared for "when tomorrow comes"; *The Company Men* still reminds us there are real people in these situations and it's up to employers, voters and head of households to pay attention.

**T**he San Diego Chargers defeated the Broncos 33-28 in Denver. A perfect ending to a bitter-sweet season.

Bitter in the sense, the Chargers played their last game of the 2010 season, missing the playoffs.

Sweet in the sense, that they ended on a winning note. With something to build on for the upcoming year.

In one of the most unpredictable, disappointing, sometimes most entertaining seasons in club history, the Chargers, finished 2010 leading the NFL in both offensive and defensive yards. Given those statistics, one would think this team owned a (14-2) record. But in fact are the only team in the 2010 season to finish at (9-7).

Philip Rivers who threw for 313-yards against the Broncos and led the league with 4,710 yards passing in 2010, summed up the game and the season by saying, "We were pretty fired up and emotional. Anytime you get into a game

like this, the first time for me, and for a lot of us knowing you're not going to the playoffs. It's a tough week. I thought we handled it well and played hard. it's good to get a win."

"In a sense it's like it started... a little sloppy. Made some errors that hurt us (like) during the year that kept us from going to the post season. All in all, it's nice to end on a winning note. Other than the '05 year, it's tough. Reality kind of sets in. Even though we won. It's over. Putting so

much time since last February. It's tough but I think we learned a lot from this year. We finished with a win. We're (9-7). It's not where we want to be or our fans wanted us to be. But I think we're going to have a lot of guy's come (back) determined and re-zeroed in to go right back at it."

There is an emptiness in the stomachs of Chargers fans hungry for post-season play. And uncertainty not knowing if there will be an upcoming NFL season when the owners and players union negotiate on a new collective bargaining agreement.

## Where to get a healthy loving pet

Of the eight million pets that enter animal shelters and rescue groups every year, approximately three million of these healthy and treatable pets are euthanized due to a lack of adoption. While there has been steady progress on the issue, three million cats and dog deaths remains a national tragedy.

"Pets end up in shelters through no fault of their own," says Michael Markarian, Chief Operating Officer of The Humane Society of the United States (HSUS). "Shelter pets make great pets."

To help these pets find homes, there's the Shelter Pet Project, a collaboration between The

HSUS, Maddie's Fund and the Ad Council. It's geared toward all Americans, particularly the approximately 17 million who will be acquiring a pet within the next year. The campaign's public service announcements (PSAs) are designed to inspire pet lovers to make shelters and rescue groups the first place they turn to when looking for their perfect pet.
