# Sunny Side Gateway Project nears completion

he wait is nearly over, the State Route 52 (SR-52) Sunny Side Gateway Project is on its way to becoming reality after two decades of planning. It is scheduled to be completed this spring.

The new permanent northbound State Route 67 (SR-67) off-ramp to Prospect Avenue opened last Friday morning. The new off-ramp is part of the SR-52 Sunny Side Gateway Project.

The California Department of Transportation (Caltrans) and the San Diego Association of Governments (SANDAG) started construction in early 2008 on this vital piece of the transportation plan for the region. When this new four-lane freeway from Santo Road, east past SR-125 and on to SR-67 is completed in early 2011, it will reduce traffic congestion and dramatically improve your travel times during those peak periods.

The SR-52 Sunny Side Gateway Project is broken down into three construction segments. The West Segment from SR-125 east to Cuyamaca Street started construction in early 2008, and was followed by construction of the East Segment at the SR-52/SR-67 Inter-

change beginning May 2008. The final Middle Segment from Cuyamaca Street east to SR-67 broke ground in 2009. An additional project completed last year, added lanes to the existing freeway from Santo Road to Mast Boulevard.

The total price tag for the SR-52 Sunny Side Gateway Project is set at \$520.5 million, which includes design, right of way capital and support and construction capital and support. It contains a variety of state, federal and local funding sources such as \$133 million from the California voter-approved Proposition 1B Transportation Bond Fund and \$35 million from the SANDAG half-cent sales tax measure known as TransNet. It's safe to say that without these latter two funding sources, this project and other transportation improvements in the county and across the state would still be on the design board.

To accommodate even further expected growth along SR-52, Caltrans and SANDAG are preparing for an additional project to widen the corridor after the year 2020. One general-purpose freeway lane and two reversible managed lanes will be added from Interstate 15 to SR-125 – similar to what motorists are seeing along I-15



The new SR-52 Sunny Side Gateway Project brings a number of construction features such as bridges, sound walls, ramp meters, and new on- and off-ramps at Fanita Drive, Cuyamaca Street and Magnolia Avenue. One of the most notable features is the new Cuyamaca Street Undercrossing and Intersection. Bike paths and pedestrian trails will run alongside Forester Creek, offering users a safe and scenic tour of the valley. Pictured above is a map of the SR-52, SR-125 and SR-67 Gateway Project.

A growing number are located in East County so we felt it was important to bring our services directly to the areas most in need. The California Welcome Center at Viejas Outlets is a well-known, very visible and convenient location for East County residents."

C2SDK wants all children and their families in San Diego, regardless of their economic status, to be computer literate and have equal access to technology and the crucial educational, occupational, and financial resources that technology can provide. Economic barriers to technology hinder the growth and development of low-income families and perpetuate poverty. C2SDK responds to this digital disparity and the real-world demand for computer literacy through its Technology Assistance Program that recycles and refurbishes used computers and delivers them to families in need. C2SDK has partnered with local businesses such as Viejas and Barona Casinos, Sharp Hospital, Cox Communications and others, who agree to donate computers and peripherals that they no longer use.

In a continued effort to reduce the number of traffic collisions caused by distracted drivers illegally using their cell phones, San Diego County law enforcement agencies are once again joining in a "Hands Free is Ticket Free" campaign against cell phone violators.

Starting Tuesday, Jan. 18 through Thursday, Jan. 20, officers will focus enforcement efforts on violations such as driving while using a hand-held wireless device and driving while writing, sending, or reading a text-based communication. As a result of that two-day campaign, over 1,000 citations were issued for violating the hands free and texting laws.

# Saddle Tramps fund raiser benefits baby Izaiah

early 300 motorcycle clubs and individual riders from all over San Diego attended the recent fundraiser and Poker run put on by the Saddle Tramps Motorcycle Club. The fundraiser was held for baby Izaiah who was severely injured on October 18, 2010 when an underage drunk driver hit Izaiah and his grandfather as they were out for a stroll.

The ride began at the VFW Hall in Lakeside and riders headed out with stops at El Caion Harley Davidson, South Bay Harley Davidson, Kennedy motorcycle Shop, Biggs Harley Davidson, and ending

at San Diego Harley Davidson where lunch was served. The Saddletramp run generated \$6,055. The winner of the Poker run donated the money back to the Baby Izaiah fund and the 50/50 drawing winner donated part of the money back as well.

On January 11 the money was presented by the club to Jacob and Lucy, Izaiah's parents, at Children's Hospital where they have been staying with their child. Saddle Tramps President Carl Smith said he really commends the family for the way they have handled such a difficult situation.

The Saddle Tramps are no strangers to tragedy. In 2010 while heading to Yuma, AZ to celebrate their 10 year anniversary the club was involved in a deadly crash on Route 98. Twenty one riders on a dozen bikes which stretched several car lengths and passed by a gold Honda civic heading East in the oncoming lane. That forced a white Dodge Avenger carrying a couple from Mexicali to swerve into the Eastbound lane right into the middle of the motorcycles. The driver of the gold Honda Civic remains at large. The accident is still under investigation.

Of those injured in that accident Wilson Traver went home in December and will be in a wheelchair for some time. William Barnes was released from the hospital January 14 and Melanie Barnes has come out of her coma and is recovering at a nursing home. The four club members who perished in the crash were Amy Heath, Lance Heath, George Miller and Tonua Traver. The Saddle Tramps will hold a Celebration of Life for George "Big foot" Miller on January 22, 11 a.m. to 4 p.m. at the VFW Lakeside. All bikers are

# Feeling the pinch? Try these belt-tightening tips


- Lower your thermostat. Each degree you lower it saves up to 3 percent on your heating bill. Turning down your thermostat 10 to 15 degrees for eight hours at night can save about 5 to 15 percent. For a \$300 monthly heating bill, that's up to \$45 in savings.
- Up to 30 percent of heated or cooled air can be lost through leaks, so add insulation, apply weather stripping around windows and doors and caulk around ducts, plumbing bypasses and other openings
- · Water heating is the thirdlargest home energy expense, so try lowering your water heater temperature to 120o F or lower to see if it's still comfortable.



Next to Normal runs at the Balboa Theatre, as a Broadway/San Diego ~ A Nederlander Presentation, January 18-23.

With a thrilling contemporary score, Next to Normal is an emotional powerhouse of a musical about a family trying to take care of themselves and each other. # 'The Green Hornet' — another 3D bust

ħe Green Hornet had its first radio broadcast in Chicago in 1936. The green-masked vigilante would fight crime with his partner, Kato, who drives their technologically sophisticated car nicknamed, "Black Beauty." The Green Hornet has been adapted into television, comic books, and film. Now, in the twentyfirst century the new version of The Green Hornet could have finally utilized all the powers that technology has progressed over the years to be an action-packed blockbuster. Except, they cast Seth Rogen in the lead role. Big mistake!

Britt Reid (Seth Rogen) is a 28-year-old sloth who's been spoiled by his successful father, James Reid (Tom Wilkinson), owner of the Los Angeles newspaper The Daily Sentinel. When Dad prematurely dies and leaves Britt as successor. Britt has no idea what to do next. He becomes friends with his dad's auto mechanic and expert coffee maker, Kato (Jay Chou). Britt decides to take advantage of Kato's expertise in engineering and chemistry so the two of them can fight crime. They

use the newspaper to their advantage to get the public acquainted with deeds of The Green Hornet. Britt hires Lenore Case (Cameron Diaz) as his personal secretary and unbeknownst to her, uses her criminalist background to help plan out the Green Hornet's next move.

This film has been in preproduction limbo since 1992. struggling to find the right actors for the lead roles and a suitable director. In 2007, Seth Rogen was picked as a cowriter and the lead actor. Up until now, Rogen has played in bit parts as a comedic relief with very few lead roles. I've always thought Britt Reid as the strong silent type with a little too much ego for his own good. Rogen just doesn't fit the role and actually as a whole, hurts the film. It's his gruff voice and flippant attitude that ruins his image

Jay Chou is great as Kato. I actually found myself wanting to see Chou more than Seth. He is no Bruce Lee but he does a respectable job in his role. Cameron Diaz is just the love interest of Britt's and Kato and adds nothing noteworthy to the movie. The main villain is Benjamin Chudnofsky (Christoph Waltz), a paranoid and ruthless Russian gangster who wants to take over the entire city. Chudnofsky is a horrible villain and another

bad flaw of the movie. His demeanor comes across bland and boring due to a shoddy

The film is another 3D disappointment that never really takes advantage of the special effect – some of the scenes weren't even in 3D. The fight sequences are wacky, appearing to give Kato the ability to


slow time using magic, but it turns out to be his body using adrenaline to speed up his muscles. The overuse of special effects during the fight scenes is supposed to enhance the 3D effect, but I wasn't impressed. The Car is definitly the centerpiece of the film but it's not enough to save this film from being this year's first bomb.

# The 2011 Toyota Sienna XLE 3.5 — a people move

The Toyota Sienna is another minivan competitor that has held its own in the battle of people movers. Starting at \$24,960 it will make owners take another look and maybe even a test drive.

The Sienna comes with two engines, the thrifty 2.7-liter dual overhead camshafts, 16-valve four cylinder engine producing 187 horsepower and 186 pound-foot of torque. Backed by only one transmission a six speed electronically controlled automatic transmis-

sion with intelligence. What does that mean intelligence? That the Sienna can sense how fast a driver is going and then shifts for the maximum fuel efficiency which is 19-city and 24 freeway. The other engine available is the peppy 3.5-liter dual overhead

camshafts, V6 producing 266 horsepower and 245 pound-foot of torque and the fuel mileage is 16 MPG city and 22 freeway.

But Sienna is really in the people moving business. Never thought about owning a

minivan? Get behind the wheel and make a few trips to the big box store or an outing with the family and be ready to sing another tune.


Standard features on the Sienna include a leather 8way power adjustable driver captain seat and 4-way adjustment for the passenger. There's a removable second row seating that slides, and the third row is a 60/40 split flip and can fold into the floor. No more dragging out seats. The Tri-Zone Climate control system will cool every corner of the Sienna and heat it up if necessary. The sound system is spectacular, and yes there are flip screens for the kids in the second row seating.

The power windows come with pinch protection - I tried it and it works. I stuck my hand into the window opening, flipped the switch and when the glass touched my hand it stopped, nice safety touch. The Sienna has all the safety equipment one could ever dream about. Toyota calls their safety system the Star Safety System, which includes enhanced Vehicle Stability Control (VSC), Traction Control, Anti-Lock Brakes, Electronic Brake Distribution, and Brake Assist. Active headrests, advanced airbag system, front driver and passenger seat side airbags, three row curtain airbags, driver knee airbag, collapsible steering column, and the list goes on.

There are only a few minivans available so picking the right van shouldn't be that tough.

I really liked the way this car drove and handled on the open road, mountains and city streets. What I really liked were the flip and fold rear seats. It mad a trip to the big box store a snap.
