at more than 1,600 participating retail locations in Southern California receives a chance for an online lottery "second chance drawing" PLUS:

# For Health's Sake

## Local tribes participate in Longest Walk

The Longest Walk III – a 5,400-mile relay across America to draw attention to diabetes in Native Americans – will kick off at La Jolla Shores on February 14, led by Dennis Banks, co-founder of the American Indian Movement (AIM). The Longest Walk III will cross through the states of California, Arizona, New Mexico, Texas, Oklahoma, Arkansas, Alabama, Mississippi, Florida, Georgia, South Carolina, North Carolina, and Virginia and end in Washington DC on July 8.

"Diabetes has reached an epidemic state in Indian Country and the percentage of diabetes

amongst Native Americans is rising" said Dennis Banks. "It is important to educate people on the dangers of this disease and the risks of amputation caused by diabetes."

Opening ceremonies, directed by Orlando Vigil of Taos New Mexico, will commence at 6 a.m. at La Jolla Shores and include a prayer by a local elder, Bird Singers, a three-hour ceremony featuring doctors, foreigners and speakers and will conclude with a pipe ceremony. Dennis Banks will provide detailed information pertaining to the walk.

Vigil will also guide and walk with members of many

Southern California tribes to and throughout the southern tribal nations of the Diegueno Kumeyaay, Cupa, Luiseno, Serrano, Cahuilla, Chemehuevi, and Quechan territories.

Key organizers in each state are developing evening lectures by Banks for walk participants. Lecture topics include the benefits of juicing vegetables and a program to reverse diabetes across Native America.

The walk will also provide the opportunity to collect diabetic concerns and stories and develop this information into a personal in-depth perspective from the Native view. In addition, the U.S.D.A and Banks will campaign for Indigenous lands to set aside two million acres of prime farming land into large vegetable gardens to begin supplying Native people with fresh produce. According to Banks, "A garden will help establish good nutrition and encourage exercise, which supports a 50-year program in development to reverse the symptoms of diabetes."

Diet, insulin, and oral medication to lower blood glucose levels are the foundation of diabetes treatment and management. Patient education and self-care practices are also important aspects of disease management that

help people with diabetes lead normal lives. Complications from diabetes can lead to heart disease, stroke, hypertension, blindness, amputation, kidney disease and nervous system diseases. Additionally, people with diabetes are much more susceptible to other illnesses.

Members of the Sycuan Band of the Kumeyaay Nation have resided in and around the foothills of the Dehesa Valley for nearly 12,000 years. Today they are a modern government providing public services to their members, employees and neighbors. The Sycuan Tribal Government operates one of the region's premier Indian gaming and resort facilities, the Sycuan Resort and Casino. The Sycuan Tribe demonstrates its strong commitment to the San Diego region through its support of civic and charitable organizations. The Tribe, through the Sycuan Tribal Development Corporation (STDC), also seeks to reinvest back into the

San Diego community with a progressive business development effort. To date, STDC has purchased the Singing Hills Country Club and the historic U.S. Grant Hotel, and is an investor in Hotel

## Eleven High Schools vie to represent California in National Constitution Competition

**M**ore than 300 students from 11 high schools will test their knowledge of the U.S. Constitution and Bill of Rights at the *We the People: The Citizen and the Constitution* state competition, Feb. 2-4, 2011. The state winner will represent California at *We the People's* prestigious national finals in Washington, D.C., April 30-May 2.

The first two rounds of the *We the People* competition take place Thursday, Feb. 3, from 9 a.m. to 3:30 p.m., at the Hilton Sacramento Arden West. Students will demonstrate their knowledge of the Constitution in a simulated congressional hearing, where they present prepared statements and defend their arguments. Panels of judges—including constitutional scholars, civic educators, and public officials—test the students' understanding of the six units of the *We the People: The Citizen & the Constitution* text.

Based on the first- and second-round scores, the top five

classes advance to the championship round held in hearing rooms in the State Capitol from 8:45-11:45 a.m. on Friday, Feb. 4. The championship class and unit winners will be announced at an awards banquet at 1:15 p.m. on Friday, Feb. 4, at the Hilton Sacramento Arden West. U.S. Rep. Tom McClintock (CA-04) will serve as keynote speaker, addressing the importance of civic participation and challenging the students to maintain their civic engagement throughout their lives.

Local competing schools: Monta Vista High School, Cupertino, Teacher: Christopher Chiang Granite Hills High School, El Cajon, Teacher: Ronald Whitney

"These are the best and brightest students not only in the state but in the nation," said David Richmond, the program's state coordinator. "California classes frequently place in the top ten at national finals, including a first-place

win last year by Arcadia High School."

The award is named for the late *We the People* state coordinator Roy Erickson, who was highly regarded throughout California for his leadership in promoting quality civic education. The award will be presented to Hallum at the opening banquet at 7 p.m. on Wednesday, Feb. 2, at the Hilton Sacramento Arden West.

Implemented nationwide in upper elementary, middle, and high schools, the *We the People: The Citizen and the Constitution* program has reached more than 30 million students and 90,000 teachers since its inception in 1987. The program is funded by the U.S. Department of Education under the Education for Democracy Act approved by Congress and directed by the Center for Civic Education.

Independent research shows that high school students who participated in the *We the People* program scored significantly higher on a test of political

knowledge than their peers. *We the People* classes scored 30 percent higher than matched comparison government classes on a comprehensive test that measured understanding of core values and principles of democracy, constitutional limits on governmental institutions, and the rights and responsibilities of citizenship.

# 'Sanctum' sinks deep with bad cast and worst script

**S**anctum has James Cameron's name all over it, so many think he's more involved than just one of the executive producers. Perhaps that's why expect-

tations about the film are never met and upon leaving the theatre I heard nothing but groans and negative comments.

The story is about a group of people led by diver Frank McGuire (Richard Roxburgh), a master diver who is anxious to

explore South Pacific's Esa'ala Caves. Most of Frank's team gets along pretty well, but that changes when his 17-year-old son Josh (Rhys Wakefield) shows up in a helicopter with some rich friends who plan to join the dive.

Once everyone is down inside the caves a tornado causes massive flooding and the cavers are trapped. They try to get out but fail and must look for alternate routes. I suddenly began to feel like I was watching *The Poseidon Adventure* without a boat. One impossible and frightening scene after another unfolds, sometimes with someone dying a gruesome death. One, maybe two would be understandable, but the movie could be called last man standing. The deaths were gruesome and

each one only made the film more depressing.

Except for Roxburgh, all of the actors are lacking believably. The script by John Garvin and Andrew Wight (based somewhat on a true experience of his) is cliché and smart moviegoers could write each scene before it happens. The film is also done in 3D actually using the same process Cameron used in *Avatar*, except in this film the 3D effects are minimal and not needed.

The only thing I liked about *Sanctum* was director of photography Jules O'loughlin doing a great job with creating a sometimes fiercely looking cave dwelling and one quite awesome at other times. Other than that I found the film dull, depressing and often hard to watch.

"The opening day of construction will move rapidly toward the realization of the dream envisioned by so many patriotic area residents," said Debbie Jackson, Secretary Veterans Wall of Honor.

MC of the event Herb Cawthorne opened the event with an explanation that the Labor of Love event for turning a shovel of dirt is a symbolic statement to move the dream towards reality. He then offered thanks to many responsible for making the project become a reality with this welcome:

"To the Kumeyaay Indians who believed in us in the beginning and gave us the initial funding to get the project started. To the Alpine Kiwanis Club who planted this vision and created the soil on which it has grown. To the Board of Directors of the Alpine Community Center, its executive director and members who have given us a spot for a wall to honor our veterans. To the VFW members and auxiliary members who gave us unconditional support and a lot of cash to bolster this event. To community members and public servants who gave us encouragement support credibility and funds to make this dream come true. And to the wall of honor committee for their dedication, hard work and faith in this honorable way to honor the people who serve our country in such a special way. Welcome."

County Supervisor Dianne Jacob, who was acknowledged for helping to pave the way for the wall, commented about the wall and why she became involved. "This is what the San Diego reinvestment firms of the county are all about," she said. "We don't spend more than we take in and we started setting aside money to reinvest back into the community for worthwhile projects. So with Dan, Herb and Larry Curtis, and Dan so passionate and expressing the importance of this project, that was an easy sell for me. To honor those who gave the ultimate sacrifice in a prominent place in Alpine to forever be remembered...how could I refuse?"

Congressman Duncan D. Hunter gave his praise to all of those who have moved the project along. God Bless you for what you're doing."

Cawthorne next introduced Viejas Chairman Anthony Pico and acknowledged his 24-year leadership of the Viejas tribe and along with the tribal councils who served with him, that they "never forgot the people who live next door. We never would have gotten this project off the ground without the support and commitment from Viejas. Back as the newly elected Chairman of the Viejas Band, he's a veteran, he's a leader and he cares."

Chairman Pico, who served in the Army's airborne infantry in the Vietnam War, introduced Tribal Council members in attendance including Victor Woods, Charley Brown, Raymond J. Cuero Hyde and wife Linda, and Pico's wife, Diana. "It's obvious we're here to honor our veterans who have so honorably served our coun-

try," Pico said. "We're here because we value courage, we value sacrifice and most importantly as veterans here know, we value peace. These are the common values that really bring us together...and strengthen us as individuals, a community, a society and as a country. There are many heroes here today, and I would like to say thank you to all of the people who made this happen...in what will become our labor of love."

While several Kiwanians worked the table getting veterans applications for names on the wall, attendees at the event were treated to hamburgers and hot dogs served from the new Kiwanis Cook Shack. Many took a short stroll to check out the huge Blackhawk helicopter towed to the event, and many such events in the community, by Director of Operations Richard Edwords.

As the a Labor of Love event came to a close Dan Foster said, "It's so unbelievable and so emotional and powerful that in America you can dream and have passions and they come true; and because of this community and all of the wonderful support here it's finally going to come true."



# 2011 Corvette ZR1

Anyone with a bundle of money who wants a super car could choose between a Lamborghini, Audi R8, Porsche 911 GT2 or a Ferrari 599. I want to offer another choice – an American one – the 2011 Corvette ZR1.

Those who think a Corvette doesn't meet up to the standards of European super cars needs to slip behind the wheel of the ZR1. At first it may drive like a normal Corvette, but putting foot to floor causes a real launch of momentum with 638 horsepower, 604 pound foot of torque from under the super light carbon fiber hood. This is because of a well-tuned Supercharged LS9 6.2-liter V8 with a dry sump oil system (found on race cars). Backed by a close gear ratio dual clutch 6-speed manual transmission; this is what I'm talking about!

The car is fast, but what impresses me most is how stable the ZR1 is under full power. That's accomplished by a team of engineers that are passionate about driving and perfection. The ZR1 is available because of GM's involvement in racing which can bring out the best in any manufacturer. The results of successful racing careers have given drivers the handling and driving perfection only found on a race track.

The GM engineers have added many options to this car. Drivers can turn off the traction control, pick a suspension setting and the ride is on. Caution: any high speed

driving should be confined to a sanctioned race track.

Going fast is one thing, but what about stopping? Chevy went to Brembo brakes for their braking power, 6-piston up front and 4-piston in the rear mounted on cross drilled Brembo ceramic brakes, and they will stop on a dime. Tires are from Michelin – Pilot Sport PS2 ZP. This car could use a five point seat belt harness system, but really the well contoured seats do a fabulous job of keeping everyone where they need to be.

The view behind the wheel is pleasing. Everything is laid out for the driver with all the controls within reach and thanks to HUD (Heads Up Display) drivers never have to take their eyes off the road.

So how does this monster drive when going to dinner? Like a Corvette! In fact, with self-restraint, it's possible to achieve 14 MPG in the city and 20 on the open road. The car does require premium fuel.

Other features worth mentioning include traction control, active handling, ability to change the suspension tuning with the turn of a knob on the center console, limited slip differential, 19-inch tires up front and 20s in the rear, coolers for the oil, transmission and axle, aluminum frame and dual mode 4-inch exhaust. The exhaust tone is like nothing else, anyone who hears it knows it's a ZR1.

The ZR1 is full of safety features, and it has keyless entry and push button start. Carbon

fiber is found all over the car, fenders, floor panel and the see through hood.

Price, bases at \$107,830. My tester car came in at \$125,195 plus tax and license. This car is amazing for the price, so check it out at a nearby dealer. My tester was painted a beautiful Jetstream Blue Metallic with Dark Titanium interior. Man, I'm going to hate to give this rocket back!

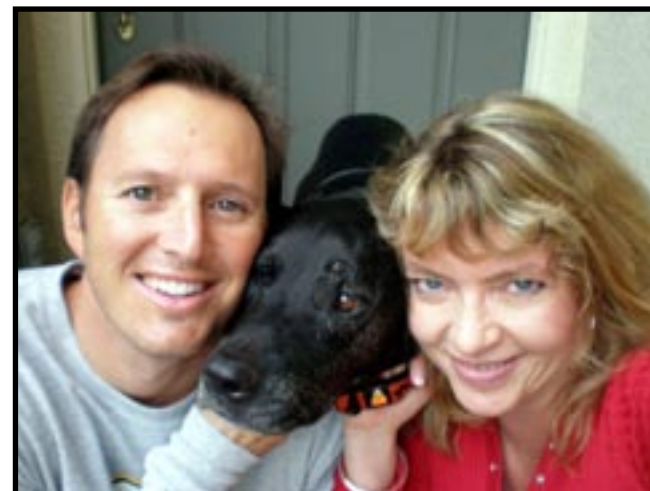
