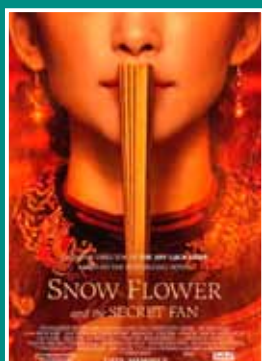

Community representatives speak out at Evening with Your Elected Representatives

The 13th Annual An Evening with Your Elected Representatives took place at the Viejas DreamCatcher Lounge on Monday, July 18. Presented by Alpine Mountain Empire Chamber of Commerce, 17 representatives or their del-

egate showed up to address the crowd of nearly 100.

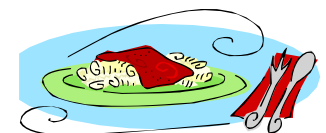
Hot on the topic of questions was the proposed Alpine High School, new tax bill ABX129 that imposes a \$150 fire parcel tax on rural property owners, SDG&E Powerlink and rural wind turbines.

Robert Shied, Viejas Public Relations Director, emceed the event. Each representative gave an introduction about him/herself and their major concerns or job status. Donna Tisdale, Boulevard Community Planning President, addressed her concerns about the number of companies wanting to put up wind farms in their

areas and the problems they are creating including noise for ones too close to homes and transmission problems. Priscilla Schreiber, Grossmont Union School District Board Member talked about the Board's decision to implement yet another criteria that must be met before the proposed Alpine High School can be approved.

Mark Price, Alpine Union School District President announced this was the 12th year the Alpine District ranked first in testing in East County. Later in discussions he appealed to those representatives to explore the reasoning of the Grossmont Union School District Board Members to not proceed with the high school. San Diego

County Supervisor Dianne Jacob reported the county was in good financial standings and that has facilitated a triple A rating and saved the residents \$7 million dollars in taxes. San Diego County Sheriff Bill Gore spoke next announcing that the crime rate in the county was down by seven percent and **See REPRESENTATIVES page 5**

Defensible space saves homes in El Cajon

A recent fire on a hillside, just above the 26-hundred block

of Windmill View Road, was quickly doused when a Fire Strike team of some 30 firefighters responded. It burned a half acre of light brush. What helped firefighters was the defensible space work recently conducted in this area that included the use of goats! If you are using a weed whacker to

Don't forget - Never leave children, elderly or pets in vehicles!

Please, as these hot summer days continue, NEVER leave your child or pet unattended in a parked car for any period of time - not even for a second! On hot days the temperature in a car can reach 120°F in a matter of minutes - even with the windows partially open. A baby/child, the elderly or your pet can quickly suffer brain damage or die from heatstroke or suffocation when trapped in high temperatures. If you see a child, a senior or pet left unattended in a car, and exhibiting any signs of heat stress, please call 9-1-1 immediately! It is

a \$100 fine to leave your pet in your vehicle - the life of a child or elderly adult is priceless! Curtail activity during hot weather conditions - please use common sense during hot weather, this is not a good time to go hiking, jogging or doing strenuous exercise or yard work. Exercise indoors, if possible.

Reminders: Heat exhaustion is marked by weakness, nausea, vomiting, headache and muscle aches. To treat heat exhaustion, cool the victim off quickly, and provide water or diluted sports drinks like Gatorade. Signs of heat stroke include: Lack of sweating, rapid pulse, headache, nausea, confusion, and even unconsciousness. If someone is suffering from heat stroke, call 9-1-1, loosen or remove the victim's clothing, and spray or pour cool water on his or her skin.

it had not been this low since 1965. The department had downsized but with new grants and a focus on technology, things should pick up.

Grossmont-Cuyamaca Community College District Governing Board President Bill Garrett announced that Grossmont College had 20,000 students and Cuyamaca 10,000. They have 1700 employees and 150 programs and certificates. Cuyamaca is very green, has a large horticulture program and also a forensic technology program. Garrett said 91 percent on the schools budget comes from the state so they are impacted by cuts from the state level. Deborah McElravy President of the Grossmont Healthcare District reported that bond issues have helped improve healthcare in the East County and there are currently many renovations underway. She said they have leased the hospital to Sharp. The hospital emergency room is the fifth busiest in the state.

August Cairies, Padre Dam Municipal Water District Director reported good news that our area is no longer in a drought zone and because of the wet winter water restric-

tion are no longer in place. Consumers have cut their water usage significantly. The District has cut 19 percent of their employees to help manage costs. Steve Kramer, Alpine Fire Protection District President responded to concerns about tax bill ABX129 stating the District already had those procedures in place. They are facing budget concerns over employee's pension plans and are working on alliances with

other departments in order to cut costs. The new fire station will be paid off in three years he reported.

Alpine Planning Group President Greg Fox explained there is a difference in the Alpine Planning Group and the Alpine Design Review board. He said their meetings are challenging when people show up wanting to address something that's not under their domain or when

people don't show up to address important matters. Jacob stepped in to explain how the Design Review boardmembers are chosen. Fox also talked briefly about the Powerlink interruptions and proposed improvements to Alpine Boulevard. San Diego Tax Collector Dan McAllister said his office continues to work on improvement with tax payers and offered his cell phone number to those present to call with questions or concerns. The delinquency rate of tax payers has dropped by 2 percent, he said. Their investment pool is around seven billion and the office is in its tenth year of triple A ratings.

Mark Anderson, San Diego County Board of Education Vice President is focusing on taking students into the future. Even though their budgets continue to be cut they are doing fantastic things with struggling schools needs. One new program, the Academic Decathlon, is helping students focus on academia. He thanked the Alpine School District for helping to keep the 6th grade camp at Cuyamaca alive.

Audience members then asked questions to the representatives for another half-hour.

Lakeside Roundup of events

Lakeside Fire Chief Andy Parr said the new fire station being built on Lakeside Ave. is on schedule and on budget.

The new 20,000 sq. ft. facility will replace the aging and outgrown Eucalyptus Hills Station on Valle Vista. The station will have 10 bedrooms, five bathrooms and can sleep 20.

The facility will include a fitness room, lockers, washers and dryers, medical and day to day storage as well as on site diesel and gas fuel, self contained generator and a hose and training T shaped tower. When complete the station will be able to sustain on its own for 72 hours, the same as a family should be able to do in any emergency. The station is being built to last for 50 years and beyond.

The fire garage will be downstairs with the administrative offices (now located on Parkside Ave.) upstairs.

A number of local contractors have been sub-contracted to work on the new facility. The opening of the new station is scheduled for the end of the year, perhaps by Thanksgiving, said Chief Parr.

For Health's Sake

The five stages of loss

There are many experiences where someone might experience the five stages of loss. Some assume this would only occur with the passing of someone close to us. Unfortunately, we can experience the five stages

of loss for several things – the loss of a job or lifestyle, a pet, a home, and even the loss of our health. Anytime we experience a traumatic change in our life, we experience the stages of loss.

Stage 1: Includes denial, isolation or refusing to accept that the loss has occurred. The sense of shock and numbness may not last, but the denial of the loss can go on for years. This can include feelings of guilt. The sense of shock or numbness can actually work to protect us and ease the loss as long as it does not continue too long.

Stage 2: Anger or resentment can be directed at the person or circumstance no longer present, and can also be misdirected to others that are sill around. The anger can be misdirected toward those who are trying to help. This phase is usually where depression can surface. Anger is actually the beginning

of the process of releasing the loss.

Stage 3: Bargaining away desperation is about a person feeling he/she wants to bargain with everyone from God, the therapist or anyone around, or maybe even him/herself. Anger and depression may persist and become more apparent.

Stage 4: Is about grief or depression and can be a time of physical release such as crying or unfortunately, withdrawal. Crying is our natural way of releasing anxiety. However, if crying dominates the activities then it may be time to visit a physician for an evaluation of clinical depression. Medication may be prescribed to ease through this difficult time and usually is prescribed for a short time.

Stage 5: Resolution and acceptance is usually the final phase and the beginning of putting one's life back together. During this phase one can turn

Hundreds benefits from clean energy and workforce training program



Sharon Rogers-Andrews completed several courses offered through Cuyamaca College's Clean Energy Workforce Training Program and has been selected to become a program instructor.

A \$1 million grant stemming from federal stimulus money injected into the economy in 2009 has ended a productive run at Cuyamaca College, with hundreds of students completing a workforce training program, and many with promising new careers in the green industry.

One such person is Paul Schankin, a San Carlos resident who found himself unemployed in August 2010 after 15 years working the technical side of the television and multimedia industry. He was recently hired by Synergy Companies, a Bay Area-based energy management company, to analyze the potential energy savings of existing homes.

He decided to pursue an interest in working at a green job and took several classes over a four-month period offered through Cuyamaca College's Clean Energy Workforce Training Program to obtain the national Building Performance Institute, or BPI, credentials needed to become an energy analyst. The grant program was administered by the Grossmont-Cuyamaca Community College District's Continuing Education and Workforce Training program based at Cuyamaca College in Rancho San Diego.

"The training I received at Cuyamaca introduced me to the software programs and some of the technologies that are used by firms to analyze buildings and residences for modification or enhancements like double-pane windows to lower energy use," Schankin said. "I am grateful for the career opportunity that Cuyamaca provided me. Whatever they can do to retrain the displaced workforce is very useful."

Green tradition

As a recognized leader in green economic and workforce development in San Diego County, Cuyamaca College was the only college in the county and one of about a dozen statewide awarded the grant from the California Clean Energy Workforce Training Program, a state initiative to stimulate the economy by developing and offering green job training.

The grant was funded by the American Recovery and Reinvestment Act of 2009 and was used to train 251 students

at Cuyamaca and Palomar colleges in solar thermal and solar photovoltaic installation, as well as training in becoming a certified building analyst to assess energy efficiency in homes.

The college also used the grant to offer job placement workshops specific to the green industry and to sponsor free public events such as a green business symposium last May. The gathering brought together more than 200 industry leaders, green employers and graduates of Cuyamaca's green job program to identify growth opportunities and ways to create new jobs in the region's fledgling green industry.

Another outgrowth of Cuyamaca's grant program was the San Diego Green Workforce Coalition, a partnership of the college district, the San Diego Workforce Partnership, and the California Center for Sustainable Energy. The San Diego Workforce Partnership funds job training programs for emerging careers in green jobs, healthcare and clean technology. The third partner is a nonprofit promoting a clean energy future.

The workforce coalition was formed to provide industry expertise to ensure the Cuyamaca program reflected relevant training for green jobs. It also sought to provide opportunities for employment for program graduates.

"Cuyamaca College has long been on the forefront of preparing students for green jobs. We're proud of our innovative offerings available through our Continuing Education and Workforce Training program, as well as programs such as orna-

mental horticulture, water and wastewater technology, environmental health and safety, and sustainable landscaping," said Cindy L. Miles, chancellor of the Grossmont-Cuyamaca Community College District.

Through the grant program, students earned 394 industry-recognized certificates and 138 national BPI certificates. A particularly innovative offering was a class in how to start up a green business, in which Cuyamaca partnered with Southwestern College's Small Business Development Center.

Keen interest in green

The numbers of students receiving multiple certifications points to their keen interest in pursuing green careers, said Darlene Spoor, dean of continuing education and workforce training at Cuyamaca.

"We just really listened to our students and developed additional classes that the students needed and requested," Spoor said. "People stayed engaged and because we were able to expand our offerings, our students are well prepared to compete in the job market."

With the grant-funded program now ended, the college is pursuing other means to continue offering the training, either through additional grants or student fees. The college has applied to become a full-fledged training center for BPI's national certifications and has taken 10 of the program's most promising graduates and trained them to become BPI instructors.

Sharon Rogers-Andrews is one of the graduates selected to teach the BPI classes within

the next few months, once the college becomes a BPI-affiliated training site.

Effusive in her praise for Cuyamaca, Rogers-Andrews is excited about the opportunity to share what she's learned in the five BPI classes she's taken. Despite being unemployed for the past 2 1/2 years after working in management positions, she manages to remain upbeat, seeing a lot of potential in an emerging field.

"I know this is the beginning of a new market," said the Oklahoma transplant.

Molly Hughes, project coordinator for Cuyamaca's program, said finding jobs for graduates has been more difficult than expected, largely because proposed federal legislation to provide funding incentives to homeowners for green-energy conversions fell through, as did the proposed requirement for energy efficiency audits of new and existing home sales. Without that legislation, the demand lessened for workers in those fields.

On the horizon is a pilot program announced in the spring by the Department of Energy and the Department of Housing and Urban Development that will soon allow qualified homeowners to take advantage of PowerSaver loans of up to \$25,000 for energy-saving measures, including the installation of solar panels.

Hughes said more students have recently reported that they were hired, an indication that the market for green jobs is increasing.

"More people are realizing that the green economy is the wave of the future and that community colleges are in the best position to offer transitional training. It's what we do best – workforce training," Hughes said.

'Harry Potter and the Deathly Hallows Part 2' — one last spell

After 10 long magical years, the story of Harry Potter who was saved by his mother's

love, finally comes to an end. *Deathly Hallows Part 2*, the last in the eight film series, ties up all the loose ends in the two hour climatic conclusion.

Harry (Daniel Radcliffe), Ron (Rupert Grint) and Hermione (Emma Watson) continue their quest to find the last of the Horcrux's six objects containing parts of Lord Voldemort's (Ralph Fiennes) soul that grant him immortality. Three of the Horcrux's have been destroyed up to this point. Voldemort knows he is running out of time and gathers his army of Death Eaters to conquer Hogwarts and finally kill Harry.

While part one was a bit on the boring side, part two makes up for it in an enormous way. After a short recap and tracking down the last of the Horcrux's, the battle between Voldemort and Hogwarts begins. That's when I leaned forward in my seat and never returned to the back position. Director David

Yates brings all of the complexity of the story together, and I never questioned any of his directing decisions. There were a few differences between the book and the movie, which is understandable due to time constraints and too many details that would bog the movie down.

The graphics are superb, and this was the first time the 3D actually didn't look all that bad, even though I felt a bit ridiculous wearing round rimmed 3D glasses like Harry's specs. I liked this film because it teaches lessons of honor,

dignity and to never lose hope. It's no wonder that a majority of the top money making epic movies such as *Lord of the Rings*, *Pirates of the Caribbean*, *Twilight* and *Star Wars* are based on premise of good versus evil.

The entire cast does a superb job. A majority of the surviving characters that have participated in all the movies have a small part in defending the castle; even Albus Dumbledore (Michael Gambon) makes a few appearances. Parents should be aware that this is the most violent Potter movie to

date, has some scary imagery and a lot of death. *Deathly Hallows* is an emotional roller-coaster ride that puts viewers through all the emotions with a few satisfying ones that Harry Potter fans have been waiting for since the beginning.

Thanks to all the filmmakers and creative artisans involved over the years, and of course the imaginative storyline created by author JK Rowling, the Harry Potter series will be a difficult movie and book series to beat in terms of creativity, entertainment and financial success.

'Snow Flower and the Secret Fan' — beautiful but disappointing

When there are more than two screenwriters on a film, the story often becomes a mixed bag of ups and downs. That's what seems to be the problem with *Snow Flower and the Secret Fan*, directed by Wayne Wang and inspired by Lisa See's bestselling novel of the same name.

The story — adapted for the screen by three writers — takes place in two time periods, switching back and forth from one to the other. As young girls in a 19th-century China, Snow Flower and Lily, both seven, are growing up in different environments. Snow Flower (Dai Yan) has a privileged upbringing in a home where Chinese tradition is strictly followed. For example, girls have their feet tightly bound — to the point of pain — so their feet remain small. The Chinese believe this makes a girl more

tempting to a suitable man. Lily (Guo Congmeng) comes from a poor family, but that's exactly the reason her family raises the money to have her feet bound as well. It's her only chance to surpass the class of her family.

The two girls meet and soon become laotong sisters — a Chinese term used in early centuries that meant "sisters, lifelong friends." The girls communicate by writing secret notes on the folds of a fan. They even sign a contract that they will be devoted to each other through their marriages and motherhood. This all unfolds a little into the film, which starts in modern times when Snow Flower (Gianna Jun) — now known as Sophia — is grown and gets hit by a car while riding on her bicycle. She's taken to the hospital in a coma. Sometime later, Lily (Li Bingbing) — now called Nina — who hasn't seen Snow Flower in years; learns of the accident and goes to the hospital. Through her memories, their earlier relationship unfolds.

Beauty shines through the story that takes place in the early era. It's enchanting, interesting and well acted. I liked learning something new about these customs and their impact on different aspects of Chinese culture. But the switch back and forth to the contemporary world comes across as quite jarring. Left unanswered are questions

about what happened to Snow Flower's family and why she is alone in the big city or why the women now have different names. Watching Nina in scene after scene just sitting by Sophia's bedside mourning their past breakup becomes boring and unfulfilling.

If that isn't enough to breakup the continuity of the film, there's a hilarious few- minutes scene where Hugh Jackman shows up looking old and ruffled as a nightclub singer. He's supposed to be a past boyfriend of Sophia's who broke up with her. As much as many of us love to see Jackman in his films, it didn't work here. His character didn't even resonate .02 on the Richter scale of concern when he heard the news. This was like inserting a scene from *Moulin Rouge* in the middle of *Crouching Tiger Hidden Dragon*. It was easy to see by the body language of audience members at the screening I attended, they too, felt this was highly annoying.

I enjoyed the story of the young girls and how their trusting relationship became too strong ever to break. Without all the humdrum transitions, *Snow Flower and the Secret Fan* could have been entertaining. Author Lisa See deserved better as did Richard Wong for his resplendent cinematography and Rachel Portman for her enjoyable musical score.

The Lincoln MKS is not your Grandfather's Lincoln! Trust me. Lincoln has aimed there sights towards a younger age group and hit the bulls eye with this car. Gone is the hefty V8 replaced by an efficient V6 that will almost put the V8 to shame. It truly does in the fuel

mileage arena. Performance is not lacking and most drivers will not be able to tell the difference.

The MKS is Lincoln's flag ship vehicle and has set the standard for fuel efficient luxury rides. The 3.5-liter direct-injection twin-turbocharged EcoBoost V6 engine produces 355 horsepower at 5700 RPM, 350 torque

(lb-ft), 1,500 - 5,000 RPM. This is backed by a 6-speed electronically controlled overdrive automatic transmission that is smooth as butter. Paddle shifters are mounted on the leather wrapped steering wheel designed so drivers can keep their hands on the wheel yet control features like cruise control, audio controls and Bluetooth.

The sound system is the best I have tested so far. The THX II Certified 5.1 Surround system in the Lincoln MKS brings home theater sound to the open road. In this acoustically engineered cabin, bass notes thump, drum beats pop, and vocals are presented with astounding clarity. And with the exclusive THX Slot Speaker, the system produces a wide sound range putting everyone in the middle of a recording session.

From the stylish front grill to the tail end the styling is outstanding. When it comes to comfort features, Lincoln

didn't miss a beat. It has a fabulous leather interior, tons of room in the back seat, trunk and around the driver and passenger seats. Each driver can adjust his/her own seat with 12 different options. This outshines most manufactures who offer less adjustments to most drivers and passengers. I never understood this reasoning.

Lincoln is a leader in occupant safety. They work hard on keeping everyone in the family safe. New MKS owners will experience a learning curve in running the MyTouch and Sync Systems. I agree it takes a little getting used to but once

it's mastered drivers will be lost without it.

Would I put this ride in my garage? Absolutely! This car does everything I asked it too, great sound, great comfort, great fuel mileage, and surprising performance. I can take this car anywhere at anytime, and I love the ride.

My tester came in at a base of \$48,390 and out the door minus tax-license at \$56,320. Someone must have been listening about my warranty rants as the base warranty is now 4-years/50,000 miles and the power train warranty

is 6-years/70,000 miles along with roadside assistance for 6-years/70,000 miles.

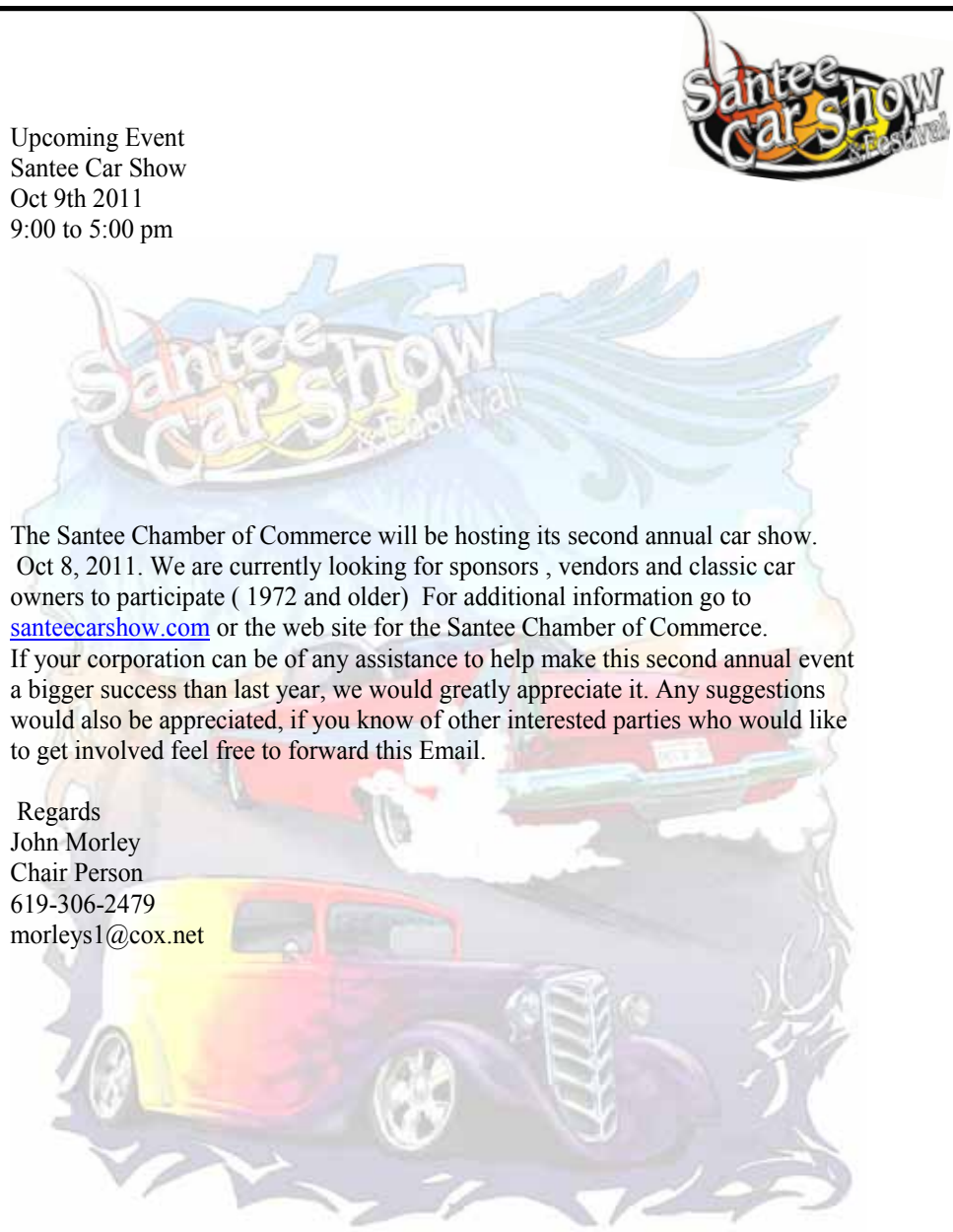

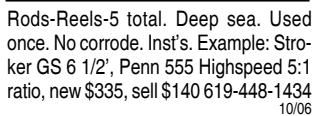
