## El Cajon Police Division moves to a new location this week

here's often nothing more exciting than moving into a new building, but for the El Cajon Police Department members the move to the new \$40 million Public Safety Center for the City of El Cajon means more for the community at large. One has only to look at the new building or step into the spacious and welcoming front lobby to imagine what improvements await the professionals who work there to maintain the community's safety and well-being.

"This facility, which will also be part of the new firehouse and the animal control center, will work for at least 50 years," said El Cajon Police Chief Pat

The 332,150 sq. ft., five-story building with an additional 212,750 sq. feet of parking was paid for by the vote of the people with Proposition O approval of a half-cent sales tax increase before construction began in 2009.

Overseen by Gafcon, Inc., a San Diego-based construction management team, the facility

signed to be "Green" and meet energy efficient standards, such as the efficient voice activated or clap on lighting system. Along with low-energy audio-visual equipment and natural ventilation/cooling, full solar panels on the trellis over parking spaces in the outdoor lot help with energy costs and assist the building to maintain power in emergency situations.

"We are deeply proud of our entire project team for successfully delivering this outstanding project to the City of El Cajon, Said Joe DeMello, senior project manager for Gafcon, and who on this tour was proudly showing off greenery on some of the roof tops to help promote a "Green" environment.

Two large parking areas below ground include designated areas for certain departments such as the 120 police officers and 347 other city employees that will occupy the building. A state-of-the-art indoor firing range in the lower area is complete with sound-proof doors and a filtration system that can recycle air. Chief Sprecco explained the indoor range eliminates the officers weather and makes it easy for them to use before or after their shifts.

The building has multiple new administrative office spaces, community meeting rooms, and separate spaces for watch commanders, lieutenants and sergeants. There are stateof-the-art crime and forensic laboratories, easily accessible ceased property and evidence storage areas and a gym (partially funded by grants) for officers and all city employees.

The detention center for short-term custody holdings has its own garage entrance with doors that can be locked while transferring detainees as well as showers or clean-up facilities. A separate men's' and women's' section and juvenile waiting area are well monitored with hidden cameras. The records division is plenty large for years of expansion and easy access.



protected while officers attend to other duties. Tactical units (swat, etc.) have their own rooms, a new patrol briefing room is first-rate, and the officer's new lockers are a much needed improvement, said Chief Sprecco. "At the old station they were elementary-school size," he said. "These new ones are as tall as the officers with three separate small compartments, constant air-filtration so bullet-proof vests can air out, a huge bottom drawer for various items and an electrical plug in each locker to recharge phones, flashlights, etc."

The Communications Center Suite, that looks like something out of a TV show, will aide personnel in maintaining safety and keeping an eye on the city at all times. Each dispatcher has his/her own console with plenty of devices within reach and a large screen on the wall visually helps with large images when needed. This area can also function as an emergency communication center - something extremely valuable during fire season or other disasters.

The City of El Cajon Public Safety Center and Police Department is located at 100 Civic Center Way adjacent to City Hall. For non-emergency information call (619) 579-3311

## Transformers to be moved through county



Large transformers are schedule to be moved through East County.

The Department of Public Works (DPW) wanted to inform the community that SDGE's contractor American Heavy Equipment (AHE) has submitted a moving permit application and traffic control permit request to transport

seven large transformers from the San Diego Port to Bell Bluff Truck Trail (east of Alpine). The truck will get onto I-8 from Greenfield Drive and will exit on Japatul Valley Road and will not be traveling through the Community of Alpine.

The first move was scheduled for August 23. This is the first of seven roundtrip moves that will occur every two to three days apart after the initial move. The moves are planned to be performed late in evening to early morning outside peak travel times. DPW is working closely with AHE to ensure all the County requirements are met and is anticipating issuing the permits later today. AHE has permits from Caltrans, the Port District, the cities of San Diego, National City and El Cajon that cover their areas.

There will be four CHP offduty patrol officers and two pilot vehicles accompanying the transport vehicle. DPW staff will be present in the field during the move across County maintained roads as necessary. Attached is a sample photo of the transport vehicle and the trailer that will be utilized. 

#### Local Representatives fighting unfair fire tax

any East County's local representatives are fighting the new \$150 Fire Tax the State of California has implemented.

Assemblyman Brian Jones (R-Santee) testified before the State Board of Equalization today to register concerns regarding the implementation of the State Responsibility Fire Fee, which mandates the collection of a fire "tax" on roughly 1 million structures in California.

In testimony before the Board, Assemblyman Jones questioned the legality of the tax, which was passed by the Legislature with a simple majority vote and signed by the Governor as part of the 2011-2012 Budget deal. Proposition 26 was passed by California votes less than a year ago, and expressly prohibits the Legislature from using loopholes to raise taxes by disguising them as fees and therefore circumventing the

Constitutional requirements for passing higher taxes.

"This is nothing more than political sleight of hand and clearly does not pass Constitutional or ethical muster" said Assemblyman Brian Jones. "It wrongly labels a 'tax' as a 'fee' and also double-taxes residents by combining new State Responsibility Area 'fees' with current local fire district assessments."

Assemblyman Jones asked questions regarding the Board's authority to collect the taxes, how the tax will be collected, and how they will handle the issue of double taxation.

"Locals already have the authority to create assessment districts for fire prevention and protection. Now, yet another tax will be levied on those who are already voluntarily contributing to fire protection, and this will disproportionately affect

the residents in Eastern San Diego County," he concluded.

The San Diego County Supervisors are also fighting this new tax on rural landowners. The following is a letter sent to Governor Jerry Brown from the County Supervisors:

"We are deeply committed to protecting the San Diego region from catastrophic wildfires and strongly oppose the recent Fiscal Year 2011-12 State Budget's decrease of approximately \$43.5 million in FY 2011-12 to CAL FIRE's budget. Public safety in the San Diego region will be jeopardized as a result of these significant funding reduction for firefighting personnel and resources.

"Additionally, the FY 2011-12 State Budget (ABX1 29) included the establishment of a fire prevention fee of up to \$150 per structure within state responsibility areas (SRAs). A SRA fire prevention fee is not the solution to balancing the State's budget. We oppose the SRA fee and urge you to take immediate action to repeal ABX1 29.

"Public Safety should be the number one budget priority for any government agency. Even during challenging fiscal times, the County of San Diego has invested in fire protection and emergency services in the region, including over \$200 million since the 2003 firestorm. Additionally, the County makes an annual \$15.5 million commitment to fire protection, approximately two-thirds of which are contracts with CAL FIRE to provide enhanced fire protection services with 24/7 coverage at more than 50 fire stations throughout State Responsibility Areas in unincorporated San Diego County. We live in a region that demands year round preparedness to wildfires. San Diego was devastated by two major firestorms in 2003 and in 2007 and has battled more than 50 additional large wildfires in the last decade. These fires resulted in the destruction of thousands of homes, the devastation of nearly one-million acres of public and private land, and the tragic loss of innocent lives. In 2003, the state estimated the reimbursable costs to state and local governments for the 2007 southern California fires alone were \$317 million, or which the federal government was responsible for \$238 million and the State and local governments were responsible for up to \$79 million. Cutting CAL FIRE funding is not a prudent solution to resolving the State's budget crisis and will pale in comparison to the costs incurred by the State to respond to the next major wildfire.

"Furthermore, the SRA Fee constitutes an illegal tax and is a desperate measure that unfairly targets rural property owners who already pay for fire protection through property taxes. This amount to double taxation because many of these property owners also pay additional taxes and benefit assessment fees to local fire districts, as much as \$392 annually. We estimate more than \$5,000 parcels with dwelling units in San Diego County would be subject to the SRA Fee. However, there is no guarantee that the same amount of funds contributed by residents in our region will be reimbursed back into San Diego County for additional fire

"ABX1 29 does not ensure that a higher level of tax being collected translates into a higher level of the protection.


In fact, as a result of budget cuts the existing levels of fire protection will not even be sustained. An additional concern is that revenues generated by this new fee will be directed to fund CAL FIRE administrative expenses and supplement existing CAL FIRE services.

"The San Diego County Board of Supervisors fully understands the severe financial crises that currently challenges all levels of government and recognize that like us, you have been forced to make difficult decisions. However, funding for fire protection should not be compromised. It is important that we corroboratively do everything possible to protect the citizens of this region and the State of California.

"We urge you to make pub-

lic safety a budget priority by restoring CAL FIRE funding immediately to protect life, safety and property throughout the state and in the San Diego region. We urge that you repeal ABX1 29."

Editor's Note: Support your local representatives in this fight with the State of California. As a fire victim of the 2003 wildfires, I saw no firetrucks in our neighborhood to protect our properties. We already pay taxes for fire protection. Why should the State penalize homeowners for living in the outskirts when our fire departments are forced to go into the heavier populated areas and cities during times of wildfires, due to the lack of fire trucks, personnel, etc.? I think we are really getting 'burned' on this one.

## Tips for packing healthful school lunches

he rush of getting the kids out the door in the morning can make packing a healthful lunch seem like an impossible burden.

The typical parent will pack around 200 school lunches yearly, and planning them all requires some serious nutritional skills. Not only do parents need to know how to choose healthful fare, but they need to know how to pick foods their kids will actually eat.

"When you plan your child's lunches, be sure to choose items that are both healthful and fun," says Edmond Sanctis, co-founder of Sahale Snacks, a producer of all-natural nuts and nut blends. 

#### The preacher and the ghost


There was a new preacher who wanted to rent a house in the country. The only house available was rumored to be haunted. Since the preacher didn't believe in such things, he rented it


and Food and Beverage Manager at Harrah's Ak-Chin Casino Resort. He understands facing back to back food promotions requires a supportive team.



s a critic, I try to keep my knowledge of a film to a minimum before seeing it, which helps with a truer observation about the movie. That practice sometimes results in a huge surprise. Take Warrior, for instance. Having seen a partial trailer here and there, I assumed it would deal mostly with fighting in a ring, and after The Fighter – last year's terrific year-end surprise – I wasn't sure I wanted to go down that road again.

Warrior focuses on two estranged brothers who end up glove to glove in a MMA (mixed martial arts) match for big bucks. Tommy Conlon's (Tom Hardy) return to his hometown in Philadelphia after 14 years starts this intense and sometimes brutal story. Having lost his mom, he's now on his father's doorstep asking for his help in training for the mega-bucks Sparta martial arts match.

Dad, "Paddy" (Nick Nolte), a recovered alcoholic, thinks this might be a joyful reunion with Tommy, but that's not the case. Tommy, who's short and sour on exactly what he thinks about his dad, makes it clear he only wants his talents as a former trainer. Noticing that Dad has filled the house with religious items, Tommy becomes even angrier telling his dad, "Mom needed you, I needed you."

Paddy agrees to help, knowing he'll have to convince Tommy he can't be serious about training if he won't give up his pills and horrible diet. The family dynamics slowly unfold through weeks of rigorous training in the gym

and elsewhere. Paddy tries everything to emotionally reunite with his son, but nothing works. Tommy is shut off to his father's pleas.

Hoping to fix family problems all at once, Paddy heads off to see his other son Brendan (Joel Edgerton), who's mad at him as well as at Tommy. However, Brendan leaves Paddy in the driveway, crying because his son won't even let him see his only two grandchildren.

Brendan, an ex-fighter-turned teacher, suddenly finds himself out of a job. He tries a few parking lot fights at local strip clubs but ends up getting massacred for only a few bucks. He too sets his sights on Sparta as a way to keep his home from foreclosure. For him it's a fight for his family. A surprising subplot about Tommy reveals that – for him – it's a fight for his country.

I soon realized that Warrior set its sights on something much deeper than fighting. As noted in the film's notes; it's truly about "redemption, reconciliation and the power of the human spirit." As he proved with Miracle, director

Gavin O'Connor knows how to get a heartwarming and crowd-cheering story out of a supposed sports movie. His excellent casting helps him do the same with this film.

Even though Tommy comes off like a pure bully and ungrateful son at the beginning, Hardy (Inception) offers up a character with a shadow of empathy, one that made me watch each scene with great expectation. And Edgerton (Animal Kingdom, Star Wars: Episode III) plays the kinder, gentler brother evenly. He projects both a sad irony and true faithfulness to his family even over the objection about fighting from his wife (Jennifer Morrison). Veteran actor Nolte is convincing as a man down on his luck but ready to get up and try once again.

Because Warrior includes many brutal fight scenes, I encourage the squeamish to risk a few minutes of closed eyes to see it. The end scenes alone will keep viewers on the edge of their seats. I wouldn't be surprised if this excellent film receives some 2011 Oscar mentions. Warrior opens September 9.

remake of the 1982 classic was inevitable. With new state of the art graphic computers, improved 3D technology, the remake should be a drop in the bucket success as long as filmmakers followed the rules of what a good movie should be; high-quality acting, a first-class script and a superior soundtrack.

Unfortunately, in the new Conan the Barbarian they only got one out of three. The acting was tolerable at best. Jason Momoa as Conan was a decent choice, but he lacked the raw charisma that Schwarzenegger had in the original. And his success was also hindered by a script that failed miserably in this remake. For instance, Conan's father, played by Ron Perlman, says, I love you son" just before he dies. Barbarians would never say the word "love." Conan later on says this dreadful line. "I live, I love, I slay...and I am content." I rolled my eyes in disbelief that someone thought that was a good line for Conan to say. Less is more, especially when it comes to Conan, who is supposed to be a barbarian - crude, rude and no manners.

The antagonist is Khalar Singh (Stephen Lang) who is looking for a magical mask that was broken apart with each piece given to tribes of distant lands to keep safe. Khalar,

along with his witch daughter, Marique (Rose McGowen), track down each of the pieces to reassemble the mask in the hopes to bring back Khalar's dead wife and then rule the world. The makeup and hair on McGowen was interesting, but she doesn't have a lot of screen time and is underutilized. Along with the mask pieces, they had to find a pure blood woman, in this case Tamara (Rachel Nichols). Her blood would activate the masks' evil powers and turn her into Khalar's dead wife. There are plenty of bare breasted women to please the guys, and I guess Momoa - shirtless and almost naked in one scene – works for the ladies.

The film's success hinges on the anticipation of good battle scenes. Not here. Most of the action scenes looked rushed and unpracticed. The actors seemed to wave their swords around, and added unnecessarily large amounts of blood spurts that look fake, spurts around a lot. One of the biggest letdowns of this remake is the total lack of well-orchestrated soundtrack that went with the action. The original 1982 soundtrack accompanied the action perfectly and was the best part of the original.

Another key thing that bothered me was why Khalar Singh's army had their sailing ship set on top of six elephants and traveled that way wherever they went. I kept wondering how they got the ship on top of the elephants and why would you do that in the first place? The movie plowed on but I kept coming back to that same question for the rest of the movie. The climax battle between Conan and Khalar was

disappointing and ridiculous. Director Marcus Nispel should have sent the script back and told them to think more like a barbarian and spend some of the money on the action scenes instead of fake looking computer generated sets.

James Sheridan and Barry Monush have done on providing fun, informational and often exciting or unknown details about Lucille Ball one of America's favorite actresses. Their new book Lucille Ball FAQ: Everything Left to Know About America's Favorite

Redhead - is a must own for Ball or fans of TV & film comedians

The 26 chapters in this book leave nothing unturned. 





## El Cajon man shoots three, burns down home

n August 21, Officers and El Cajon Fire personnel responded to a radio call of suspicious circumstances at 1033 Prince Street in El Cajon. The caller described a male walking into the residence with a gun and made the statement

Jarred Slocum and his partner Officer Tim McFarland were the first to arrive. As they were moving into position on the house, the suspect, identified as Kevin James Collier fired several rounds and Officer Slocum, striking him in the head. Officer Slocum was able to return fire as he retreated from his position. He collapsed a short distance away, still within line of sight from where the

shots had been fired. Officer McFarland saw Officer Slocum had been hit and rushed to assist him. As Officer McFarland drug Officer Slocum to a safe position, two citizens ran out and helped him. Officer Slocum was taken to the hospital and underwent surgery for his injury. He is listed in critical but stable condition.

Officer Slocum has been with the El Cajon Police Department since March 2007. He is married and has two children. The family has asked for privacy while they help him recover from his injury. Officer McFarland graduated the police academy in January 2011 and is currently in his field training. He started with the police department as a maintenance aide in 2004. He was later promoted to a communications operator and was a dispatcher from 2009 until he was hired as an officer. Officer Slocum is Officer McFarland's Training Officer.

The El Cajon SWAT Team was deployed to the scene, however the fire set inside the house prevented an immediate entry. Fire personnel began fighting the fire and used water drop helicopters to prevent the fire from spreading to the neighboring houses. SWAT was eventually able to make entry along with fire fighters, and confirmed there were no survivors in the house. A body was found in the front portion

of the house. A second body has been discovered in the rear of the house. The bodies are believed to be Kevin Collier and Beverly Rakov. However, positive identification is pending the medical examiner's investigation.

Members of the Bomb/Arson Squad are assisting El Cajon Detectives in the search of the residence. They hope to be

able to identify the cause and origin of the fire and assist in evidence collection.

As details of the case began to emerge, investigators learned that Collier had sent text messages to friends that he had shot his daughter, Rhilee Jean Collier and his mother-in-law, Beverly Rakov, and that he started her house on fire. As detectives

worked the scene, they found a truck parked on the street outside 1033 Prince Street. The truck is a work truck used by Collier. Officers found a small child in the back seat of the truck. It appears the child suffered a gunshot wound to the head. Detectives believe the child is Rhilee Collier however; they are waiting confirmation from the Coro-

## Operation Shadowbox focuses on downtown El Cajon crime

by El Cajon Police Chief Pat Sprecco:

n November 2010, I sent a written request to the San Diego Field Division Special Agent in Charge for assistance from members of the Drug Enforcement Administrations Mobile Enforcement Team (DEA/MET) in targeting drug trafficking in the city of El Cajon. I would like to thank Acting Special Agent in Charge Bill Sherman for his assistance in this matter. Our officers had noticed increased narcotics trafficking and violent crime in certain neighborhoods of El Cajon. These crimes have been attributed primarily to Iraqi organized crime elements, and as this investigation has discovered, the Sinaloa Cartel, a Mexico-based drug trafficking organization (DTO) which supplies them.

On January 5, 2011, members of DEA/MET and our Special Investigations Unit discussed the joint operation. DEA/MET Group Supervisor Toby Byrd and El Cajon Police Department Special Investigations Unit Sergeant Mike Hook supervised the operation, and were managed by DEA Assistant Special Agent in Charge Steve Tomaski and El Cajon Police Lieutenant Steve Shakowski. The targets of this investigation are members of an Iraqi DTO which has suspected affiliation with the Chaldean Organized Crime Syndicate. This syndicate began in the early 80's in Detroit, Michigan. Crimes associated with the syndicate include murder. arson, weapons and narcotics trafficking, money laundering, fraud, theft, counterfeiting, racketeering, alien smuggling, assault, kidnapping, and armed robbery. Chaldean organized crime has historical ties to the Sinaloa Cartel, and the Mexican Mafia.

The investigation soon focused on 811 E. Main Street in El Cajon. This location houses an Iraqi social club and is a hub of criminal activity conducted by Iraqi organized crime in El Caion. Crimes documented at 811 E. Main include: attempted murder, methamphetamine and marijuana sales, sale of diverted pharmaceuticals, gambling, resisting arrest, illegal liquor sales, and illegal sales of firearms.

Complaints have been made to the El Cajon Police Department for many years. These complainants varied and included wives of men who attend the club complaining of their family's money being gambled away. Neighbors complained of apparent drug sales in the parking lot and suspicion of gambling, prostitution, and other nuisance activity. Complaints from club members themselves described

a criminal element at the location involved in drug dealing. Intelligence indicates that people managing the club are aware of the criminal activity and demand a portion of the money received. Armed guards are allegedly provided during high stakes card games. DEA Intelligence corroborated that gambling and prostitution occur on the premises.

A 1998 El Cajon Police investigation into gambling led to the execution of a search warrant and the seizure of illegal slot machines. A 2007 DEA investigation identified 811 East Main as a gathering location for several Iraqi narcotics distributors. In September 2009, the Regional Auto Theft Task Force initiated an investigation into several subjects who conducted illegal activity at 811, including the illegal sales of firearms and possession of hand grenades.

tion Shadowbox, from January 2011 to present, DEA/MET and El Cajon Police have purchased large amounts of narcotics, pharmaceuticals, firearms, and improvised explosive devices (IEDs) from subjects at 811 E. Main. Information indicates subjects from 811 arrange narcotic shipments from El Cajon to Iraqi DTO elements in Detroit, Michigan. Narcotics and firearms purchases have been made from associates of 811 in other locations around El Caion, as well as purchases of narcotics and firearms from other distributors around San Diego County who have uncertain links with the Iraqi DTO. In April 2011, a DEA undercover operative was shown a hand grenade at 811 East Main and was told additional grenades were available, being obtained from a Mexican military source of supply.

This operation has so far resulted in 60 arrests. 30 arrests will be referred for 30 State prosecutions and charges include sales, possession for sales and conspiracy to distribute narcotics and pharmaceuticals. and possession of firearms by convicted felons. 30 arrests will be referred for Federal prosecution and charges include participation in a Continuing Criminal Enterprise, conspiracy to distribute and distribution of narcotics, marijuana, and pharmaceuticals, conspiracy to import marijuana, and possession and distribution of automatic weapons.

The investigation has resulted in the seizure of over 13 pounds of methamphetamine; over 4 pounds of MDMA (ecstasy) and pharmaceuticals including Vicodin, Oxycontin, Codeine, Xanex, and Percocet, one pound of cocaine, heroin,

n an emotional ceremony on Sunday afternoon, the San Diego Padres permanently retired number 51 worn on Trevor Hoffman's jersy. This was only the fifth time in the Padre's franchise history of retiring a number. Hoffman was honored for his talent, commitment, character, and integrity both on and off the field of play. In my opinion this player is undoubtedly the greatest closer in the history of major league baseball.

Hoffman finished his career with an astounding 601 saves, 552 in a Padres uniform. He carries the distinction as the major league's All Time saves leader. Owning a 2.87 ERA (lowest in team history), he was a seven-time All Star, and multiple Cy Young Award and MVP nominee. Because of this and his dedication to the game and community, no one in the Padres organization will ever again wear his number 51.

Cheers rang out from the

crowd when the bell loudly gonged signaling Trevor's introduction with the ever so familiar AC/DC song "Hells Bells" ringing throughout the stadium. The bullpen gate opened as it had countless numbers of times for him in the past. This time Trevor emerged with his wife Tracy and three sons flanked at his side. Slowly walking from the outfield grass to the infield stage, a thunderous standing ovation from the 40,065 fans in attendance reverberated throughout the park roaring their appreciation for him, his family, and his achievements.

Longtime Padres broadcast radio announcer Ted Leitner, the Master of Ceremonies for this event, did an outstanding job describing Hoffman. "I present to you a great player, a great talent, a great competitor, and a great Padre, number #51 Trevor Hoffman," said Leitner to the fans.

his former fellow teammates and player's wives, and coaches as they walked up a red carpet to greet Hoffman. For those well wishers not in attendance, taped congratulations and memories were shared chronicling the famous closer's illustrious life and career. The tribute began with a family photo album depicting a young Hoffman that was narrated by his brothers. All of the tribute was heard and seen on the Park's video screens.

Taking the podium Hoffman said, "Today is an emotional day, a special day. This is unbelievable, a dream come true. If this doesn't touch your heart; I don't know what will."

He praised and thanked his loving parents, his beautiful wife, and his two brothers for their love, leadership, guidance and support. Hoffman thanked his former teammates and coaches of whom were surprise guests in attendance, and the Padres organization, including the management and staff for the great many seasons he had with them and for hosting the event.

Hoffman spoke about his sons growing up with the Padres and the quality of people

they were around, and praised the lessons they learned from hanging out in the clubhouse. He explained the love, desire, and seriousness he had every time he crossed the chalk lines of the playing field. "I wanted to make sure I did the job that was put in front of me. I felt the energy from all you guys," he said.

Admitting appreciation of the time he had with the fans and the love and emotions that they shared, Hoffman also spoke admirably about the Padres players whose numbers were previously retired (Steve Garvey, Tony Gwynn, Dave Winfield, Randy Jones) and what they stood for. Of all the special guest's at the ceremony, it was these four he said that made him realize the relevance of his number being retired.

The prestigious event ended with all watching a videotape recording of the late Ed Hoffman (Trevor's dad) singing the national anthem at Boston's Fenway Park in 1981. This was a perfect ending to a spectacular pre-game event, and, a proper prelude to the following Padres' home game that they won 4-3 in extra innings.

crack cocaine, and over 3,500 pounds of marijuana. Additional seizures include over \$630,000 in US currency, 3 luxury cars, and the seizure of 34 firearms including semi-automatic assault rifles and several fully automatic firearms, and 4 IEDs. The IEDs were processed with the assistance of the San Diego County Sheriff's Bomb Squad and the FBI.

Several identified subjects in this investigation have lengthy criminal histories including controlled substance possession and distribution, grand theft auto, burglary, resisting arrest, possession of dangerous weapons and battery. As the investigation continues, additional members of the Iraqi DTO are expected to be identified and arrested.

Recently, a search warrant was served at 811 E. Main by the El Cajon and La Mesa SWAT Teams and representatives from all of the agencies involved in the investigation. As a result of the search warrant 100 people were detained on scene and released. Over \$16,000 was seized along with evidence of illegal gambling. State Department of Justice Agents were on hand to aid in the portion of the investigation dealing with gambling allegations. The offices of the San Diego County District Attorney and the United States Attorney, Southern District of California, have agreed to prosecute targets of this investigation. Intelligence indicates this Iraqi drug trafficking organization is involved in money laundering between Detroit, Michigan and

El Cajon, California. Agents with the Internal Revenue Service have been contacted to assist in the financial aspect of this investigation. The Bureau of Alcohol, Tobacco, Firearms, and Explosives is involved in this investigation and will assist with enforcing firearm laws in accordance with their responsibilities. The United States Border Patrol and Immigration and Customs Enforcement will be assisting with enforcing immigration laws on subjects with illegal immigration status.

This is an on-going criminal investigation. I would like to thank all of the law enforcement agencies involved in this process. Additionally, I would like to thank San Diego County District Attorney Bonnie Dumanis, as well as United States Attorney Laura Duffy and their offices for their assistance in this investigation as we prepare cases for prosecution.

## The Chaldean community is outraged by recent illegal activities

This week federal and local authorities in the city of El Cajon arrested over 60 people in an investigation, dubbed "Operation Shadowbox," at a local Chaldean social club. The investigation was seeking to dismantle an Iraqi drug- and gun-trafficking organization with ties to a Mexican Drug Cartel and a Detroit crime syndicate, that was thought to be plaguing the Chaldean and Mexican communities. According to Federal and

State courts of the 30 people charged on Thursday, only 5 happen to be of Chaldean descent. The perception that the 60 people arrested were all or mostly of the Chaldean culture is factual not the case.

In a press conference held Wednesday, the Chaldean community expressed outrage with this news. The Chaldean community can not and will not tolerate this negative attention brought upon them by some misguided individuals. who in no way epitomize our community. Chaldeans, as well as all Americans, need to stand together in a united front against such disgraceful activities. Local Chaldean leaders will collaborate with the San Diego Police Department, San Diego County Sheriffs Department and the San Diego District Attorney's Office to ensure the elimination of illegal and dangerous activities in our communities.

"It's deplorable what these Chaldeans have done to tarnish our good name. Chaldeans have worked so hard to come to this great country to achieve the American Dream as have countless other immigrants from all over the world have done so in the past. We've made tremendous efforts to assimilate into America by working and serving our local communities and now the negative spotlight this investigation has brought upon our community, there is a perception that this behavior is indicative of the Chaldean culture. I want to assure everyone throughout San Diego County that this couldn't be farther from the

olvo has decided to hit the ground running when it comes to getting the word out about the 2012 line up. Starting with the XC70, Volvo has most manufacturers preview their new vehicles at different spots


around the country. Volvo decided to put together a Road Trip Gateway Colorado.

Mark Maynard and I started our journey in San Diego. We drove a Volvo S60 to the Westin Hotel in Los Angeles, spent the night and laid out our travel plans. We left LA and headed to Las Vegas where we were on our own. You can't give a \$32,550 dollar Volvo to a bunch of auto reviewers without concerns. Volvo fixed that problem by making it a contest with fuel mileage part of the trip including maintaining 25 MPG on the road and gathering extra points for the final competition. We averaged 25 and up to 31 MPG on the trip. After a few side ventures in Vegas we were off to Colorado.

The XC70 is a nice ride, and I doubt many drivers get to look at their passenger say, "Wow this car rides good, and the seats are very comfort-

The XC70 comes with two options - front wheel drive or all wheel drive, which our tester had and was helpful when we got lost looking for Grafton Colorado, a well preserved town from days gone by. Owners have two engines to choose from and one transmission. The first engine is an inline six-cylinder and it develops 240 horsepower and 236 foot pounds of torque and has a fuel estimate of 19 MPG city and 25 on the freeway. The other engine is also an inline six-cylinder but turbocharged and gets 300 horsepower and 325 pound foot of torque with fuel mileage averaging 17 MPG city and 23 on the freeway.


