Viejas Casino announces plans of expansion with 150-room hotel

At a major press conference on Wednesday, Aug. 31, Viejas tribal leaders and casino executives unveiled plans to build a new \$36 million, 150-room hotel adjacent to the existing casino in Alpine with a grand opening scheduled for the 1st quarter of 2013.

Unveiled were early conceptual design renderings of the hotel that will include a pool, fitness room, business center and other amenities. The hotel will be located on the east side of the casino building where the Bingo Pavilion is now located. Bingo will be moved to another area of the casino. The project also includes an expansion to the seating area of the Harvest Buffet.

Viejas Tribal Chairman Anthony Pico said the tribal members were excited and proud when they made the announcement to them several weeks ago. "It's been a long time coming," he said. "We have been planning this

for at least 15 years, and it almost came to fruition but the economy changed. But now we can move forward, and our tribal members are united on the project. They are very proud."

Tribal leaders were joined at the news conference by representatives of local Chambers of Commerce, the San Diego Convention and Visitors Bureau and others, who praised the project for its job creation and impact on the local tourism industry.

Scott Alevy, CEO of San Diego East County Chamber of Commerce said this is great news for our entire region. "A project like this takes on added significance in a challenging economic environment, where every new job means so much to local families and the local economy," said Alevy. "Beyond the local construction jobs, this new hotel will have a positive impact on local businesses that provide goods and services to Viejas Casino, the retail center and now the hotel."



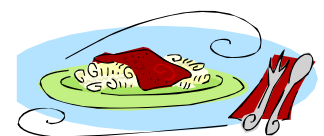

The Viejas Casino hotel project is expected to create more than 400 construction jobs and additional local jobs for ongoing operations once the hotel is built. Swinerton Builders has been selected as General Contractor for the project. The company's local projects have included construction of the Marriott Del Mar and Omni Hotel in downtown San Diego, as well

as historical renovations at Hotel Del Coronado and the U.S. Grant in San Diego.

"We're a privately owned company and around since 1888," said Don Adair, Senior VP and General Manager of Swinerton. "Our markets are casinos and hotels. We're excited with this opportunity to bring another 400-500 jobs

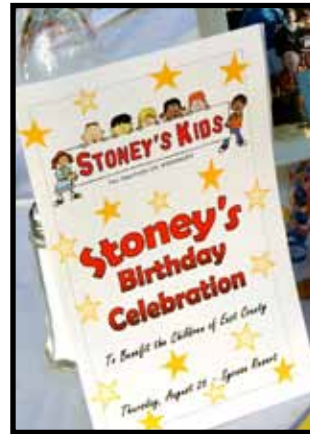
Stoney's Kids celebrate 20th anniversary

The foundation is dedicated to improving the health and welfare of the children of East County by supporting the programs, activities, and means for young people to develop essential life skills and make healthy choices for a successful future.

The annual event featured a cocktail hour with music provided by musicians from the East County Youth Symphony. Silent and live auctions were held which included items such as a Golf weekend, a Taylor guitar autographed by Toby Keith and a diamond and emerald ring. Measuring up

Q: I'm confused about some supplement recommendations I've read. Some are recommended in milligrams and some in IU. How do they differ and are they convertible? Thanks for your help.

A: Dr. Wright: IU stands for "international unit." An IU is the amount of a particular substance required to produce a certain biological effect.

But unlike milligrams and other units of measure, the IU measurement is based on the potency of the nutrient, so 1 IU of vitamin E is not the same as 1 IU of vitamin A. And since each substance's IU value is different, it's impossible to have a single equation that will convert IUs into another measurement, such as milligrams.

All substances measured in international units are officially defined by the International Conference for Unification of Formulae.





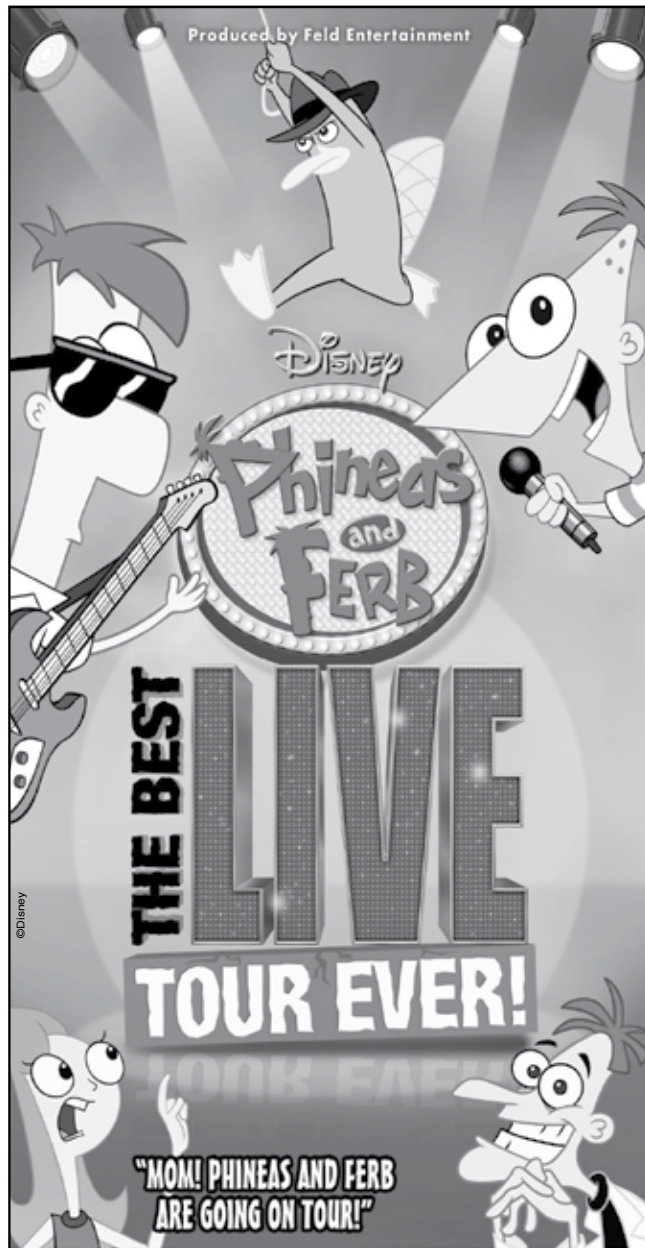

East County Youth earns Cox Conserves Heroes award

The annual Cox Conserves Heroes program recently awarded the finalists in San Diego County to deserving entrants

who were creative in ways to create, preserve, improve or enhance the shared outdoor places in our communities. Blake Powers, who helped to develop the East County Produce Exchange, was chosen as one of three Youth Heroes this year.

Created by Cox Enterprises and The Trust for Public Land (TPL), the program takes place in multiple Cox locations across the nation. Applicants' projects must meet the following criteria: cannot be part of one's job; must be located within the community as defined by the local Awards Program; should be something that anyone could do; cannot be pre-existing – such as a recycling program; A Hero should have helped to create, protect and/or care for an outdoor place available for public relaxation, reflection or

recreation by the community; The Hero's story should inspire others to act; and Previous Cox Conserves Heroes and finalists who received donations for their environmental nonprofits of choice are not eligible.

Some of the types of projects considered include: Cleaning up/refurbishing a park or public place; Helping to provide public access to a previously inaccessible place; Beautifying a public place, e.g. planting/ tending to a community garden; Volunteering at a local park; Water conservation/ protection-related projects; Creating a program that gets people to public places; Donating and/or assisting in the acquisition of land for public use; and Advocacy, education and/or community outreach for parks and open space.

Once all of the nominations are in, applicants are narrowed to a pool of twenty. The Heroes Judging Circle, a panel of civic leaders within the conservation field, then selects the top finalists. The finalists are profiled on the Cox Conserves Heroes website and in local media, and the public is asked to vote online for their favorite.

At the conclusion of the voting period, the finalist with the most votes is selected as the Cox Conserves Hero for his/her market. A donation is made to the Hero's environmental

charity of choice. First-place adult and youth winners will designate \$10,000 toward an environmental nonprofit of their choice. Second-place will receive \$5,000 for their nonprofit and third-place receives \$2,500. These years Heroes were acknowledged at a Padre game on August 19.

The East County Produce Exchange provides an opportunity for neighbors within the local community to trade homegrown produce monthly, so nothing goes to waste. Community members are asked to bring their fruits, vegetables, plants, herbs, eggs, flowers, crafts or anything homegrown to trade with each other. Powers, a sophomore at Steel Canyon High School, said he got the idea while driving or riding around the area.

"I started noticing a lot of fruits and vegetables that weren't being used, so my friend John Chapman and I started the East County Produce Exchange where people bring their items the last Saturday of the month in Jamul to A.R.C.H.E.S. (Alpine Ranch Creative Health and Ecological Solutions, Inc.), www.archesinc.org

It was his mother, Katie Powers, who entered Powers in the Cox Conserves Heroes program. "My family has been very supportive in helping me

to collect produce and encourage me through the process of the Heroes program," he said. "It means a lot to me to be recognized by Cox; I never realized this was such a big idea."

Powers, who plans to attend college and seek a career in "green-friendly" architecture, is donating his \$2500 Cox Conserves Heroes award to A.R.C.H.E.S.

Other youth finalists included Isabel Herrera who has spent the last three years inspiring people to protect the ocean and enlighten others about environmental issues. She focused her efforts on City Heights, trying to change behaviors such as dumping and polluting. Isabel will donate her prize to Ocean Discovery Institute, www.oceandi.org. Luis Malo volunteers and assists in coordinating various clean-up activities at his high school and his Chula Vista community. He's active in the Chula Vista High School PEACE Club, where members clean up graffiti throughout the neighborhood. Luis will donate his prize to the Chula Vista High School (CVHS) Peace Club, <https://sites.google.com/site/cvpeaceclub/>.

'Seven Days In Utopia' has great family values

In *Seven Days In Utopia* a young golfer soon turns road rage into a life-learning experience after an old man finds him sitting and bleeding by his wrecked car and takes him in. The

movie, based on David L. Cook's best-seller *Golf's Sacred Journey: Seven Days at the Links of Utopia*, leaves little doubt about its tone, for it opens with scripture verse Isaiah 30:21, "Whether you turn to the right or to the left, your ears will hear a voice

behind you saying, "This is the way; walk in it."

Aspiring golf pro Luke Chisolm (Lucas Black) is in a match for his life where nothing goes right. Getting overbearing suggestions from his caddy, who is also his father

(Joseph Lyle-Taylor), Luke grows befuddled as shot after shot goes awry. The last straw occurs when his father finally walks away as Luke has a tantrum right on the golf course. Luke responds by jumping in his car and taking off down the highway at high speeds while punching objects in his car. When a big bull stands right in front of him, Luke swerves to the right, crashing through a field and coming to a stop with blood oozing down his head.

Fortunately, rancher Johnny Crawford (Robert Duvall) approaches on horseback. He lends Luke a hankie for his head and takes him back to his ranch. By this point, it's no secret where the movie is going, but it's an inspirational journey worth watching.

As Luke is introduced to Johnny's close friends, he becomes aware of their gentle ways and easy-going manner. He's given a room at a boarding house, fed and clothed and introduced to the young and pretty Sarah (Deborah Ann Woll). He soon learns she's studying to be a horse whisperer, and that even though she might be attracted to him, she's no easy conquest. Luke gets a few unfriendly gestures from a

young local (Brian Geraghty) who also has his eye on Sarah.

After a few uninvited visits into Johnny's place Luke discovers he was once golf pro and an alcoholic. Taking Luke under his thumb Johnny uses numerous elements of his life – golfing, fly fishing, painting, flying – to teach Luke morals and ways to better himself and play better golf like remembering what SFT (See it, Feel it, Trust it) stands for.

A fine cast with actors like Duvall, Black, Melissa Leo, Deborah Ann Woll, Brian Geraghty, Jerry Ferrera, Joseph Lyle Taylor, KJ Choi and Kathy Baker keeps the story moving and the good lessons

about life continually coming. Once Luke leaves his new friends and heads off to the Texas Open, the film's plot is basically over, and the next segments are clearly cliché.

Seven Days In Utopia, a great family film, gets its messages across without preaching, striving to answer the question Johnny asks in his narration, "How could a game have such an affect on a man's soul?" There are some answers in the film and more for viewers to figure out themselves. The movie contains action, a tad of romance, humanity and humor (the scenes of the guys in the Texas Hold 'Em poker game is not to miss).

'The Debt' is edgy and haunting

The *Debt*, an espionage thriller focusing on characters seeking revenge in 1997 for atrocities that occurred during the Holocaust, is a remake of the 2007 Israeli film with the same title. Although swift

time-period changes and back-story create slight confusion at the beginning of the film, the incredible cast members – including Helen Mirren, Jessica Chastain, Sam Worthington, Ciaran Hinds, Tom Wilkinson, Marton Csokas and Jesper Christensen – keep the intrigue slowly building.

Former secret agents Rachael Singer (Helen Mirren, *The Queen*) and Stephan (Tom Wilkinson, *The Ghost Writer*) arrive in Israel where Rachael is being honored for her daughter's (Jessica Chastain, *The Help*) tell-all book about her mother's dangerous and clandestine experiences during her and other Mossad agents' 1965 mission to kidnap Nazi war criminal Dieter Vogel (Jesper Christensen). He was known as "The Surgeon of Birkenau" whose experiments left thousands dead or disfigured. As Rachael is nervously egged on by her daughter to get up and speak, Rachael is obviously traumatized by the book and recalling those dangerous times.

It doesn't help when their third team agent, David (Ciarán Hinds, *Harry Potter and the Deathly Hallows: Part 2*), steps into the room, looks about, eyes Rachael and then abruptly leaves. At one time

Rachael and David were involved in a romantic affair while they held Vogel hostage.

The story unravels through different eras in which Worthington (David), Chastain (Rachel) and Csokas (Stephan) portray the younger characters. The drama really starts once the agents begin their heist of Vogel, now a practicing gynecologist. How Rachel eventually traps him is quite harrowing. During his capture in a small apartment in Germany, the lives of these three agents, who were strangers in the beginning, slowly unfold before our eyes. Vogel taunts them when they remove the tape over his mouth to feed him, hoping to cause one of them to drop his/her guard.

Shortly after the luncheon in 1997, Rachel and Stephan learn David was killed by an automobile. Was this an accident, murder or suicide? Rachel and Stephan aren't sure, but it leaves a big hole in what was and what might be, both professionally and personally for each of them. Stephan insists that Rachel must make

one more sacrifice to complete the mission they started years ago. However, is she mentally and physically up to it? That's a question even Rachel cannot answer.

In addition to terrific performances by a strong cast, John Madden (Proof) deserves credit for his superb direction, and screenwriters Matthew Vaughn, Jane Goldman and Peter Straughan must be recognized for their tight, compelling screenplay adaptation. But I think the real visionary who makes this film haunt and enthrall is cinematographer Ben Davis (Hannibal Rising). He creates dark shadows that show just enough in a scene to create a chilling edginess without revealing too much plot. His eye behind the camera is a great mirror to the words on the page.

The Debt engages from beginning to end and is a great contender for some of the better films of 2011.

evening also includes a great dessert.

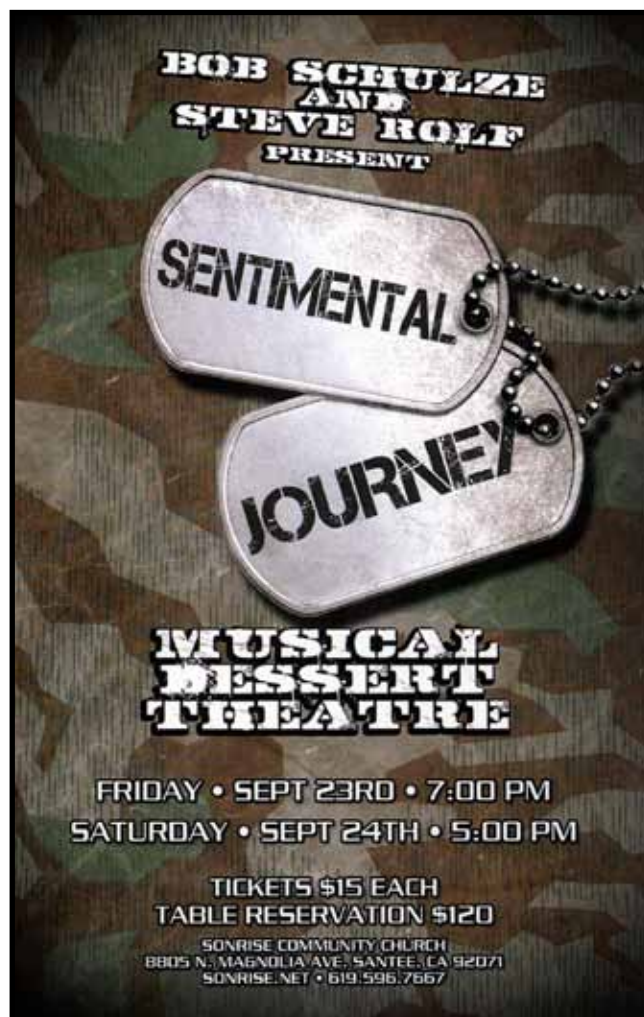
Rolf said this show will be especially touching as these two comrades must learn to get along and figure out if they can learn from one another.

ORDINANCE NO. _____

AN ORDINANCE ADDING NEW CHAPTER 9.66 TO THE EL CAJON MUNICIPAL CODE REGARDING ABANDONED SHOPPING CARTS

This ordinance adopts the City of El Cajon Abandoned Shopping Carts ordinance, in order to require the owners of shopping carts in the City to effectively manage the control of their carts. The ordinance provides that at the request of the Director of Community Development an owner of shopping carts is required to submit a plan outlining the management of the shopping carts so that they do not become a public nuisance. If an owner's plan is ineffective the Director would have the authority to require that the shopping cart owner utilize an alternative, more effective, shopping cart management system.

This ordinance also requires that every business providing shopping carts for the use of its customers post warning signs in close proximity to every entrance and exit, notifying its customers that the removal of shopping carts from the owner's premises is prohibited by law. The signs must be multilingual, and meet certain minimum requirements.

The ordinance also authorizes the adoption of administrative fees, by City Council resolution, to reimburse the City for the actual costs of removal and storage of any shopping carts, or parts of shopping carts, found off of the owners' premises.

Any violations of the ordinance may be prosecuted as a misdemeanor by the City Attorney's office.

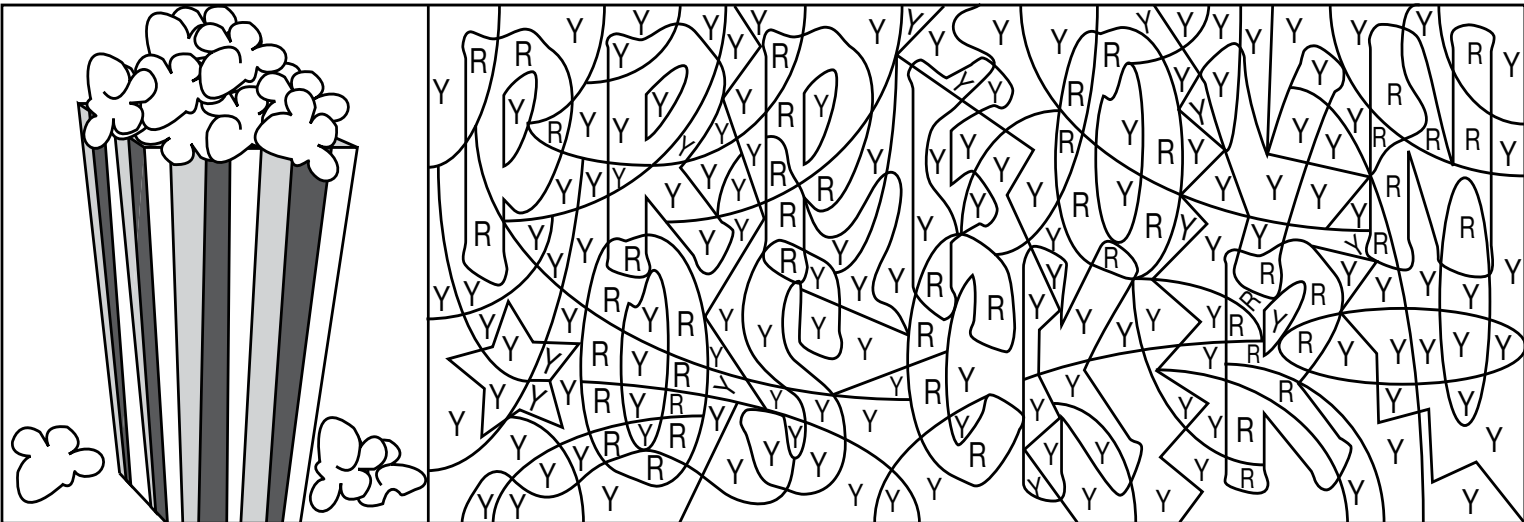

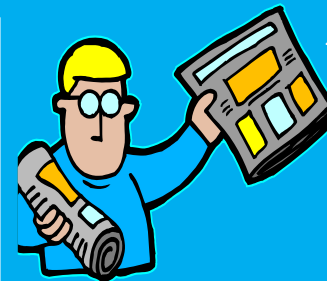
