Let them eat cake, the slogan made popular by the French wife of Louis XIV, could have been the slogan at Viejas this past Tuesday when Viejas Casino offered its customers a free meal at the Casino's award-winning Harvest Buffet. From 9 a.m. to 9 p.m. excited and happy guests went through the quick line in the DreamCatcher to get a wristband with an assigned time to line up for the meal.

was Selina Bahena from El Cajon. "I think this was very generous of Viejas, and much needed, especially considering the job loss," Bahena said. Her friend Carol Pearson said, "It's very nice and a wonderful thing to do."

As guests enjoyed the offerings of the casino, a terrific New Orleans style Dixie band marched throughout the Casino getting everyone revved up for the happy occasion. The team members at Viejas made up the band, some playing their own instruments. They marched

with exuberance in beautiful glittered costumes and masks, while throwing out beads, and keeping a lively beat. Guests throughout swayed with the music getting into the festive mood. Stilt walkers drew big smiles and gorgeous showgirls held big signs over their heads to announce the time of the next seating.

The entire Viejas staff made the extremely busy day appear easy. "The food and beverage and management crew had about three days of run-throughs to make sure everything worked in precision and went off without a hitch," said Nancy Kennedy, Marketing Manager of the Viejas Outlet Center.

Seating 350 people at one time, with attendants joyfully clapping at the end of every table as they all walked in together shouted a generous spirit

of welcome that showed on guest's faces. Jim Wild, Viejas V. P. of Operations, welcomed the diners by thanking them for their patronage and alerting them to Viejas plans for expansion with the new hotel. ## The Viejas Band of Kumeyaay Indians upholds its culture

The Viejas Band is one of the 12 remaining bands of the Kumeyaay Indian Nation whose ancestors have inhabited this region for more than 10,000 years. Like their ancestors before them who were great hunters, craftsmen and early environmental keepers of Mother Earth, the Viejas Band has continued to be a respectful and motivating force for its people and the community at large.

While celebrating the 20th anniversary of Viejas Casino and Entertainment on September 17, the tribe's history in the community speaks for itself, both in contributions to the community and preserving its own culture.

Kumeyaay women made fine baskets in coil fashion, pottery, most of the clothing and created shelter, which varied with the seasons and environments. The

Kumeyaay practiced animal husbandry. They had a complex pattern of land ownership and division of labor that included a network of agricultural holdings in different geographic areas that were cultivated on a seasonal basis.

For years Viejas tribal members have practiced Kumeyaay ways and sacred rituals such as sweat lodges, ceremonies, gatherings and creating useful but also beautiful creations of art. Chairman Anthony Pico, in 2009, journeyed to Peru to participate in spiritual healings and broaden their perspective of the practice. The result was an invitation to Shaman Don Martin Pinedo Acuna and his interpreter and shaman-in-training, Marco Nunez who came to the Viejas reservation for a three-day workshop that was open to the public.

"These men live by a simple rule," Pico said at the event. "All we have to do is love

every individual human being we meet and the rest is gravy."

Last year Viejas tribal members put a spotlight on health when they joined their brothers and sisters in the Longest Walk 3, a 5,400-mile walk-run-ride relay across America to draw awareness to the diabetes epidemic among Native American Indians.

And once again this year, the tribe held its Summer Cultural Program, where tribal youth learned more about the history of their ancestors, the Kumeyaay language, and more.

The Viejas Band has attained its success through hard work, thoughtful planning and a generous spirit. The reward is widespread benefits for residents and organizations throughout San Diego County. And for the tribe - pride in its efforts and a continuation of its customs, traditions and culture for generations to come.

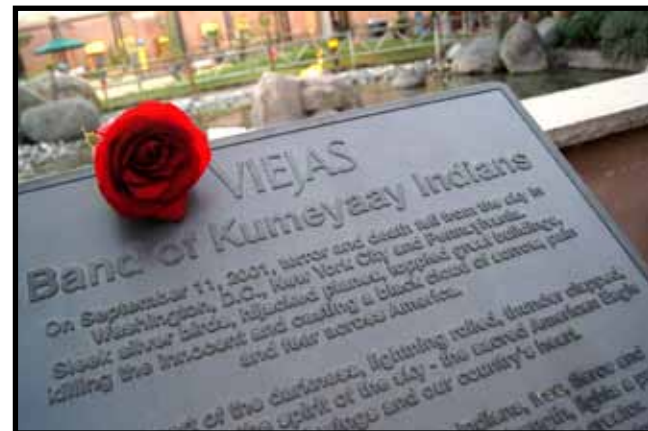

to cope. And I sang it for our nation so we as a nation could come together and begin the healing process.

**V**iejas Band of Kumeyaay Indians Chairman Anthony R. Pico, Tribal Council Treasurer Sam Q. Brown and Tribal Member and lead singer Ral Christman participated in a 9/11 Ceremony of Remembrance on September 11 at the Viejas

Outlet Center near the eternal flame located in the fountain near the Viejas 9/11 marker. Joining them was Miss Kumeyaay Nation 2011-2012, Miss Olivia Barrett.

"It gives me great pleasure to have the opportunity to lay a wreath at the Eternal Flame in remembrance of our

country and remembrance of those who lost their lives and remembrance of those people who were injured physically, emotionally, pathologically and spiritually," Pico said before introducing those in attendance.

As the wind gently blew the patriotic flags standing near the tribal leaders, a crowd gathered in reverence to listen to traditional songs. "Today we are going to sing four songs that are thousands of years old, and very respected by our people," Christman said. "They are songs of celebration of life – life past, life future, and life present. These songs hold special meaning especially today."

Christman recalled that ten years ago after the falling of the

twin towers the leadership at Viejas was honored by the City of New York. They were asked to come and offer a prayer to represent all of the first nations and Native American tribes of this continent there at Ground Zero.

"Our Chairman at the time Anthony Pico and Vice Chairman Bobby Barrett called on me to go to New York to spread some of our blessings and share some of our songs," Christman said. "I was there to sing some of these songs only a few weeks after 9/11. It was a very special time for me and Vice Chairman Barrett and for our entire tribe back home. I also witnessed a great sadness as our military, fire department and police department were digging to find people below the debris. So I sang

As the native words of inspiration and healing poured out many focused on the singers and dancers, while others looked at the fire bending in the wind to commentate fallen lives. After the songs a wreath was brought out and placed on a pedestal as a sign of mourning.

## Lakeside Planning Group

Lakeside Planning Group board member L. Cyphert announced this week that the Helix Water Board voted to suspend the El Monte Project. Alternative uses for the property will be looked at.

During the presentation/discussion, a project presented by a civil engineer for the installation of curb, gutter and sidewalk on South side of laurel St. between Vine and Ashwood was approved.

The improvements require a parking prohibition for the duration of the project as well as a conversion of individual mailboxes to a cluster unit.

## Proposed Publicly Initiated Actions

A project has been proposed to create an equestrian and pedestrian friendly pathway parallel to Flinn Springs Rd. that will extend approximately 0.6 miles in length and allow for safe passage of hikers and horseback riders. The pathway will be DG and 10 feet wide on the west side of the road.

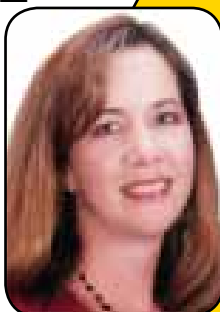

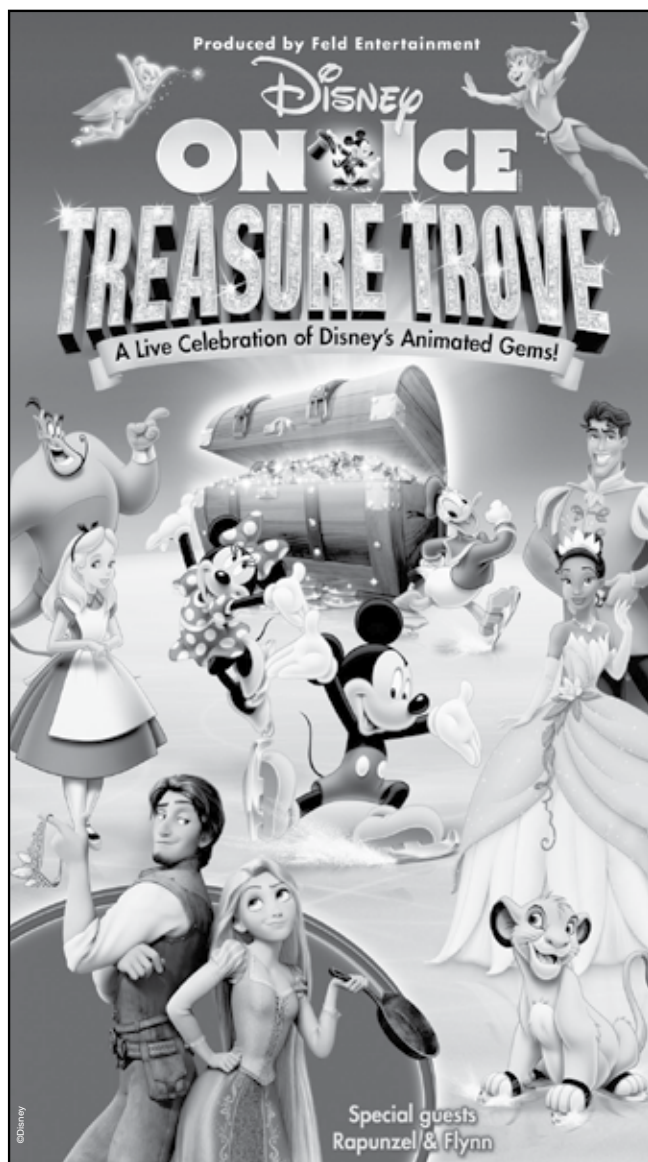

## Sycuan Casino announces grand re-opening after major renovations

Patrons walking into Sycuan Casino will notice amazing renovations have taken place all through the Casino. The Hnedak Bobo Group (HBG) and Cleo Design have worked their magic to include striking carpets featuring custom-designed patterns, new tile and stonework, ornate wall coverings, woodwork and architectural ceilings.

Design and architecture teams renovated the gaming areas, created an all-new non-smoking buffet, a new sports bar and grill restaurant and installed a one-of-a-kind specialty lighting fixture in the main lobby. About the design HBG's Architect Shawn Hobbs said, "The space already had two venues that were brought up to speed so the idea was to pick up on the flowing curves and enhance the esthetic by extending it from one end of the casino to the other."

Jannicke Faetten, Cleo Design's Interior Designer added, "Cleo Design was given a book

from Sycuan about the history of the tribe and what it stands for. That's why we selected more earthy tones to fit in with the area and the clients this property serves."

Michael Tabor, Director of Marketing at Sycuan Casino, next led the tour to the Prim Rose room that offers 8300 square feet of gaming action with video and reel machines and gaming tables. "We spent 1.3 million remodeling this room and our Wachana Restaurant," said Sheila Howe, General Manager of Sycuan Casino. "After that we decided to do the entire facelift of the casino, so that's how the renovation came about."

After a brief stop in the Sycuan showroom theater – now renamed Live & Up Close – Tabor escorted the tour group to the new lighted feature in the main lobby created by Technifex. "What we wanted to do with the light feature was to create a new sense of entry," Hobbs said. "With up to the minute technology we've created the effect of water and a show that emulates water using only light and sound."

Explaining some of the features of the show that reflects changing images – four seasons, fireworks and several others – on the floor from a 2-ton structure 46 ft above the floor, which is illuminated by 240,000 miniature LED lights, was Technifex owner Rock Hall. "This is a collaboration of our company, HGB and Cleo Design other producers and artists who created the images in the show," Hall said. "This is one of a handful of 3-dimensional displays in the world. We created our own software to create the animation and bring it to light all controlled by a computer."

Next up on the tour was the casino's new GameDay Sports Bar & Grill. Beautifully designed with a slick décor, the sports area is a combined gaming and sports viewing experience with 29 multi-game, multi-denomination bar-top gaming machines offering video poker, keno and slots all in one device and surrounded by 39 high definition and projection TVs. The design team has done a terrific job with sports memorabilia including the original four Padres owners' seats from Petco Park, a full San Diego Chicken costume, the 14-foot tall metal Louisville Slugger Padres bat from Qualcomm Stadium, a full Jimmy Johnson engine and more than 100 signed and unsigned photos and miscellaneous sports memorabilia. The menu features more casual fare, including appetizers, pizza and hardwood-smoked barbecue specialties.

Last stop on the tour was

a visit to the new Paipa's Buffet completed in May and relocated to the redesigned smoke-free wing. Renovations to the buffet include a new kitchen, seating to fit 320 people and more specialty food stations. Executive Chef Paul Schwab has complemented the visual upgrades by incorporating fresh, new menu items including snow crab legs, brick oven pizza, a fresh pasta station, freshly made tortillas, grilled steaks and an expansive new dessert bar. With the addition of snow crab legs and continuation of its signature slow-roasted prime rib, Sycuan has repositioned its buffet as the new "Surf & Turf Buffet."

San Diegans are invited to experience the newly revamped Sycuan during the casino's grand re-opening celebration September 24-25. Weekend activities include: Friday, Sept. 23 – National Native American Day falls one day prior to the grand re-opening, and Sycuan will host a very special traditional celebration to commemorate the momentous day for the tribe and casino alike. The ceremony will include bird singers, a traditional blessing ceremony with Chairman Daniel J. Tucker and the Sycuan Tribal Council, and end with a ribbon cutting ceremony. 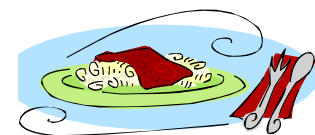

# 'Contagion' has a great cast but lacks anything new in the epidemic genre

From the early years of filmmaking to modern times, many movies about epidemic outbreaks have been released. *Children of Men*, *The Andromeda Strain*, *28 Days Later*, *12 Monkeys* and *Outbreak* are a few that come to mind. Even the most recent *Rise of the Planet of the Apes* contained a hint of that theme. As far as plot goes, Steven Soderbergh's *Contagion* offers little new about fear and horror about to end the world, but this director's behind-the-camera ability to be fresh -- along with help from an all-star cast -- elevates his thriller from boredom, if only just slightly.

Business woman Beth Emhoff (Gwyneth Paltrow) manages a family but also travels internationally. When she returns home from Hong Kong with a slight cough it's only a matter of days until she and

her young son are writhing on the kitchen floor, and shortly after, die.

Left to pick up the pieces are her husband Mitch (Matt Damon) and teen-age daughter Jory (Anna Jacoby-Heron). Soderbergh uses random flashbacks and scenes from around the world to reveal that a deadly virus killed Beth (which actually gives Paltrow play throughout the film). What makes this virus so deadly? It can kill people who simply touch a hand rail or stand next to someone coughing.

With global panic rising, the Center for Disease Control and Prevention kicks into overdrive, bringing out their best doctors and researchers including Dr. Ellis Cheever (Laurence Fishburne) and his colleague Dr. Erin Mears (Kate Winslet). These two immediately start investigating, Ellis more from the desk and Erin actually in

the field. Joining those searching for answers are Dr. Leonora Orantes (Marion Cotillard) and Dr. Ian Sussman (Elliott Gould). One of the jumping scenes that begin to happen too often, include Leonora heading to the Hong Kong area to further determine the origin of the mysterious virus. While there, some surprising experiences change her life forever.

Mitch, who eventually learns

he is immune to this bug, hopes Jory inherited his immunity. Just in case, he keeps her confined and away from the boyfriend, which is not an easy task. Meanwhile, he continually plagues the doctors about what actually killed his family members. It's Mitch's character as an ordinary man who keeps the story grounded. However, the film's momentum continues to build with the perplexing actions of a quirky

blogger (Jude Law) whose motivations are constantly in question.

There are some undercurrent mentions here as well as references to issues like health care and family values, or looting and mayhem which occur whenever a disaster strikes -- but these things are easy to miss when all eyes are watching for the next person to be infected. Overall, *Contagion* offers nothing new in this genre, but fans of various cast members may enjoy the film.

I don't get this with every car I drive but once I slid behind the wheel, grabbed the leather-wrapped steering wheel and felt the racing seats of the Subaru WRX Wide Body grab me I knew this would be a rare experience. What a hoot to drive. If this car could talk it would remind me of a dog that just wants to run – meaning getting out on the open road. Mountains, freeway, city streets, even heavy traffic is enjoyable thanks to a good sound system with AM/FM/CD, six speakers, 3.5 mm input jack, Bluetooth, iPod capability, XM-Sirius radio and a USB port.

There's no back up camera, or event navigation, but I didn't miss any of these features. However, the Symmetrical All-Wheel Drive, which has the engine mounted in-line with the drivetrain, provides

a seamless transfer of power to all four wheels. Other AWD systems need additional drivetrain components to route the same power to the wheels, often using complex designs. More components tend to reduce vehicle efficiency and could add to higher maintenance costs.

Drawn from more than 40 years of intelligent performance, the horizontal layout of the Subaru Boxer engine combines balance with power and efficiency, and the high-performance of an intercooled turbocharged 265 horsepower is standard on the WRX. While the WRX STI turns up the boost to deliver a full 305 horsepower, I can verify the 265 from the WRX is more than enough get-up-and-go. Fuel mileage is acceptable, 19 MPG-city and 25 freeway.

The vehicle has a sport-

tuned 4-wheel fully independent suspension with front and rear stabilizer bars. It also has a fully synchronized 5-speed manual transmission with Incline Start Assist – a sweet feature. Think it needs a 6 speed? Then opt for the STI with a 6-speed manual. The 5-speed was butter smooth and the ratios were perfect.

The interior has plenty of room for passengers, gear or groceries. Other comforts include power windows, a center console with storage, great instrumentation with perfect

lighting, race-inspired pedals, and rear seats that flip and fold for more storage space. To flip down the rear seats just pull the handle located at the top of the trunk opening.

The joy of a Subaru is driving it! I don't care where one is heading, just get one and try it. The price starts at \$25,495 for the base WRX, and the Premium Model runs \$27,995. 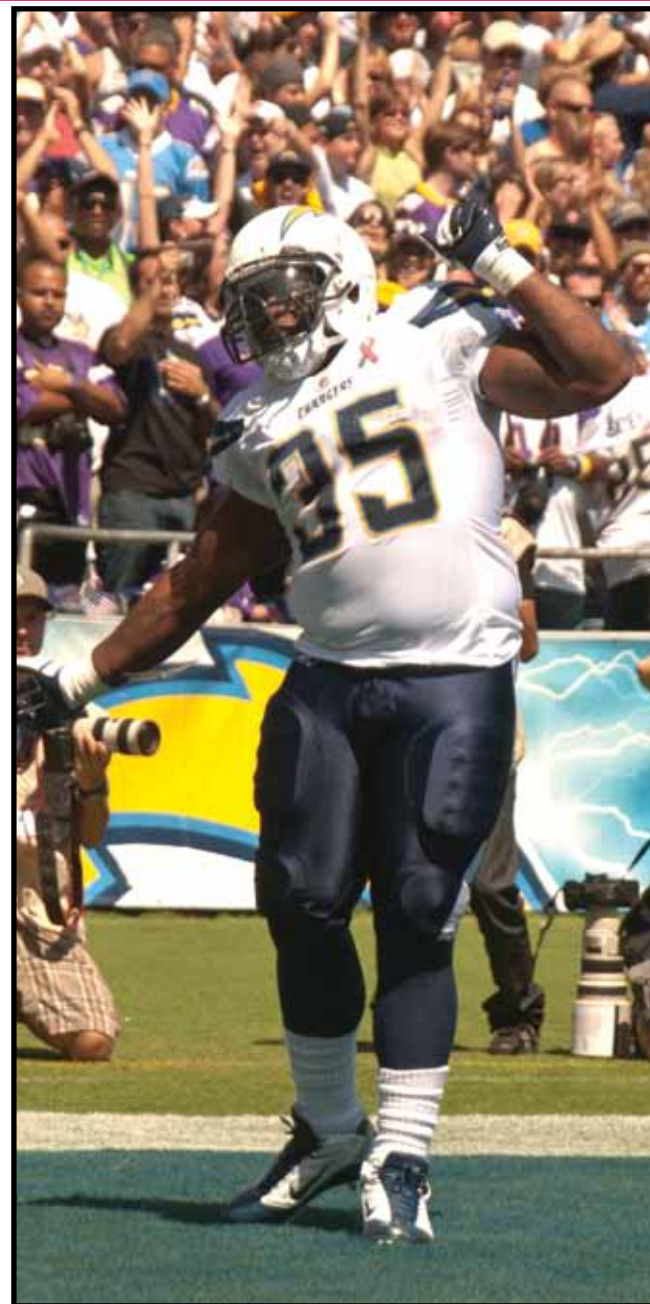

Following is a summary of an Ordinance adopted at the Joint Meeting of the City Council/Redevelopment Agency of the City of El Cajon on September 13, 2011. Full text is available in the City Clerk's Office, 200 Civic Center Way, El Cajon, California.

### ORDINANCE NO. 4971

#### AN ORDINANCE ADDING NEW CHAPTER 9.66 TO THE EL CAJON MUNICIPAL CODE REGARDING ABANDONED SHOPPING CARTS

This ordinance adopts the City of El Cajon Abandoned Shopping Carts ordinance, in order to require the owners of shopping carts in the City to effectively manage the control of their carts. The ordinance provides that at the request of the Director of Community Development an owner of shopping carts is required to submit a plan outlining the management of the shopping carts so that they do not become a public nuisance. If an owner's plan is ineffective the Director would have the authority to require that the shopping cart owner utilize an alternative, more effective, shopping cart management system.

This ordinance also requires that every business providing shopping carts for the use of its customers post warning signs in close proximity to every entrance and exit, notifying its customers that the removal of shopping carts from the owner's premises is prohibited by law. The signs must be multilingual, and meet certain minimum requirements.

The ordinance also authorizes the adoption of administrative fees, by City Council resolution, to reimburse the City for the actual costs of removal and storage of any shopping carts, or parts of shopping carts, found off of the owners' premises.

Any violations of the ordinance may be prosecuted as a misdemeanor by the City Attorney's office.
