

's time to "fall back" and change our clocks back one hour on Sunday. Nov. 6, and please make sure to change the batteries in all of your smoke alarms as well – it's a proven lifesaver! Having a "working" smoke alarm reduces a person's chance of dying in a fire by half. For the very

best protection, install smoke alarms on every level of your home, outside every sleeping area, and in every bedroom. Smoke alarms should be mounted high on walls or ceilings, and tested monthly. It's important to replace smoke alarm batteries at least twice a year, unless they're 10-year lithium batteries. Even if your smoke alarms are hardwired. replace the batteries in case of a power outage. Have a home escape plan and practice your plan with your family, this includes having a designated meeting place outside. Stay





If you have your magnifier reading glasses on, you can read the disclaimer that the results shown on the advertisement are atypical. Of course they are. Despite the weight loss industry taking in 60 billion dollars a

year, statistics reveal that 95 to 98 percent of dieters regain the weight in the long run, often with added pounds.



Dr. Aaron to speak at Alpine Kiwanis on his career and treating President Reagan after assassination attempt

҇hese days Dr. Benjamin L. Aaron enjoys, golf, family and the lovely view from his home on a hill overlooking the East San Diego County valley. With a long career as a Naval heart surgeon and at one time head of George Washington University Hospital in Washington, D.C. retirement was inevitable. For the doctor who has many recollections of a memorable career, one is specifically significant. Dr Aaron was the surgeon that operated on and removed the assassin's bullet from President Ronald Reagan in 1981.

Born in Jefferson City, Missouri, Aaron attended high school in Kansas City, Mo. It

was an arm injury as a youth in a roller skating accident that placed him in treatment at a hospital many times. "I was just a young kid watching what was going on and it was all simpatico with me. I also had an aunt who was a doctor, and she was a big influence on me. I could see myself in that arena."

Aaron spent fours years in medical school in Texas. Married in 1952, he joined the Navy in 1957, and came to California where he did an internship at the Naval Hospital in Oakland and also did a residency there in general surgery. From there he went to the Naval Hospital in New York where he trained in thoracic surgery. Following was a year's fellowship in Richmond,


Virginia and a three month fellowship in cardiovascular surgery at the University of Alabama in Birmingham. At the fellowships he worked with prominent surgeons in their programs.

"I began thinking about being a thoracic cardiovascular surgeon when I was in surgical training," Aaron said. "That was an area that wasn't nearly as prominent as it is now. The heart —lung machine was just invented when I was in my surgical training."

Aaron spent 22 years in the Navy, most of it in Naval Teaching Hospitals. Before retiring he became the Chief of Thoracic Surgery at the San Diego Naval Hospital and moved his family to Alpine. After his retirement in 1979 Aaron went to George Washington University Hospital running their training program in thoracic and cardiovascular surgery.

On March 31, 1981, Aaron was sitting at his desk doing paper work when his radio station broke in with news that there was an assassination attempt on President Regan as he was leaving a speaking event. Wounded in the attack by John Hinckley, Jr. was the President, White House Press Secretary James Brady, and Secret Service agent Timothy McCarthy. As Aaron heard sirens getting louder, he knew the wounded were heading to their emergency room.

"Every hospital in D.C. has a special telephone," Aaron said. "Any time the President

moves, his medical guard knows what hospital is closest, and we were the closest one so his limousine headed right to us. At first they didn't think the President was shot, but then he coughed up a little blood and confessed to secret service agent Jerry Parr that he

iana Saenger, entertainment editor for the East County Gazette for nine years, took home two awards from the 38th annual San Diego Press Club awards on October 25, at the San Diego Hall of Champions.

With the theme of The Story Prevails, competition included 159 categories and 100s of member and nonmember entries. Saenger took third place in the Non-Daily Newspaper - Profile category; "A Fascinating Man Creating Positive Footprints For Horses and People." The profile in the East County Gazette reflected on with her interview with horse trainer Buck Brannaman, the inspiration for the Nicholas Evans novel on which the film The Horse Whisper was based. Brannaman does not whisper much. but in the four-day workshops he teaches around the country nine months a year, he teaches horse owners how to treat the animal as a partner rather than an adversary to be "broken" or tamed.

About her awards Saenger said, "Journalism is not a big paying career, but award recognition from prestigious organizations is encouraging and rewarding. I love what I do. I meet interesting people on all ends of the human spectrum, relish their stories and always hope to make their day better by sharing their story with the world. I'm very blessed."



Good performances highlight rogue writer's work in 'Rum Diary'

ohnny Depp has never made a routine movie, and his new *Rum Diary* from Director Bruce Robinson and GK Films, certainly continues the actor's extraordinary efforts to entertain an audience.

Hunter S. Thompson was sort of a rogue writer, and this film is adapted from one of his unfinished novels. Barely 20 during his rousing times in the Caribbean where the story takes place, Thompson made a failed effort to become a newspaper man in Puerto Rico. He wrote about all of his escapades in the beautiful and tropical island as a second attempted novel. It was highly autobiographical and took place in the 1960s.

Years went by and the novel languished until Depp urged Thompson to finish it and get it published in the 1990s. The young actor thought at that time it would make a good movie. He was right.

Set in the seedy and unglamorous world of newspaper publishing, *Rum Diary* gives Depp a chance to play the youthful aspiring writer who has a tendency to drink a little more

than merely socially. Wanton drinking, partying and carousing shapes Depp's character of Paul Kemp, a disguised version of Thompson himself.

Michael Rispoli plays Sala, a bedraggled and rum-soaked photographer on the newspaper who befriends Kemp. In the most hilarious scene in the movie, Sala and Kemp must drive a wrecked car through the streets of San Juan. With Kemp forced to sit on Sala's lap. It's a very funny episode indeed, and lightens the film by providing the funniest moment between the two cut-up guys. Rispoli plays a winning, loveable rascal and mangy sort whom you can't help but like.

The structure of the film is rather loose and free-form, much like Thompson's rumaddled mind must have been when he jotted down his ideas. Kemp's life seems to merely float through events that he seemingly stumbles upon with innocence and humor. He falls in with Sanderson (Aaron Eckhart) an unscrupulous land developer who hires him to write favorably about the hotels and condos that will eventually destroy the environment. Struggling between poverty and the right thing to to live the high-life or to expose the scalawags for who they are. He also battles with having to fight off Sanderson's sexy wife Chennault (Amber Heard). Heard makes a great impression in the film as a seductress who can elicit sympathy when things don't go exactly the way she planned. She is free and doomed at the same time, and Heard's acting ability fleshes out this beautiful, but sad girl's dilemma.

Richard Jenkins makes a fine

impression as the frazzled editor of the dying paper, and injects some comedy into his dour figure with the use of a comical wig. Jenkins, of course, is capable of much more, but he infuses the part with the feeling of the frustration of being the captain of a sinking ship.

Note must be made of Giovanni Ribisi, in the pivotal, but small, part of Moberg, a former staff member. He is now so alcohol-embalmed and drug-soaked that he can barely function, but he's perceptive

and may hold the key to truth. It's an amazing characterization and probably one of Ribisi's best parts.

The scenes of Puerto Rico are naturally beautiful. Not often photographed in films (excellent work by Director of Photography Dariusz Wolski) Old San Juan is an architect's dream and appears as a baker's confection as the building's colors dance off the screen as whipped fantasies. So does Depp entertain here? Hey; it's Johnny Depp.

Pub League to World Cup story unfolds in 'Rise And Shine: The Jay Demerit Story'

Many kids have dreams but what makes an extraordinary person is one who pursues those dreams beyond reality. That's the case of Jay DeMerit who played three different sports in his home town of Green Bay, Wisconsin. His favorite sport was soccer, but coming from a state known for football, chances of making that his ultimate career were slim. Rise And Shine: The Jay Demerit Story is an inspirational film about how far DeMerit went, the sacrifices he made and the odds that he sheered like a lawn mower to reach the status of U.S. Soccer Player and International Soccer Star.

After playing soccer at University of Illinois at Chicago and for a few U. S. teams, he wasn't drafted. He then went to England and buddied up with friend Kieran Keane. Both boys, still in their teens, wanted to be pros. They worked odd jobs and dedicated every moment to play soccer with guys in parks perfecting their skills. At one time broke and hungry, they moved into Keane's family home, where there was already lot of siblings. Everyone, ex-

plained Keane, "Would hide food when it came into the house so the few days when it was all gone we'd have something to eat." Demerit recalls living on a can of beams and toast for years.

Eventually the guys joined a soccer club that was at the bottom of the pyramid in order of skills and status. Their skills improved and they worked their way up the ladder, but DeMerit still wasn't offered a contract. Luck changed in 2004 when he was called in for pre-season games with Northwood, a team in seventh place in the pyramid. In that game DeMerit's skills were noticed by the opponent's team manager, Ray Lewington. He offered DeMerit a one year contract to play for Watford.

The documentary is a tad long but the more I watched, the more intrigued I became. DeMerit is as self-effacing about his arduous journey as he is his passion to play soccer. And when he scored the so-called "£40 million goal" that helped promote Watford into the lucrative Premier League, I couldn't help but get excited. For the 2010 FIFA World Cup in South Africa, DeMerit played

on Bob Bradley's 23-man squad for all four of the U. S. matches against England, Slovenia and Algeria. He played in the second round match against Ghana, in which the USA was eliminated.

Interviews in the film include DeMerit's teammates and coaches (Bob Bradley and U.S. National Team players such as Tim Howard, Stu Holden, and Carlos Bocanegra) friends, family, teachers, mentors, and influences along the way. Also included is behind the scene footage from him and his team at the 2010 World Cup straight from DeMerit's camera.

Directed and written by Nick Lewis (local San Diegan) and Ranko Tutulugdzija, the movie is about much more than soccer. They state on their website, "This is a film with a universal message of hope and self-belief, taking place in the world of soccer but carrying over into all facets of life. We think it is a story that will inspire those who see it"





The process is called an "adoption" because BLM retains title to the animal for one year after the adoption.

pliance officer or designated representative will visit each adopter to ensure the animal is being cared for and has a good home. During this time adopters cannot sell their adopted animal. Adopters must notify BLM if the animal is moved.

After the first year, adopters may apply for title. BLM will pass title of the animal if all the stipulations of the adoption agreement have been met. The animal becomes the private property of the adopter only after BLM transfers title. which completes the adoption

In the emergency room all three wounded victims were being attended amid a room full of secret service and other people. Staff had done initial triage and determined a bullet, which ricocheted off the armored side of the limousine, had hit the President in his left underarm, grazed a rib and was lodged in his lung nearly an inch from his heart.

"They had put in a chest tube to drain the blood from his chest to get his lung inflated," Aaron said. "He responded pretty quickly, and we could see a bullet fragment on the x-ray. They asked me what I wanted to do. So after 20 minutes when his chest would not stop bleeding, which could cause more serious problems, I made the decision to take him to surgery."

The surgery went well, and the bullet, found right behind the heart in the lungs, was removed. It was only later that the FBI discovered the bullet was an explosive bullet called a Devastator. It was intended to explode, however the bullets Hinckley purchased were meant to be used in a standard .22-caliber long rifle. Because he fired them from a .22-caliber pistol, the lack of velocity didn't make the bullets explode. The Secret Service cleared and took

over an entire wing of the hospital. Reagan had his own room but secret service agents were always near. Nancy Reagan had a room right next to his.

"I had explained everything to Nancy and would spend about 25 minutes with her every morning on my rounds," Aaron said. "She was very gracious and always had a lot of questions. She was very perceptive and just wanted to know what was going on."

Aaron said he had no qualms when scrubbing in to work on the President. "If we do our job right I knew everything would be okay," he said. "That's what we're trained for, and I was ready to do my job.'

Aaron retired and left George Washington University in 1996. Unable to get used to not going to work, he took a position doing surgery for a private group in Texas. Then he spent three years traveling to Mexico with a group to do general surgery on patients without medical care. In 1998 the couple bought their hill top home, and Aaron spent a few years flying airplanes. Now officially retired, "I spend my time giving advice to my golf buddies," Aaron said.







Chargers give Kansas City a Halloween treat

here's a log jam atop the AFC West. Three teams are tied for first place; the Chiefs, Raiders, and San Diego Chargers, all owning (4-3) records. This occurred on the heels of a 23-20 Chargers overtime loss to the Kansas City Chiefs at Arrowhead Stadium in Kansas City, viewed by a national television audience on the stage of Monday Night Football.

For the second week in a row, the San Diego Chargers came up short again.

Chargers center Nick Hardwick, as he had done thousands of times, snapped the ball to quarterback Philip Rivers. This time Rivers fumbled the snap giving the ball and game away. The Chargers failed to score and the Chiefs won in O.T. on a 30-yard Ryan Succop field goal with 5:16 left in the game

Shooting himself in the foot is what Chargers' quarterback Philip Rivers did throwing two horrible first quarter interceptions. The Chargers also committed twelve inexcusable penalties.
