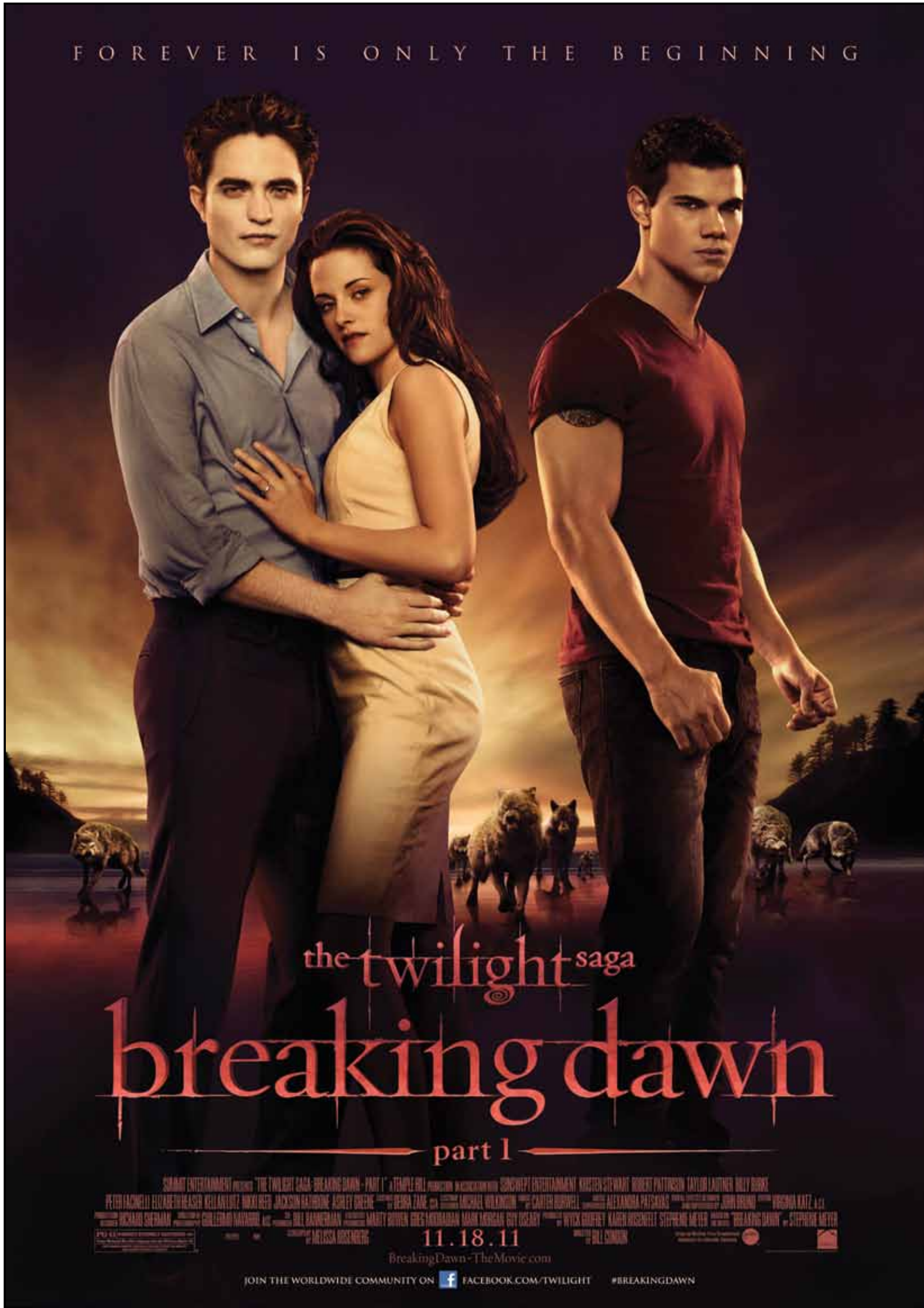

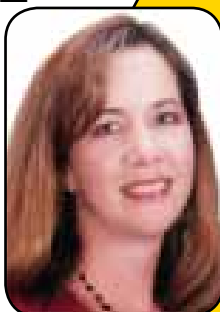

For Health's Sake

Bypass your bypass — recommendations for surviving the holiday heart attack season

Temperatures are dropping and the holidays are around the corner.

Danger — We are now entering what is often referred to as "The Heart Attack Season."

California Department of Public Health warns consumers not to eat Roopal Swad Candy Imported from India

Dr. Ron Chapman, director of the California Department of Public Health (CDPH), today warned consumers not to eat Roopal Swad candy imported from India after tests conducted by CDPH found unacceptable levels of lead. Consumers in possession of the candy should discard it immediately.

Recent analysis of this candy by CDPH determined that Roopal Swad candy contained as much as 0.18 parts per million (ppm) of lead. California considers candies with lead levels in excess of 0.10 ppm to be contaminated.

Roopal Swad candy is imported and distributed by India Imports & Exports, Inc. in Los Angeles, which initiated the voluntary recall. CDPH is currently working with the distributor to ensure that the contaminated candies are removed from the market place. Sold in a 7-ounce (200 gram) clear plastic package, the candy is visible through the package and wrapped in silver foil with a dark brown design. The package label is yellow with the brand name "Roopal" at the top in a red oval. The words "Swad Candy" appear in the middle of the package.

Pregnant women and parents of children who may have eaten this candy should consult their physician or health care provider to determine if medical testing is needed. Information, including photos, is available on the CDPH website at the Roopal Swad Candy Imported From India Due to High Levels of Lead page. Consumers who find this candy for sale should call the CDPH Complaint Hotline at 1-800-495-3232. For more information about lead poisoning, contact your county childhood lead poisoning prevention program or public health department. Additional information is available on the CDPH Childhood Lead Poisoning Prevention page.

As Thanksgiving draws near I have observed a great contrast of complaining versus thankfulness. It's amazing how easy it is to fall into a stupor of complaining and nagging. Or at times to neglect what we have, and take for granted the blessings all around us.

Whenever I hear someone complain, I think back to my trip to Africa and realize somebody else has it worse than we do. Granted, many are experiencing hard times and difficult financial circumstances all around the world. I want to encourage you to remember with Christ we have everything we need. With Jesus, we can have joy, peace and happiness; just as my friends in Malawi, Africa do despite their lack of material possessions. We may have people in our lives who are worse off than we are, and if we take our eyes off of ourselves and reach out to others, we can avoid the trap of ungratefulness. I am thankful that I can know Jesus Christ as my Lord and Savior. He is my Provider and freely gives me joy and peace. I am truly grateful.

Colossians 3:15, "And let the peace of God rule in your hearts, to which also you were called in one body; and be thankful."

Psalms 100:4, "Enter into His gates with thanksgiving, and into His courts with praise. Be thankful to Him, and bless His name."

Life is valuable; cherish everyday because it's a gift. Why do I give this advice, I have survived cancer by a miracle of God's grace. I realize everyday when I wake up, is a special day. I love you in Jesus.

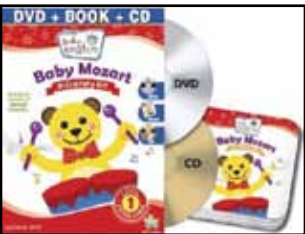

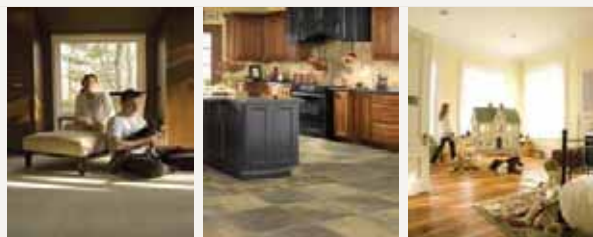

Great cast in 'Tower Heist' stages a clever crime caper

Hitting on topics such as Occupy Wall Street and Madoff type schemes that face investors today, *Tower Heist* couldn't have opened at a better time. So appropriate for today's headlines, it's almost as if Brett Ratner and Universal Pictures looked into a crystal ball years ago when the film was given a go.

The Tower, a luxurious Central Park condominium, is a central character in this comedy with a terrific cast that focuses on one end or the other of a swindle and its aftermath. Josh Kovacs (Ben Stiller), who's arrested by FBI agent Claire Denham (Téa Leoni), has been manager of The

Tower for so long he knows every idiosyncrasy of each tenant. He runs the high rise with the precision of a well-oiled clock, paying special attention to billionaire Arthur Shaw (Alan Alda) who occupies the top floor penthouse.

It's only takes Denham's arrest of Shaw for swindling his clients to raise Josh's blood pressure. Hoping to help the employees of The Tower, Josh secretly invested their pension funds in one of Shaw's ventures. As each one learns about their fate, Josh realizes he's doomed their lives.

When he hears news that Shaw might have hidden a large sum of cash in his penthouse, Josh gets an idea. He rounds up some of the em-

ployees including a Jamaican maid (Gabourey Sidibe), the new concierge and father to be (Casey Affleck), the elevator operator (Michael Peña) as well as a tenant about to be evicted (Matthew Broderick) and forms a plan. Bringing in a street delinquent (Eddie Murphy) the plan is set to unfold while the Thanksgiving Day parade takes

place right down near the base of The Tower.

Murphy and Stiller enhance the ensemble cast by not playing their characters over the top. Affleck carries his role well, and Sidibe adds some surprising elements to her character. Alda pulls off the shyster Shaw as if he was

born to play the part. The appealing story, as told by Ted Griffin and Jeff Nathanson's screenplay, appears to be one often seen when catching the trailer or even at the beginning of the film. Yet filled with twists and turns at every corner and including lots of humor, *Tower Heist* is thoroughly entertaining.

'J. Edgar' — disappointing and unentertaining

A prominent director (Clint Eastwood), a fascinating biopic (J. Edgar Hoover) and an Oscar-nominated actor (Leonardo DiCaprio) set high expectations for the recently released *J. Edgar*. I was excited to see this film, but for me it didn't measure up.

Taking a look through far too many flashbacks at Hoover's life before, during and after he served as the FBI director under eight presidents, there was more that I didn't care about in the film than what I did.

Dustin Lance Black's screenplay hits all the key points of Hoover's life — his highly guarded private life, in-depth looks at those who supported him and those who tried to bring him down, his focus to stop gangsters, his distaste for Martin Luther King, his scorn for the Bolshevik invasions in 1919 and more. However, for me that was an overload of info and there were too many problems with the execution of the film.

Eastwood likes to work with his team and production design by J. Murakami (*Changeling*, *Hereafter*, *Gran Torino*, *Invictus*) mostly makes every scene whether in early or later years of Hoover's life feel authentic. Tom Stern's cinematography for the most part was okay. What bothered me throughout the film was repeated full face or body shots of Leo as J. Edgar. They eventually took me out of the story, and I wondered if we were supposed to count the hairs on Leo's head or admire the make-up job or why this became such a big focus. It was one of Eastwood's problems with this film as well as using too many stock footage of scenes involving the Lindbergh baby kidnapping, chasing gangsters, etc.

DiCaprio does a fair job as Hoover. His thick-skinned scowl in dark times is always in confrontation with his blank

expressions when trying to figure out what's he supposed to be doing or what he wants to hide from the public. Naomi Watts as Hoover's lifelong secretary Helen Gandy — who at one time Hoover proposes to — was hampered by a script that reveals her as puppet without emotion. Why did she remain his confidant to the point of breaking the law?

Judi Dench is superb as Mrs. Hoover, a mother who relishes her son as a mommy's boy and who dictates a lot of his behavior throughout his life. Her comment "I'd rather have a dead son than a daffodil for a son," leaves little guessing about both of their situations. Armie Hammer supported

his role as Clyde Tolson with conviction against the odds. The story of whether or not he and Hoover were sexual partners went on for too long and the make-up on the elder Tolson was so bad it interfered with the story.

Mostly missing in *J. Edgar* is a clear cut appraisal of who this movie is for and what it's really about. It's almost as if Eastwood threw a little of Hoover's personal conflicts, questionable antics as FBI director, desires to make a difference in crime and traumatized submission to his mother into a big bowl. What's left is a big batch of an unidentifiable story with little entertainment.

Water Authority corrects mistakes in San Vicente pipeline report

A story that ran in *The San Diego Union-Tribune* on Sunday, Oct. 30 and was subsequently covered by several broadcast media, "Tunnel Costs Rose by \$298 Million Over Time," contained errors that misrepresent the cost of one of the Water Authority's most important water supply reliability projects, the San Vicente Pipeline.

The article mistakenly reports that the total project cost for the San Vicente Pipeline was \$459 million. In fact, the total project cost was \$342 million. The article makes the fundamental error of comparing a preliminary construction cost estimate for one project (leaving out its other non-construction costs that comprise its total budget) with the combined total budget of two separate projects (the \$342 million pipeline project and the \$117 million San Vicente Pump Station Project). This detailed information was provided to the *Union-Tribune* well before publication. The San Vicente Pump Station is a completely separate project – budgeted separately, bid separately, built separately and approved separately and apart from the San Vicente Pipeline project.

In addition, the article implies that the Water Authority Board of Directors was not clearly informed of the San

Vicente Pipeline's total costs when it approved the construction contract in 2005. That assertion is false. The Water Authority has a thorough budget review and project review process. The budget review process includes input from the board to management prior to the formulation of the General Manager's recommended budget; development by management and distribution of the General Manager's recommended budget document to the board; two days of budget workshops in which the recommended budget is reviewed and the board members ask questions and provide feedback; and final board adoption. These projects have been approved by the Board of Directors in successive Water Authority budgets dating back to 1999.

Also, the Board is kept informed about the status of capital projects through presentations at its Engineering and Operations Committee, special board and committee workshops, project site tours and, when appropriate, discussions in closed sessions.

The article questioned the cost of planning, design and construction management for the San Vicente Pipeline, but a published industry report shows those costs on this project are in line with water

industry standards. The Water Authority provided the *Union-Tribune* with a 2005 Association for the Advancement of Cost Engineering International Project Cost Analysis paper: www.sdcwa.org/sites/default/files/files/2005-aace-international-project-cost-analysis.pdf showing that actual construction costs for water and wastewater projects such as this typically fall within a range of 63 percent to 82 percent (see Table 3 in the report). The Water Authority's major capital projects typically have 65 percent to 80 percent hard construction costs.

The newspaper's story also mistakenly reported that Traylor Shea is seeking "up to \$140 million" in its lawsuit with the Water Authority. In fact, the company is seeking up to \$35 million. The complaint alleges four different legal reasons, or "causes of action," for recovery of the alleged damages of \$35 million, but it is the same \$35 million being sought each time.

Finally, the article reports on a dispute between the Water Authority's pipeline project contractor and one of its subcontractors, and the subcontractor's claims that legal conflicts between the Water Authority and Traylor Shea led to the loss of his business. This allegation is untrue. In this case, the Water Authority

contracted with Traylor Shea. Traylor Shea subcontracted work to the subcontractor. The subcontractor's work was determined to be defective. Traylor Shea – as was its right under the contract – chose to correct the deficient work itself. The Water Authority has already paid all sums attributable to the work that was to be performed under the subcontract and has no legal basis for making any payments to the subcontractor. Any such payments would constitute a gift of ratepayer money that would violate the California Constitution.

The article contained these mistakes despite the Water Authority repeatedly providing much of the information listed here to the newspaper well in advance of the article's publication. The Water Authority is seeking a correction of the record.

All activities funded through the City's CDBG program must be for activities that will improve the living conditions/environment for low and moderate income individuals and families in El Cajon. In addition, all CDBG projects must meet one or more of the local Priorities to qualify for funding. The Priorities are fully described in the FY 2009-2014 Consolidated Plan which is available for review at the Redevelopment and Housing Division public counter, located at 200 Civic Center Way, Third Floor, El Cajon, CA 92020 during normal business hours. Keeping pets safe during the holidays — veterinarian reveals problems

As the pages of the calendar flip and we move closer to the holiday season, pet owners should be aware of common — but hidden — dangers to their pets as we transform our homes for the celebrations to come.

“The holidays are supposed to be a time of joy for our families, but in preparing for the season, many pet owners run the risk of exposing their pets to household dangers that could present potential life-threatening hazards to their pets,” said veterinarian Lori Pasternak, of Helping Hands Affordable Veterinary Surgery and Dental Care (www.helpinghandsvetva.com). “These latent hazards could derail a family’s holiday season if their pets become ill as a result of these hidden perils.”

Pasternak’s list of prospective risks include:

Decorations — While holiday decorations can make a home feel more festive, they can be tantalizing traps for pets. Pet owners should keep decorations and ornaments higher up on trees so they are not consumed by pets. If a pet decides the colorful garland or tree trim might make a tasty snack, they can and will get stuck in your pet’s intestines, necessitating immediate surgical removal. Moreover, exposed cords from electric lights can cause electrocution or oral burns if chewed.

Gift Wrap — When it’s time to pull all the gifts out of hiding to be wrapped, take care that your pet isn’t in the room as you spread out all the wrapping paper, bows and ribbons.

If a cat should start gnawing on the ribbon, it will literally “stitch” the cat’s intestines together as it is being passed through the gut. Surgery is one holiday gift you don’t want to give your family pet.

Holiday Feast — While turkey and ham make up the majority of traditional holiday meals, turkey and ham bones can become lodged in the intestines if swallowed in large pieces. Be careful that your guests don’t give in to the holiday spirit too much and choose this time to offer table scraps to your pets. Your pet could become seriously ill or even choke to death.

Flowers — The poinsettias many choose to use as holiday centerpieces are also toxic to most household pets if they are

chewed and swallowed in large enough quantities. The level of toxicity is completely proportionate to the size and weight of your pet, but instead of doing the math on that equation, it’s better to choose other types of floral arrangements that don’t endanger your pets.

“The holidays should be a time for fun, not an unscheduled trip to the animal hospital,” Pasternak added. “If something does happen, don’t hesitate to take your pet to the nearest animal hospital, and know that if you come to ours, we work with our pet owners on affordable payment structures in emergency cases. But we’d rather not see you this season. The best holiday gift you could give your pet is

a hazard-free household so they can enjoy the warmth and joy of your celebrations safely and soundly.”
