After breakfast, everyone enjoyed a special SeaWorld show before heading to Target in a procession of law enforcement vehicles with full lights and sirens flashing and wailing. 

## **Police Chief retires**

¬riday, Dec. 9, will be the last official working day for El Cajon Police Chief Pat Sprecco. Literally working his way up the ranks, he has been with the City of El Cajon for 39 years as both a volunteer and an employee.

He joined the department as a cadet in 1972; in 1974, he was hired part time to maintain and wash police vehicles: and he served as an intern in communications, records, and investigations. He was hired as a Police Officer in 1976 after completing his associate degree in criminal justice admin-

istration at Grossmont College. While a student at the college, he worked as a campus security officer. Sprecco's hard work and dedication earned him the rank of Sergeant in 1982, Lieutenant in 1993, Captain in 2006, and ultimately Chief of Police in March of 2008.

Pat Sprecco has been an integral part of the design, construction, and relocation for the new state-of-the-art Police Station. He guided this department with compassion, humor, and ingenuity, and has been a true advocate for community involvement in the fight against crime.

Sprecco implemented programs for Council recognition of property managers certified for Crime Free Multi-Housing, and for residents enrolled in Neighborhood Watch. He was crucial in the development of the Cold Homicide Program, the current SWAT Team, the Special Enforcement Division and many others.

He is a recipient of the Medal of Valor, two Police Medals, and a Meritorious Unit Cita-

Sprecco has generously shared his insight and knowledge with organizations such as Communities Against Substance Abuse, San Diego County Chiefs and Sheriffs Association, ARJIS Management Committee, Toastmasters, East County Regional Gang Task Force, and Grossmont College Foundation.

Sprecco and his wife Alma have been married for 33 years and have three grown children and five grand-children. Both come from families with a long history in law enforcement. Sprecco's contributions to the City, his forward-thinking, and his can-do attitude have earned him the respect of the Department, his colleagues and the community. We are fortunate to have been under the protection of a man of his caliber and dedication. We wish him a long, happy, and healthy retirement!



# Effort to form a Countywide Arts Council underway led by Art Pulse

s San Diego County has grown over the past decade, so has its arts community, and there is now an effort under way to provide support. Leading the drive is April Game, Executive Director of Art Pulse. Art Pulse is a four year old arts services organization with a mission to support the health of the arts countywide. A series of public forums co-presented by directors from county arts councils around the state are taking place weekly to illuminate what county arts councils are, what they do, and to identify the services that San Diego County needs most.

Art Pulse is committed to

making sure the forums reach each area of the county and that everyone has an opportunity to attend, ask questions and be heard. "The only way we will know what our cities need and want is to go there and ask them. We are not stopping at arts leaders, but including our mayors and civic leaders, and opening the conversation to the community as a whole," says Game. "What are your questions? Your hopes? What are your fears? Let's talk about them. We are in this together, let's build this together.

Ed Fosmire agrees. Fosmire is the Executive Director of the Oceanside Museum of Art and former Director of Grants and Professional Development for the Arts Council for Long Beach.

"Whether a community or municipality has a viable arts council says a lot about that community. It speaks volumes about a collective interest in promoting a major economic engine, the creative sector, as well as the relevance of the arts in contributing to the quality of life." Fosmire co-presented the Solana Beach forum held on December 1st and is a supporter of the initiative.

According to Game, there is some confusion about what

arts councils do, how they are formed, how they are funded, and how they support their regions. That is the key reason she will be co-presenting the forums with arts council leaders from around the state. Arts leaders like Kristina Young, Executive Director of the Arts Council of Napa Valley.

"Arts councils provide much needed leadership, collective messaging, programming, and marketing for the artists and arts organizations in their counties," says Young. "With a mandate to support and foster all local arts, arts councils are in the unique position to do important work that no other local organizations can for their communities."

"Local Arts Agencies are the bedrock of creative communities," says Michelle Williams, Executive Director of the Cultural Council of Santa Cruz County. "They provide the critical infrastructure upon which the arts can thrive."

"An arts council can also help to develop a community's understanding of the vital role that the arts play in terms of public value and economics," says Patrick Brien, Executive Director of the Riverside Arts Council. This is crucial to building an argument for arts support in a time when some people still consider arts and culture a frill.

"Arts councils are the glue that binds the arts community together in collaborative efforts that are mutually beneficial," says Richard Stein, Executive Director of Arts Orange County. "In this rapidly changing economic and media environment, arts councils also play an increasingly vital role in getting the message out to the entire community about the wealth of arts engagement opportunities available to people of all ages and means."

According to the California Arts Council, San Diego County is one of only seven counties in the state that do not have an arts council. The others are either in sparsely populated areas in the primarilv agricultural Central Vallev. San Bernardino County, and the extremely poor Imperial County on the Arizona/Mexico border. "San Diego County is the second most populous county in the State and one of the most popular places for vacationers and business travelers in the world. We require and deserve the cultural infrastructure other counties already enjoy.'

Game is confident. "The health of our people and our region through the arts, and the health of the arts themselves, depends on the success of an independent, nonprofit organization dedicated to this mission and fiercely committed to going the distance. An arts council is a safety net and a vehicle for stability and cultural advancement that nearly all counties in the state already enjoy. The time is coming for San Diego County to join its peers and to thrive accordingly."

Young and Williams will be co-presenting the December 8th community forum co-hosted by the City of El Cajon (El Cajon Public Library, 201 E Douglas Ave. 6-8 p.m.). Stein and Brien will be co-presenting the December 15 forum in Escondido (California Center for the Arts, 340 N. Escondido Blvd, 6-8 p.m.). # Whatever happened to cute?


# **Dear Worried About Christmas**,



# Toy Safety: Purchasing safe toys for the correct age

There are thousands of toys on store shelves to choose from, but making sure a toy is safe and age appropriate for a child is well worth the search to prevent injury or even death.

sumer Product Safety Commission, in 2010, there were an estimated 140,700 emergency room treated injuries related to toys among children. Strict safety standards are regulated through the CPSC requiring toy manufacturers to label certain

to young children, and provide a recommended age of child to be using the toy. But it is up to the purchaser to ensure the toy is safe and the correct age level for the child.

There are some guidelines that shoppers should follow to keep children safe during their playtime. Remember though; use your own judgment as you know the child's maturity level and can best decide if the toy is suitable or not.

### Top toys to take into consideration

- Non-motorized scooters and riding toys - Riding toys, skateboards, and even shoes with wheels go fast and falls could easily cause injury at any age. Helmets and safety gear, including elbow and knee pads, should be worn properly at all times and be sized to fit the child.
- Small balls, coins and toys with small parts - Government regulations specify that toys for children under the age of three cannot have parts less than 1 1/4 inches in diameter and 2 1/4 inches long as these small objects can pose a choking risk. Any ball with a diameter of 1 1/4 inches or less should not be given to a young child.
- Balloons Deflated or broken balloons are another choking risk. Deflated balloons should be kept away from children younger than eight years old and broken balloons and the balloon string should be immediately discarded.

- Art materials Crayons, paint and other art items under the age of three. Make the packaging.
- the home when charging.
- Play swords, guns and **other weapons** – These toys should be given only to mature, grade school age children. They should be bright colors so they are easily differentiated from real weapons and should not be sharp or come to a point.
- are meant to be airborne can result in serious eve or head injury if not used properly. It is recommended that children under eight not play with projectile toys.

Consumers in possession of these candies should discard immediately. Recent analysis of these candies by CDPH determined that Bee Sunny Day Gummies candy contained as much as 0.18 parts per million (ppm) of lead and BAVAN Mix Goli candy contained as much as 0.22 ppm of lead. California considers candies with lead levels in excess of 0.10 ppm to be contaminated.

Bee Sunny Day Gummies candy is sold in a 3.53 ounce (100 gram) package. The package is orange and yellow with orange writing stating 'Sunny Day Gummies' on the front with pictures of various insects and flowers. The package contains 10 pieces of "gummie" candy each wrapped in plastic with the wording 'Sunny Day Gummies'.

Bavan Mix Goli candy is sold in a 14 ounce (400 gram) clear plastic package with an orange and white label. The candy is visible through the package. The candies are crescent-shaped and come in various colors (red, blue, green, yellow, orange, and white). The brand name BAVAN is at the top of the label and "Candy (Mix goli)" is in the middle of the label.

The distributors of these candies are working with CDPH to ensure the contaminated candies are removed from the marketplace. Consumers who find any of these candies for sale are encouraged to call the CDPH Complaint Hotline at 1-800-495-3232.

Pregnant women and parents of children who may have consumed this candy should consult their physician or health care provider to determine if medical testing is needed.

broken or defective, becoming dangerous. Also, without original packaging, age guidelines and warning are not available. Examine each tov carefully looking for cracks, paint chippings or even leaking battery fluid.

• Be aware of what toys are made of as some products have dangerous substances

that can be harmful when

• For toys that produce sound, look for toys that have a volume level to protect children's hearing. A noise rating may also be listed on the product. If there is not a rating listed, you can contact the toy manufacturer and request this information. An extremely loud toy for children is 90 decibel.

Remind children to properly put away their toys because if they are left out, they can become a tripping hazard for everyone. Proper supervision of children at play will also result in a safer playtime.

Consumers can find upto-date toy recalls and report dangerous toys and injuries caused by a toy on the CSPC website, www.cpsc.gov/.
