tape reduction task force to examine the land development permitting process and identify opportunities for operational improvements that would result in more efficient permit processing. Behind the scenes at LMS

Saturday School can be fun and educational, at least that's what a group of adults thought last Saturday when Lakeside Middle School Principal, Steve Mull, took them on a behind the scenes tour of the new and old multi million dollar remodeling of the school.

What started out as a small group of Historical Society members grew into an interested crowd of 45 Lakeside citizens, school board members and even Dr Brian Bristol, the School District's new Superintendent. Everyone was excited about seeing the extensive remodeling project, a dream come true for the Principal and Building Committee who worked on the plans.

The front of the school has had a dramatic change although it is hard to see from the street at this point due to construction equipment and screening

The former bus circle has been moved to the right of the school so buses, parent's cars and walking students no longer create a dangerous mix competing for a quick exit.

In it's place there is a large quad area for multi uses such as rallies, ASB gatherings and band performances.

To the left of the school the auditorium is in the same location but the former kitchen and teachers lounge have been magicly transformed into an elegant glass lobby entrance for theater goers and it can also be used as a meeting room and other multi uses.

The school will be geared toward theater arts ... a passion of Mr. Mulls. He calls it "The Jewel of Lakeside." The inside of the auditorium has taken on an electonic transformation with rows and rows of lights, microphones, and sound system which was donated by the Lakeside Stadium Association. The stage has been lowered and enlarged to hold over 100 youthful actors. There is a grid to hold scenery backdrops and also new curtains.

Gone are the stacking chairs and in their place rows of stadium seating for 380 people, the seating actually folds back to the walls to make way for a large dance floor.

It seems that everything has been carefully planned out so it has multi uses.

Behind the stage in what used to be the Principals offices, there is the "green room"

where actors ready themselves for the stage. There is a wall of art to honor Dr Steven Halfacre, the former school Superintendent, who worked so hard to keep art alive in Lakeside schools.

Since Performing Arts is the focus of this school the dance classes are geared toward theater productions. They have top notch bands and orchestras. Even the wood shop builds sets for the stage. Shop Teacher, Cliff Mull, had to get a special credential to teach this class. He said that woodshop isn't going away but it is changing with computer tecnology.

Most of the actual classrooms are older, some from the 1950s and even back to the 1930s, but they have been modernized with the latest learning tools and every one has rows of computers and a "Smart Board" which is a modern electronic version of a blackboard and all the rooms are interconnected by this technology. No other school district in the country has this, Mr Mull said "It is unbelievable what the kids are learning." Teacher, Mr Best, has one of the oldest classrooms and he has taught in there for over 20 years but he was a leader in pushing for the newest tecnology for the

Motorcycle riders around the world honor young boy's wish

t started as a request when 13-year-old Josiah Trujillo met P.J. Byrne during a poker run to Rady Children's Hospital. Trujillo, a big fan of Harley Davidson motorcycles, suffers from Spina Bifida. He asked Byrne if he could get 3000 bikers to ride by his house. Not wanting Trujillo to be disappointed, he told the youth he lived in Carlsbad, not Sturgis, and asked if 100

would be okay, which Trujillo said it would.

With motor-roaring engines, helmets and jackets bearing emblems from clubs all over Southern California, and other states it was the hearts full of compassion that brought more than 4000 bikers out last Sunday for the "Ride For Josiah" to ride by Trujillo's house. Encased on the front porch, his big smile and silent wave was a silent thank you

to the roar of thousands of bikes. Many went up to greet Trujillo in person and riders were invited to park their bikes in an adjacent field and be treated to a lunch by the Trujillo family and sponsors.

Bikers around the world held the same compassion to make a young boy's wish come true. Bikers from London and 22,000 miles away in Australia also rode for the cause. Crystal Radcliffe fired up her Harley 1200 Sportster Custom early in the morning to join friend Vic Cook in the ride. The San Diego Ride also included a ride by Rady Children's Hospital where children waved excitedly from the windows as the bikers paced by.





Youth Of The Year Award nominations now being accepted

The City of El Cajon Teen Coalition would like to recognize youth for making a difference in our community. If you see, hear, or know of a youth who has gone the extra mile to improve the quality of life in our community, take this opportunity to acknowledge and reward that effort. "The Success of Tomorrow...Depends on the Youth of Today!" How Does This Work? The City of El Cajon Teen Coalition presents a "Youth of the Year" Award to recognize those youth who go above and beyond in serving their community either through their leadership abilities and/or their quality or level of community service in El Cajon. Leadership can be defined as those individuals who consistently facilitate a team vision and help guide others towards success. Community service is work that helps better the community through the value and impact of those served.

Final awards will be based on dedication, commitment beyond what may be required by school, and demonstrated impact of those served. Who is Eligible? Two youth will be awarded each year: one youth currently at the middle school level (grades 6th – 8th) and one youth currently at the high school level (grades 9th - 12th). For Health's Sake

Know your medications

is here, the American Pharmacists Association encourages consumers to talk with their pharmacist about their medications before they pack their bags. This will help ensure each person knows the best way to pack their medications, what to do if the medication is lost and anything to be aware of with travel and the medication.

Travel disrupts healthcare routines and the normal things consumers do to take care of themselves – such as adhering to a medication regimen – can sometimes fall from the top list of priorities.

Here are some tips to help travelers maintain a healthy medication regime throughout the travel season:

Organize a health kit that contains all of your prescription and over-thecounter medications, herbal supplements, vitamins and minerals. Ensure that medications are packed correctly and pack ample medication and equipment. Some medications have special storage instructions or require specific dosing equipment. Always carry your medications in the original bottles in the carry-on luggage if flying or crossing borders

Family Medicine

Bring more medications than expected to use. Talk to your pharmacist about the possibility of obtaining a medication "vacation supply" from your insurance company, he/ she may be able to help. Being prepared for unexpected extended travel helps ensure safe and effective medication use. It is also good to know your insurance company's policy on medication transfers and replacement supplies if your medication is lost.

Pack a "Preventative Medicine" Kit. Talk with the pharmacist about any overthe-counter medications that should be packed for the area of the world being traveled to. Basics include: anti-diarrhea, anti-nausea, antihistamine, anti-motion sickness, mild laxative or stool softener, medicine for pain or fever and antibacterial/antifungal cream/ointment.

Get up-to-date on anv vaccines that may be needed. Make sure to get your annual flu shot. If traveling overseas, make sure all of the travel vaccine recommendations put out by the CDC are met.

Beware of "Drugged Driving." Certain medications can impair perception, judgment and reaction times causing a hazardous driving situation. Talk with your pharmacist

about side effects your medication may cause and whether you can adjust your dosing schedule to avoid times you may need to operate a vehicle.

Carry an undated personal medication and vaccination record. This is a list of prescriptions, over-the-counter and herbal medications, how to take them, and why. This list should also contain an up-to-date history of vaccinations. If unexpectedly admitted into a hospital, or must see a healthcare provider while traveling, the list can help them understand your current treatments. To download a personal medication list www.pharmacist.com/pmr.

Have a plan for adjusting medication regimen. Travel may require you to adjust your medication regimen, or when you take your medication, for time and routine changes. If you are traveling across the country and would normally take a medication twice a day, for example, you may need to adjust that schedule to take your medications approximately twelve hours apart—which may be earlier or later than your first bedtime or morning on another coast. Ask your pharmacist about how to alter your schedule to fit your health-care needs.

Be careful or avoid drinking alcohol, especially when flying or visiting cities in higher altitudes. Alcohol can interact with many prescription and over-the-counter medicines.

Ask your pharmacist if there are any foods or beverages that conflict with current medicines. Travelers are more inclined to eat unfamiliar foods when traveling to new cities or foreign countries.

Practice good hygiene, get rest and eat well. Frequent hand-washing/cleansing, use of alcohol-based hand sanitizer and coughing /sneezing into your sleeve or a tissue will protect you and others. In addition, try not to overdo it and not get run down, eat right and drink plenty of water (and depending upon the location, bottled water may be needed) are good practices that can reduce the risk of getting sick.

Grossmont Healthcare District presents scholarships to nursing students


he Grossmont Healthcare District (GHD, a public The Grossmont reallitude District (C.1.2), and agency that supports various health-related community has nity programs and services in San Diego's East County, has presented \$6,000 in scholarships to three nursing students based on their community involvement and future plans in the nursing profession. They include Karen Adams of El Cajon, Melissa Foster of La Mesa and Linda Matheny of El Cajon. Adams received \$3,000, while Foster and Matheny each received \$1,500. All three are nursing students at Grossmont College.

"We were impressed with each recipient's career goals, as well as their volunteer experiences," said GHD board member Michael Emerson, who served as chair of the Community Grants and Sponsorships Committee, which reviewed the scholarship applications.

Adams, who hopes to work in a hospital, clinic or school, has traveled to Fiji and Nicaragua on relief assistance trips. Foster, who wants to focus on preventing childhood obesity, taught exercise at Murray Manor Elementary School in La Mesa. Matheny, who inspires to help provide healthcare to those without health insurance, has administered flu shots to college students and supported fund-raising walks for epilepsy research.

The GHD scholarships are named the Richard Bea RN Memorial Nursing Scholarships in memory of former GHD board member Richard Bea, a registered nurse who worked at Grossmont Hospital for 18 years. Bea served on the GHD board from 1996, including as board president, until his death in 1999.

The scholarships are intended to encourage the development of nurses new to the profession. Applicants are required to have completed one year in a registered nursing program approved by the National League for Nursing Accrediting Commission and provide evidence of current enrollment and community volunteer work, along with a letter of recommendation and a 500-word essay on "The Future of Nursing in My Community." They also must reside within the GHD boundaries for a minimum of one year, or have graduated from a high school located within the District.

The official SNV Website, maintained by AGNT conveners, offers free to all participants, customized programs, full resource libraries, artwork, instructions, curricula and extensive practical toolkit.

The Season for Nonviolence has been launched at the United Nations each year from 1998 through 2012. These events have brought forth substantive endorsements and commitments from the former UN Secretary General, Kofi Annan, the U.S. Ambassador to India, Vice President Al Gore, and the Director General of UNESCO on behalf of its Culture of Peace and nonviolence appeal by the Nobel Peace Laureates. The theme for this year's studentbased program is "Global Peace Through Social Media: There's an APP for That!" Speakers will include students from Susan B. Wagner High School, and media guru, Nipun Mehta, a young west coast innovator who has redefined social technologies for volunteerism and compassionate service.

Again, this year, the City of El Cajon's Mayor, Mark Lewis, issued a proclamation proclaiming the city's support for 'A Season for Nonviolence' urging all residents to participate in local, national and global campaigns to honor those who are using nonviolence to build communities that respect the dignity and work of every human being.

Dear Girl Just Wants to Have Fun,





Action packed aerial bantering and culture in 'Red Tails'

It's been more than 20 years since HBO made the movie The Tuskegee Airmen detailing the all-black World War II aerial squadron who surprised their comrades with their flying skills. For almost that long, George Lucas has wanted to make the first of a three-part story about the Tuskegee Airmen, but studios balked about the story's allblack cast. So Lucas threw in his own money to make Red Tails, the first of that series, and if it's profitable, Lucas will proceed on.

Most of the backlash about the movie is more about the simple plot and poor dialogue, and not the actual acting. The 332nd Fighter Group is stationed in Italy and assigned to fly their P-51 Mustangs painted with distinct red tails in support of other American forces. Major Emmanuel Stance (Cuba Gooding Jr.) and Colonel A. J. Bullard (Terrence Howard) share command of this outfit. Stance is to make sure his guys stand up to their assignments while Bullard spends time at the Pentagon fighting for his flyers to have the same rights as their while equivalents.

Screenwriters John Ridley and Aaron McGruder have a high bar with creating strong personalities of actors that other than Gooding Jr. and Howard, which many moviegoers are not familiar with. Squadron leader Marty "Easy" Julian (Nate Parker) has problems squaring his shoulders to lead, and that along with his own flying missions soon cause him to take a flask of alcohol with him and often rely on it too much.

Joe Little (David Oyelowo) is a hot shot on ground and off. He's always the one when Marty says to head home, that takes off on his own for one last blaze of bullets. He's ahead of the curve in town, too. While the black soldiers are not even welcome in the club with other soldiers. Joe lands Sofia (Daniela Ruah), a very beautiful young lady who surprisingly falls for Joe even

other's language. I found this plotline a little hard to believe.

Samuel "Joker" George (Elijah Kelley) is a real kick, both on the ground and in the air. Meanwhile there's David "Deke" Watkins (Marcus T. Stripped of all electronic devices, given a blanket and a bunk, the real work began.

Even though Lucas went all out with interviewing real Tuskegee Airmen, hands-on training for the men in actual P-51s and hiring Industrial Light & Magic and other companies to handle special

Director Shawn Levy on 'Real Steel'

irector/Producer Shawn Levy is a well-known name among moviegoers giving audiences some of the most successful films which to date have grossed more than 1.7 billion dollars worldwide. Those include Date Night, two Night At the Museum films, The Pink Panther, Cheaper By The Dozen, Big Fat Liar and more. Levy was the director of Real Steel, the heartfelt story about an absentee father (Hugh Jackman) trying to reconnect with his 11-year-old son (Dakota Goyo) through the sport of robot boxing. The film has done nearly \$300 million at the box office world wide. Levy was

about the release of the Real Steel movie and Blu-Ray & DVD Combo released January 24, 2012.

Q. How hard was it to get Hugh Jackman to be lead in Real Steel?

SL: He's a great actor and very accessible, and I found him really interesting. He did want to make sure the movie was about more than robots before he signed on. He's genuinely a really nice guy and easy to work with. He makes the entire cast feel at ease.

Q. Why was the topic of MMA fighting appealing to

SL: Because it's a film with

a cinematic scale that exceeds anything I've previously done. You have to leave it to the audience to master the technical complexities of the film. There's a lot to the thoroughness and beauty of aesthetics. And whether the viewing is a second or third in ones own home, repeated watching will reveal different aspects. There is so much going on you have to allow your eyes to wonder.

> **Q.** Why do you think audiences embrace it so much?

SL: I didn't know who fans were most impassioned about in the film but we got positive feedback from parents and families. Especially fathers and that's in the movie. I also was told that fathers cried in the final fight. Even robot boxing fans found it warm hearted.

Q. I was surprised to learn the story was adapted from a 1963 'Twilight Zone' episode.

SL: Yes, the premise of that show was a robot hero's

Q. The production of the film is amazing and I undertstood you actually wanted the camera crews to feel they were in the ring?

SL: Yes, so we had to precapture the fights with real human fighters in a mo-cap stage. And my visual effects and production crew - some who iar with this technology. And as far as the future, it didn't seem there was too much to make it seem like 2020. I didn't want the future to feel futuristic or the movie to feel distant from us. I wanted it to feel accessible and the emotions to resonant.

Q. How much extra control did you have over the Blu-Ray release – there doesn't seem to be anything missing.

SL: While working on the film we shot some of the extra scenes we'd need. I really wanted to give viewers the presence of sound and image as broad and as profound as we could. The extras really go in-depth behind the scenes and visit every aspect of the production. The details and vivid tech design are some of the best I've seen.

Q. How lucky were you to find such a good actor in Dakota Koto?

SL: He was a real find. Very sweet. He just did a visit to Japan for the toy premier, and it was quite a trip, but he handled it fine. He's a well-raised kid.

Levy graduated at the age of 20 from the Drama Department of Yale University. He later studied film in the Masters Film Production Program at USC where he produced and directed the short film Broken Record. This film won the Gold Plague at the Chicago Film Festival, in addition to being selected to screen at the Director's Guild of America.

He currently has 19 films in production and serves as executive producer of the new hit ABC comedy Last Man Standing, starring Tim Allen.



orth of the Border is a new restaurant at Viejas Casino on the upper level. Open three weeks, North of the Border is drawing raves from customers for its food and décor. The stylish and intimate space offers much for the eye to see from walls with wonderful graphics, wall covering in what looks like snake skin and colorful titles covering a pole that announces tacos. The lightening is soft and focused and even the multi-colored floor boards are vibrant and add atmosphere to the room.

Casino Shift Manager Lou DiBella said the restaurant is doing well. "We're very proud that all the design and work was done in-house," he said. "We're getting lots of good feedback about it."

The menu is simple, but the food far exceeds that of a typical taco shop, yet at very reasonable prices. Six different tacos are offered, none over \$5.25. One diner told me she really enjoyed her fish taco and found it very fresh. Burritos come in 11 choices and the A LA Carte menu features tostadas, quesadillas and side options. A help-your-self condiment bar at the front lets eaters finish off their own plates.

Combination Plates come with rice and beans and offer several choices of items including carne asada fries. I was surprised by the Carne Asada plate I ordered that came with rice and beans and several side condiments. The Carne Asada was the best tasting and most tender I have ever had. There was plenty of food for only \$7.50. The menu items are excellently seasoned and inspired by a blend of flavors and spices from North of the Border. Viejas Sou Chef Roger Hernandez is partially responsible for the fine tasting



Tim Babbitt, the Food and Beverage Manager of North of the Border, is partly responsible for the restaurant's success. He's a moving machine, constantly checking on diners to make sure their food is right and enjoyable; keeping the room looking top shape and at times helping the staff so that all customers get first rate food and service.

"I'm really enjoying this restaurant," he said. "It's fun, we have great food, a great staff and it's a terrific spot for our guests to set and relax and enjoy the ambiance of the Casino."

North of the Border is open Sunday – Thursday, 10 a.m. – 10 p.m., Friday and Saturday, 10 a.m. – 2 a.m. Patrons are reminded everyone must be 18 years of age or older to dine in the casino.
