

"The Success of Tomorrow...Depends on the Youth of Today!" How Does This Work? The City of El Cajon Teen Coalition presents a "Youth of the Year" Award to recognize those youth who go above and beyond in serving their community either through their leadership abilities and/or their quality or level of community service in El Cajon. Leadership can be defined as those individuals who consistently facilitate a team vision and help

guide others towards success. Community service is work that helps better the community through the value and impact of those served. Final awards will be based on dedication. commitment beyond what may be required by school, and demonstrated impact of those served. Who is eligible? Two youth will be awarded each year: one youth currently at the middle school level (grades 6th - 8th) and one youth currently at the high school level (grades 9<sup>th</sup> – 12<sup>th</sup>). Note: Recognized work by youth is based on their personal merits and contributions and is not intended to be limited to their school involvement. # Jacob asking state regulators to review GPS data after SDG&E helicopters breach 'No Fly' zones again

an Diego County Supervisor Dianne Jacob is asking state regulators to review GPS data from helicopters working on the Sunrise Powerlink transmission line after SDG&E helicopters violated "no fly" zones on three separate occasions last month. The "no fly" zones are designed to protect golden eagles during nesting season.

When SDG&E helicopters violated a "no fly" zone in March of 2011, the utility stated publicly that it would use GPS devices to avoid future violations. Now, Jacob wants the California Public Utilities Com-

mission to explain why the GPS systems failed to prevent the most recent incursions.

"SDG&E helicopter activities have been plagued by dangerous mishaps that have outraged communities along the route and called into question the integrity of the CPUC's monitoring activities," Jacob wrote in a letter to CPUC Commissioners. "Were it not for a constituent with the aviation experience to carefully document the violations he observed, project monitors never would have uncovered the January "no fly" zone violations," she wrote.

Jacob told Commissioners that regulators were not investigating constituent complaints related to helicopter problems unless constituents provide detailed information regarding the date, time and location of an alleged incident, along with a description of the helicopter. She said this did not go far enough in light of SDG&E's past pronouncements that GPS devices would immediately alert pilots entering into "no fly" zones

In June of 2011, a Sun-

rise helicopter dropped a 16,000-pound section of lattice tower some 200 feet from the sky. It landed next to a busy Imperial County highway. That same month, transport hooks from the same helicopter malfunctioned, and

a different section of lattice tower dangled precariously in the air as crews lowered it to the ground. In August of 2011, an air compressor fell from a helicopter working on the Sunrise Powerlink spilling some 50 gallons of diesel fuel.





ick and Kristin Balcombe are missionaries and ordained Pastors in Peru. The story of how they met is interesting. Nick grew up in San Diego. His parents, Bruce and Jo Anne, left San Diego in 1999 with their children to go to Peru. Nick Balcombe, then 17, returned to San Diego in 2000 to attend San Diego Christian College where he received a bachelors in music. The following summer Balcombe went

back to Peru to serve along with his family in the local church. He left there August of 2001. Kristin arrived in Peru in September of 2001 to volunteer her services at the same church as the Balcombe family.

"Because she was a single girl and a missionary, my parents kind of adopted her as a daughter," Balcombe said. "The entire time I was in college, I kept hearing about this adorable and amazing girl who loves the Lord and who would be great for me. But I didn't pay any attention to their comments. In 2004 I got a picture of my family from my sister. There was this beautiful girl in the picture, and I was surprised to learn that it was Kristin."

Golden (Marcella) Williams passed away on January 23, 2012 peacefully in her sleep with family at her bedside. She was 96 years old. She married her Husband Bob Williams in 1935 and raised five children.

Marcella's rose garden and volunteering at the Lakeside Historical Society along with the Garden Club were some of her favorite things. She was co-founder and honorary lifetime member for the Lakeside Historical Society and Lakeside Golden Club. She was a member of the Delightful Doll Club. Marcella resided in their family home in Lakeside and received a "People of Preservation" award in 1988 for restoring and preserving her Irving Gill home.

Nick and Kristin started a long distance communication for six months. His family returned to San Diego in 2004, and eventually Kristin came for a visit. Balcombe bought an engagement ring two weeks later. He became a young adult pastor at Sonrise Church in Santee. Encouraged by Pastor Tony Foglio, Sr. to enter the missionary field, Balcombe knew it was the path for him. With knowledge of the culture and Spanish and a love for the people, he retuned to Peru in 2005 to be near Kristin. They were married the following June.

In Peru, the Balcombes became involved in *Camino de Vida*, a mission started by Pastor Robert and Karyn Barriger from San Diego. *Camino de Vida* (Way of Life) is dedicated to forming lifechanging partnerships with people around the world to provide humanitarian aid for those in need in Peru, South America. They get congregation members to go out in the community and do service projects like paint and clean houses, sweep streets, give out clothing, food, have medical clinics; and give them a Gospel Tract, tell them God loves them and invite them to church. A Bible study group the Barriger's started has grown to more than 5,000 people. "It's one of the more influential churches in Peru," Balcombe said. "We also spread the word that we have wheelchairs for anyone who needs one, and while it's being personally handmade for them, we witness to them."

As Director of Outreach and Humanitarian Aid for *Camino de Vida*, Balcombe and his wife are working on trying to get religious freedom passed through the country's congress. *Camino de Vida* has a network of churches throughout the country. "Our churches are interdenominational," Balcombe said. "We see our church as the Kingdom of God. We like to help these other churches to do the missions that God has called them to do. That's the evangelism we respond to wherever Kristin and I go. We ask ourselves how we can respond to this church so they reach the needs of others."

Camino de Vida services are held in a large building and there are eight services on a weekend. Money that comes in, said Balcombe, is sent back out to the other churches rather than spend it on their own church building. Because Balcombe and the others do so much for the people of Peru and are pro-government, they have less problems than Christian Missionaries do in other countries.

Balcombe is excited about the Microcredit program they have started in Peru where women borrow a small sum to start their own business, and when they repay the loan they can borrow a higher amount. They now have 590 women in the program. One such woman is Maritza Saldaña who started selling homemade donuts.

"Out of all the years I've been doing community aid, this program is the least amount of investment with the most results in the least amount of time," Balcombe said. "It gets people from being dependent on aid organizations to becoming productive members of society. They also learn how to grow spirituality. \$40 changes a woman's life. This is a way to end poverty."

Nick and Kristin have two children, Jude, 4 and Reese, 2, with another one on the way. They appreciate any donations to their ministry. For more information visit www.nickandkristinbalcombe.com

## Dear Dr. Luauna



hy do bad things happen to good people? I go to church with a very nice family who just had a terrible thing happen to them. They attend church regularly, and I see and hear them praying all the time. Does all that praying really work? Signed, Does God Really Hear?

Dear Does God Really Hear,

I have been a Christian for 33

years, and I have experienced difficult circumstances during that time. One instance happened about one year after I received Christ. I was taking my kids to the daily Morning Prayer meetings. That morning in Colorado, the sun was shining and the scenery was breathtaking. We were filled with joy, singing on the way, "In the name of Jesus, we have the victory..." In an instant tragedy struck. I watched from a few steps behind as my son fell off the bike and landed on the street on his head. There was nothing I could do. The fall was so severe his legs were tangled in the spokes of the bike tire as he was laying there. I ran to him as fast a I could, the first thought the enemy brought to mind was, "He is going to die from a brain hemorrhage, the same way his father did." My heart sank. I held him in my arms standing in the middle of the street and cried out with a loud voice, "God, not my son!"

An ambulance rushed us to the hospital. In the emergency room the doctor told me he his skull was cracked almost all the way around his head. Blood was rushing to his brain and his head was swelling like a balloon. The same way my husband died. The doctor said, they had to release the pressure, cut into his brain and there could be the possibility of brain damage. The battle which wages in your mind during that time is unbelievable, Satan was whispering in my ear, "You are a rotten mother," and so many other accusations. All I could do was pray. I got on my knees right in the Emergency Waiting Room and cried in anguish to God, when words could come between the weeping, all I could say was "Help me Jesus!" over and over again. The doctor came for me after the tests were done, He said, "The x-rays show his skull is cracked." I asked desperately, "Please do another x-ray!" I insisted, pleading, "Please do another x-ray!" Finally he gave in. The doctor came back and said, "This time the x-ray shows no crack." I knew God heard my prayer for my son.

Bad things do happen but Jesus is right there, *John 16:33*. Our Heavenly Father does hear our prayers, the Bible says in Revelation 8:3, the prayers of the saint rise into the throne room of God and are a sweet-smelling aroma before Him.



# 'Albert Nobbs' — worthy to see performances

ross dressing comes to the forefront in Albert Nobbs for a very good reason. It's not a frivolous attempt to be the opposite gender, but Glenn Close's character of Nobbs is caught in financially downtrodden 19th century Ireland. As a woman, there is no work for her. She was born out of wedlock and lived in a convent until she was 15-years-old. She was then kicked out to fend for herself. Unfortunately, she was gang raped and brutally assaulted by a group of men. (This is not shown in the film). To survive, she decided to masquerade as a man and live as a male to protect herself.

Now wearing a man's suit and presenting herself to potential employers as a man of skills, she gets herself a nice job as a waiter in a respectable hotel in Dublin. Nobody is aware of her true identity, and she plays her emotions close to the chest to avoid any involvements. Close does the usual Hollywood trick of removing all her makeup, chops her hair short, and wears nice cravats and beautifully cut morning coats to complete the effect.

Close was born with a natural square jaw, and this helps in her transformation to the look of a man. (The film was awarded a Best Makeup Oscar® nomination). However, having been a Glenn Close fan for most of her career, all I kept seeing was Glenn Close in a suit and pretending to be a man. She instead presents a milguetoasttype character who more or less whispers so that her lady-like voice is not revealed.

Nobbs has become so used to playing a man that she thinks if she gets engaged to young Mia Wasikowska (Helen), a young downstairs maid at the hotel, she can live a "normal" life as man and wife. That is unless the unsuspecting Wasikowska discovers on their wedding night that there's something missing. But there is no danger of that happening because Mia loves the handsome, muscular young Aaron Johnson (Joe), a n'er do well who wants to steal Albert's money and run off to

Albert's secret is revealed to his/her new hotel room-mate. Janet McTeer, who plays a housepainter named Hubert Page. The new room-mate almost doesn't fit into the tiny

space because Page is tall, big, and muscular. Nobbs is shocked to learn that part of that bulk is composed of huge

breasts, as Page is also keeping a secret. Honestly, let's give credit where it is due and say that McTeer does a marvelous job of acting with her difficult role. She pulls off the look of a man better than does Close. The part is not large, but it is impressive.

The pace of the film is nearcomatose, with both Close speaking in soft, languid tones and the progression of scenes set at a speed an unconscious person could follow. This can cause the audience to lapse into an induced coma at first, but a good dose of strong coffee or whiff of Ben-Gay can keep one awake. This is not to say that director Rodrigo Garcia hasn't fashioned a beautifully made film with the help of his production designer (Patrizia von Brandenstein), set decorator (Jenny Oman), art director (Susie Cullen) and cinematographer (Michael Mc Donough).

In my opinion Albert Nobbs is worth a trip to the theater to see Close's Oscar® nominated performance for Best Actress, and Janet McTeer's for Best Supporting Actress.





# College district makes significant contribution to region's economy

just-released analysis shows the Grossmont-Cuyamaca Community College District's yearly economic impact on San Diego's East County region exceeds \$477 million, including the nearly \$100 million the local economy receives directly from college district operations.

The comprehensive report clearly shows the college district provides substantial benefit to its students, the East County area and the San Diego County region.

The study by Idaho-based Economic Modeling Specialists Inc., analyzed the real costs of college operations, such as payroll and supply purchases, the economic benefits to students for the investment in their education, and the benefit to taxpayers and the region as the result of a better-educated workforce.

Local data on industries, occupations and demographics were used to determine the college district's impact on increased regional earnings,

returns to taxpayers, income formation and a broad collection of social benefits and avoided costs.

Among the study's findings:

On average, the lifetime income of a student at Grossmont or Cuyamaca colleges increases by \$6 for every dollar they invest in their education.

Students get a 15.4 percent return on their educational investment, recovering all of their costs within 10 years.

Over the course of a working lifetime, a graduate of Grossmont or Cuyamaca colleges earns almost \$560,000 more than someone with a high school diploma.

California benefits through improved health and reduced welfare and unemployment, saving the public an estimated \$4.5 million each year.

Higher earnings by Grossmont and Cuyamaca college students and increases in state income expand California's tax base by \$87.2 million each year.

East County's economy receives more than \$99.4 million per year due to the college district's operations.

Grossmont-Cuyamaca's total annual economic impact on East County: \$477.5 million.

"This economic analysis provides the hard numbers quantifying what we have long known -- our students get better-paying jobs with the skills they learn at

our colleges, and taxpayers and the community at large benefit by higher employment and increased investment opportunities, higher business revenues, reduced dependence on government assistance and less crime," said Bill Garrett, president of the district Governing Board. "Clearly, this study shows that dollars invested in this college district are an investment in the future of East County and the surrounding region."

EMSI, which studies economic data for colleges and universities worldwide, also analyzed the overall impact of the nine community colleges in San Diego and Imperial counties. Its studies placed the total annual impact of the colleges on the state economy at an astounding \$6.6 billion.

# Be a smart investor

Our office regularly receives inquiries from frustrated rental owners that complain about their experience with property management companies. Among the top complaints are the following:


- Prolonged vacancy with no solution
- Uncollected rent with no resolution
- Request for services and updates are ignored or procrastinated
- Property repairs and maintenance are not timely, workmanship is shoddy and/or not competitively priced
- Financial reporting deadlines are not met

Our staff listens to our clients as our company has performed plenty of clean-up on mismanaged properties. However, we also ask some pointed questions of the complaining rental ownesr. We want to know the conditions under which their property managers were hired. We want to know what the specific expectations were within what timeframe, and what resources were offered. Often we discover that the rental owner wants to dictate the terms of the management assignment without the experience to predict the results.

It's also important to know how the rental owner chooses to be involved. Have they been part of the management team? Some owners are more involved than others, but did they clarify these expectations?

Some well-intended "hands-on" rental owners actually create a hindrance to a company's systematic approach, policies, procedures and routines that are the essence of quality management. An owner needs to refer all inquiries, questions or concerns to the property manager and stay in contact for support. If an owner is not available to weigh in on an issue before the decision is made; do they support the decisions of the property manager put in a tough spot due to the owner's absence?





his is a 2011 car but I think the Saab is one of the premier car manufacturers out there, and they still are building a fan-

tastic 5-passenger, four-door sedan. Marvin K. Brown Saab is waiting for the 2012 models, but they have a good selection of 2011 and willing to make great deals.

My test car was a 2011 Saab 9-5 which had styling lines like no other. I had the 9-5 with the All Wheel Drive feature that keeps drivers on the road in just about any road condition.

This Saab had the 2.0-liter four cylinder turbocharged engine producing 220 horse-power and 258 foot pounds of torque. The turbocharger is rather tame, in that it does not snap your neck on heavy acceleration. The Saab also keeps everything under control thanks to its advanced suspension system. I had the six-speed automatic that was perfect in every shift that should get 230 MPG in the city and 33 on the freeway.

But the real joy of a Saab is driving it as well as looking at its sleek profile. Saab is a major aircraft builder and this car has aviation cues throughout. The most notable is the speedometer with a dial version but also a rolling speedo just like an airplane.

The driver compartment is well done and easy to operate. Everything is at an easy glance

and reach. I loved the center armrest that raises up for a very comfortable arm position. Plenty of connectivity ports for front and rear occupants and a sound system that can put a smile on anyone's face.

My Saab had a wonderful sunroof that was great for all passengers, and comes with an electric sunshade as well. Storage was abundant and could handle just about anyone's gear in the car as well as the trunk.

I was very pleased with the looks, handling, stopping and accelerating of the 9-5. In the mountains is where it seemed to be the happiest. Anyone who has never been in a Saab should take a run down to Mis-
