n March 15 at the Nan Couts Cottage in La Mesa, Susan Hall gathered the group of 25 people around the quilt for the monthly Community Drum Circle. By 6:30 p.m. everyone had chosen a percussion instrument to play from a quilt on the floor. The instruments range from castanets to rain sticks and drums from Africa, to the Middle East and Thailand.

Drum Circles are not per-

formances; rather they are for recreation and rejuvenation. Participants are not expected to drum with rhythmic precision or perform composed rhythmic patterns. Instead, everyone contributes his or her sound to the circle and the music, creating a whole that is greater than its parts.

Hall, a health education professional and owner of RhythmWorx, stated scientific research has shown the benefits of group drumming are not only experienced emotionally, but also physiologically.

"I have more than 600 instruments, so this is a pretty small collection," Hall tells the group. "You are free to use any and all of them," she said.

Some people bring their own instruments. Angela Large has been to several of the drum circles and this night brought her large goblet-shaped drum. "It's a Toga drum that I got for my birthday," Large said.

Her Djembe drum poised between her knees, Hall began tapping out a rhythm and the musicians – ranging from children to the elderly – joined her banging on drums and shaking bells and tambourines. The cottage filled with a heart-pounding boom.





# Santee residents voice concern over proposed power plant

he proposed 100MW Quail Brush Generation Power Plant Project encountered continued resistance at the San Diego Planning Commission meeting downtown Thursday morning. Somewhat a victory for the project's opponents, a 30-day continuance was granted, delaying a decision on rezoning the 22-acre plot from openspace to industrial.

With Santee residents and members of the grassroots citizen group StoptheSanteePowerPlant.org (SSPP) in attendance, the message was clear: block the San Diego Planning Department's recommended approval on changing the zoning of the site, which would clear the way for Cogentrix, a North Carolina-based company, to start construction near state Route 52 and Mast Boulevard, and on a portion of the Mission Trails Regional Park.

While a 60-day continuance was initially requested, a shorter length of time was eventually agreed upon by Councilmember Marti Emerald, and Cogentrix representative Robin Madaffer. Pursuant to this, Eric Solorio, project manager with the California Energy

Commission (CEC), advised Chairman Eric Naslund and the committee that there would be a public workshop on March 22 at the Mission Trails Visitor Center. According to the CEC official notice released late Thursday, the purpose of the workshop is to "continue developing a dialogue between staff, members of the public and agencies interested in the proposed project."

Opponents doubt the claims by Cogentrix that the plant will be utilized only during peak hours, and at no more than 43 percent capacity. Members of SSPP demand that the California Energy Commission base the company's request to build the plant upon maximum operational capacity. Cogentrix officials, including Vice President C. Richard 'Rick" Neff, did not respond to requests for comment.

SSPP member Roslind Varghese described the beginnings of SSPP as a true grassroots movement, in which members balanced work, family life and amateur activism. Members also went door-to-door handing out homemade flyers, and soon discovered that the majority of residents living less than a mile from the plant were unaware of its construction.

Varghese finds the actions behind the Quail Brush Project to be both "ethically and morally wrong," and pointed out that both the CEC and Cogentrix have yet to address any emission and noise levels based upon maximum operational capacity. In her attempted to address these concerns with the planning commission, Varghese was shut down by Chairman Naslund and a decision that only statements relating to the opposition of the continuance would be heard.

According to a Noise Abatement and Control ordinance, a maximum of 75 dBA is allowed at the site. But Varghese claims that data from Cogentrix "shows the noise levels greater than 80 dBA at the site of origin," and disputes the environmentally-safe claims of the type of gas engines proposed for the plant.

Santee resident Mike Press, who attended with his father-in-law and two young daughters, is a homeowner concerned about falling property values, as well as the impact the plant would potentially have on the health of his and his neighbor's children.

"I have a house [in Santee], my father-in-law has a house there, and my kids are going to grow up there," Press said. "I heard a lot about the pollution, basically the air quality, noise and everything that comes with the power plant. I think even at 43 percent, it's bad news with the emissions that are going to be put out."

And according to a May 2010 study by Lucas Davis at the University of California, Berkeley, Santee homeowners concerns about falling property values are not baseless. The study showed that homeowners living within close proximity to a power plant can expect a noticeable depreciation, usually between 4 and 7 percent.

Santee Mayor Randy Voepel is opposed to the power plant but also believes there are issues beyond Santee's control. According to his post on the SanteePatch.com "Ask Randy" forum, two such issues are the location of the site being in City of San Diego city limits, not Santee, and budgetary shortcomings preventing Santee from pursuing a court battle.

Two areas of concern near the proposed construction zone are the West Hills High School and the West Hills Park, home to the West Hills Little League. Both are less than half a mile away.

According to West Hills High School Principal, Paul Dautremont, PTSA President Karen Fleck, discussions have taken place with all parties concerned.

Peter Adams, an SSPP member, appreciates the approved delay as it gives him more time to consolidate the area's homeowner associations. According to Adams, two such associations pledging their support are Sunset Greens and Treviso Homeowner Associations, both of which are in an

area that could be affected by the project. Adams says he is currently in discussions with several other associations, further solidifying the coalition. Like his fellow SSPP members, Adams feels that Cogentrix has been less than forthcoming regarding emission levels. Hall alternately slowed and sped up the tempos and the first round of drum music lasted for about 10 minutes. Every participant stopped exactly on the same beat and cheered each other. Then someone started a new beat for all to follow.

Although it was loud, the drum beat soothed 7-year-old Blake Large who snoozed for a few minutes in his mother's arms as she rattled a tambourine. Large also brought her daughter Macayla, 11, and friend, Noel Besette, 12 who was surprised how good the circle sounded.

"This is very cathartic for our family," Large said. "The kids look forward to coming each time and each one likes to experiment with different rhythmic beats and sounds."

Ruta Brazis-Velasco placed her drum back onto the quilt in the center of the circle. "I came here because of all the stress I feel," she said. "I'm coming back. It's a winner for me," she said.

"Everyone leaves here

feeling better after the drum

circle," Hall said. "Whatever problems or pains they came in with melt away. One time a man came in complaining of a migraine headache. By the time he left, it was gone."

The City of La Mesa liked Hall's concept of a drum circle as a way to personal and community health. The City's Live Well Initiative funds the event each third Thursday of the month.

"Children are always welcome here, Hall said. "Part of the Live Well Initiative is to encourage families to spend time together, and kids love any chance to make noise."

# The truth about anxiety and stress

n the 1970s Ricky Nelson song, "Garden Party, one of the refrains goes, "You can't please everyone so you've got to please yourself." That may ring true to you if you're constantly stressed about making everyone around you happy.

Have you ever wondered how some people are able to conquer worrying about everything all the time? First off, they probably know that worry, stress and anxiety can lead to fear, tension, anxiety, anger, and exhaustion. That's why they've decided to make changes in their lives.

Some studies have shown that changing lifestyle practices can help decrease stress and improve the quality of your life even beyond your best expectations. According to the American Institute of Stress, over 110 million Americans take medication for stress related causes every week. Those numbers go up when the holidays come along. People who are already predisposed to stress often find themselves feeling blue and more stressed out than usual at this time of year.

Worry less, enjoy life more Most of us worry about things that make us feel stressed, but some people spend an excessive amount of time worrying about tomorrow. Someone once said "Don't tell me that worry isn't good for you. I know better. The things I worry about don't happen." Many chronic worrywarts probably wish they could change the way they view the world, but they simply don't know how to stop worrisome thoughts.

Stress is a natural reaction to an enfolding possible problem. When we feel stressed and start worrying, those thoughts trigger an alarm in the brain, telling our bodies that something may be wrong. The fight or flight response calls in the nervous system and ask it to respond. Hormones are released, jolting the body into action. Muscles become tense, pulse increases, and breathing increases. Heightening the senses during a crisis is essential to survival. This is a natural and important biological response.

The problem is some people can't shut off worrying. Keep in mind our bodies are designed for short bursts of stressful activity, but ongoing daily stress often means that the system has been left 'on' to respond. If you

may be getting signals that your body is over-worked. Stress varies from person to person, but it can involve, mental, physical or behavioral changes. If you have difficulty concentrating, have headaches, tight muscles or have difficulty sleeping, these may be stress signals you shouldn't ignore. Some people may experience a combination of signals. Ultimately, if stress and anxiety are not resolved, it may impact your ability to work effectively. It can also increase the risk of injury and disease.

#### Make new lifestyle choices

#### Learn relaxation and mindfulness techniques.

Have a healthy diet. When we have a healthy diet and get adequate rest, we tend to remain healthy and feel positive about ourselves. Good sleep and nutrition also help maintain more steady levels or our so-called stress hormones which keep us more stable emotionally.

**Exercise.** For people who are prone to anxiety there's real evidence that regular, moderate exercise can have anti-anxiety and antidepressant effects.

Maintain a positive attitude. Stay focused on the good things going on in your life. Reflect on your successes instead of things that are out of your control.

#### Write down your worries. Journaling what worries you

may help pinpoint the real core of some problem so you can work on them more objectively.

**Take time out for you**. Engage in activities that make you feel energized and rejuvenated. That may be as simple as taking a quiet walk, practicing yoga

or learning a new hobby. The important thing is to find things to do that give you pleasure instead of sitting around worrying. You can manage stress by averting your attention to new lifestyle choices. This will help you live a better life while coping with life's pitfalls.

#### Rent Sense

#### An ounce of prevention

Recently our firm heard a distressing story from some tenants. We took over management of a property with uncollected rent going back several months. We visited the property and noted a number of conditions that should not be tolerated by the owner. On the other hand, there were repairs that should be taken care of for the renters.

A subsequent meeting with the tenants revealed a poorly documented lease, unresolved renter issues requiring immediate attention, poor communication throughout the lease term and a discomfort with the required confrontation to resolve the nonpayment of rent. The renters indicated that a roof leak following a wind storm caused damage to their furnishings and therefore they felt justified in holding back rent. Obviously these are items that need to be sorted out, and we will help facilitate that.

During this conversation our employee mentioned the importance of having renters insurance. This is a conversation that we have with every resident that we put into a lease. What was unfortunate in this situation is that even when a renter is faced with a specific damaging incident that could have been abated with preparation, there are considering actions that will only compound the loss and complicate future rental housing alternatives. Let's consider one ounce of prevention - renters insurance. What exactly is it?

A rental owner normally carries property insurance. However this policy probably won't cover any personal belongings and often demands personal financial accountability if a renter is found contributing to a loss. Renters insurance is a combination of liability and content coverage that fills this gap. Renters have the option to add personal liability and content coverage to protect their personal belongings in the event of such things such as theft, vandalism, fire or smoke damage, loss due to sudden water or wind damage. Usually personal liability protection includes the property loss and personal injury due to acts of owners' pets, and unintentional acts by owners or family members. Without such resident coverage in place rental owners and/or their property manager will have to deliver the bad news to the renters that they are on their own.

As a small business owner Hynd is constantly working to keep his overhead down. He must also contend with new tax laws, EPA requirements, Hazmat laws, and human resources law changes.

Hynd does most of the office work and leaves the hands-on work to his mechanics Mike Bent and Joey Harrod, the youngest mechanic at the shop. "It's rare to have young men want to work on boats because usually they want to do computer work," Hynd said.

Working along with Bent to repair an engine, Harrod shook his head. "Not me. I love doing this. It's far more interesting," he said.

Hynd sends his technicians to Mercury, Evinrude and Volvo schools around the country every year. This helps them keep up with the best and most efficient practices to fix those engines correctly the first time. Many customers come to Sunset Marine as firsttime boaters. "They usually have a lot of questions," Hynd said. "I don't blow them off like the big boys do. I've seen so many people come and go in this industry because of bad customer relations.'

Hynd recalled a time when he had repaired a man's boat but shortly after got a call that the boat wasn't working. Hynd grabbed his tools and went to the launch ramp. When he got to the dock, the man's boat was idling just fine. But when Hynd looked through the murky water he saw the

man had launched his boat and detached the trailer from his truck.

"I pointed down to the trailer connected to his boat, and holding back a smile, said, 'There's your problem,'" Hynd said. "As embarrassed as he was, we managed to get the truck hooked back up to the truck and re-launch his boat the right way. After this long, I've seen it all."



# Actor John Schneider talks about his new film 'October Baby'

ohn Schneider began acting at the age of eight in many plays in New York. When he was 14, he and his mother moved to Georgia where he became involved in the local theater. His career quickly blossomed. At age 17 Schneider had a small role in Smokey and the Bandit starring Burt Reynolds. But it was the TV series of The Dukes of Hazzard that brought Schneider his big break when he won the role of Bo Duke.

Schneider has since made many movies, started his own production company and has nine films currently in production. He is very excited about his newest film, October Baby and was very generous to agree to an interview.

Q: Provident Films —known for its association with such hit faith movies as Courageous and Fireproof are behind this film, and brothers Jon and Andrew Erwin are making their directing debut. So what drew you to this film?

JS: I make a lot of little movies, and when you get two brothers from Alabama who make music videos making their first film and they want you to be the dad, that's a scarv thing to hear. But I'm a huge fan of trying to help people with their dream, and every now and again I have the opportunity to work with someone like that. But in this case, these brothers are so talented, it's unbelievable. Every now and

again - and maybe it happens about three times in your life if you're lucky - you know that they are special.

Q. The story is about Hannah who discovers she was adopted from a failed abortion; but it's really about more than that. Was that part of your decision to appear in October

**JS:** When I went to see the first cut, I was thinking please let this be good for them (Jon and Andrew). The first moment I saw those kids running through the field and holding hands and jumping into the water, I knew these two guys were different. Jon and Andy are the real deal.

**Q.** How incredible was it that the movie got major distribution and marketing?

JS: I truly believe that October Baby could get recognition from the Academy because of the obvious talent of these two guys. The film has no big car crashes in it and it's not a Hunger Games. But it's a well crafted film with nothing in it but genius times two, and obviously Samuel Goldwyn Films also knows that as do a lot of people because this little movie shot by two guys who used to shot football games is opening in 300 +theatres.

**Q.** The Erwin brothers were part of the co-writing team on this movie as well as directors? What particular skills did they bring to the story?

**JS:** The great pacing where it just felt so real every new scene. I think because they were music. video directors they learned they only had a short amount of time to tell the story. It also has many elements. Someone who saw it said it's like a good Broadway show that makes you about to tear up but then something funny happens. You don't often see tears of joy in a film. but in the entire montage at the end when forgiveness is running rampant, you see that in this movie because someone chose to forgive a mistake that their dad, or friend or mother

JS: From my three daughters. I helped raise two of them, and I helped birth Karis with a midwife. There's a special bond between dads and daughters. So that's where part of that comes from. That relationship is born from me talking to my kids throughout their lives. But that gets harder when they're about 17 as teenagers. It also comes from many conversations and my openness to actually listening to them and to apologize to them if I'm wrong and not to if I'm right, which is still tough to do. Rachael Hendrix, who plays my daughter (Hannah) in the film, is so wonderful - her eyes go on forever right into her soul.

**Q.** There were several good performances in the film.

JS: Yes, Jason, played by Jason Burkey, is Hannah's best friend. He's a great actor and was so funny to yell at and laugh with. Jason and Hannah are best friends, and I think they still think of each other as those kids running into the water together. Jason gives a perfectly honest performance, and we get a beautifully honest performance from her. Shari Rigby, who pays Hannah's birth mother Cindy, is wonderful in telling her husband about the birth.

Q. This movie feels rooted in reality and seems appealing to many age levels.

JB: It is. It's beautifully crafted. It's an honor to be part of a movie that has already affected people. I'm getting emails from the brothers about folks who saw the preview and have had that conversation with adopted children or with adopted children from failed abortion attempts. I'm so thankful for these guys. I think they have opened an area of wonder and healing that no one has opened before. I think they have and will change a bunch of lives with this film.

NOTICE IS HEREBY GIVEN that the El Cajon City Council will hold a public hearing to accept and consider public testimony regarding the proposed activities and allocation of funds for the Community Development Block Grant (CDBG) program and the HOME Investment Partnership Program (HOME) and adoption of the FY 2012-13 One Year Action Plan. The Public Hearing will be held on **Tuesday, April 24**, **2012 at 3:00 P.M. in the El Cajon Council Chambers at 200 Civic Center Way, El Cajon, CA 92020**.

CDBG and HOME grants are funded by the U.S. Department of Housing and Urban Development (HUD). The CDBG funds must be utilized to meet one of three national objectives to qualify for funding: 1) benefit low and moderate income persons in the community; 2) aid in the elimination of slum and blight; or 3) meet other community development needs having a particular urgency because existing conditions pose a serious threat. HOME funds may be used "to provide incentives to develop and support affordable rental housing and homeownership affordability through the acquisition, new construction, reconstruction, or rehabilitation with suitable amenities, including real property acquisition, site improvement, conversion, demolition and other expenses. It may also be used to provide for the payment of reasonable administrative and planning costs, and to provide for the payment of operating expenses of community housing development organizations (CHDO's) – 24 CFR 92.205(a)." Each participating jurisdiction must set aside 15% of their HOME entitlement for CHDO's.

The FY 2012-13 One-Year Action Plan is the document that provides details of the projects and programs to be funded through CDBG and HOME funds for fiscal year 2012-13. This Notice lists a summary of the projects that were tentatively approved at the February 14, 2012, public hearing, subject to final adoption by City Council and approval from HUD. These projects and programs comprise the core of the FY 2012-13 One-Year Action Plan, a draft which is available for review at the Redevelopment and Housing Division public counter at 200 Civic Center Way, Third Floor, El Cajon, California beginning on March 22, 2012 for a minimum of thirty (30) days.

The El Cajon City Council took the following tentative actions at the February 14, 2012 public hearing: Directed staff to prepare the FY 2012-13 One-Year Action Plan allocating \$999,879 of anticipated FY 2012-13 CDBG funds, \$612,436 of available unallocated CDBG funds, \$380,080 of anticipated FY 2012-13 HOME funds, and \$10,390 of available unallocated HOME funds as set forth below. # Aztecs fall out of the NCAA tournament

oncluding an unpredictably satisfying season, the #21 nationally ranked (AP) San Diego State men's basketball team (26-8, 10-4) returned home to Montezuma Mesa as their season concluded Saturday afternoon when North Carolina State upset them 69-55 in the NCAA Midwest Regional Tournament held in Columbus, OH.

But what a ride it was for the Aztecs this year. Not expected to do much by the 'experts, and after decisive regular season wins over USD and Long Beach State, SDSU continued to win making believers of the nation after posting hard earned victories over BYU, Wyoming, and then securing and sharing the MWC Conference Championship with the New Mexico Lobos after beating them in their house.

One of the best programs in the country, SDSU basketball has evolved around their legendary coach Steve Fisher. Instilling a "we can beat anybody" attitude, the Aztecs made believers out of themselves and their fans while the rest of the nation watched as they made their third straight appearance in the NCAA March Madness Tournament.

"This is what everybody dreams about doing, playing in post season NCAA play," said Aztecs head coach Steve Fisher. "Never assume it's a God given right. It's a privilege to be here. We have earned our way in."

The Aztecs had a competent game plan and competed with the Wolfpack in the first half but were eventually out-muscled by their big men in the paint and

were out-shot by their perimeter players, most notably their star point guard Lorenzo Brown. He did a great job running the N.C. State offense and led his team in points with 22, a few of those coming on clutch three-point shots.

A hot selection committee choice, the N.C. State Wolfpacks shot the lights out of Nationwide Arena hitting a blistering 58 percent of their shots, collaring nine more rebounds than SDSU.

Team and league MVP Jamaal Franklin of the Aztecs led all scorers with 23 points.

Senior forward Tim Shelton is saying good-bye as an Aztecs warrior playing in his last game for SDSU.. This is a guy who due to nagging injuries rarely practiced during the regular season but persevered for five years. Because of his contributions to the team both on and off the court, the Aztecs coaching staff will say hello to Tim when he joins their ranks as a coach while continuing to mentor the younger players.

"This was a sensational team. They worked hard and did everything that was asked from them," SDSU assistant head coach Brian Dutcher said. 'Obviously we feel bad. This is the kind of team we have to beat a year from now if they want to make a deep run into the playoffs. There are always lessons to be learned. We don't want to dismiss this loss. 

nelter Dogs to Dream Dogs, the K9 training facility and shelter rescue program, takes in 'unadoptable' dogs from local shelters and trains them to be family, therapy or service dogs.

Shelter Dogs to Dream Dogs works in two ways - local shelters call owner Cate Sacks when they have dogs in line to be euthanized. Sacks works with the animal to correct its bad behavior and trains them for one week before they are ready to be adopted.

"I train any dog for any type of lifestyle," explained Shelter Dogs to Dream Dogs owner, Cate Sacks. "Whether you need a family pet, an emotional support, or a service or therapy dog, I can create that K9 for you.'

Sacks matches each dog to an owner or family that fits the animal's personality. She then educates people to understand why the dog is a good match for them and teaches the owners how to bring the dog home comfortably and smoothly.

Next, Sacks evaluates each pet to consider if they can be trained to be a service dog. Some dogs make great support animals for people with issues like Post Traumatic Stress Disorder (PTSD), Parkinson's syndrome or have physical disabilities.

Shelter Dogs to Dream Dogs is also a K9 training facility. Programs are offered hourly, in packages or in one- or twoweek bootcamps. Pets arrive at the facility with severe behavioral issues and leave with good manners and respect for their owners.
