





Junk food, for example, including fatty, sugary snacks, triggers pleasure centers in the brain. That's why when bowls of candy or chips are in front of you, it can be hard to stay away.

Think of your brain this way—it only weighs about 3 pounds—that's a small portion of an adult's body weight, but it consumes about 20 percent of your daily calories. That's a good motivator for having a brain-healthy diet.

Follow these tips to stay on course and boost your brain's fitness.

Memory boosting food

In order to memorize and retain new information our brain cells have to make new connections. One way they do this is when we get excited about something or have deep feelings and emotions.

Acetylcholine is the "messenger" that keeps our brain cells on high alert for new information. You'll find acetylcholine in eggs, liver and soybeans. Vegetables like cabbage, broccoli and cauliflower also seem to help improve memory.

On memory tests, researchers have found that people who eat these foods do better than people who do not have these foods on a regular basis.

Concentrate on these foods

Good concentration skills depend on a steady flow of messages between brain cells. The first step in improving concentration and focus is by eating healthy food at regular intervals throughout the day.

The brain also needs myelin, a fatty substance that insulates the nerve fibers so signals can be more easily sent from one brain cell to another. These nerve fibers are like electrical wires in a well-oiled machine.

You can do your part by eating healthier and keeping the "machinery" of your brain in top shape.

A diet that includes myelin includes oily fish, walnuts, pumpkin and flax seeds. So don't skip meals, pack snacks with seeds and nuts and you're on your way to improving your concentration.

Lift your spirits with these foods

Our moods, good, bad and everything in between, involve an exchange of electrical "messages" carried by neurotransmitters between the brain cells. One of those transmitters carrying messages to the brain is dopamine. Foods that are sugary and fatty have dopamine which is why we may feel good when we eat these foods. But soon, there is a sharp drop off of feeling good.

A healthier way to feed your brain is with precursor, the molecules that form dopamine. One of those precursors called phenylalanine can be found in food like soybeans, edamame, beets, almonds, eggs, meat and grains.

Chocolate can help boost your spirits because it drives up dopamine, but use it as a pleasurable snack not as a large part of your diet.

More healthy eating tips

Keep an eye on your blood pressure. Even in healthy older adults, high blood pressure can damage blood vessels in the brain and reduce the brain's oxygen supply. This can result in nerve cells that are damaged, a factor that can impact decision-making and memory.

Instead of eating salty foods, cut back on sodium and eat plenty of fresh fruits, veggies and whole grains.

A healthy diet will help you maintain a healthy weight. Excess weight can have a negative impact on your brain's health regardless of whether you have diabetes or high blood pressure. Lower your intake of sugars and white flour and eat plenty of fiber-rich foods, and use olive and canola oils.

For years we've been told that veggies are good for our health, but some research now suggests that green leafy vegetables in particular, may help slow mental decline. So don't forget to stock up on leafy greens like kale, and lettuces like romaine and spinach.

A healthy diet may lower your risk of many conditions, but eating three meals a day packed with brain-healthy food, can improve your brain power.







The history of Oktoberfest?

It began with the Royal Wedding on Oct. 12, 1810.

Crown Prince Ludwig, later to become King Ludwig I, was married to Princess Therese of Saxony-Hildburghausen on October 12, 1810. The citizens of Munich were invited to attend the festivities held on the fields in front of the city gates to celebrate the happy royal event. The fields were renamed Theresienwiese ("Theres'a Fields") to honor the Crown Princess, although the locals have since abbreviated the name simply to "Wiesn". Horse races in the presence of the royal family marked the close of the event that was celebrated as a festival for the whole of Bavaria. The decision to repeat the horse races in subsequest years gave rise to the tradition of Oktoherfest

The History of The Munich

Oktoberfest: Oktoberfest is one great big international celebration. People have been coming to Munich for almost 200 years for the celebration and now come from all over the world to participate in this 16 day party.

Oktoberfest started as a wedding celebration party. Prince Ludwig of Bavaria, who was later crowned King Ludwig I, wanted the people of Munich to share in the celebration of his marriage to Princess Therese of Saxony-Hildburghausen on October 12, 1810. He organized a horserace, offered copious amounts of beer and food, invited all the people of Munich and voila! Oktoberfest was born.

The festival was such a success that Ludwig decided to hold it again the following year in conjunction with the state agricultural festival. In 1816 carnival booths were added

and in 1819 the town fathers of Munich decided that the festival should be celebrated every year. Over time, the length of the festival was increased and the date moved backward because of the great weather at the end of September in Bavaria.

Since its beginnings the Oktoberfest has thus been canceled 24 times due to war, disease and other emergencies. By 1960, the last year that horse races were held, Oktoberfest was already a worldfamous festival. People from all over the world started attending Oktoberfest in droves.

Oktoberfest is now celebrated all over the world at different venues and in varying measures but definitely, Oktoberfest Munich is the king of festivals and we have King Ludwig to thank for it. A toast to King Ludwig and Therese!

German authentic Oktoberfest recipes -

Obatzter

(German beer cheese spread) Obatzter (pronounced "OH-bots-duh") is a Bavarian fullflavored cheese spread. Classic Biergarten fare, Obatzter is especially popular at Oktoberfest celebrations. Also spelled Obazda or Obatzda. Known as angemachter Käse or Gerupfter in the state of Franken

Makes about 2 cups Ingredients •Camembert, cut into pieces -- 16 ounces •Butter, softened -- 3 tablespoons •Red onion, minced -- 1 •German ale (optional) -- 1/4 to 1/3 cup •Paprika -- 2 teaspoons •Ground caraway -- 1 teaspoon •White pepper -- 1 teaspoon Method

1.Place all of the ingredients together in a large bowl and mash together with a large fork or potato masher until smooth and fluffy. Alternatively, you can pulse all of the ingredients in a food processor. Adjust seasoning to taste.

2.Place the cheese spread in a bowl. Garnish with more minced red onion, chopped chives or sliced radishes if you like. Spread on slices of Bauernbrot or serve with soft pretzels.



Blaukraut (German braised red cabbage)

Blaukraut, also known as rotkraut or rotkohl, is a popular German side dish. It is most often served with pork, sausages, goose, duck or game and a side of mashed potatoes or potato dumplings. In England, the same dish is called Suffolk red cabbage. **4 to 6 servings**

3.Stir in the vinegar and then add the remaining ingredients. Reduce heat to low, cover and simmer for 30-35 minutes, or until the cabbage is tender. Adjust seasoning and serve.

Kartoffelknödel (German potato dumplings)

Kartoffelknödel figure in the cuisine of most of the regions of Germany, and are a typical side dish with roasted and braised meats. This particular dumpling recipe, using both cooked and raw potatoes, comes from Bavaria. Potato dumplings are also popular in the Czech Republic, where they are known as bramborové knedlíky

4 to 6 servings Ingredients

•Baking potatoes, peeled -- 2 pounds •Breadcrumbs (optional.) -- 1/4 cup •Salt and pepper -- to taste •Nutmeg -- 1/4 teaspoon •Egg (optional), beaten -- 1 •Croutons -- 6-8

Method

1.Bring a large pot of salted water to a boil and add half the potatoes. Boil until the potatoes are cooked through and tender, then drain, cool and put through a ricer or mash until smooth.

2.Using the fine holes of a grater or food processor attachment, grate the remaining potatoes and place in a a large bowl of water with a little vinegar added (this keeps the potatoes white).

3.When all of the potatoes are grated, remove them from the water — saving the water — and place them in a colander. Squeeze them until they are very dry. Or you can place the grated potatoes in a clean dishtowel, wrap them tightly and twist the towel to remove any excess moisture.

4.Carefully, drain the excess water from the potato soaking water, retaining the potato starch that should have settled to the bottom of the bowl.

5.Mix the potato starch into the riced or mashed potatoes, along with the grated potatoes, breadcrumbs, salt, pepper and nutmeg. Mix in the egg if using.

6.Using wetted hands, take about 3/4 cup of potato mixture and form it into a rough ball. Press a crouton into the middle and smooth out the ball. Repeat with the remaining potato mixture.

7.Bring a large pot of salted water to a simmer. Drop the dumplings carefully into the simmering water and cook for 15-20 minutes. Do not boil or the dumplings could fall apart. Drain and serve hot.



Kids will enjoy 'Hotel Transylvania'

he 3D animated Count Dracula is a parody of the original Dracula, (played by Bela Lugosi), in Sony Pictures Animation comedy Hotel Transylvania. It's really Adam Sandler doing his best and most hilarious impersonation of the veteran horror star.

The venerable Count has decided to branch out and open a luxury "five-stake" resort for all of the world's monsters and misfits to get away from it all and enjoy a little rest and relaxation. That includes Frankenstein (voice of Kevin James), Frankenstein's wife Eunice (voice of Fran Drescher), an obese mummy (voice of Cee Lo Green), the werewolf (voice of Steve Buscemi), Quasimodo (voice of Jon Lovitz), Wanda, a pregnant werewolf (voice of Molly Shannon), the Invisible Man (voice of David Spade), TV's Mindy Kaling as a Skelton Wife, and a shrunken head hanging on the door (Luenell Campbell). There are other assorted monsters and aliens, much like the famous bar scene in the Star Wars epics.

The thin and simple plot, easy for kiddies to understand, revolves around Dracula's idea to throw a huge birthday party for his daughter, Mavis (voice of Selena Gomez), who is celebrating her 118th birthday. Since she is a teen-ager in monster's terms, all she wants to do is learn to use her wings as a bat and fly the coop. Daddy Dracula gives her very little freedom.

A teen camper/hiker inadvertently stumbles upon the Hotel Transulvania and wants to join in on the activities. Jonathan (voice of Andu Samberg) is young and cute and the perfect catnip for Mavis. Daddy Dracula is having a fit and is overly protective of his only little girl. What's worse is that Jonathan is a human being and not a vampire. A human is not worthy to be Mavis' boyfriend. As a result, all sorts of funny situations pop up to give Dracula plenty of "scream time" when reacting with the other characters.

Animated pictures take a long time in development before completion. Made by Sony Pictures Animation for Columbia Pictures, the film began life in 2006. With starts and stops, the film went through a

series of five different directors. Finally, in 2011, Genndy Tartakovsky was asked by the studio to direct his first feature film. He re-wrote the script and re-shaped the film into his own vision. By November 2011 the part of Mavis was cast with pop star Miley Cyrus. Other assignments conflicted with the film's schedule, so she dropped out. It was a stroke of luck for youngster Selena Gomez because she got the part and does well as the voice of Mavis.

Although the film slows in part of its 91-minute length, other parts are lively and fun. The music enhances the enjoyment, with songs sung by Becky G. and Will I Am. The kids should love it and teens will like the contemporary take on the songs.

ORDINANCE NO.

AN ORDINANCE ADDING CHAPTER 8:30 TO TITLE 8 OF THE EL CAJON MUNICIPAL CODE MAKING CERTAIN ACTIVITIES IN-VOLVING SYNTHETIC STIMULANTS AND SYNTHETIC CANNABINOIDS A PUBLIC NUISANCE SUBJECT TO CIVIL ABATE-MENT AND PENALTIES

This ordinance adopts the City of El Caion Synthetic Stimulants and Synthetic Cannabinoids ordinance, in order to protect the public health and safety within the City of El Caion from the dangers and ill effects of synthetic stimulants, commonly known as psychoactive bath salts (marketed under multiple brands) and synthetic cannabinoids commonly known as psychoactive herbal incense (most commonly marketed as "Spice" or "K2"), by declaring certain activities involving these drugs to be a public nuisance and subject to all available civil remedies.

Synthetic stimulants and synthetic cannabinoids contain dangerous chemical com-pounds designed to mimic the psychotropic effects of illegal stimulants and hallucinogens such as cocaine, methamphetamine, LSD, ecstasy and marijuana, vet are manufactured in a way to avoid triggering the Federal Controlled Substances Act.

The ordinance declares it a public nuisance for any person to distribute, sell or possess with the intent to distribute or sell synthetic stimulants and/or synthetic cannabinoids, and further declares it a public nuisance to possess synthetic stimulants and synthetic cannabinoids when such possession injuriously affects any person or persons, other than the person in possession, in such other person's or persons' health, safety, welfare, or comfortable enjoyment of life or property. In addition, this ordinance subjects any person maintaining this type of public nuisance to civil penalties up to \$2,500.00 for each day the nuisance is in existence



Ralling from the ranks of the unbeaten, the (2-1) San Diego Chargers trudged off the field at Qualcomm Stadium last Sunday after losing to the (3-0) Atlanta Falcons 27-3.

From both sides of the line of scrimmage, time of possession, yardage, and ultimately points, the Atlanta Falcons did to the Chargers what the Chargers did to the Titans a week earlier. Totally dominate a game.

starting lineup after sidelined by injuries, tight end Antonio Gates appeared to be back to form running his routes and getting open downfield. Catching three passes for 23-yards, Gates reminded Chargers fans he still has perennial Pro-Bowl skills.

Fully mended from a broken clavicle suffered in the first exhibition game, Ryan Mathews also returned to the starting lineup, gaining 44-yards on 10 carries. He also caught five passes for 32-yards.

What both players did not do was to hold onto the football, losing it at critical times. Gates dropping a sure touchdown pass from Rivers early. Mathews fumbled away the ball in the second quarter on a first and goal at the seven yard line. Both stifled potential rallies killing any home team momentum.

Constantly rushed, hurried, and harassed all afternoon, although sacked only once, Chargers quarterback Philip Rivers had his hands and face full of Falcon defensive pressure. For the first time in his career at the starting quarterback, and for the first time in 151 consecutive contests, the Chargers offense did not score a single touchdown in a game.

In what may have been his worst game ever, Rivers finished with a dismal 42.5 quarterback rating after completing 21-of-38 passes, throwing no TD's, and two interceptions.

An obviously disappointed Rivers was positive in his postgame statement. "We're excited about what we can become, but we're not there yet. We can only control what happens this week, and we have to go get ready to be our best," he said.

Jackie Battle and the running game of the Chargers woke up again in the fourth quarter, after busting off a 52yard run late in the game.

Atlanta defensive safety Thomas DeCoud had a field day collecting three turnovers. The former Cal State Bear intercepted two Rivers passes and pounced on a Chargers fumble.

Defense for the Chargers was a non-factor, allowing the Falcons offense 384 yards of total yards, 275 of them from Atlanta QB Matt Ryan's arm.

There wasn't enough of Chargers 2012 draft pick Melvin Ingraham and his disruptive rushes. Bolts special teams blundered on a rare Mike Scifres shanked punt of 29-yards, leading to a Michael Turner late touchdown.

The Kansas City Chiefs coming off a huge win will host the Chargers at tough Arrowhead Stadium. Game time 10 a.m.


