Santee Chick-fil-A surpassing its goals

fter watching the enormous crowds that started frequenting the new Chick-fil-A in Santee the minute it opened, it's no surprise that the business is thriving.

"We're still holding strong in the top 10 percent in the nation," operator and owner Nathan Knecht said. "We've seen proof that Chick-fil-A loves Santee and Santee loves Chick-fil-A. This area is the right demographic for Chick-fil-A."

The Chick-fil-A Corporation is aware that new stores have erratic sales during the first few months Knecht said. "They are more focused on our quality of product and customer service," Knecht said. "They monitor our customer scores through the surveys from the customer receipts."

Knecht said the company allows a few months for the

new business to settle into a routine before they begin to see a growth in sales. "They do want to see some profitability," he said. "So we need to keep our labor and food cost in line with the averages in the industry and make sure we're being good stewards of the finances."

One thing Knecht wants more focus on is the breakfast menu at Chick-fil-A. "We have the most delicious breakfast type for this time of day and these items are not on the menu during the rest of the day."

Chick-fil-A will start offering samples of the breakfast items soon during the day from 6:30 - 10:30 in the morning.

"Dan Cathy is making some new changes," said Knecht. "This week the restaurant will be rolling out some new menu items, mainly redoing all of our salads. He wants to broaden our appeal to the crucial Millennial market." Now, nearly a year later, the Atlanta chain — which surpassed KFC last year to become the nation's largest domestic fast-food chicken chain, with sales of \$4.6 billion — on Tuesday will announce detailed plans to try to broaden its appeal to the crucial Millennial market, whose business it will need in order to continue broadening its national and, ultimately, international growth plans.

The new salad lineup will focus on fresh ingredients such as greens, blueberry's, roasted pepper blend, blue cheese crumbles and with warm sliced chicken on them. The brownie is leaving as the fresh baked chocolate chip cookies are more popular. Cathy is also having all of the company's 1,700 restaurants to offer instant back-of-the-house tours for curious customers.

"These will start in a few weeks and most likely be midafternoon around 2 or 3 p.m.," Knecht said. "Customers just need to sign up for them."

Knecht is settling into a routine in his new business. He's already passed the biggest challenge he faced which was hiring and training. His crew is finding what job suits them best.

"I'm pleased our speed of serving has gone up considerably," he said. "That's good as we don't want anyone to wait. We have great managers and our sales are 50 percent higher than we anticipated."

The Santee Chick-fil-A is already working with schools, sports teams and charities for spirit nights where they can give flyers to participants and

California Native American Heritage Commission declares Ocotillo Wind Project area a Sacred Native American site

he California Native American Heritage Commission (NAHC) has declared the Ocotillo Wind Project area in Imperial Valley a sacred Native American site. The determination came yesterday afternoon following hours of testimony from Southern California tribes, impacted community members, conservation organizations and representatives from Imperial County and the project developer, Pattern Energy. The lead agency on the utility-scale wind energy development, the Bureau of Land Management (BLM) failed to appear at the hearing to defend its record.

Among those submitting testimony on behalf of the tribes were representatives from U.S. Congressmen Juan Vargas and Duncan Hunter, and California State Senator Joel Anderson.

Following hours of testi-

mony, the Commission voted unanimously to declare the Ocotillo Wind Project area a sacred Native American site afforded protections under section 5097.9 of the California Public Resources Code, and asked for assistance on enforcement options from the California Attorney General's office.

The Commission determined that the BLM failed to engage in federally-required meaningful consultation with affected tribes, and that the BLM's development partner, Pattern Energy, failed to mitigate significant negative impacts on documented historic Native American cultural resources.

The Ocotillo Wind development project is located in the sensitive Ocotillo Desert in western Imperial County and includes 112 massive turbines, each with a blade sweep larger than a football field, and a height of 450 feet, which is taller than most

skyscrapers in downtown San Diego. The BLM's own archeologists declared the project area a cultural resources "mega site." Hundreds of significant Native American cultural resource sites have been documented, including cremation sites, petroglyphs, geoglyphs, ancient villages and prehistoric trails.

Viejas Tribal Chairman Anthony R. Pico commended the Commission for its careful deliberation and objective assessment of evidence submitted by all involved parties. "It is gratifying to finally get a fair and objective hearing, after years of having Native American concerns dismissed by the BLM and their development partner, Pattern Energy. While we support renewable energy, Ocotillo Wind is clearly the wrong project in the wrong location. We express our gratitude to Commission members for recognizing this travesty and we hope that their ruling helps prevent similar situations from occurring on future development sites.



few months back I was so sick I had to go see the doctor. That alone indicates the condition was rather serious. I do not like going to the doctor because you have to sit in the waiting room with sick people. I never know what contagious diseases are lurking in the shadows of that doctor's waiting room.

After a few days of this, I was able to stay in the conscious world a little bit longer and consequently I was watching TV a little bit longer. The thing I found about TV is that TV dominated by chatterboxes.

Actually, it is all three. Part of our divine inheritance is the power of faith. It is our great work in life to learn to put it in the right place—God, Good and Spiritual Principles, not in fear or in the problems or the difficulties but in the great possibilities because of who we really are and whose we are. Faith comes to us as a seed. Jesus termed it a mustard seed. It is our privilege to nurture it through acting on it. It is a developed skill. And, it is an experience. For Health's Sake

New approach to hip replacement surgery a success for local man

hanks to the outstanding weather in Southern California, David, a 57-year old resident of Rancho San Diego, could often be found outside walking his dog, playing golf or soaking up the sun. His active lifestyle included plenty of time at the gym as well, but little did David know that a single pain a few years ago would force him to the sidelines and result in two hip replacements.

It started when David awoke to a sharp, stabbing pain and stiffness in his left hip. Thinking it was a case of bursitis, he took some over-the-counter pain relievers and tried yoga but the discomfort worsened to the point that he developed a severe limp, was unable to sit for extended periods and could not put on his shoes and socks without doubling over in agony. An MRI revealed a lifealtering diagnosis: avascular

necrosis, a condition whereby the hip bone dies from a lack of blood flow. A hip replacement was all but inevitable.

David's quality-of-life was in disarray as his balky hip made it difficult to deliver presentations at his job and he quickly gave up all physical activity. Nine months after his ordeal began and walking with a cane for support, David contacted Dr. Harbinder Chadha of LSC Orthopaedics at the recommendation of a co-worker.

"Although Dr. Chadha prepared me for it, I couldn't believe how quickly I recovered from the procedure," said David. "I never imagined that my second hip replacement would go even better."

Although David was under the impression that his right hip was unaffected by the avascular necrosis, he felt the familiar discomfort take hold in 2012. Once again, he was left virtually immobile and once again, he paid a visit to Dr. Chadha, who scheduled another SUPERPATH "Total Hip Replacement surgery.

In July 2012, David received a new right hip via the SUPERPATH™ technique. Going in, David had merely hoped to repeat the positive experience from his earlier procedure in 2010, but he was amazed at the chain of events following his surgery.

"I was wheeled into the recovery room at 10 a.m. and just one hour later, I walked unassisted to the bathroom," said David. "That afternoon, my doctor informed me that there was no need to spend the night in the hospital. I was discharged at 5 p.m., nine hours after I underwent hip replacement surgery."

David's recovery progressed quickly: he was doing light exercises in the gym after one week and completed physical therapy in one month. By the end of September, he expects to be teeing off.

"I can't say enough about Dr. Chadha," concluded David. "Never in my wildest dreams did I anticipate such an easy recovery. I hope that anyone who needs a new hip will consider SUPERPATH™."

Sneak Peek of Sage & Songbirds Garden Tour

hey began watering their new garden just as they had successfully done with all of their other planted areas

The only problem...this was a succulent garden that Lynn and Mendi Wyatt had planted.

When a few plants started looking bad, Lynn gave them more water. The worse they looked, the more water he dumped on them.

"I proceeded to drown them!" he laughed. "You have to make a mental change to water these plants less

The Wyatts have been creating and planting new garden areas on their Alpine property for the past 11 years.

It was a rock that initially made them decide to purchase the lot on which their dream house now sits. But this is no ordinary rock...

It is a gorgeous, moss-covered boulder, perched on the edge of a knoll with a million dollar view, and it was love-atfirst-sight.

Today, it is a keystone of Lynn's rock "fort", one of many rock and boulder creations on the 1.5 acre lot with a bounty of boulders.

Capitalizing on the treasure they had, the couple began building rock walls to retain soil and create planter beds when they first moved in to their custom-built Alpine home. And they haven't stopped!

Single-handedly, the two of them cleared and hauled away a huge hillside of brush, and discovered and uncovered literally hundreds of tons of boulders along the way. Long flat rocks were elevated on smaller stones to serve as benches.

The Wyatts planted each new area as it was created.

"We know where every rock and bush is on this property, Lynn said, "because we either put it there or had help putting

"We started small and it just got bigger and bigger," he said.

Many lessons were learned along the way. The Wyatts stuck with the things that "worked," and nixed what didn't. As with many folks just starting a garden, they put in a lawn and sprinkler system.

Neither of those "worked," Lunn said. Rabbits ate the lawn and the sprinkler system wasted water and resulted in high water bills, Mendi added.

The lawn was removed and replaced with more droughttolerant plants, and drip irrigation installed for watering them. That "worked," they said.

A recirculating water feature with falls and creeks was installed by Bob Graham, and that "worked", Lynn said, so they hired him to solve a mud slippage problem on a dirt

Using river rock strategically placed over weed cloth, he not only solved the erosion problem, but Mendi was delighted that the area can now be weeded in a few minutes, rather than several hours it previously took.

Learning to deal with high winds was another challenge the Wyatts faced. An outdoor flagstone patio with wrought iron gazebo ended up as a total disaster when the wind completely destroyed the metal structure, and rainwater flooded the flagstone.

The flagstone was replaced with a raised cement patio (with hidden bilge pump to divert the water), and a sturdy patio cover was constructed by The Patio Man. Outdoor kitchen components now make the area as functional as it is attractive.

The reclaimed flagstone was then used to start a path into a new area of the garden--and a whole new plant palette for the Wuatts. This was the start of their succulents.

Mendi said she loves that they are the perfect accent to their boulder-filled landscape.

"They are pretty, too," she said. "I never realized the colors they have!"

With the realization of the rock and succulent compatibility, the Wyatts are on a new roll. They are forging additional paths along the outer perimeter of their property, where the incredible views are unobstructed, and the boulders can flaunt their grandeur.

"The paths give us a chance to come out for a walk in the morning with a cup of coffee. or in the evening with a glass of wine, and enjoy it all," Mendi

Visitors will certainly share in Mendi's sentiment. Theirs is Garden #3.

Great production value and action in 'Oblivion'

aunty Tom Cruise is saving the world again in Oblivion. It's difficult to review a movie that baffles from the start, and not being able to figure out the plot right away - and actually never really "getting it" until way into the film - and then not completely.

The earth has been invaded by aliens called Scavs. They destroyed the moon and blasted it into chunks that look like blue cheese on a serving platter. They float around the sky in place, never seemingly escaping from the moon's gravity. The earth, too, has been blasted to smithereens. It's either a professional nod to Planet of the Apes production designers, or Universal got the left-over sets on the cheap. We see the venerable Art Deco Empire State Building sticking out of the mud, but Charlton Heston wearing his torn designer loin cloth is nowhere to be seen. Cruise has taken over the building and uses it for his own purposes. His job is to destroy all remaining aliens. He doesn't have to worry about any "filthy" apes.

Russian-born beauty and Parisian fashion model Olga Kuryenko makes a terrific entrance by crash landing in a rocket encapsulated in a sleep module that was launched 60 years ago. All those magical unquents and salves previously used as a model came in handu because she doesn't have a wrinkle after all those years festering in the compressed air of the capsule. Voila! Tom thinks she looks familiar and he dreams about her when they met in New York before the invasion. Tom gives her a crinkled-eved look of affection in a huge stretch of method acting. But who is she?

Cruise works in tandem with Vika, British actress Andrea Riseborough. Vika monitors his space shuttle as he careens around earth fixing drones that are supposed to be destroying the aliens. They are under the command of Sally (Melissa Leo), who only communicates from a remote satellite via video screen. Leo uses a honey-sweet accent (sounds like Tennessee) to convey both charm and terror, and she's terrific at never veering too far either wav.

Obviously, it was director Joseph Kosinski's intention to make the film mysterious, but hopefully he merely slipped off the camera boom, hit his head, and made it incomprehensible instead.

He had practice earlier by directing Tron: Legacy, and his sci-fi sensibilities carry over to this highly stylized depiction of the future in 2077. Although he wrote the script with William Monahan, Karl Gajdusek, and Michael Arndt, he must have dropped a few pages on the floor before filming started and didn't notice the gap in the plot.

It's a good thing we have Cruise around to always be there when we need saving. All his pictures have one aspect of his being the tough, eager, and capable leader and savior for just what ails us. And those teeth! He's a walking advertisement for a visit to your dentist. Simply stupendous.

Production design (Daren Gilford) on the film is superb The futuristic sets are the latest in industrial minimalist chic. Cruise's aerie is set on a tall pole into the mountain above the clouds. Famed architect Frank Lloyd Wright's dictum that houses should be "of" the hill and not "on" the hill were ignored. So much for organic

architectural integrity. Cinematographer Claudio Miranda of Life of Pi goes in the opposite direction with this by the use of non-color and only splashes of subtle hues for effect. Costume Designer Marlene Stewart keeps things simple for the ladies so that the designs could be from any future century.

Oblivion is a beautifully made film technically. Computer nerds will want to see if electronically-generated scenes can be distinguished from the real thing. Character development is sparse, so emotional involvement is light, although one can sympathize during the proper moments. It's basically an action movie, and an awfully good one at that, if you want to know the truth.

he Reuben H. Fleet Science Center is more than a destination. It's informative, intriguing, with a huge focus on children and science, a great place for families; its Planetarium is eye popping and the IMAX theatre is known for presentating visually exciting and entertaining films.

Rocky Mountain Express is currently showing on the huge IMAX screen and is spectacular. Imagine learning about historical steam trains that were part of the completion of the Canadian Pacific Railway (CPR) in 1885. This endeavor to complete one of the greatest engineering feats in history is part soap opera, romantic memoir and thrilling drama.

Award-winning filmmaker Stephen Low pulls out all the stops to present this production in vivid reality using spectacular IMAX aerial cinematography, archival photographs and

maps. Anyone who has heard the whistle of a steam locomotive roaring down the rails with a blast of white steam from the burning coal decorating the sky will feel that same tingling while learning the surprising difficulties this Railway expe-

The completion of this project ranks among the greatest engineering feats in history. Thousands saw this as a great job opportunity and many lost their lives in their efforts. The huge mountains they had to get through over or around were as iffy as sending man to Mars. But American railway superintendent William Cornelius Van Horne never took no for an answer.

Spanning thousands of miles and some of the world's greatest natural barriers, the CPR's grand transcontinental project and its wandering ribbon of steel drew together far-flung communities isolated in the

wilderness, shaped a new nation and changed the face of the North American continent forever.

With a full 15/70 negative world's largest film format - and rendered in six-channel sound, this story will definitely enthrall those who get into the specifics, but also visually inspire. There's a reason this film has won multiple awards. The scenery of the lakes, bridges, mountain tops and beautiful skies are as picturesque as if being right there in person to see them.


Low's extraordinary 30-year career creating films draws on his expertise and love of highfidelity cinema.

This story kind of mirrors today in that many people face obstacles in what they want to do and what they have to do. "Exactly," Cook said. "I see him as a punk kid who finds what he really wants to do and goes for it, and it changes his entire life."

but Billy Elliot the Musical is still his favorite show. He plans on making the stage his career.

"I like being with everyone in our company, we're like one big family," Cook said. "I really like when the audience claps and cheers. That's just awesome, and makes all the hard work well worth it."

advisory capacity to the city council and the city manager; shall make recommendations to the city council and the city manager with respect to military veteran related issues, ceremonies. events and activities that occur within the City shall provide a forum for discussion of issues relating to military veterans; provide advice and assistance to City residents when requested regarding resources available to veterans' spouses and dependents; and shall act as a conduit of communication and coordination between the local military veterans' community and the city of El Cajon.

SECTION 4: Section 2.24.410 of Chapter 2.24 of the El Cajon Municipal Code is hereby added to read as follows:

2.24.410. Administrative services.

The recreation department shall provide staff support to the veterans' commission as needed.

SECTION 5: Section 2.24.420 of Chapter 2.24 of the El Cajon Municipal Code is hereby added

2.24.420. Membership-Residency and appointment.

The veterans' commission shall consist of five members. Not less than four members must be residents of the city at the time of applying for the commission and who shall continue to reside in the city during their term of office. The fifth member may be a non-resident provided, however, that the non-resident member is at all times qualified as set forth in subsection

B. In order to have a broad representation of the various military veterans' issues and groups in the city, three members of the commission must be honorably discharged from the armed services, and an active member of one of the following veterans' groups:

- 1. American Legion, Post 303
- 2. Veterans of Foreign Wars, Post 2275
- 3. Navy Fleet Reserve Association. Branch 47 4. AMVETS. Post 17
- 5. Marine Corps League Detachment, Post

C. In addition to the members designated in subsection B of this section, one member of the commission must be honorably discharged from the armed services, but need not be an active member of a veterans' group identified

in subsection B

D. In addition to the members designated in subsections B and C of this section, one member of the commission must be in active service or a reservist with the armed forces.

SECTION 6: This ordinance shall be effective thirty days following its passage and adoption.

Putter most important club

A good player who is a great putter is a match for any golfer. A great hitter who cannot putt is a match for no one.

Ben Sayers

The putter is statistically the most important club in the golf bag. No other club is hit, or at least planned to be hit, on every hole. In a par round, up to 50 percent of the strokes could be putts. I also contend that it is psychologically the most important club in the bag. How many fist pumps are seen after a drive in the fairway or a green hit in regulation?

Because of the importance of putting, there should be an equal importance placed on putting practice. A quick search of the web will show that there is an abundance of putting training aids. Many of these training aids focus on the technique of putting (ball position, body position, putter path, etc.) rather than the results of putting. Other training aids focus only on the results without any feedback to help correct flaws (i.e. putting mats). The Putting Fork Pro, on the other hand, can do both. The speed required is subjective to you or controlled by others. It is subjective in that it is your decision on how to play the shot. Do you want to ram it in the back of the hole? Do you want to 'die it into the hole?' Everything else is controlled by others. Is the green fast or slow? Is the putt uphill, downhill, or sidehill? You get the point.

So that leaves the line. Can you hit the line necessary to make the ball 'intersect' the hole at the speed you select? Can you repeatedly hit it? That is where the Putting Fork Pro comes into play. The Putting Fork Pro is the only tool that gives you instant feedback on


