Lakeside Round Up of Events

akeside Fire Protection District Division Chief Jim Kirkpatrick, offered thanks to Eucalyptus Hills homeowners for their patience during the fire training activities in the hills. Heartland Training Facility has been conducting annual refresher training exercises in their El Cajon classroom and field training along the streets and roads of Eucalyptus Hills.

Eleven Heartland strike team cities, districts, and tribal areas participated in the training exercise. Teams broke up into groups of six. Each person represented what would be an engine during a real fire incident. Teams met with instructor Doug Naylor, a retired Fire Captain from El Caion at the Eucalyptus Hills old school at the top of Valle Vista. There they simulated an active fire heading out of Muth Valley toward Eucalyptus Hills heading from Muth Valley to Hwy 67 with an estimated time of 1 to

 $1\,\%$ hours where it is expected to jump HWY 67 and head into the hills. The team was given 45 minutes to form an Intel plan and advised there would be two aircraft with a no divert. The teams then headed out in groups of six.

There are three categories of protection in accessing a home; non-threatened, threatened defensible and non defensible. The teams accessed water sources, access, stay behinds (elderly and those who stay behind during an evacuation), locked gates and tree-lined drives with power lines. People with locked gates should put in a Knox lock which will allow access by firefighters. Power lines are a big issue. Firefighters may go in on a road with power lines and trees along the road and become trapped when the power lines ignite and go down.

When the firefighter teams met back at the school with the instructor they reported what conditions they found and how well they felt the homes could be defended. As part of the training the instructor asked questions including what they would do if one of the firefighters became separated from the others. After some discussion the answer was honk the horn. The instructor pointed out that what can go wrong will go wrong; so it's important not to get tunnel vision but to rely on their training. This was a key to the importance of having annual refresher training. Training in

Eucalyptus Hills will continue until the end of May.

Sheriff's Sub-station

Captain Lisa Miller of the Santee Sheriff's station said the search for a sheriff sub-station in Lakeside has narrowed to two locations. While not ready to publicly announce the two locations, she said they both have the pulse of the community. The final location and hopefully an opening will be finalized within the next year.

Centennial Moment: End Horse Racing on Main Street in 1914

Below is an excerpt from a brochure published in 1961 in honor of the City's 50th anniversary of incorporation: "50 Years of Progress." The brochure chronicles events in the City by each year, from incorporation in 1912, through present day, at that time, in 1961. This Centennial moment focuses specifically on the year 1914.

John H. Dodson, who had been the postmaster of El Cajon from 1895 until 1901 when he turned the office over to J.G. Burgess, took up the duties as Justice of the Peace. This year Dodson resumed the duties as postmaster.

During the time that Dodson had been Justice of the Peace, he brought the end to horse racing down Main Street from Lincoln Avenue to Magnolia Avenue. He made the statement that it made it dangerous to women and children crossing the street to get their mail

in Browder's Drug Store. He bluntly told everyone who took part in such sports, in the future if he could catch them, would be fined \$3 each. And that was alright with him as that money would go into his pocket. The Trustees asked the Board of Supervisors for a rifle and 5,000 rounds of ammunition so that the City Marshal could back up his authority.

An electrical lighting system was established by the board to

illuminate the streets at night. Nineteen street lights were proposed, to include that area bounded by Washington Avenue, Claydelle Street, Orange Avenue and north on Magnolia Avenue to the bridge.



Nonmelanoma skin cancers can be dangerous, disfiguring and deadly

ccording to The Skin Cancer Foundation, an estimated 3,170 deaths from nonmelanoma skin cancers will occur in the US in 2013

May is Skin Cancer Awareness Month, and while the dangers of melanoma are well known, it is important not to neglect the warning signs of the two most common types of skin cancer: basal cell carcinoma (BCC) and squamous cell carcinoma (SCC), which can also become disfiguring and even deadly if not diagnosed and treated promptly. Because about 90 percent of nonmelanoma skin cancers are associated with exposure to ultraviolet (UV) radiation from the sun, The Skin Cancer Foundation encourages everyone to practice proper sun protection and learn how to spot nonmelanoma skin cancers.

"Melanoma is the most talked about skin cancer because it's the most deadly; however, basal and squamous cell carcinomas should be taken seriously as well," says Perry Robins, MD, President of The Skin Cancer Foundation. "Most nonmelanoma skin cancers are preventable, if a complete sun protection regimen is followed. This is why protecting sun-exposed areas, such as the ears, nose and lips, and learning the warning signs of these common skin cancers, is so important."

Between 40 and 50 percent of Americans who live to age 65 will be diagnosed with either a BCC or an SCC at least once. The Skin Cancer Foundation urges everyone to learn the

facts about nonmelanoma skin cancers:

Basal Cell Carcinoma is the most common form of skin cancer, with an estimated 2.8 million diagnosed annually in the US.

What causes it: BCC is usually caused by a combination of cumulative UV exposure and intense, occasional UV exposure, the kind you might experience on sunny vacations.

Interesting fact: BCCs sometimes resemble noncancerous skin conditions such as psoriasis or eczema.

What to look for: Warning signs include an open sore, a reddish patch or irritated area, a shiny bump or nodule, a pink growth, and a scar-like area.

Squamous Cell Carcinoma is the second most common form of skin cancer, with an estimated 700,000 cases di-

resulting in approximately 2.500 deaths.

What causes it: SCC is mainly caused by cumulative UV exposure over the course of a lifetime.

Interesting fact: SCCs are most common in areas frequently exposed to the sun, such as the rim of the ear, lower lip, face, bald scalp, neck, hands, arms and legs.

What to look for: Warning signs include a scaly red patch, an elevated growth, an open sore, or a wart-like growth, and these lesions may sometimes bleed.

To properly protect against the dangers of skin cancer, follow The Skin Cancer Foundation's Prevention Guidelines:

- Seek the shade, especially between 10 a.m. and 4 p.m.
 - Do not burn
- Avoid tanning and UV tanning booths.
- Cover up with clothing, including a broad-brimmed hat and UV-blocking sunglasses.
- Use a broad spectrum (UVA/UVB) sunscreen with an SPF of 15 or higher every day. For extended outdoor

broad spectrum (UVA/UVB) sunscreen with an SPF of 30 or higher.

- Apply 1 ounce (2 tablespoons) of sunscreen to your entire body 30 minutes before going outside. Reapply every two hours or immediately after swimming or excessive sweat-
- Keep newborns out of the sun. Sunscreens should be used on babies over the age of six months.
- Examine your skin headto-toe every month.


