Skatepark becomes a reality

he first fully designed county skatepark will become a reality in Lakeside. The groundbreaking for the skate park – to be named the Daily Disposal Skatepark - was held July 9

at Lindo Lake Park east of the tennis courts.

Dignitaries spoke of the tireless efforts of a core group of Lakeside citizens who never gave up the dream of three dedicated men. Past Chamber

of Commerce president Steve Menefee, said, "The memory and inspiration of Rick Smith, Harold Hilliker and Joseph Caci, who have passed and dreamed for us to have a skatepark, continue to inspire us to get r' done.'

The county will pay for construction of the park and the rest will come from tax dollars. "It's local money coming back to the community," County Supervisor Dianne Jacob, said. The community raised \$65,000

Vietnam helicopter now serving in a different arena

nyone who has seen a huge red Uh-1H Huey Blackhawk helicopter being towed around the county, or been to an event where the helicopter is on

display, usually has questions about what its function is and where it came from.

The helicopter is part of Blackhawk Helicopters, Inc. Silvia Krauss is owner and President of the Company.

She met her husband Ken in 1989. Silvia handles the paperwork and administration aspects of the business in leasing and operating the copters. Ken Krauss is Vice President, runs the daily operation of their three helicopters, and is the main pilot for the Blackhawk, which does most of the heavier lifting jobs the company takes on. The other two copters are under contract with SDG&E to provide power line patrol and construction

Ken Krauss grew up in Los Angeles and went to college in Tennessee before transferring to Christian Heritage College (now San Diego Christian College) in San Diego.

"I was working on fixed wing airplanes thinking I wanted to be a missionary pilot," Krauss said. "When that didn't work out, I transitioned into helicopters.'

In 1987 Krauss went to work on tuna boats and started doing maintenance on helicopters all over the world. He began buying helicopters and soon was able to offer his services for various tasks

The Blackhawk is certified and able to lift up to 4,000 lbs. on the hook and with an 1800 HP engine, up to 3,500 above

sea level. Some of the tasks of Blackhawk Helicopters, Inc. include: A project on Del Dios Highway clearing Eucalyptus trees and Palm trees in Tecolote Canyon; Assisting with trail restoration on Cowles Mountain by lifting in granite, rocks and materials to be spread on the trails; helping the Park Service in Torrey Pines to clear garbage out of the canyon.

"We've done plane crash retrieval in hard to get to areas; recently retrieved a brand new Jeep a guy in Los Angeles drove off a cliff (he was okay);

set water tanks; and set 230 air conditioner units in Arizona on an Amazon building in one day; and occasionally forestry fire-fighting," Krauss said.

The company trailers the Blackhawk to most jobs because it saves hours of flying time, the cost of fuel, and they don't have to be concerned about the weather. Many of their jobs affect environmental concerns.





Sharing a piece of history

Centennial Moment: Push to widen Main Street and more in 1935



Below is an excerpt from a brochure published in 1961 in honor of the City's 50th anniversary of incorporation: "50 Years of Progress." The brochure chronicles events in the City by each year, from incorporation in 1912, through present day, at that time, in 1935.

The Rotary Club did a good job of campaigning for the widening of Main Street through the City. The work was completed on May 20, when a huge celebration took place. Business was reported almost immediately to show an increase. The City

was making an early recovery from the depression.

Mrs. Lethia L. Knowles passed away this year. She was an outstanding citizen of the community. She had served on the City Council. But perhaps her greatest achievement was the "Knowle's House," a restaurant. Hardly a single real estate salesman failed to end a tour of the Valley for a lunch at the "Knowles' House." It sort of put the topper on the sales pitch, and usually resulted in the sale when the customer was filled with good food. The townsmen equally agreed that it was a good place to eat, especially when "Irish Stew" was featured on the menu.

The City Fathers made a major decision in the advancement of communication in the City Hall when they voted to have a telephone installed.

The Trustees decided on a pay raise from \$75 a month to \$100 for the Chief of Police.

for two years without a lot of disturbance." Krauss said. "Bu not having to take in big bull dozers that disturb the ground cover, it's better for the environ-

Blackhawk's other Chief pilot is BJ Juleson. The company has several full time mechanics, and some part time assistants. Joe Vaine is a driver and in charge of marketing, and does external load operations. Fric Verkouteren is a mechanic and does external load operations. Al Clarkson and Chris Freeman are drivers and do external load operations. Jeremy Murphy and Shawn Hammontree do external load operations. Gabino Favela is principal mechanic. Richard Edwords is the Heavy Lift Operations Coordinator. Edwords has been with Blackhawk for 15 years. He loves his job and says every task they get is an adventure.

"I enjoy when I get to take the Blackhawk out to events," Edwords said. "It's like eye candy. Everyone enjoys seeing it, adults, our military and especially kids. But I like how this is a second life for this helicopter, and I can see in the military service men and women returning from duty they kind of identify with it too,

because they are starting new lives with new jobs as well.

"I also enjoy our team at Blackhawk," Edwords added. "Whether the pilot, water guy, radio operator, safety check person or boss, we all look out for each other and everyone is

In addition to the Blackhawk being a powerful workhorse, it has a prestigious reputation.

"The Blackhawk, a name we gave it, no significance to the military or any other related company, flew in the Vietnam Theater for three years," Krauss said. "It was manufactured in 1964. It was with a company called the Rattlers and Firebirds, an aircraft association of members who served in Vietnam. We bought it in 1999 and made some modifications. It's just as good now as when it came out of the factory. It got shot in Vietnam, so it's a wounded vet.



The least we can do is honor those who flew it over there so we have the names of the pilots on the helicopter. John Meteko was one of the pilots who flew the helicopter in Vietnam and came here one time to fly it

Silvia and Ken Krauss are proud they created a company that serves the community and their faith.

"I look forward to getting up in the morning and getting to the hangar," Ken Krauss said. "There is a satisfaction to this job, but it's not about putting advertising out there, it's more about the helicopter and honoring the guys who serve it. And we have a strong committee with our relationship with God and to conduct business with honesty and integrity. We don't look at ourselves as owners; everything we have belongs to God and our focus is, 'What can we do to honor



At the Movies

'Pacific Rim' — so over the top it dulls the senses

t's really too early to pick the Worst Film of the Year, but we have found it. This is it! *Pacific Rim* wins hands down. *World War Z*, my previous selection, seems like Shakespeare's greatest work compared to this overblown potboiler.

Appealing to the lowest common denominator, this film was made for impressionable boys who love to see things destroyed, squashed, blown to bits, and obliterated. Director Guillermo del Toro has been given a lot more money with a budget of \$180 million. The picture's accountant will have to enter rehab if the film flops.

Let's see... is there a plot? Well, in a cursory way. Some monstrous sea creatures, which look like a combination between a hammer head shark stuck onto Godzilla's body, become a problem. Emerging from a big fissure in the ocean, the creatures are out to colonize the earth and rid the planet of human beings. The war between humans and amphibious creatures begins.

Every action film needs a hero, and Charlie Hunnam (Raleigh Beckett) of TV's hit show Sons of Anarchy fills the bill with his steel-like six-pack and biceps. He plays a washed up pilot who isn't up to snuff on the new robots, but he's an ace when it comes to knowing the old equipment's capabilities.

The over-sized machines need two pilots. His former co-pilot was his brother Yancy (Diego Klattenhoff – there's a name for you!), killed by one of the sea monsters. Because most of the cast is a hightestosterone gathering of all men, the producers threw in a female who could bring in big box office in Japan.

Rinko Kikuchi is Mako, the token "girl" who can barely speak English, looks startled most of the time as if saying "What am I doing in this great big sci-fi movie?!". Guided by mentor Stacker (Idris Elba), she somehow qualifies to pilot one of the ultra-huge robots from the inside. Don't ask. She is so dainty she barely looks strong enough to push one of the levers or peddle furiously with her size-two feet. Because she is a star in all of Asia, she comes through and turns out to be a "boffo" pilot and puts Hunnam to shame. He probably has it in his contract not to star with her again because she steals all his scenes.

What can one say about a film in which the robots and monsters – CGI or not – dominate the screen with grunts, groans, shrieks, and bellowing? Cleverly based on many Japanese monsters, they are called Kaiju. John Knoll and Hal T. Hickel of Industrial Light and Magic were hired to create the visual effects. Unfortunately, the lighting man must have been asleep at the kleig light as so many of the scenes are too dark to see anything.

The action is the core of the film. Accompanying the fighting are the sound effects. Never have there been such ear-shattering noises, crunches, bangs, crashes, and door-slammings. It's painful.

If sound designer Scott Martin Gershin is responsible for


