Centennial Moment: City mail delivery started in 1943



Knox House on Magnolia in El Cajon

Below is an excerpt from a brochure published in 1961 in honor of the City's 50th anniversary of incorporation: "50 Years of Progress." The brochure chronicles events in the City by each year, from incorporation in 1912, through present day, at that time, in 1961. This Centennial moment focuses specifically on the year

The citizens of El Cajon petitioned Postmaster Jackson C. Roether to initiate City delivery throughout the City, Bostonia and several other areas in the vicinity. Roether took the matter up with officials and was able to establish three routes. Route 1 would cover Bostonia and the north side of Main Street. Route 2 was to be

that area covered by the business area as well as several side streets. Then there was Route 3 which covered most of the area south of Main Street, from Pierce Street to the west and out to South Second Street to the east. This picture is of the Knox House Museum, which at one time served as the first post office.

In additional activity: The post of Police Chief was still being changed rapidly. Rex Huffman was offered \$175 a month for the job, but he had hardly settled in the job when he received a much better offer from the County Sheriff's office, and resigned. Fred A. Parrott took over the job at \$200 a month.

The City Council petitioned the Federal Government for a sum of \$7,000 grant under WPA for the construction of the County Library along with City and County offices.

A new fire house was authorized at a cost of \$3,800, provided the money could be partly made up by contributions. The structure was built on South Orange Street.

Most reently the station welcomed former DGTV 10 San Diego Anchor Bree Walker to the station. Walker is hosting a show on the last Saturday of the month, which is broadcast live from the station's Alpine studios on Arnold Way. In additon to the FM signal, the stationcan be streamed at www. themountainfm.com. It is also available on all smartphones and tablets with a download

of the free 'Tunein Radio' application.

The station prepared in advance for the increase with having the necessary equipment on hand and stated that as of late Sunday night, the upgrade was complete and that 107.9 The Mountain was broadcasting at its newly authorized power.

The level payment plan option is available to all SDG&E customers. Upon signing up, SDG&E will project a customer's monthly energy bill based on the average dollar amount of the last 12 bills. Even if energy usage goes up or down, level pay plan customers will pay the same amount each month for the first three months. Adjustments are then made to the monthly payment amount every three months based on actual energy use, but the total energy cost for 12 months is the same whether or not a customer opts in to the level pay option.

"More than 30,000 customers take advantage of the level pay plan option," said Caroline Winn, vice president of customer services for SDG&E. "This is one example of SDG&E's commitment to provide energy options for our customers and support them when they need help paying their bill or simply to make their lives easier.

Customers can enroll online at www.SDGE.com/LPP for the level payment plan or by calling SDG&E at 1-800-411-SDGE (7343). Additional bill assistance programs are also available at www.sdge.com.

Customers who do see a spike in their bills during the summer as a result of their cooling system can also look at new technology to help them reduce their energy use, further reducing costs. For example, new smart thermostats can be controlled from a smart phone so customers can turn on their air conditioning before they arrive home. By doing this, the house cools down at a slower pace and the system doesn't have to work as hard and uses less electricity.

Additionally, customers can learn more about how their home uses energy and view hourly usage by logging onto My Account to view their own energy data and set up a personalized energy savings plan for their homes and

County Water Authority news

he San Diego County Water Authority, in partnership with the City of San Diego, is purposing a major hydro-electrical power project at San Vicente Reservoir to boost the regions' local energy supply now that the San Onofre Nuclear Generating Station is permanently offline.

The initial assessment is expected to cost less than \$150,000, and to be completed next spring. Construction likely would take at least five years. The proposed project at San Vicente is expected to generate between 240 and 500 megawatts, depending on the location of the upper reservoir, projected price differences between peak power and off-peak power, operational constraints and other factors.

The proposed pump storage project could generate up to 500 megawatts, enough power for approximately 325,000 homes. It would require the construction of a small reservoir in the hills above San Vicente along with other facilities.

The County Water Authority act was amended by the state legislature in 1999, enabling the agency to enter the wholesale markets for electricity and gas. It also allowed the Water Authority to sell hydroelectric power generated by the agencies water delivery system to any retail electric provider.

He offers these tips especially for balcony gardeners:

Plant the right plants for the amount of sunlight you have — most herbs and vegetables require six to eight hours of direct sunlight a day. So what do you do if you have just one balcony and it doesn't get that much sun?

take partial sun/shade (three to six hours of sun in the morning or early afternoon) or light shade (two to three hours of direct sun or lightly shaded all day.)

cilantro and parsley (both prefer cooler weather); dill, bee balm, spearmint chamomile. Some light shade herbs: garlic chives, peppermint, rosemary. Some partial or light shade veggies: lettuce, broccoli, green onion, collards, cabbage, peas, carrots, strawberries, beans, sweet potatoes.

surfaces increase the light your plants receive. Plants in regions with short growing seasons usually need the full six to eight hours of light per day.

At the Movies

Interviews with filmmaker and killer whale trainer in 'Blackfish'

abriela Cowperthwaite, a documentary filmmaker, has spent more than 12 years directing, producing and writing documentary programs for television networks including ESPN, National Geographic, Animal Planet, Discovery and History. She became interested in the whales in captivity in 2010 when renowned SeaWorld trainer, Dawn Brancheau, was killed by Tilikum, a 12,000 pound orca.

Blackfish unveils the orca's extraordinary nature, the species' cruel treatment in captivity over the last four decades, and the growing disillusionment of workers who were misled and endangered by the highly profitable sea-park industry. When you see grown men cry because of what part they have played in the whales' captivity - it's almost heart-breaking. Cowperthwaite and ex-SeaWorld -trainer Samantha Berg, agreed to an interview about the documentary and situation of the captivity of the whales.

Q. How did you first get interested in this idea?

GC: I heard about Dawn Brancheau being killed by a killer whale. It was a tragic event I needed to understand. I started reading about it and realized there was so much more about the story than I anticipated.

Q. I understand you had just taken your kids to SeaWorld and felt something was not right about this report, correct?

CG: Yes, I began to peel back the onion and continued to learn things that were revelatory and that began to form the parrative of the film.

Q: Were the other trainers eager to speak about their experiences?

GC: They were a little hesitant to participate in a documentary because it's a controversial subject. But others were ready to go forward.

Q. Samantha, were you hesitant about getting involved in the documentary?

SB: Until February, 2010 it never occurred to me to get involved in anything like this, but after Dawn Brancheau was killed, it was what had me unpack my entire experience at SeaWorld and start to think about what I actually knew.

Q: Were you surprised at what you discovered or finally put together?

SB: After finding out more about what killer whales' lives were like out in the wild in talking to journalists and scientists and whale activists, I began to understand that I had to tell my story.

Q: As a trainer, you had some firsthand knowledge of things, correct?

SB: Yes, because I was one of a few people who was at Shamu Stadium when Tilikum arrived at SeaWorld Orlando in 1992 after killing Keltie Byrne at Sealand of the Pacific in Victoria, British Columbia in 1991.

I knew how management characterized that accident, and then I found out what actually happened. So I had to speak out; I really didn't have a choice.

Q. When you took this job were you informed about any danger by supervisors or management?

SB: I was hired in February of 1990 so Tilikum was not an issue back then. There had been more than 30 accidents in the SeaWorld parks between killer whales and trainers and I wasn't informed about any of them. I started at age 20 and was gung-ho and excited about the job. There was a part of me that didn't want to see these animals as anything but cute and cuddly, and I never thought my life was in danger. When I look now, the information the company provided to us about the animals wasn't complete. It's partly the trainers not wanting to know and management characterizing things in a particular way. Even today, I don't think some of the trainers realize how dangerous this job is.

Q: From watching this film and your unwavering passion and often sadness; I wondered what kept you going on this journey?

GC: Once I learned the truth; my mandate was to tell the truth. I felt I had no other choice. I wasn't looking to "stick it to the man." I almost pushed back against that because I felt

Mother and daughter hash it out in 'Girl Most Likely'

risten Wiig has made quite a name for herself on television, delighting audiences with her unique brand of comedy. She's now expanding her talents to include motion pictures. Screenwriter Michelle Morgan has tailored the script to Wiig's unique delivery and acting chops.

Imogene (Wiig) is a young woman who has a talent for writing. She grew up in a humble home on the Jersey Shore with mom Zelda (Annette Bening). Imogene's background is extremely humble, but the literary scene in New York is more tempting, and she wholeheartedly makes efforts to join it. She has had some minor success and feels she has what it takes to become a good writer.

She has one problem, however, that does not speed her career along. Her confidence is shot and she struggles with her lack of ambition. Wiig can make depression look funny as well as sad. She does that in scenes that make us laugh at her predicament and then get tears worrying over her failures. And there are times we want to smack her upside the noggin' and say the classic Cher line, "Snap out of it!"

Someone you do not want to smack is Bening as Wiig's modern mother. Her every appearance on screen is a light beam of joy and talent personified. Bening has been nominated for an Oscar® and should have a dozen of them on her mantle.

As Imogene's mother, she's addicted to gambling and playing the field with much younger men. Matt Dillon shows up in her bed as George, and it's apparent he's her current "boytoy." Imogene is not exactly surprised, but she doesn't approve of mom acting like a teen-ager.

Lots of laughs here with Dillon; who usually plays a dim bulb. This reviewer has always liked Dillon and feels he deserves bigger and more comedy parts in the future.

Glee star Darren Criss adds some youth to the film as Lee. He's renting Imogene's old bedroom at the beach cottage. He brings some maleness to the household; a commodity sorely needed in Imogene's disintegrating life. In order to take advantage of Criss' musical abilities, Lee works at a dive nightclub in town. With every song he sings and dance he performs, Criss lights up the screen and may have to take Gene Kelly's place in the movies! He's that good.

The film is a breath of fresh ocean air in this summer of blockbusters. It may not be the funniest or the cleverest comedy this year, but it is a welcome look at a family that may have more, and funnier, problems than us.





over on high-rise balconies where the winds can be fierce. Terra cotta allows moisture to escape fairly quickly, which is helpful for people who like to water a lot. Non-porous plastic or glazed pots hold water longer and are better for windy balconies, where soil dries out quickly. Use brightly colored containers to add style and visual interest to your garden.

- Most vegetable plants require even watering - don't let them dry out completely and don't keep them soggy. Apply water directly to the soil.
- · Make sure your containers have drainage holes or a drainage system. If they have an attached tray to catch excess water, don't allow the plants' roots to sit in the water, which promotes rot and fungus. Either empty the tray regularly, or use a design that holds the water away from the roots.

Use the right dirt:

- It's important to use dirt that allows for good drainage. Most edible plants don't like to sit in wet dirt, and soil without good drainage tends to become compacted - a difficult medium for plants that like to stretch their roots out. You can buy a sterile soilless potting mix, a soil-based potting mix, or mix up your own batch using 1 part compost, 1 part perlite and 1 part potting soil.
- Don't use garden soil or top soil, which won't allow adequate drainage.
- On windy balconies, topdress your container with small rocks to keep the soil from drying out so quickly.

Joulus offers one more tip for high-rise dwellers: Rely on self-pollinating plants, or plants that don't need pollination by insects, unless you're willing to hand-pollinate.

"You likely won't see many bees buzzing around the 40th storu." he says.

Don't worry about pollination for root vegetables, like carrots and potatoes. Some self-pollinators include beans, peas, tomatoes and peppers.




