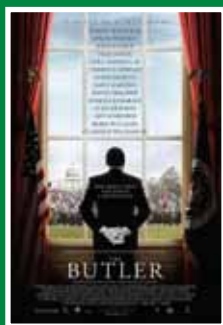

Chancellor Cindy Miles named one of the top community college CEOs in the nation



Chancellor Cindy Miles

Cindy L. Miles, noted for her innovations in education and her caring leadership style as chancellor of the Grossmont-Cuyamaca Community College District, has been picked as the top chief executive officer for two-year colleges in the nine-state Pacific region by the Association of Community College Trustees.

She joins four other regional winners of the annual award from the ACCT, a Washington D.C.-based organization representing trustees at more than 1,200 community colleges nationwide. As the Pacific region's pick, Miles is automatically in contention for the national CEO honor to be awarded Oct. 4 at the 44th Annual ACCT Leadership Congress in Seattle, Wash.

The association's Pacific region includes a total of more than 240 community colleges in nine western states, two Canadian provinces, and three American territories in the Pacific. Regional winners were selected on extensive criteria, including innovative programs, committee memberships, empathy for others, educational publications, history of awards, and outstanding characteristics.

"Our Governing Board was

delighted to nominate Dr. Miles for this prestigious honor and I am thrilled that she is being given the high-profile recognition she so richly deserves," Governing Board President Bill Garrett said. "Our district works well because of the strong relationships that Dr. Miles has built with the trustees, staff, students and the community."

In his nomination letter, Garrett praised Miles for working tirelessly to promote student success; seeking new funding sources during California's severe budget crisis, and her innovation on behalf of community colleges everywhere.

Since she took the helm of the 27,000-student Grossmont-Cuyamaca Community College District in 2009, Chancellor Cindy L. Miles has been widely hailed for leadership, making tough calls during the worst financial period in community college history.

As the state slowly pulls out of the economic quagmire that saw the district lose \$16 million in state funding between 2008 and 2012, and in the wake of the passage of Proposition 30, the governor's tax measure for education, the district's two colleges are gradually restoring the more than 1,600 class sections cut during the worst of the crisis.

It was during this period of economic upheaval that Miles took the lead in promoting the district's own ballot measure, Proposition V, a \$498 million construction bond measure that was approved by East County voters in November, despite naysayers' questioning of the district's move placing the initiative before voters. With the governor's tax measure already slated for the ballot, concerns were raised that a tax-weary citizenry would shoot the bond measure down.

"Dr. Miles took charge of the effort, doing everything from meeting with service groups to working shifts at the call centers soliciting voters – all this was on her own time, in addition to her usual duties running the college district," reads the nomination submitted on Miles' behalf.

The economic downturn also influenced Miles' efforts to strengthen the district's fundraising, recognizing that community colleges needed to seek private funding in addition to state dollars. Instead of two separate foundations for each college that competed for donations, Miles led the creation of a unified organization, the Foundation for Grossmont & Cuyamaca Colleges, that could more broadly and strategically seek donors.

"I am humbled and very grateful for this honor, which I share with all the tremendously hard-working people at both colleges and the district," Miles said. "I'm very lucky to work with Governing Board members who share a common vision of doing everything we can to help our students succeed."

Miles, who in 2012 was the recipient of the Women in Leadership award for education from the San Diego East County Chamber of Commerce, has even had a city declare a special day in her honor. That happened in 2009, when she was lauded by the city of Hialeah, Florida for her leadership as head of the Hialeah campus at Miami-Dade College and her service to the community.

More recently, she served on a steering committee for the American Association of Community College's 21st Century Initiative, formed in response to President Obama's challenge to increase the number of community college graduates by 2020. Last year, she represented the CEOs of the state's 112 community colleges on a committee that selected Brice Harris as the new chancellor of the California Community Colleges.

In the course of 20 years, Miles has served many roles, from faculty member, program director, fund-raiser and researcher to senior administrator at institutions large and small: Paris Junior College, Austin Community College, the University of Texas at Austin, the League for Innovation in the Community College, Community College of Denver, Miami Dade College, and the Grossmont-Cuyamaca Community College District.

A Texas native, Miles received her doctorate in educational administration from the University of Texas at Austin; a master of science degree in secondary and higher education from Texas A & M University-Commerce; and a bachelor of arts in biology from the University of Texas at Austin.

Lakeside Planning Group announcements

Update on Rockcrest Rd. Parking Prohibition (near River-view Elementary). This item was heard at the June and July meetings and was deferred to the county for more information and/or to determine if they would want further input from the planning group. The county reported they have worked with stakeholders and reached a compromise which will remove four parking spaces (instead of the 15-16 originally proposed). The school will communicate with parents to discourage off-site parking.

The county will review a request to re-paint the white stripe on the curve on Industry Rd.

Open-Forum-Opportunity for the public to speak. East County Equestrian Group requested to be on the September agenda.

County Presentation

A. Staff update of the drainage facilities master plan. The county of San Diego presented an update to the Drainage Facilities Master Plan.

B. Lighted Pedestrian Crosswalk on Lakeside Ave. in front of Lakeside Farms Elementary. The installation of an "in pavement lighted pedestrian crosswalk" on Lakeside Ave., 838 feet east of Vista Camino was presented by the county. Forty pedestrians cross in the area each hour according to traffic studies. The cost will be between \$60 and \$80,000.

C. Panwester minor subdivision off Los Coches Rd. tentative parcel map applicant proposes to subdivide the property into four residential parcels and a remainder parcel. After much discussion from nearby neighbors the motion passed with exceptions.

D. Request for letter of support for highway safety improvement program funds to be used for the intersection at Winter gardens Blvd. and Wintergardens Drive to improve access to Wintergardens Elementary. Vote to move forward.

E. Intersection improvement project—Olde Hwy 80 and Pecan Park Lane. Relocate intersection further east for a standard t-configuration. County staff was asking the LCPG to support placing this project on the intersection improvement list. Motion passed to support.

F. Los Coches Rd. substation rebuild—SDG&E presented plans to rebuild the Lake Jennings substation. The existing substation will operate while the new one is being built with hopefully no interruptions said SDG&E representative Don Parent. All construction will be within SDG&E land. The work hours will be Monday – Saturday, 7 a.m. to 7 p.m.

The next LCPG will be September 4 at 6 p.m. at the Lakeside Community Center, 9841 Vine St.

Below is an excerpt from a brochure published in 1961 in honor of the City's 50th anniversary of incorporation: "50 Years of Progress." The brochure chronicles events in the City by each year, from incorporation in 1912, through present day, at that time, in 1961. This Centennial moment focuses specifically on the year 1948. Parking meters came up in the City Council with considerable argument both for and against. A petition was circulated along Main Street, and presented to the Council. It contained 1,223 signatures –

1,179 against the meters and only 44 for them. The matter was tossed out of the Council for good.

Residents of the City requested the County to consider an extension of West Main Street up into Fletcher Hills, and eventually to connect with the proposed Alvarado Freeway.

The Cuyamaca School was completed on South Johnson Avenue.

In January the first two paid firemen were appointed. They were Fire Chief Raymond M. Halgren and Fireman Herbert Teeple. Ten Volunteer Firemen were available. Fire

insurance rates in the City were now set at \$32 a year on a \$10,000 home.

\$108,000 was set as the budget for 1949 and \$1.30 as the tax rate.

Mrs. Maudella Peterson won a City-wide slogan contest with these words, "Dress Up – Clean Up – Cheer Up."

The San Diego Gas and Electric Company announced that 1,540 homes now had electricity.

The thing I forgot was it was Sunday in an Amish/Mennonite community. If you have never been in such a community, let me inform you that on Sunday the only thing open are churches. I had forgotten this little tidbit.

During the week, I made a list of several Amish restaurants. I had plans of visiting each of them before I left and having shoofly pie, a whole pie, in each restaurant.

When I got to the first restaurant, it finally hit me. This was Sunday and everything in an Amish/Mennonite community was closed. I do not usually go to a restaurant on Sunday

unless it is some special occasion. I was a little chagrined to realize everything was closed. This only heightened my anticipation of the shoofly pie delicacy awaiting me come tomorrow.

At times it feels like tomorrow will never come, but eventually tomorrow came and I awoke with a song on my lips, a pang of hunger in my stomach and a desire to indulge in a shoofly delicacy.

I finally arrived at my first Amish restaurant and I was drooling so much I could hardly tell the hostess I was just a party of one. Boy, what a party it was going to be.

Being a gentleman, I contained myself as best I could and ordered a very scrumptious repast. Nobody can cook like those Amish women. Oh, what a lunch I had. I think what made it so wonderful was the dessert expectation hovering over me like an angelic halo.

Just as I was finishing my lunch the lovely young waitress, all dressed in Amish attire, came by inquiring if I would like to see the dessert menu.

"No," I said with a delectable determination, "I know exactly what I want for dessert."

We exchanged smiles. I have no idea what she was smiling about; maybe the anticipatory tip. I knew what I was smiling about; the anticipatory dessert.

I tried to contain myself and

carefully pace out my instructions.

"Young lady," I said as calmly as possible, "I will have a piece of shoofly pie. In fact, why don't you bring me the whole pie." And with that, I smiled

The waitress looked at me rather strangely and said, "What kind of pie do you want?"

Being the kind of person that enjoys a good old-fashioned joke, I responded, "Ha ha ha. A shoofly pie, if you please."

"What's a shoofly pie?"

I can take a joke as well as anybody but there comes a time when all jokes need to be put aside and bring on the shoofly pie.

"This is an Amish restaurant, isn't it?"

"You've heard of a shoofly pie, haven't you?"

"No, I've never heard of such a pie."

At the Movies

Oscar written all over Forest Whitaker in Lee Daniels' 'The Butler'

The first scene in Lee Daniels' *The Butler* starts off with an emotional wallop. Cecil Gaines, a Black man, sits in a chair in the White House waiting for an interview. His mind drifts back to 1926 when a horrible event happened on a Southern cotton plantation where Cecil (Michael Rainey Jr.) was a young boy helping his dad (David Banner) and mom (Mariah Carey) pick cotton.

Now it's 1957 and Cecil (Forest Whitaker) is a grown man, married and with two boys. He eventually landed a job at a hotel where a White House employee (Clarence Williams III) discovered him, which led to Cecil becoming a butler in the White House.

It's an interesting time -- an era of civil unrest -- for the mostly black White House staff. Segregation of Southern Blacks has reached a fever pitch, and groups like the Black

Panthers and Freedom Riders are creating riots.

At work, Cecil is always a quiet servant obeying the first lesson he learned from his supervisor Freddie (Colman Domingo) -- who warned him, "There is no room for politics in the White House, and you hear nothing, you see nothing."

At home, Cecil is not much different. He's always tired, and his wife Gloria (Oprah Winfrey) is lonely and not impressed with his job. She manages to raise their two boys, Louis (David Oyelowo) and Charlie (Elijah Kelly). But then her absence from the party life and lack of attention from her husband results in an affair with a neighbor (Terrence Howard). She also becomes friends with a bottle of booze.

Presidents come and presidents go while Cecil works his way up the ladder. He learned well from the prior head butler (Cuba Gooding Jr.) and his second-in-command (Lenny Kravitz). By now Louis is ready for college. Although mom and dad want him to go somewhere close by, he's appalled at the treatment of the blacks and wants to go down south where he's with his own people. When Louis gets involved with the Freedom Riders and the Panthers, he creates horror for his mom and a never-ending worry for Cecil.

Whitaker gives a tour-de-force performance as the butler and is sure to get attention come Oscar time. As Cecil, he emits nerves of steel, yet with moistened eyes when he must carry a tray of coffee or tea into a room of white politicians who openly discuss their disgust of the blacks as if he's a lampshade in the room. Whitaker also convinces us that his character believes he has no options on the home front. He understands his wife is un-

happy with him — but knows he must keep his position.

When their young son joins the service to fight in Vietnam, it adds another solid wall between Cecil and Gloria. Winfrey plays her part well enough, yet I couldn't stop seeing Oprah every time Gloria was in the scene.

The seven presidents Cecil serves are portrayed by several actors. Robin Williams turns in an amusing turn as Dwight D. Eisenhower; John Cusack is Richard Nixon; Alan Rickman portrays Ronald Reagan (Jane Fonda his wife Nancy); James Marsden plays John F. Kennedy; Liev Schreiber is Lyndon B. Johnson; and Orlando Eric Street plays Obama. Gerald Ford and Jimmy Carter are skipped over in the film.

Most of the casting works with some characters adding a much needed lightness to the heavy subject of racism that is hard to watch. In addition to Whitaker's superb performance, Oyelowo (*Lincoln*, *The Help*) is exceptional as Louis. He must buck his dad's status and ignore how far he's come from working in the cotton fields as a slave to a prestigious job serving the country's leaders. Louis is a die-hard warrior fighting for what he feels is right at any cost, and the price for himself and his family is high.

Adapted from Wil Haygood's 2008 Washington Post article "A Butler Well Served by This Election," *The Butler* is based on the real butler Eugene Allen who served seven years in the White

House. Lee Daniels' (*Precious*) film not only reminds us of a troubled and unforgivable past

history of more wrongs than right, but that there are still some terrific actors in Hollywood.

'Elysium' - an exciting space-fantasy thriller

Starring Matt Damon and Jody Foster *Elysium* brings together two top stars in in a science fiction film by South African-born director/writer Neill Blomkamp. Given a budget of \$115 million - estimated by TriStar Pictures, Blomkamp wrote the script and said "No, this isn't science fiction. This is today. This is now."

The director's outlook is somewhat gloomy, considering the theme of the picture is what happens to earth in 2154. Not a pretty picture at all. The earth is ravaged -- when isn't it in a sci-fi film? -- and living conditions are dreary for the or-

dinary human being. But wait! There's hope for the wealthy! There's a high-tech space station lurking by that is like Utopia. Not only that, but there are miraculous machines that can cure diseases and make everyone like new. Naturally, those lucky enough to have the money to live there do not want any immigrants to clutter up the place. All those who try to penetrate the space station are brutally turned away.

Enter Matt Damon. There has to be a big star to abuse, sock in the nose, and terrorize. After all, the studio has to justify those big bucks they pay him that bloat the budget. Unfortunately, he plays an ex-con named Max DeCosta who has an accident in the factory

where he works. The industrial incident has infected him with cancer that can only be cured by one of the miracle medical machines on Elysium.

No one is allowed on Elysium unless they are citizens of the space module. Naturally, Max is determined to get to the satellite and get cured. He has only five days and will do anything it takes. One attempt is made to kidnap a billionaire (William Fichtner) and steal his identity code to enter the utopian space.

None of this can be done today without voluminous amounts of computer gadgets and lots of wires and switches. Max's best friend Julio (Diego Luna) is the computer nerd, along with the help of Spider (Wagner Moura). In a cringe-inducing scene Max has a computer memory drilled into his head to protect secret codes.

Adding to the complications Max reconnects with his boyhood crush Frey (Alicia Braga) and her little girl Matilda (Emma Tremblay). The girl is suffering from terminal leukemia and must also get to

Elysium for a cure. Braga plays her role as a nurse with confidence and authority. Braga's actions and concerns for her daughter's welfare feel sincere.

Action scenes are liberally sprinkled throughout the film, but there is also some heart peppered within due to the little girl's dilemma and the past that Max and Frey shared as kids. If a normal person endured the beatings, pummeling, and smashing that Max suffers, he would end up in traction for a decade. But Damon comes through with some scratches, a stab wound, and a few bruises. All this after he suffers a brutal attack by a ten foot high robot. Damon must have been sabotaged by the hair stylist after having his noggins shaved to a very unattractive nub.

Oscar® winner Jody Foster is Delacourt, the Secretary of Defense of Elysium, and she's a mean one. She conjures up a coup to rid the space habitat of its president so she can take over. Foster always commands the screen, and this is a good part for her to show her screen power to advantage. Delacourt

does not want Max to reach the station to cure his cancer, so she pulls out all of her power to kill anybody who gets near. Foster is tough, nasty, authoritative, and wonderful in her CEO-type part. It's good to see her after a long break off the screen.

Elysium is actually quite an enjoyable film with good actors. The production design by Philip Ivey (*District 9*) excellently captures the ravaged cities on earth (filmed in the poor sections of Mexico City) and

the beautiful, Beverly Hills-type suburban green areas on Elysium.

The special effects by Industrial Light and Magic and Imagine Engine capture or surpass the best screen images now available. The flying vehicles are advanced in design, yet meet the requirement that they look well-used and rough around the edges. The movie should please all Matt Damon fans, and sci-fi lovers should be delighted.

The Aquarium of the Pacific is the fourth-most-visited Aquarium in the nation and truly worth a two hour drive to Long Beach. Settled right along the coastline; the giant Aquarium features 11,000 animals in more than 50 exhibits. Inside there are exhibits, a variety of multimedia presentations on ocean science and important environmental topics for up-close encounters, and a 4D film.

Kids and family will be so excited to look through a viewing window into the large shark exhibit, and come nose-to-nose with sand tiger, zebra, and

white tip reef sharks, as well as the freshwater sawfish.

The outside Shark Lagoon features more than 150 sharks, and the Bamboo and epaulette sharks glide around the three shallow touch pools, where guests can reach in and touch these gentle and graceful animals.

Whales: Voices in the Sea is an interactive multimedia exhibit and companion website that seeks to bring educational content about the natural history, acoustics, and conservation of whales to aquarium visitors, students, and the general public. There's a Sea Otter and Penguin Habitat.

Fun for all ages is the outdoor Lorikeet Forest where guests enter through screen doors, walk down a winding path lined with a waterfall and trees. The chirping overhead comes from brilliantly colored lorikeets flying about and looking for a resting place, often a guests' hand or head. The 100+ Australian natives of five subspecies of Rainbow Lorikeets measure approximately 10 inches in length and are eager to land on a hand to get a sip of sweet nectar!

Measuring approximately 10 inches in length, lorikeets exhibit a dazzling color combination, ranging from brilliant blues and greens to exquisite reds, yellows, and deep purples. When seen in full sunlight, these beautifully colored birds

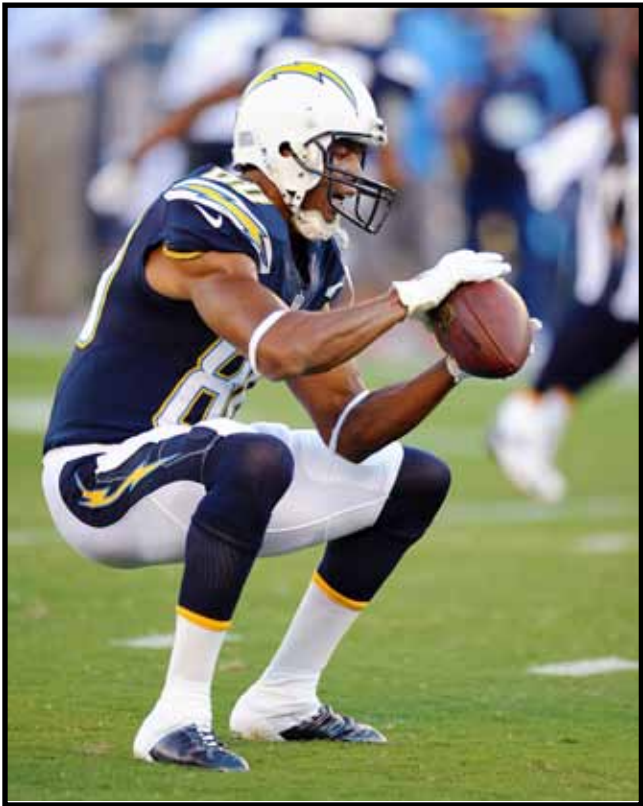
