### Mother Goose Parade a huge success



Chairman Pico then greeted those in attendance and asked for a moment of silence to remember President John Kennedy on the  $50^{\text{th}}$  anniversary of his assassination.

"He represented to all of us his equality for everyone, op-



### Chargers comeback beats the Chiefs 41-38

ike gunslingers shooting it out Bolts quarterback Philip Rivers and Kansas City quarterback Alex Smith (Helix H.S.) exchanged bullets at Arrowhead Stadium KC, MO. in a divisional matchup.

Sharpshooter Philip Rivers under duress delivered a well thrown 26-yard touchdown pass to wide receiver Seyi Ajirotutu with 24 seconds left in the game completing a 7-play, 78-yard drive giving the Chargers the

lead for good in a comeback victory over the Chiefs in a wild shootout, a game with eight lead changes.

Improving their record to (5-6), snapping a three-game losing streak, the Chargers are back in the mix for a playoff spot.

"It shows a lot about the character of this football team. It hasn't been an easy couple of weeks. Some very difficult losses not finishing games," stated Chargers head coach Mike McCoy.

Some call it divine intervention when Rivers connected with Ajirotutu, just his second reception of the season. Ajirotutu two months to the day was given another chance to play and is making the most of it. You may have seen him conditioning himself running the stairs at the SD Convention Center waiting for that phone to ring, which it did from Rivers recommendation. Number #16 of the Chargers is making a name for himself, which by the way means "GOD has done this".

With those eight lead changes in the game, seven in the second half, this was a gutsy comeback for the Chargers on the road. They never quit.

San Diego scored 17-points in the final quarter against a team that had given up 20 points in the fourth quarter to their opponents all season.

After Kansas City lost their two best pass rushers (20 sacks combined) to injuries Tamba Hali (ankle) and Justin Houston (elbow) Rivers pinned his ears back throwing the ball accurately, getting sacked only once late in the game on a DB blitz.

Rivers playing at an uncanny level completed 27-of-39, 392-yards, three touchdowns, no interceptions with a QB rating of 127.3

Recognizing two-deep zone coverage on the game winning

play, the signal caller checked off twice until he saw two-deep man coverage and took advantage of it. The veteran threaded the needle on the TD pass putting it in a position that the receiver could only get, which "Tutu" did.

A great call by the coaches with great blocking, a great pass, and a great catch.

Running back Danny Woodhead was key in the game especially on the winning drive catching two passes then getting out of bounds stopping the clock. He scored two touchdowns in the contest, one rushing, one receiving.

Defensive coordinator John Pagano threw a lot of looks at the KC offense. Defensive back Shareece Wright in a maligned secondary worked his way through a sloppy beginning making a couple key plays in the second half. DL Kendall

Reyes sacked the QB on the last play, a fitting end, giving the team a total of three sacks for the game.

Rookie linebacker Mantai Te'O had his best performance of the season.

The Chargers made the plays they needed to make.

In his first AFC West Divisional win, Head Coach McCoy upbeat and very pleased with his team's performance said, "It's a big team win. We just kept fighting. This was going to be a street fight."

"It's a positive step in the right direction, but we have a long way to go. There is a lot of football left and we are moving on to the Bengals this week."

The Bolts host the Cincinnatti Bengals Sunday at Qualcomm Stadium Kickoff is at 1:25 p.m.


