Kiwanis Clubs participate in 29th annual "Miracle Mile of Quarters" | Lakeside Roundup of Events

n Saturday, May 3, the Kiwanis Clubs in San Diego County will send their representatives to participate at Rady Children's Hospital in the annual Miracle Mile of Quarters (MMQ). The Event starts at 8 a.m., runs through noon, and involves youngsters from Kiwanis Sponsored Youth Organizations, Key Clubs, Circle "K" Clubs, and newly created "Open Class" which includes youths from any Organization such as Boy Scouts and Girl Scouts.

The 50 teams of youngsters will be issued 2000 quarters for each team. They have three hours to complete their designs on one mile of plush red carpet placed in front of Rady Children's Hospital. At past events approximately 350 youngsters participated and 60 or more Kiwanians assisted in judging, feeding the youngsters and over seeing their activities.

The participants are graded on the following: Theme/ Content Style, Creativity, Movement/focal Point/ Composition and Craftsmanship. Each San Diego County Kiwanis Club bring quarters to be used in normally totaling \$25,000 in quarters, checks or cash to benefit Rady Children's Hospital. Plaques will be handed out to the winners and three places will be awarded each Youth Organizations winner.

The Alpine Kiwanis Club brought \$8,000 in quarters in 2013, and will repeat that this year. Later in the year the Kiwanis Club of Alpine will also donate half of the proceeds from "The Alpine Bike Challenge" being held on April 26 in Alpine. To date the Kiwanis Club of Alpine has donated more than \$800,000 to Rady Children's Hospital with funds raised by their MMQ Golf Tournament and the Alpine Bike Challenge.

In 1964 a group of parents got together to figure out a way to build a lighted football field and as a result the El Capitan Stadium Association was formed. That first rodeo was held in a makeshift arena. on a vacant lot, with temporary seating and chutes. It was such a success that the Association decided to keep doing it as long as they had a location to put it on. In 1969, Mrs. Marion Carlson graciously donated 8 acres of vacant land to the group. That land is where the current Lakeside Rodeo Arena is located. Over the years many things have changed on the rodeo grounds and in the Stadium Association, but one thing remains the same; supporting the Youth of Lakeside. Lakeside Rodeo — 50 years of giving back

odeo is a sporting event that pairs man and beast in what is often a very physical contest. For the animal it is a natural environment where he tests his limits against any force of nature or man. For the contestant it is a choice to test his limits against the unknown. At the Annual Lakeside Rodeo they come together in this arena as opposed to the corral, the ranch or the plains. Welcome to the Lakeside Rodeo Arena, with its long and varied history and its undisputable value to the 'Youth of Lakeside."

It all started... on July 5 of 1920 when the first rodeo was actually held in Lakeside. Organized by resident Bill Kuhner, it was held just south of Lindo Lake in a makeshift arena. For several years there was no rodeo, but it returned to Lakeside in 1933, when the "Lakeside Rodeo Association" was formed. The rodeo was moved to an area west of what is now Channel Road, where the organizers built a grandstand, chutes and fences within the days prior to the event, then had to take it all down after the event... only to put it back up for the next rodeo. The Rodeo was held infrequently throughout the next several years, moving to several locations.



El Capitan Stadium Association is created...

In the mid 1960's a group of parents were trying to organize fundraisers to build a lighted football stadium for the El Capitan High School. The parents of students attending, or about to enter the high school. wanted to make sure that the school provided the same level of services as the other schools within the growing district and, with the district building another high school at that time, money was just not available to provide sports facilities for the students of El Capitan High. The totally volunteer group of parents, school administrator/teachers and community leaders, organizing themselves under the title of "El Capitan Stadium Association," eventually met with a long time resident cowboy of Lakeside, Ben Bruton, who suggested once again putting on a rodeo for a fundraiser.

...And Rodeo became an Annual event! The first rodeo for the newly formed Stadium Association was held in the spring of 1964. There were no rodeo grounds, so Ben found temporary seating, chutes as well as fencing and put on a rodeo in a vacant field much like it was done in the past. The event was successful enough that the Stadium Association decided that they could do this every year as long as they had a place to hold the event. In 1966 the El Capitan Stadium Association was formally incorporated as a "not for profit" organization.

An incredible gift to the youth of Lakeside...

In December of 1969, Mrs. Marion Carlson approached the organization and gifted 8 acres of vacant land, the current site of the Rodeo facility, to the group for fundraising for Youth and to hold the Rodeo.

Through the years, members (volunteers) left and new members (volunteers) joined, but the group remained focused and completed the building of the football field, lighting, bleach-

ers and concession stands for the High School. Along with the school improvements, the group started working on building the Lakeside Rodeo Arena as a permanent fixture in the community. During that time, the Stadium Association began the annual leasing of a portion of the rodeo land to the Grossmont Union School District to allow El Capitan High School to build and maintain an Agricultural Department in East County and in 2012 Grossmont Union School District gained ownership of that area to remodel and proudly create an outstanding Agricultural education center.

The 1980's were busy for the Stadium Association. The Eastern San Diego County Junior Fair had been held for decades at Gillespie Field, but was asked to relocate. The Fair Board and The Stadium Association got together and went to the Grossmont Union School District, where they asked to lease a piece of land directly behind the now existing Rodeo Grounds, next to the track. That lease was fully granted to the Stadium Association and then the Association sub-let to the Fair Board for the "Jr. Fair" to be held on-site each year. The annual "Jr Fair" is the gateway to the San Diego County Fair for livestock and Home Arts Youth Exhibitors.

In the late 1980's the El Capitan Stadium Association felt that the high school was not the only entity in the community that needed their help. The Association changed their Constitution to benefit the "Youth of Lakeside." To date, there is probably not a Youth organi-

zation or school within Lakeside's boundaries that has not enjoyed a substantial financial support from the Association. Youth sports has acquired improvements to their individual fields, equipment and outfitting in uniforms of their teams. The members assisted the Eastern San Diego County Jr. Fair in building their current facility and each year we continue to financially participate in the Fair auction to help the FFA and 4-H participants sell their individual projects.

Current donations

Fiscal year April 2013 to January, 2014 the ECSA recorded \$104,000 in monetary donations to the Youth to date. In addition, ECSA provides over \$20,000 in annual scholarships to graduating seniors and encouragement scholarships to eighth grade students to keep them focused on completing their education. Special needs summer programs are funded as are playgrounds at schools, gardens grown by students and desperately needed text books the District cannot afford. Reading Is Fundamental book giveaway, Our Town, <u>Every 15 Seconds</u>, journalism classes, auto mechanics, drafting, computers and fiber networks along with printers, Breakfast with Santa, Boy Scouts, student leadership and countless other needs are met by the Association.

Today's membership

Of the original Association members, only Jodi Hostetler Bruton (Hugo, OK) and Jimmy Rymer (Julia, CA), remain. Jimmy still participates and donates his time each year as Santa for the Annual Breakfast with Santa celebration. The majority of today's members have been active over 20 years and new members are always encouraged to join.

After 50 years, the Association proudly remains a totally volunteer group of concerned citizens who are willing to consistently dedicate a hours and labor at the grounds to raise funds and to ensure that the Youth of Lakeside receive every advantage possible for a bright future in education, sports, the arts, as well as social and community groups.

mericans have been Δ buckling up for years, and for good reason. The proper use of lap and shoulder belts has been shown to reduce the risk of fatal injury to front seat car occupants by 45 percent, while reducing their risk of moderate to critical injury by 50 percent. Further research has shown that unbelted rear seat passengers increase the death rate of front seat passengers by up to 5 times.
