SDG&E's modification of restrictions on work hours on Main Avenue undergrounding project in order to shorten the duration of construction. El Cajon Police Citizen's **Academy begins March 19**

The El Cajon Police Department is now accepting applications for the 2014 Citizen's Police Academy. The Citizen's Police Academy is a 10-week program that allows members of the community to learn how their police department functions. Students will attend weekly classes and learn about topics that include: the history of law enforcement, the criminal justice system, and crime scene investigation. Students will see presentations from the various divisions within the Police Department and participate in hands-on exercises, such as conducting traffic stops, dusting for fingerprints, and a firearms simulation.

The academy will begin on Wednesday, March 19, and conclude with a graduation ceremony on Wednesday, May 21. Classes will be held every Wednesday, from 6 to 8:30 p.m. at the El Cajon Police Station, in the Community Room, located at 100 Civic Center Way, in El Cajon. Although everyone is encouraged to apply, residents and business people within the City of El Cajon will be given top priority. Applicants must be 18 years of age or older. A total of 25 students will be accepted on a first come, first served basis, pending a background check and approval. Applicants will be notified of their application status via mail by March 7, 2014.

If you are unable to download the application, they are available at the front counter of the Police Department, or one can be mailed to you. not from me.

I grew up in a generation that never kissed on the first date. Sad to say, that idea went out with Noah and his ark and you can kiss that idea goodbye.

Nothing wrong with a kiss, if it is with the right person. It seems we are living in a culture where all anybody thinks about is kiss, kiss, kiss. So much so, that the average kiss is just that, average. Whatever happened to the romance factor behind the kiss?

I am one that is not given to hugging people let alone kissing them. I have friends in a certain church that believes in what they call, "A Holy Kiss." They take it from the Bible where it says that we are to greet one another with a holy kiss. As soon as I find out and understand what a holy kiss is, I might start doing it. But not until then and don't count on it.





'The Monuments Men' - a touching, courageous true life story

n a world of huge technology where our most private information is everywhere, it's always surprising when a story the majority of us were unaware of hits the big screen. Such is the case with The Monuments Men, a true story directed by, co-written (with Grant Heslov) and starring George Clooney.

During WWII Hitler began to raid and empty European museums, castles and cathedrals of nearly 500 million historic and valuable art pieces to hide so after the war it would all be showcased in his own Fuhrer Museum. While ttrying to simultaneously liberate and protect Europe, the Allies, under the command of General Dwight D. Eisenhower, also wanted to safeguard Europe's art and culture within the realities of war. The Monuments Men formed as a special unit with the objective to save as much of Europe's material culture from Nazi destruction as possible.

When President Franklin D. Roosevelt approves a proposal by art historian Lt. Frank Stokes (Clooney) – who served in WWI to form a task force to rescue the 1000s of cultural art at risk, the journey is on. Stokes (portraying the real art historian George Stout) recruits his team, an eclectic group who agree to go into war zones to recover these treasures, but really have no idea what they are facing.

It was while reading the book by Robert M Edsel and Bret Witter that Clooney's producing partner, Grant Heslov, suggested this be their next feature film. Clooney saw this as way to recapture some of Hollywood's more focused era and reveal this incredible

"There's a certain romance around these movies - The Great Escape, The Dirty Dozen, The Guns of Navarone, The Bridge on the River Kwai," Clooney said. "In those movies, you fell in love with the characters and the actors as much as the story. And we thought The Monuments Men was a great chance to cast interesting contemporary actors together for our version of that kind of movie - it's a fun and entertaining way to

Although the motley crew goes through a short military training, they are somewhat taken aback when they reach the war zones. However each man puts everything they have on the line to fulfill this assignment - even their own life if

The cast couldn't be better. Matt Damon plays James Granger (inspired by James Rorimer, who later became director of New York's Metropolitan Museum of Art). Bill Murray plays architect Richard Campbell inspired by Robert Posev who while embedded with Patton's Third Army during the war, discovered the salt mine at Altaussee where the Nazis had stashed the Ghent Altarpiece and the Bruges Madonna, among many other

John Goodman plays Walter Garfield, inspired by the reallife Monuments Man Walker Hancock, a renowned sculptor. Jean Dujardin takes on the role of Jean Claude Clermont, a French Jew who is an art dealer in Marseilles. "Downton Abbey's" Hugh Bonneville steps in to portray Donald Jeffries, a flawed man seeking a second

Bob Balaban takes on the role of Preston Savitz. "Savitz is an intellectual, an art historian and a theatrical impresario." Savitz is inspired by Monuments Man Lincoln Kirstein, an American impresario, art connoisseur, author, and a major cultural figure in New York who co-founded the New York City Ballet. The last Monuments Man is Sam Epstein, played by Dimitri Leonidas. Epstein, not quite 19, is the only real soldier in the group. He's been recruited for his ability to drive and to speak German. The inspiration for Leonidas's character is Harry

While on assignment Granger meets Claire Simone (Cate Blanchett), inspired by real life Rose Valland, an employee of the Jeu de Paume gallery in Paris. Never approving the removal of the treasures, she kept thorough records of where many of the famous paintings or sculptures were sent to. Blanchett is easily believable as Claire, even getting a little flirtatious with Granger who is

kind but does not jeopardize

In addition to learning just how many items the Germans confiscated and destroyed, there are some very touching scenes that really emphasize what these men sacrificed. One is in a camp where Campbell has just stepped into a rigged shower. The men had received some packages and his was a homemade CD from his family. While he went to the shower, Savitz puts it on the camp PA system. Water streams down Campbell's face as he listens to the words of "Have Yourself A Merry Little Christmas." Murray's exceptional facial expressions in the next few moments somberly portray deep sadness, inquiry, and introspection all at the same time. It's a moment the audience gets right

In another scene, Stokes is addressing his men with a poignant speech, that for me, made the entire film worth seeing. "You can wipe out an entire generation, burn their homes to the ground and somehow they will find their way back. But if you destroy their history, their achievements, it's as if they never existed," Stokes says.

The Monuments Men has action, surprises, some humor and a lot of humanity. Ccomposer Alexandre Desplat's rousing score heightens nearly every scene. I'm sorry to say the majority of the film critics did not like it. Maybe it just didn't have enough sex, drugs or gratuitous violence present in most movies today.

One critic commented: "It's like an over-the-hill gang variant on The Dirty Dozen, except not as much fun." Another said Clooney seemed to want to find a new perspective on something as big as World War II by looking at it from a small, specific point of view.

So what's wrong with a variation on The Dirty Dozen? The film had 12 major film nominations and won six of them. The Monuments Men is by far so much more than a "small, specific point of view."

It's stories like these, buried in the past, that when revealed strike a bit of awe, and in this case a pride in the heroic men who achieved this mission. I watched the film twice on two different occasions and both times heard many viewers praising it on the way out.

ABOUT THE MONUMENT MEN

he "Monuments Men," were a group of approximately 345 men and women from thirteen nations, most of whom volunteered for service in the newly created MFAA section during World War II. Many had expertise as museum directors, curators, art historians, artists, architects, and educators. Their job description was simple: to protect cultural treasures so far as war allowed. In the last year of the war, they tracked, located, and in the years that followed, returned more than five million artistic and cultural items George Stout. Photos stolen by Hitler and the Nazis. Their role in preserving cultural treasures was without precedent.

The Monuments Men remained in Europe for up to six years following the conclusion of fighting to oversee the complicated restitution of stolen works of art. During that time they played instrumental roles in rebuilding cultural life in the devastated countries of Europe by organizing temporary art exhibitions and musical concerts.

Robert M. Edsel, who founded and heads the Monuments Men Foundation, said so much is still missing. They could be anywhere, in your grandfather's attic, or hiding in plain sight. 




