Yucca Harvest Gathering at Viejas unites young and old in important traditions

aditions are often handed down or followed through the centuries by families, and the Native American descendants are dedicated to make sure many of the traditions remain ongoing in their culture.

One such person is Virginia Christman, an Elder and Past Chairman of the Viejas Band of Kumeyaay Indians, and keeper of the tribe's cultured past. She was one of the first to arrive at the second Yucca Harvest Gathering held at the Viejas Tribal Culture grounds in Alpine, California.

The day was blusterously cold and windy, but that did not stop this celebration. Tarps went up to protect from the wind, portal heaters were brought in was the portable propane cookers. As tables were filled with pans, wraps, utensils and vegetables for Christman's Yucca stew to be served later in the day, she did her traditional sage blessing around the cooking and eating area and the grounds where the bird singers and dancers would perform.

First event on the day of harvest was to send the youth and men up in the hills of Viejas and cut the Yucca plants down.

Young boys and girls then carried the beautiful flowered plants of ivory and scarlet colors and laid them on the tables.

Christman had girls and other woman ready with gloves to begin plucking off the blossoms and for the young girls to learn this ancient tradition.

"When I had my children they used to go up there every vear and then cut the stems. remove the flowers and make a big pot of yucca," Christman said. "We will also have shawii. made from the acorn. The Yucca Harvest Gathering has died out over the years, but my son Ral encouraged me to make the community aware of this tradition so that's why we have the yucca harvest and why I want to educate others so when I'm gone our traditions will carry on.

As the girls began their job of removing the yucca blubs from the stems, Christman told them the yucca plant could be used for many things such as soap, shampoo, clothing, and shoes. Christman began boiling the flower bulbs, explaining to the girls the water would begin green but during the five hour cooking process continue to lighten up with fresh water as some of the stronger natural elements were removed from the flowers.

By early afternoon the Viejas Tribal Culture grounds were alive with local tribal members, vendors, and members from the Quechan and Fort Yuma ADAPP as far away as Arizona.

Doreen Jefferson, a counselor with the ADAPP (Alcohol

and Drug Abuse Prevention Program) at the Fort Yuma Indian Reservation in Winterhaven, California, brought their youth and some adults over to the festivities.

"We want to keep them aware of our culture so we take them on road trips to see and learn what they can," Jefferson said.

Prevention specialists Janie Parrish, a member of the Navajo Nation, and Anna Shayo, two young women from the Inter Tribal Sports program through AmeriCorps VISTA, had heard about the day's event at Viejas and wondered over.

"We were surprised to find out they are focused on the same goals as us," Parrish said. "And that's to help Native Americans have a healthier lifestyle through traditional foods and incorporating more native cuisine in their diets."

As the yucca was nearly ready, a host of tribal members began bringing in steam trays of home-cooked food for their quests and members to enjoy along with the yucca and shawii. More bird singing filled the air as young children scampered about enjoying the

company of their tribal mates.

By the end of the day as Christman continued to teach, visit and enjoy the labors of love from her tribal members, everyone was amazed at this tiny woman's stamina. After nearly 12 hours on her feet, she remained smilling, singing and even taking a step or two to the

bird-singing songs.

And as Christman remarked several times throughout the day that she would not be around much longer, it was clear that 1000s of years of her ancestors' hearts of passion continue to run through her blood and ultimately will carry on her wishes.

The Alpine Challenge rides again for a good cause

The Alpine Challenge is a charity bike ride. All proceeds from the event benefit the Alpine Challenge Scholarship Fund and the Rady Children's Hospital San Diego. Because the event's committee and ride-day personnel are all volunteers, 100 percent of the proceeds pass to the fund

The ride takes place in Alpine, located in the rural foothills 30 miles East of San Diego. The entire route is well supported with SAG stops and roving support vehicles. The Alpine Kiwanis group begins preparations early. The week before, Event Director Ed Paul gathered Kiwanians at their morning meeting to fill goody bags for the riders. Kiwanis teams, set up tents the day

before the ride on April 26 at Summers Past Farms.

The next morning check-ins began and volunteers - Kiwanians, Boy Scouts and Key Clubbers made their way to covering the different corners with big Alpine Challenge

The organizations' goal is to two-fold; to establish a perpetual fund for a minimum of sending two kids to college every year, and donate half of the money raised to Rady Children's Hospital San Diego. To date, 24 students have committed themselves to "The Alpine Challenge," and after completion of their scholastic commitment will receive the guaranteed benefit promised from the Alpine Challenge Scholarship Fund. Currently 17 students have graduated from high school and continued their education due to the Alpine Challenge.

At the first event in 2001, 70 riders participated. Last year more than 500 riders participated in the event from across the state, country and outside the United States.

About the Challenge, Event Director Ed Paul said, "It's so

And then it was May

by Dr. Rev. James L. Snyder or a very brief time last week I was under the impression I was all caught up. Don't you like the feeling that comes knowing you are up to date and everything is accomplished? I do, I just do not experience it enough.

It was entirely my own fault. I was gloating over the fact I had accomplished everything on my to-do-list and had some time to spare. Spare time is a rare commodity these days, at least for me. I do not even have spare change and it has been months since I have seen my spare tire.

Time is a different matter altogether. Just when I think I have a little spare time on my hands, I find it slipping through my fingers.

Without actually thinking the issue through carefully, I opened up my calendar and discovered something quite startling. It takes a whole lot to startle me. In fact, it takes a whole lot just to get me started on anything. However, I looked at my calendar and was woefully startled.

I noticed on my calendar it was the month of May. What happened to March and April? In fact, what happened to January and February?

May is no different from any other month. I just wish the months would slow down a little bit. It seems at the beginning of the month everything is going rather slowly and then when you hit the middle of the

month the days must go into some kind of panic and race towards the end. Why these days of the month have to hasten towards the remainder of the month is something I will never wrap my head around.

Every day of the month insists it will only be around for 24 hours. Not 25 hours. Not even 20 hours. But every day insists on being around for 24 hours and then it disappears. Now, where does it go?

I noticed in my calendar there were many items that needed doing. As I looked at them, I realized I had done them the month before. Some things are so insistent that you do them every month. My electric bill, for instance. Why do I have to pay that every month? Why can't the electric company give me a vacation once a year?

Another thing that bothers me. When I am having a good time at whatever I am doing, why does time pass so quickly? I remember in school the time leading up to recess went ever so slow and I never thought it would arrive. Once I got out to recess, it went so quickly I had to return to class almost before I left the classroom. What is that all about?

I took a little bit of time to think about what good old King Solomon said about the subject. "To everything there is a season, and a time to every purpose under the heaven" (Ecclesiastes 3:1).

Time is a commodity either you spend it or lose it. The bad

part is once you lose it you can never get it back. Enjoy today, it's the only today you have.

About Dan Warnock:

At 22 I was a new mom holding my sweet baby boy and making plans for his life. When my baby boy was 22, he was fighting for his life. On that tragic day, I received a call from his friend telling me "Daniel had an accident. He hit his head. He asked me to call and tell you he's okay." My first question was, "Is he bleeding?" The answer was, "No, he's on his way to the hospital." I called the hospital and heard, "he is coming by Life Flight and the ER doctor will call after they've examined him."

I waited what seemed forever. The doctor started talking and at one point I asked him to "back up and say that again." He said "your son broke his neck. We are waiting for the neurosurgeon to determine what will happen next." I couldn't even fathom what a broken neck meant.

After arriving at the ICU the nurses asked if Daniel was my son. I said "Yes." They told me he was such an inspiration to them. They said most of the patients in his position are very bitter and angry and that they were in awe of Daniel's positive attitude.

Fourteen years later Daniel continues to inspire people with his outlook on life. He does what he can to help others. He is an artist and enjoys creating things. Having a van would give him so many opportunities. He could go back to college; he could enjoy an evening movie with friends, go on a date and maybe even take a vacation. He would be able to attend birthday parties, weddings, and funerals. He often misses these events due to lack of transportation. Before his accident, Daniel was constantly on the go. He enjoyed LIFE. He had a good job and worked hard and played just as hard. He was up before the sun so he could watch it rise and he enjoyed hanging with his family and friends long after it set. Now Daniel is a quadriplegic. He lives his life from a motorized wheelchair and on other people's schedules. He doesn't complain about that.

He is MY HERO! As his mom (and his caregiver) I love him and would truly love for him to have more in his life! He deserves MORE! Thank you for voting! Come do it again tomorrow.



veryone has their favorite sport but over the years ice-skating has gained tremendous new followers every year. What with ice-skating capturing TV audiences during the Olympic competitions and touring ice shows coming to fans' home towns, the interest continues to grow.

1984 Olympic Gold Medalist Scott Hamilton was a favorite right off the bat with his brave jumps, innovative programs, and appealing personality. In 1986 after he left the Ice Capades, Hamilton, along with his IMG manager, Robert D. Kain, started touring with their own show which eventually became Stars on Ice. Hamilton is still producer of the show, Jef Billings is the Director/Designer, and Jeffrey Buttle is the Choreographer.

Olympic Gold Medalists Meryl Davis and Charley White come to San Diego with Stars on Ice

hese days it's hard to turn on a television and not see the smiling faces of Meryl Davis and Charley White. The skating partners took the world and their fans by storm early this year at the Winter Olympics in Sochi with their Olympic Gold Medalists ice dancing performance. They also broke the previous world record for free dance and short program to become the first Americans to win the gold medal in ice dancing.

Davis and White, who hail from Michigan, met at a young age. White began skating at age five and skated in icehockey competitions. He then took to the rink in skating and ice dancing competitions and in 2004 won a bronze medal in single skating at the 2004 U.S. Championships. Davis began skating at age five as a single skater, and three years later began ice dance.

teamed together in 1997 by Davis' coach, Seth Chafetz. In their first competition together they won the silver medal at the Junior Olympics in the Juvenile division. In the 2000-1 season they placed 6th as novices, and qualified for the 2001 U.S. Championships.

Hard work and many more competitions were accomplished year after year as the partners moved up the ladder in their precision and winning medals, national titles, and Grand Prix championships. Davis and White are currently the longest-lasting team in the United States.

As they finished their whirlwind of excitement at the Olympics, Davis and White were invited to be contestants on Dancing with the Stars. They accepted. Davis' partner is Maksim Chmerkovskiy, and White is dancing with Sharna Burgess. The competition is narrowing down and fans have rallied around the Olympians but the remaining dancers are Eventually the two were also doing extremely well.

rehearsals for the popular TV show. Davis and White also need to fly to ice skating rehearsals for the Stars on Ice tour hitting 10 cites beginning in May, and then back to the intense rehearsals for Dancing with the Stars. Tweets and Facebook comments continue to admire both athletes' prowess on the dance floor and the iouful exuberance when working with team members and facing the judges.

The determined-to-win at all cost Chmerkovskiy can be a trifle rough on his partners but Davis has a charming ability to calm him down and wrap him around her little finger. White's joy-de-vie and exceptional foot work on the dance floor continues to inspire his partner, other dancers and fans.

With the Stars on Ice tour about to begin it was gracious of Davis and White to take a few moments out of their horrendous busy schedule to answer a few questions for Saenger Syndicate.

 ${f Q.}$ How challenging was this year's Olympics?

Davis: To be an Olympic champion is such an honor, and Charlie and I worked long and hard to get there. We felt like we had done everything we could from the very beginning of the competition. We had an awareness that previous skaters had performed well before us, and if we did not skate perfectly we could forget about our dreams. Now 17 years of hard work has been justified. To come away with a gold medal is amazing.

Q. The buzz about you both

was immediate. You make it look so easy, but how different are the challenges there than being on the ice?

Davis: We are trying to take some of our experience on the ice to the floor with us. But, we are definitely finding that a lot of our habits and techniques on the ice do not translate well to the floor. It's a unique challenge which is exciting to us. I think it's different for everyone. I think when people come from different fields that everyone brings something unique and faces a different set of challenges. I think that is the case for all the contestants this year as well.

White: We've basically switched from one high-pressure situation to another. Ice dancing forces you to capitalize on the momentum of one foot, but it's so different than ballroom, because when you take one step — boom! — it's one step. No extra boost. We actually kind of feel a little limited in what we can do. It's a little scary. Meryl is probably my biggest competition this season, experience-wise. But who knows? Drew Carey is one of those stars with a huge fan base. He might beat me.'

Q: Soon you're off to Stars on Ice. How different is it to skate with others than just the two of you?

Davis: You do quite a few shows, and by the end of the tour you feel like this little family. Developing those relationships and those bonds is this cool, exciting process. I'm just enjoying the whole experience.

O: Will you have any chance on the tour to speak to fans?

White: There is a meet and greet for fans after almost every show. It's really invigorating to see and feel the love from our fans.

Q. Will you be doing any new routines?

Davis: Charlie and I are actually doing a different version of our free dance for the show. It's to the music of 'Scheherazade' and we're both also doing a piece to Rachmaninoff.

Q: I know there is very little time to relax so how do you handle that?

Davis: I really like spending time outside because we spend so much of our training indoors. Oftentimes we will get to the rink when the sun comes up and leave when the sun is setting, so on a weekend I really like to spend at least one day outside and not be stuck indoors all day.

Q: What advice would you give any youngsters who dream about becoming a professional ice skater?

Davis: I think success is finding happiness! Everyone certainly has different goals in life, and things that are important to them and also things that are not important to them. I think first the important thing is to be doing what makes you happy. If you have that passion and love for skating that is a big start. Of course, you also need to work and train very hard. You sacrifice a lot of other interests and fun things, but nothing worth having comes easy.

On Feb. 5, 2014, Davis and White appeared among five other Olympians in a one-hour special on NBC television, How to Raise an Olympian. In addition to performing in different venues, they are both attending the University of Michigan.

'Walking with the Enemy' — a superb retelling of a true event

enjoy watching movies based on true stories when they are done well. Seeing a film about something historical or inspirational is entertaining to me. Walking with the Enemy offers all of these elements.

The story takes place in Budapest during a period in 1944 when Germany invades Hungry. At first the Germans insist they are not going to harm the Hungarians – unless, of course, they are of Jewish decent. As Hitler escalates his demands to rid the world of the Jews, Hungary is torn to shreds, families

are killed and little of ordinary life remains.

Elek Cohen (Jonas Armstrong), representing Pinchas Rosenbaum, the real life person the film is based on, originally gets sent to a work camp where the men are tasked to hard work. It's not long before actual war is evident, and Elek plus a few others escape the camp — thanks to the bombing raids of the allies.

When Elek arrives home, he finds his family gone, and another family, not Jewish, living in his home. The only thing that keeps Elek in reality involves the girl he met before leaving for the camp.

Hannah (Hannah Tointon), who falls instantly for Elek, finds him a place to stay at the Glass House. Run by friends of her family it's a shelter for the Swiss, since at this time Switzerland is neutral

As Jews are pulled from their homes and loaded onto trucks to be sent to the trains and then death camps, or shot on scene, Elek feels a responsibility to take

a stand. When two high ranking SS Officers are killed, Elek and his friends bury the bodies but keep the uniforms.

The boys start wearing these uniforms and patrolling the streets with phony papers. When they come upon a group of Nazi soldiers herding the Jews off to their death, Elek intervenes and requests a number of them for a work party. The Jews are then taken to the Glass House or other places in the village to hide.

The cast in this film is excellent. Armstrong easily shows his romantic side in scenes with Hannah. But he also projects how the rage remains just under the outburst stage so he can maintain his secret rescues.

Tointon appears adorable in her portrayal of Hannah as a 1940's beauty with a bubbly personality to match. She's devoted to her family and especially to her younger sister Rachel (Flora Spencer-Longhurst.)

Ben Kingsley generates much compassion for his character and slides into the role of Hungarian regent Miklos Horthy like a hand in a glove. Horthy has the willpower to try saving his country and its residents – but not the resources or skill.

The SS Officers are superbly revealed as icy and aloof by Charles Hubbell (Adolf Eichmann) Simon Kunz (Otto Skorzeny), Burn Gorman (Nazi Col. Skorzeny), and others.

The film is helmed by first-time director Mark Schmidt – co-founder of Liberty Studios that made the film – who does a great job placing the audience members square in the middle of this story. The drama feels intense from the first scene, and so does the empathy for a real story, which may be new to most viewers.

Dean Cundey's eye behind the lens elevates this story; mostly shot in Bucharest and Budapest, as do the amazing set designs that made me feel like I was stepping onto the streets in World War II.

Many people refuse to see yet another Holocaust movie. Still, as tough as the reminders are about the losses and travesties related to that horrific tragedy, the heroes of those who lived this experience and the revelation of where they are today, make Walking with the Enemy a vividly inspiring film.

First time director talks about 'Walking with the Enemy'

iberty Studios is a San Diego motion picture studio that has just released its first full-length feature film – Walking with the Enemy. Mark Schmidt, Founder and President of Liberty Studios, Inc. said their focus is on bringing untold inspirational true-life stories to the big screen. Walking with the Enemy is about the German invasion of Hungary in 1944, and how a young Hungarian saved 100's of Jewish lives through his Nazi officer impersonations.

As their feature film was about to open in 10 theaters in San Diego, Schmidt took a few minutes out of his busy schedule to talk about the film.

Q. How did you get involved with this story?

Schmidt: There are many people who do heroic things to save people and this young man (Pinchas Rosenbaum) was one of them. I researched books of what happened in Hungry in 1944 then and his name popped up a few times. I went to Budapest, Hungry and did some investigative stuff there and met people in a village who told me things that happened there during that time.

Q. Kenny Golde wrote the screenplay from a story you composed, correct?

Schmidt: Yes. I wanted to direct the film so it would come out the way I wanted it. I took charge of all the details.

Q. The film is beautifully stunning. Like last year's The Book Thief, it looks so real and really draws in the audience in right from the beginning. Where did you do most of the filming?

Schmidt: We did most in Eastern Europe in Bucharest and Budapest and a little bit in San Diego. We shot for about 100 days total.

Q. Was Dean Cundey your first choice as your cinematographer? Schmidt: Yes, he did a great job. I love the way he gets the color out and the lightning; he's very talented. Everything is an art, so you have to find talented people for everything – sound, music, actors, photographers, set designers – and our team was very good. We looked for locations that made our story feel as real as possible. We showed some clips to people who lived there at that time and they felt we accomplished that goal.

Q. Is the final film what you wanted it to be? Schmidt: It's what I envisioned. I had to double and triple check everything as director, but everyone was really nice to work with.

Q. You had a great cast. Was it difficult to pin down the actors you envisioned?

Schmidt: Jonas was excellent as this young man and he scored a near top standard in testing. He really embodied a young man who risked his life every day to save people.

Ben Kingsley, a great professional, was our first choice and we were honored to have this very talented man in the film. Flora Spencer-Longhurst was amazing as the young Rachael. We knew we had to use people who were trained, but we also had a lot of unsung heroes as extras.

Q. Are you getting the response you wanted for the film? **Schmidt:** We had a great response at the Palm Springs film festival. We sold out with five screenings of 450 people. The scores came in at 4.58 out of 5 total score. There were even tears in some of the men's eyes. So many innocent people back then risked their lives to hide people, and there are still survivors around who have seen the film and wanted to watch it to the end. One was Rose who lost her entire family and was a sole survivor. She said, "The film was

hard to watch but so beautiful to see what so many did to help us.'
