he Fire Safe Council of San Diego County's Defensible Space Assistance Program (DSAP) provides low income seniors and / or disabled citizens residing in San Diego County assistance in clearing 100 feet of defensible space around their homes to reduce fire danger. Through this program we can offer thinning and clearing of brush, tree trimming and thinning, raking of dead leaves and pine needles, and chipping of removed

There is no cost but participants must meet certain age and income criteria. There is no application deadline but assistance will be given on a first come first served basis. Call our office with any questions at (619) 562-0096.

Residents are not helpless when it comes to protecting their homes and lives from disastrous wildfire events. We can't stop fires from happening altogether, but we can reduce the damage to our families, homes, and communities through practices such as creating Defensible Space. With proper steps taken to make changes to the home, landscape and community before a wildfire event, individuals can make a difference.

Wildfire doesn't have to burn everything in its path. In fact, cleaning your property of debris and maintaining your landscaping are important first steps. Due to the extreme drought conditions wildfire risk will be even greater this year and it will be important to complete yard work earlier than usual to avoid causing a wildfire by using yard maintenance equipment.

- Clear leaves and other debris from gutters, eaves, porches and decks. This prevents embers from igniting vour home.
- Create a "fire-free" area within five feet of the home. using non-flammable landscaping materials such as rocks, pavers and/or highmoisture content annuals and

#### Special El Cajon celebration planned For NASCAR Champion Jimmie Johnson

he El Cajon City Council is recognizing El Cajon native Jimmie Johnson for his racing accomplishments and philanthropic contributions to the community on Tuesday, June 17, as he returns to El Cajon for this special celebration. The City is encouraging everyone to attend and show their support for one of NASCAR's biggest stars.

El Cajon Mayor Bill Wells, the City Council, Senator Joel Anderson and other local dignitaries will be honoring Johnson during a special ceremony beginning promptly at 11 a.m. local time. Additionally, portions of the event will be broadcast live on 101.5 KGB.

Johnson continues to

make his hometown proud. In 2013, he won his sixth NASCAR Sprint Cup Series championship, adding to a NASCAR record five championships in a row (2006-2010). At just 38, he is the youngest driver to win six titles. His 66 Sprint Cup wins since 2002 ties him for eighth on the all-time wins list.

Despite his extremely busy schedule, Johnson still visits San Diego each year, not only to see family, but to give back to the community through the Jimmie Johnson Foundation. To date, his Foundation has given more than \$6.5 million dollars to schools here in El Cajon and across the nation.




## The Cajon Valley Jamboree begins Friday

# Why mothers would make good politicians

n looking forward to Mother's Day, I could not help but think about the mess our country is in right now. Not that messes remind me of mothers in particular, but honesty compels me to admit they are good at cleaning up messes. And, the messes they cleanup are not their doing. That is what makes it so great.

Somebody needs to clean up the mess we are in.

Anybody who steps outside their house knows that the country is in a terrific mess these days. It would be impossible to blame one political party over another. In this area, everybody is equal. The truth is, politicians make messes. Furthermore, they leave these messes for other people to clean up. Many politicians have dirty mouths and minds, but none has dirty hands from cleaning up messes.

There are two kinds of politicians in our country. Those who make messes and those who allow those messes to be made. Wouldn't it be nice to find a politician who actually would clean up a mess?

Our country is in the soup, and not the kind of soup your mother used to make. Politicians make soup out of circumstances that nobody can stomach while mothers have a marvelous way of making soup out of almost anything, and it tastes heavenly, plus it is good for you.

Recently, some politicians have been in an uproar and quite nervous over the swine flu situation. And there is good reason. With all the pork in Washington these days, they should be afraid they might catch whatever is going around. Maybe, and I know I'm a little sadistic here, it might be good for a couple of them (okay, all of them) to come down with some kind of flu to send them to their beds for at least a month. Possibly a high fever might clear up their thinking. Plus, our country could use a vacation from politicians. We could put them all in quarantine until the danger is over. (I'll let them know when it is over. Honest. Cross my fingers and hope to vote.)

But getting back to my subject, I believe mothers would make wonderful politicians for several reasons. Mothers, generally speaking, know how to ask questions.

"Have you washed behind your ears?"

"What time are you getting back?"

"Do you have clean underwear?"

"If all your friends jumped off a bridge would you?"

It is one thing to ask a question, but it is another thing altogether to ask the right question. I firmly believe asking questions is a highly refined art. Mothers expect an answer to their questions immediately... without delay.

Question a politician, you get the runaround. Question your mother and she will chase you around. It would be more beneficial to be chased around by your mother than to have some politician give you the runaround.

Another reason mothers would make good politicians

is that they never stop until the work is finished. Everybody has heard the old saying, "A man works from sun up to sun down, but a woman's work is never done." At the end of the day, every mother has something to show for her work.

It would be beneficial for our country if every politician were apprenticed to a mother with four or five kids. Let him follow her around for a week, if he can last a week, and he will get some idea of what working is all about.

Let some politician clean up after four or five kids for a week and experience what real work is all about. Perhaps, if he has to clean up messes of other people's making he might think twice before he makes a mess himself. The only work a politician really does, is working his mouth, which rarely accomplishes anything useful.

By her very nature, a mother is always thinking about others. Rarely does she take any time for her own personal pursuits. Other people come before her interest and comfort. Wouldn't that be a wonderful trait in some politician?

Instead of always thinking about reelection and what can get him reelected, he begins to think about other people and their needs.

Instead of putting his political career ahead of everything else, he would sacrifice himself to benefit other people, to help clean up the messes around him

Although it may seem like a good idea, we cannot afford to send mothers to Washington and neglect the important work she has at home. Nehemiah said it so well, "I am doing a great work, so that I cannot come down: why should the work cease, whilst I leave it, and come down to you?" (Nehemiah 6:3).

God knew exactly what he was doing when he put together a marvelous creature we now know as Mother.

It is much easier and less risky to keep people at arm's length, yet it is a lonely life. Proverbs 18:24; A man who has friends must himself be friendly, but there is a friend who sticks closer than a brother. Proverbs 17:17; A friend loves at all times, and a brother is born for adversity. John 15:13; Greater love has no one than this, than to lay down one's life for his friends.

I want to share with you about a good friend of mine, her name is Jill. I built walls since I went through rejection as a little girl, placed in an orphanage, a detention center; not wanted by my mother or father. Then the betrayal in a marriage caused me to close off more and I became very cautious. When Jill came in to the Women's Home, there was something different about her. After one year, she said to me, "I'm going to be your best friend." My instant reflex was to put my guard up to protect myself. I just looked at her, smiled and said sternly, "I don't have any best friends, only acquaintances." What I didn't know was Jill had come from a loving family and she learned something I hadn't called "trust." Jill must have known from my different testimonies in the Women's Home, how I had been abandoned as a child and rejected. Somehow she was able to look beyond all of that and she began to work towards being my best friend.

Of course, I was like a porcupine and at times my words and actions could slice like a razor. These character traits came from rejection, betrayal and heartache. Did I ever scream at her? Yes. Was I ever rude? Yes. At times I cut her off completely. Again, she was able to cut through those walls like a machete cutting through a massive jungle. After about the tenth year, believe it or not, I discovered that Jill was a true friend. Someone I could talk to, someone who would not betray me, someone who would speak the truth to me in love. Thirty years later, Jill is my best friend. I hope that it won't take you that long to have good friends. But to be a good friend, you have to be able to look beyond the brokenness in a person and be willing to love unconditionally. Jill taught me that I can trust and today, I have hundreds of true friends.

In this quest to make friends, will you ever be betrayed? Yes. Will you ever need someone to pull the knives out of your back? Most assuredly. Will you meet someone you thought was your friend, only to discover they truly were not? Absolutely! What is the answer? Make friends anyway. Those who are truly your friends will be there to weather the storms of life with you. To be a good friend, you should read, memorize and walk in 1 Corinthians 13:4-7; "Love suffers long and is kind; love does not envy; love does not parade itself, is not puffed up; does not behave rudely, does not seek its own, is not provoked, thinks no evil, does not rejoice in iniquity, but rejoices in the truth; bears all things, believes all things, hopes all things, endures all things.

#### Eleuthero

This is the most well-researched adaptogen (with more than 3,000 published studies). It often is called the

"king" of adaptogens. (It was introduced in the US as "Siberian ginseng," but it is not a ginseng.)

Main actions: Along with providing energy and vitality,

accompanied by depression or anxiety.

Korean or Asian ginseng is helpful for increasing physical performance, especially endurance and energy. It is

eleuthero protects the body against the ill effects of any kind of stress, such as extremes of heat or cold, excessive exercise and radiation. More than any other adaptogen, it helps normalize any type of physiological abnormality—including high or low blood pressure... and high or low blood sugar.

Important benefit: Eleuthero is a superb "ergogenic" (performance-enhancing) aid that can help anyone involved in sports improve strength and endurance and recover from injury.

#### Ginseng

Used as a traditional medicine in Asia for more than 5,000 years and the subject of more than 500 scientific papers, ginseng has two primary species—Panax ginseng (Korean or Asian ginseng) and Panax quinquefolius (American ginseng).

Main actions: Ginseng is antifatigue and antiaging. It increases muscle strength and endurance and improves reaction times. It also strengthens the immune system and the heart and helps regulate blood sugar.

Important benefits: American ginseng can be beneficial for recovering from the common cold, pneumonia or bronchitis (particularly with a dry cough)...and chronic stress

effective for restoring adrenal function and neurological health such as learning and memory.

#### Rhaponticum

This herb contains more anabolic (strengthening and muscle-building) compounds than any other plant. It is my number-one favorite herb for increasing stamina and strength.

Main actions: It normalizes the central nervous and cardiovascular systems...improves sleep, appetite and mood... and increases the ability to work and function under stressful conditions.

Important benefit: This herb is wonderful for anyone recovering from injury, trauma or surgery.

#### Rhodiola

Rhodiola has gained popularity over the past few years as studies show that it rivals eleuthero and ginseng as an adaptogen. It is widely used by Russian athletes to increase energy.

Main actions: Rhodiola increases blood supply to the muscles and the brain, enhancing physical and mental performance, including memory. It normalizes the cardiovascular system and protects the heart from stress. It also strengthens immunity.

Red flag: Don't use rhodiola alone—it is extremely astringent and drying. It is best used along with other adaptogens in a formula.

#### Schisandra

This herb has a long history of use as an adaptogen in China, Russia, Japan, Korea and Tibet. The fruit is commonly used, but the seed is more powerful.

Main actions: Schisandra can treat stress-induced fatigue...protect and detoxify the liver...treat insomnia, depression and vision problems...and enhance athletic performance.

Important benefit: This adaptogen may help night vision—one study showed it improved adaptation to darkness by 90%.

#### Combinations are best

Any one herb has limitations in its healing power. But a combination or formula of adaptogenic herbs overcomes those limitations—because the adaptogens act in concert, making them more powerful.

This concept of synergy—multiple herbs acting together are more effective than one herb acting alone—is key to the effectiveness of the herbal formulas of traditional Chinese medicine (TCM) and Ayurveda. Both these ancient forms of medicine often employ a dozen or more herbs in their formulas.

But it's not only the com-

bination of herbs that makes them effective—it's also the quality of the herbs. There are many more poor-quality adaptogens on the market than high-quality (or even mediocre-quality).

My advice: Look for an herbalist or herbal company that knows all about the source and content of the herbs it uses. Example: Herbalist & Alchemist, a company that grows most of the herbs used in its products.

Or find a product sold to health practitioners, who then sell it to their patients—this type of product is more likely to be high-quality. Example: MediHerb, from Standard Process.

Herbal formulas from my company, Natura Health Products, also meet these criteria for high quality.





ack by popular demand will be John Collver's War Dog T6/SNJ aerobatics performance and new this year, his race with jet car "Smoke and Thunder."

The 26 feet long, 2,300 pound jet car is powered by a Westinghouse J34-48 jet engine originally used in the North American T-2A Buckeye jet trainer. 

Q. Actor, writer, producer, director; do you have one you prefer over the other?


KD: I love producing on a film because you become part of the story-telling process

# Chargers select six in 2014 NFL Draft

he San Diego Chargers selected a total of six players in the 2014 NFL Draft, May 8-10.

In the first round, the Chargers selected cornerback Jason Verrett (Vur-RETT) from Texas Christian.

A 5-9, 178-pound native of Fairfield in Northern California, Verrett was a highly-decorated three-year starter at TCU. As a senior in 2013, he was the Big 12 Conference's co-Defensive Player of the Year, a consensus second-team All-America and a first-team

All-Big 12 pick. One of the nation's top cover cornerbacks, opposing quarterbacks rarely challenged Verrett during his senior season at TCU as only 52 passes were thrown in his direction and only 17 were completed. As a result, he finished the year with 39 tackles,

14 passes defensed and a pair of interceptions. He finished his career at TCU with 160 tackles, nine interceptions and 35 passes defensed. As a freshman in 2010, Verrett was a first-team All-NorCal Conference pick at Santa Rosa Junior College.

He became the fourth former TCU Horned Frog drafted by the Chargers in team history and the first since 2001 when the Chargers drafted LaDainian Tomlinson in the first round with the fifth overall selection.

In the second round, the Chargers made a trade with Miami to move up seven spots to No. 50 overall to select Georgia Tech outside linebacker Jerry Attaochu (uhTAU-chew).

The Chargers sent the Dolphins their pick in the second round (No. 57) and their

fourth-round selection (No. 125) for the right to move up. It marked the second time in two years that Chargers General Manager Tom Telesco traded his second and fourth-round picks to move up in the second round. Last year, he traded the Chargers' second (45) and fourth-round (110) picks to Arizona to move up and select linebacker Manti Te'o with the 38th overall pick.

Attaochu, 6-3, 252 pounds,

was a three-time All-Atlantic Coast Conference pick at Georgia Tech, a first-team selection as a senior and an honorable mention pick as a sophomore and junior. He also was a third-team All-American by the Associated Press as a senior. Attaochu was a three-year starter for the Yellow Jackets who finished his career with a school-record 31.5 sacks, 43.5 tackles for loss, 196 total tackles and four forced fumbles.

# Padres get offensive with their bats

n a much-needed Mother's Day weekend for the team thirty-six games into the season, the Padres batters finally woke up. Thirty-six hits, and twenty-four runs later, (the total of hits and runs the team scored in three games over the weekend against the Marlins), one would have to assume that the 'Swinging Friars' are back knocking the cover off the ball. This is the team we thought they were when coming out of spring training.

Finishing the recent 10-game home-stand (5-5), the Padres had to sweep the visiting Marlins in the last three games of the series to get to that mark after starting off a dismal (2-5) at home.

Outfielder Chris Denorfia, one of the few consistent 'Swinging Friars' this season, who also made a couple of great defensive plays in the Padres 5-4 win Sunday, said, "We feel pretty good about the series and about the homestand. You're finally starting to see a team that is starting to click a little bit. We really relied on our pitching for the majority of the year. Now we get to the opportunity to step up."

Will Veneable led off the game Sunday with a home run setting the tone on Mother's Day the team is looking more comfortable at the plate. It shows in their approach, be-

ing more selective at the plate, looking at more pitches, and waiting for the one they can hit.

"We've been putting in plenty of work," Denorfia said. "Nobody is taking it likely, that's for sure. Everybody was pretty angry the way we got off the season offensively. We are seeing a lot of guys who take pride in what they do every day and work really hard. The results are starting to come."

Over the weekend the Padres hitters appeared to know what they were doing at the plate. A good fastball-hitting team, they waited for the Marlins hard-throwing starters, to throw them a pitch they could hit, laying off the off-speed junk of breaking pitches and changeups, frustrating the opposition.


Knocking the cover off the ball the Padres players appeared to be riding a giant carrousel while running around the base path at Petco Park. The one constant on the team pitching has been good all year, especially out of the bullpen. Twenty-three year old Robbie Erlin has pitched into the seventh inning in his last three starts and was the winner Sunday against Fernandez and the Marlins pitching six and a third strong innings not allowing any runs.

Padres skipper Bud Black seams pleased with the effort of Erlin and the team. "He's got a good fastball, both sides of the plate and a good changeup," he said. "When Robbie pitches a good game, it's about a history of pitches that are working effectively. I thought the change, curve ball, secondary pitches were outstanding. He's going to hold his velocity (88-90mph). He's capable of doing the kind of work he's done today."


The bullpen, usually lights out, collapsed Sunday giving up four runs in the eighth before Houston Street closed it out in his usual nail biting fashion, loading the bases but not giving up any runs in the ninth to get his eleventh save in eleven attempts.

Timing couldn't be better for the 'Swinging Friars' to wipe the dripping pine tar from their hot bats. Hoping to continue their hot hitting, the team is off on Monday and traveling to Cincinnati for a 3-game series and then to Colorado for another series this weekend, in two of the most hitter-friendly ballparks in the majors hoping to get back to the .500 mark.

"It's more like what we're hoping for as a group," Black said. "The guys are starting to swing the bat better, much better at bats as far as on base percentage. Again, we need guys on base."





#### **ORDINANCE NO. 5008**

AN INTERIM ORDINANCE ADOPTED AS AN URGENCY MEASURE PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 65858 TO ESTABLISH A MORATORIUM ON THE APPROVAL OF ANY NEW HOOKAH AND ELECTRONIC VAPOR SUBSTANCE INHALATION SHOPS AND LOUNGES IN THE CITY OF EL CAJON

THE CITY COUNCIL OF THE CITY OF EL CAJON DOES ORDAIN AS FOLLOWS:

SECTION 1: Findings and Declaration of

That the City of El Cajon has an overriding interest in planning and regulating the use of property within the City. Implicit in any plan or regulation is the City's interest in maintaining the quality of urban life and the character of the City's neighborhoods. Without stable, well-planned neighborhoods, sections of the City can quickly deteriorate, with tragic consequences to social, environmental, and

On January 14, 2014, and March 11, 2014, the City Council heard testimony from the public requesting amendments to the El Cajon Municipal Code ("ECMC") to regulate, through the City's Zoning Code ("Title 17" or "the ECMC"), the establishment of locations of husinesses that sell electronic/vanor inhalation products (commonly referred to as "electronic cigarettes," "e-cigarettes," "hookahs," "water pipes," "hookah pipes," and other similar devices, as well as such cartridges, substances, and additives used to experience the sensation of smoking vapors tobacco and non-tobacco substances) (collectively, "Electronic/Vapor Inhalation Products"), and as well as to consider amendments to the ECMC to regulate the sales of Electronic/Vapor Inhalation Products in the City of El Cajon.

The City Council recognizes the dramatic increase in the use of Electronic/Vapor Inhalation Products within the community, and the commensurate increase in businesses offering Electronic/Vapor Inhalation Products for sale to the public and businesses providing areas where customers can smoke or inhale vapor from hookahs, electronic vapor devices. or electronic hookahs, often referred to as lounges or bars ("Lounges"); and that the problems associated with the unregulated sale of Electronic/Vapor Inhalation Products, and the use of properties for Lounges, will lead to increased consumption of such products by the youth of the community, thereby likely leading to unhealthy behavior on the part of youth, with concerns related to the harmful effects Electronic/Vapor Inhalation Products could have on our youth. The City Council has also become concerned with the unregulated use of commercial property for Lounges, which might create unwanted and undesirable activities in and around the properties where Lounges are established, and has determined that local control through land use regulatory authority is necessary to ensure public health, safety and welfare by sing the effects and impacts Lounges might have to the community.

Accordingly, the City Council has an interest in modifying the City's land use regulations to adopt a legally enforceable method to regulate the establishment of vendors of Electronic/ Vapor Inhalation Products and businesses operating Lounges in the community.

Amendments are needed in Title 17 (Zoning Code) of ECMC to accommodate this change Pursuant to FCMC Section 17 20 020 amendments to Title 17 can be initiated by

adoption of a resolution of intention by the City Council or the Planning Commission. Resolution No. 020-14 was adopted by City Council on March 11, 2014.

As a junior in 2012, Attaochu racked up 69 tackles, 10 sacks and 12 tackles for loss and as a senior, he set career highs with 12.5 sacks and 16 tackles for loss.

The 21-year-old Attaochu was born in Ibadan, Nigeria, before his family moved to the United States and settled in Washington, D.C. A science, technology and culture major at Georgia Tech, Attaochu prepped at Archbishop John Carroll High School in our nation's capital.

In the third round with the 89th overall selection, the Chargers selected left guard Chris Watt from Notre Dame. He was a three-year starter and a two-time first-team All-Independent Football Bowl Subdivision pick for the Fighting Irish.

Watt (6-2, 311) was part of an offensive line that allowed just eight sacks in 2013, tied for second-fewest in the nation. In 2012, he started all 13 games as Notre Dame went 12-1 and played Alabama in the National Championship game. One of his teammates on that team was Te'o. During that 2012 season, Notre Dame's offensive line allowed just 16 total sacks and they cleared holes for their running backs to amass more than  $20\overline{0}$  yards in seven games, their most such efforts since 1996. Watt moved into the starting lineup as a redshirt sophomore in 2011 and started all 13 games for the Irish at left guard.

A 23-year-old native of Glen Ellyn, Illinois, Watt earned All-America honors as a prep at Glenbard West High School in Glen Ellyn. He has an older brother, Kevin, who played defensive end at Northwestern from 2007-11. Watt earned a degree in marketing at Notre Dame.

Watt is the 18th former Notre Dame Fighting Irish player to be drafted by the Chargers. It's the second-most players drafted from a single school in team history.

In the fifth round of the 2014 NFL Draft, the Chargers selected defensive tackle Ryan Carrethers from Arkansas State. A two-time All-Sun Belt Conference pick, the 6-1, 333-pounder finished his collegiate career with 196 tackles, 14.5 tackles for loss and 6.5 sacks. As a senior, Carrethers blocked two kicks, including a 38-varder with no time remaining to secure a 23-20 victory for the Red Wolves over Ball State in the GoDaddy Bowl. Carrethers' 93 tackles during his senior season were thirdmost in the nation among defensive linemen.

A 23-year old native of Nashville, Tennessee, Carrethers played football and competed in wrestling at Brentwood Academy. It's the same high school that Chargers left tackle King Dunlap attended.

Carrethers is the first player from Arkansas State to be drafted by the Chargers.

In the sixth round, the Chargers added to their stable of running backs with the selection of Marion Grice from Arizona State. A 6-0, 208-pounder, Grice was a second-team All-Pac-12 pick and an honorable mention All-America choice by several publications as a senior.

A 21-year-old native of Houston, Texas, Grice spent his first two collegiate seasons at Blinn (Tex.) College, before transferring to ASU for his final

two seasons. As a Sun Devil, Grice scored 39 career touchdowns, fourth-most in school history, while totaling 3,045 all-purpose yards on rushes, receptions and kickoff returns. As a senior, Grice led the team with 1,941 all-purpose yards (second-most in school history) and he was the only NCAA FBS player in the nation with at least 400 yards in each of the previously-mentioned categories. In two seasons at ASU, Grice scored 234 points, most-ever by a Sun Devil in a two-year span. As a junior, his eight touchdown catches were the most in the nation by a running back.

Grice is the 10th former Arizona State player to be drafted by the Chargers.

The Bolts closed out the draft with the selection of wide receiver Tevin Reese from Baylor in the seventh round, a three-time All-Big 12 Conference pick, including first-team as a senior.

The 5-10, 170-pound Reese is a 23-year-old native of Temple, Texas. In four seasons at Baylor, he caught 187 passes for 3,102 yards and 24 touchdowns, leaving Waco as the school's thirdleading receiver in all three categories. Reese scored 21 of his 24 touchdowns on plays of 40 yards-or-longer, the most in NCAA history. A truly explosive player, the average length of his 24 touchdowns was 50.6 yards and nine of his touchdowns were on plays of 60 yards-or-longer.

Nicknamed "Sweet Feet," Reese prepped at Temple (Tex.) High School. He was an all-district wide receiver and kick returner, and a state qualifier in track and field as both a jumper and hurdler.

Reese becomes the third Baylor Bear to be drafted by the Chargers all-time.

•Remove dead vegetation from under your deck and within 50 feet of the house.

 Remove flammable materials (firewood stacks, propane tanks, dry vegetation) within 30 feet of your home's foundation and outbuildings, including garages and sheds

• If you have trees on your property, prune so the lowest branches are 6 to 10 feet from the ground.

 Don't let debris and lawn cuttings linger. Dispose of these items quickly to reduce fuel for fire.

• Keep your lawn hydrated and maintained. Dry grass and shrubs are fuel for wildfire.


