La Mesa Soap Box Derby trophy winners announced

Steve Blake, director of the Drew Ford/Kiwanis Club of La Mesa Soap Box Derby, has announced the names of the top finishers in the double-elimination derby held at La Mesa Middle School on Saturday, May 17.

Those who captured first place in the stock and super-stock divisions, respectively, are Andrew Knapp, 9, of Lake Forest CA, and Brandon Stephenson, 9, of Lakeside. Stephenson continued his trophy-winning streak, having placed first in the stock car division at last year's La Mesa Derby.

"With the financial support of Drew Ford and other sponsors, both champions will be sent to the National All-American Soap Box Derby in Akron, Ohio, birthplace of the classic family program," said Blake.

To be held in late July, the National Derby will see upwards of 800 drivers in competition.

First through fourth-place finishers of the local La Mesa Derby are:

1st - 9-year-old Andrew Knapp of Lake Forest.

2nd - 12-year-old Cory McGranahan of El Cajon.

3rd - 9-year-old Paxton George of La Mesa.

1st - 9-year-old Brandon Stephenson of Lakeside. (2013 Stock Champion)

2nd - 9-year-old Cody Boller of Alpine.

3rd - 11-year-old Preston Knapp of Lake Forest.

4th - 12-year-old Cooper Magill of Spring Valley.

Up next for the La Mesa Kiwanis-run event will be two days of Soap Box Derby Rally Races, usually the first weekend of November. "Rally races are held to provide our young drivers the opportunity to gain experi-

ence with the event so they know what to expect about steering and braking the cars, the sound and feel of the road surface, how the double-elimination brackets work, and so forth," Blake said.

Local Girl Scouts fueling success of Operation Thin Mint

Six east county girls were among top Girl Scout cookie sellers honored during the 13th annual Operation Thin Mint® Sendoff aboard the USS Midway Museum on May 3.

Four live in La Mesa: Savannah Baird and Ashley Prus (both of Troop 21), Carolyn Bank (Troop 3630), and Taylorann Quick (6014). The others are Santee resident Christina Bailey (Troop 67691) and Sydney Robinson (Troop 6641) of Lakeside. Each sold at least 2,014 boxes of Girl Scouts cookies in 2014 — a goal achieved by just 31 Girl Scouts in the San Diego-Imperial region.

Taylorann Quick sold 4,000 boxes — the second highest number in the entire jurisdiction. Of the boxes she sold, 1008 will be shipped to deployed military through Operation Thin Mint®.

Altogether, the east county Girl Scouts sold a grand total of 14,339 boxes. Coincidentally, exactly 2,014 of these were donated to Operation Thin Mint (OTM)®.

The girls' cookie successes earned them the opportunity to take center stage with U.S. Congressman Juan Vargas and top brass at the sendoff — as well as to ride helicopters. The flight carried a special

meaning for Carolyn, whose late grandfather, Dr. Milton H. Bank II, was a Navy pilot who had also landed on the USS Midway.

This is the 10th consecutive year the USS Midway Museum hosted the sendoff, which was open to the public. More than 2,600 revelers gathered on the historic ship's flight deck as an Uncle Sam on stilts revealed that generous San Diegans are shipping a total of 198,470 boxes of OTM cookies to military troops this year. The action-packed morning also featured skydivers and a Coast Guard helicopter lifting a pallet of Thin Mints from

Fire Inspection scam – businesses beware

Heartland Fire & Rescue would like to alert the business community to an ongoing fire inspection scam. Please be aware of contractors who attempt to conduct unsolicited fire inspections.

The "contractors" running this scam show up at businesses saying they are from the Fire Department or that the Fire Department sent them to do a fire inspection. They will then conduct a visual inspection of the premises and later send a bill for the inspection. These bills can run into hundreds of dollars. Be very cautious before signing any paperwork because, in most cases, these companies have a notice and waiver disclosure on their forms. By signing you may be giving them authorization to enter your business and perform the inspection services. This is a problem in all three of the Heartland Fire & Rescue cities of El Cajon, La Mesa, and Lemon Grove.

Official inspections are conducted by either Heartland Fire & Rescue or City personnel. These employees wear fire department uniforms or apparel with the City insignia. They also have badges and department identification cards. Many of the contractors wear apparel that may closely resemble this.

During an official inspection by the City or the Fire Department, any violations or corrections are addressed in writing. Some of these corrections can be made by you, the business owner, while others may be more technical and require the services of a state licensed contractor. If the work repairs require a contractor, it is up to the business to hire a licensed contractor of their choice. Neither the City, nor the Fire Department, will send a contractor to your place of business for these repairs. If there is a fee for an inspection made by the City or the Fire Department, an invoice will come directly from the City's Finance Department via mail.

If you have reason to doubt that an inspection is not being conducted by official personnel, please do not hesitate to call our agency at (619) 667-1355 to verify employment.

Each minute on the phone with this technician caused me to lose more of my cool until I was absolutely hot under the collar. He knew almost as much about my problem as some stray cat in the backyard.

Finally, I had enough and thought the best part of valor on my part would be to bid him adios before I said some things that I would later regret.

After I hung up and cooled down a little bit I thought of something. Why don't I just unplug the whole mess and then restart everything. It worked and I did not have to say it with some strange accent.

In my devotions that morning, I read from Psalms 33:4 where David says, "For the word of the LORD is right; and all his works are done in truth."

Sometimes the best course of action is to do it yourself. Not being a do-it-yourself guru, it does not come naturally to me.

If you blame someone else for your problems, you are pointing the finger in the wrong direction.

Continued hospital excellence — Yes on H

A bipartisan coalition of East County community leaders are recommending a “yes” vote on an upcoming June election ballot measure that would assure continued operations

at Grossmont Hospital until 2051.

If approved, Prop. H would allow for the extension of the current lease agreement between the Grossmont Health-

care District (GHD) and Sharp HealthCare to operate the publicly-owned hospital for an additional 30 years until May 29, 2051. GHD is an East Region public agency that serves as landlord of Grossmont Hospital's property and buildings on behalf of taxpayers. The existing 30-year lease with Sharp, signed in 1991 and scheduled to expire on May 30, 2021, gives operational responsibility of the La Mesa hospital to Sharp HealthCare.

Supporters of Prop. H, including officials with GHD and Sharp HealthCare, are in favor of the measure because they say it demonstrates how a public-private partnership

should work, where the public resources of a state-of-the-art community hospital join with an award-winning nonprofit healthcare system to benefit the public.

“There will be no fiscal cost to local taxpayers to approve the lease extension,” said Dr. Michael Long, 2014 GHD board president. “Approval of the lease extension ballot measure means Grossmont Hospital will remain a community owned hospital for decades. It also gives Sharp the leverage to finance hundreds of millions of dollars for facility improvements at the hospital at no additional cost to taxpayers.”

“The Grossmont Hospital Medical Executive Committee, a group composed of the elected leaders of the hospital's medical staff, has endorsed the lease extension ballot measure,” said Dr. Brian Moore, Grossmont Hospital chief of staff and the chair of the Executive Committee. “Extending the relationship with Sharp HealthCare is in the best interests of Grossmont Hospital, its patients and the community.”

The Prop. H organizing group, called “Citizens for Continued Hospital Excellence – Yes on H,” have received endorsements in favor of Prop. H from every mayor and city council member in the East County cities of El Cajon, Santee, La Mesa and

Lemon Grove. Additional endorsements from local elected officials include State Senators Joel Anderson and Marty Block, Assembly members Brian Jones and Shirley Weber, San Diego County Supervisor Dianne Jacob, San Diego Mayor Kevin Faulconer and San Diego City Councilman Scott Sherman. Organizations supporting Prop. H include the San Diego County Taxpayers Association, Business Leadership Alliance, San Diego East County Chamber of Commerce, San Diego East County Economic Development Council, San Diego County Democratic Party and Republican Party of San Diego County.

CDPH warns of poisoning associated with some skin creams from Mexico

The California Department of Public Health (CDPH) is warning consumers to avoid using skin creams in unlabeled or hand-labeled containers brought from Mexico, after reports of mercury poisoning associated with these products.

These creams are used for lightening the skin, fading freckles, blemishes, and age spots, and treating acne. They come in containers without labels or with hand-made labels. Some creams are light in color and turn dark grey/green after prolonged exposure to light. Some of them have contained more than 200,000 times the legal limit of mercury.

In the last four years, at least 60 people in California have been affected by the use of these creams. They include children and babies who became very sick from contact with the mercury contamination in their homes or through skin contact with family members who used the products. Children and pregnant women are especially sensitive to the toxic effects of mercury.

In addition to this consumer warning, CDPH is also working with its local, state and federal public health partners to warn people in California and Mexico about this serious health risk. CDPH has sent an [alert](#) to health care professionals, advising them to be aware of the symptoms of mercury poisoning. CDPH has also created [a one-page fact sheet that is available in English and Spanish](#) for sharing with patients or the general public.

Common signs of mercury poisoning in adults include irritability or depression, nervousness, difficulty concentrating, fatigue, shaking or weakness, tingling or numbness in hands, feet, or around the mouth.

In children, common signs and symptoms of mercury poisoning include irritability, anorexia, sleeplessness, poor muscle tone or weakness, leg cramps, hypertension, rash, excessive salivation or thirst, peeling skin, pink hands and feet, and gingivitis.

If you or your children have any of these symptoms and are using a skin-lightening or acne cream from Mexico, stop using the cream immediately and consult your health care provider about being tested for mercury poisoning.

For free medical advice in English or Spanish, call California Poison Control at 1-800-222-1222. Poison Control experts can also advise you on how to safely dispose of these creams.



'Belle' — based on a true story, is beautifully done

"Don't be afraid. I'm here to take you to a good life; a life you were born to." That's the opening line of the English Sir John Lindsay (Matthew Goode) speaking to a young girl (Guga Mbatha-Raw) of mixed race. It turns out she is his illegitimate daughter that he is taking possession of since her mother has died.

Since he is a Royal Navy Captain in the 1769 Colonial Empire who must return to duty, Lindsay takes the pretty young girl to Kenwood House to be raised by his uncle Lord Mansfield (Tom Wilkinson) and his wife Lady Mansfield (Emily Watson).

His uncle is both bewildered and astonished that his nephew has brought her here and

begs him to take good care of her, love her as he would, and that she gets all that is due her. When asked her name, her father replies Dido Belle Lindsay.

As Dido looks into her father's eyes, a man she does not know, there's a connection between the two and her father feels comfortable leaving her there. The household becomes a rumor mill, and soon villagers also know of the situation which puts Lord Mansfield, the renowned legal genius and Lord Chief Justice of England on the spot.

Fortunately for Dido, her half-cousin Elizabeth (Sarah Gadon) also resides in the house and as the two girls are near the same age they become fast friends. Dido is such a gentle child she does not mind that Elizabeth can eat with the family in the dining

room; but because of her color, Dido must eat in the kitchen.

Years pass and according to society; it's time for the girls to marry. Elizabeth draws quite a few prospects but when around her beautiful and alluring cousin, she is no match. Also Elizabeth has no dowry, while Dido's father has provided well for her and legally, she's due to inherit some of the Mansfield fortune. Occasionally it becomes a problem between the girls but they have a bond they do not break.

Soon to appear on scene are Lady Ashford's two sons James (Tom Felton) and Oliver (James Norton). While Oliver begins to court Dido and have feelings for her, his brother James is the opposite. Hostile and outraged that she's part of the Mansfield household; at one point he becomes physically abusive to her. In time Dido sees that it's Lady Ashford pushing for her son's reunion with Dido only because of her inheritance.

Not to worry, Dido somehow finds love with the vicar's son, John Davinier (Sam Reid). Not only is he truly in love with Dido and understands her situation, he's a political activist who joins her in her fight for the abolition of slavery.

The fine cast handles this based-on-a-true-story movie very well. Mbatha-Raw totally fulfills every emotion of Dido. She has appeared in 23 TV shows or movies and has another seven in production. Expect to see more of her in future films.

It's always good to see Academy-award nominated Tom Wilkinson. He's perfect in this role along with Watson. I love when he's asked by his wife if he loves Dido and he replies "As though she were created of you and me."

The real Dido Elizabeth Belle lived in 1700s England with the Mansfields. Lord Mansfield made history when he ruled on the Zong case in 1783 that changed the course of slavery in the British Empire.

Belle is a well-produced, heartwarming and intriguing film.

‘Godzilla’ — rules again

YIPES! *Godzilla* has grown leaps and bounds physically from his original legend. Warner Bros. has trotted out a brand new Godzilla monster who is 350 feet tall – big enough to kick in the windows of a high rise as well as its walls in downtown San Francisco. But all that terrific action is saved for the climaxing scenes, of course. Needless to say, Godzilla has returned and he is just as bad a guy as in his original 1954 incarnation. Or is he?

Borrowing from his long history, the new Godzilla is much spiffier than the old ones and I believe beautifully created. It's hard to believe, but there were 28 Godzillas made by its creators at Toho Film Studio in Tokyo. Although we never took them seriously, the Japanese did because of the nuclear connection and the fact they had been atomic-bombed not a few years earlier in World War II.

So the radioactive scare was real to them. To the Japanese, it was plausible a nuclear bomb explosion may have mutated animal forms and thus likely could produce monsters such as Godzilla and Mothra in the old films and the Motas

in the new one. Some of the Japanese-made films were pure camp, and we laughed along with them. The films attracted some actors famous in the west such as Raymond Burr, Cesar Romero, Joseph Cotton, Nancy Cartwright, and England's Vinnie Jones. The films didn't do much for their careers, but Godzilla didn't sink them, either. And no less a director is Martin Scorsese who has been an admirer of the zany sci-fi monster pictures.

What's up with the 2014 version of the beloved monster? Audiences so love Godzilla, they cheer when he makes his first appearance on screen. He has become a world-wide hero, and it seems his star glitter has not diminished one iota during the past 50 years of his celebrity

We now have young Aaron-Taylor-Johnson, a Brit playing an American soldier (as Ford Brody) and a bomb disposal expert for the U.S. Navy. He's the product of scientists Joe (Bryan Cranston) and Sandra (Juliette Binoche) who work at the local nuclear power plant. Earthquake tremors rattle the plant and Joe is determined to find out the cause. In the meantime, over in the Philippines mining pit, Japanese scientist Serizawa (Japanese film star Ken Watanabe) finds fossil bones bigger

than a whale.

Fifteen years after a nuclear accident at the plant, Cranston's character Joe goes off the rails and rants and carries-on trying to convince the authorities his suspicions are right about the radiation. Strangely, after all the years pass he doesn't grow one gray hair, even though his son Ford is now a strapping 23. Cranston is the only actor in the film who shows any emotion at all, whereas the other actors are nearly automatons with stone faces. Taylor-Johnson simply stands there and looks hand-

some but shows no inclination to act. We will reserve judgment until his next film forces him to emote.

On the whole, however, the film is extremely enjoyable.

Director Edwards uses the old show business trick of only giving us glimpses of Godzilla throughout the film until the climax. Tensions build, our expectations are running rampant, and the excitement of

seeing a city being destroyed brings back memories of the old films. When Godzilla and the Motas engage, we are in monster Heaven and our adrenalin goes into overdrive. It's well worth the wait.

Kennedy said Coleman brushed off praise by saying, "All I did was turn double plays, Mantle and the other guys did the rest."

The festivities included giveaways of 1984 Padres autographed jerseys, Padres tickets and the grand prize, a road trip for two to see the Padres play the Cubs in Chicago.

Witnessing this event made it clear that the members of that championship team are still

very much in the hearts and minds of Padres fans everywhere. Go Padres!
