

CA GROWN launches campaign to help California food banks

launched a social media campaign aimed at helping feed the state's hungry. For every photo of a California grown or produced food or beverage posted with the hashtag #CAGrown, CA GROWN will donate a pound of food to a California food bank.

California provides the nation with 90 percent of their produce, and yet over 3.7 million adult Californians experienced food insecurity in 2009 according to the California Health Interview Survey.

The hashtag promotion was launched at Ag Day at the State Capitol in Sacramento in March. "We created this program to help raise the awareness about the importance of buying food grown locally,

while at the same time providing that locally grown food to those in our community in need," said Nick Matteis, executive director of the Buy California Marketing Agreement, which manages CA GROWN.

CA GROWN is partnering with the California Farm Bureau Federation's (CFBF) Young Farmers and Ranchers

to help coordinate the donations. "We are very excited about our partnership with CA GROWN and expanding our annual contributions to food banks through the Feeding America Harvest for All program," said Kevin Robertson, chairman of the CFBF Young Farmers and Ranchers

Californians can participate by posting photos of meals at restaurants, or of anything grown or produced in California. CA GROWN also encourages people to take a picture with any products labeled CA GROWN, such as grapes, strawberries, eggs, flowers, etc. The campaign, which will run through October 31 will culminate in food donations at local food banks. Hashtags will only be counted on accounts that do not have a privacy block.

"It's heartwarming to see the photos that people are posting on social media, it's especially great to see young people getting involved," said Secretary of the California Department of Food and Agriculture Karen Ross. To view some of the photos, use #CAGrown to search Twitter and Instagram.



Help build a playground in one day at Wells Park on Saturday

re could use more volunteers! The City of El Cajon needs volunteers to help with the assembly of a one-of-akind, customized KaBOOM! playground at Wells Park on June 5 and June 7. The existing playground at Wells Park was in need of replacement. A new playground will provide youth with a new area to play and have fun!

The City of El Cajon, Foresters, Stoney's Kids, Boys & Girls Club of East County and KaBOOM! (a national non-profit organization that has built more than 2,400 playgrounds) have designed a customized playground for Wells Park, located at 1153 East Madison Avenue. The playground, funded primarily by Foresters, was created from personal drawings and local community members'

Sidewalk CPR Day is Thursday, June 5

Sidewalk CPR Day is set for Thursday, June 5! The goal of this Southern California campaign is to train approximately 3,500 citizens in "Hands Only CPR," thus increasing the number of lifesavers in our community. Sudden cardiac arrest kills over 1,500 San Di-

egans each year and medical science has proven that community based CPR programs, designed to teach bystander CPR, has a direct impact on cardiac arrest survival.

On June 5, from 9 to 10a.m., Heartland Fire & Rescue personnel will provide Sidewalk CPR training at City Hall in El Cajon, La Mesa and Lemon Grove. Then, from 10 a.m. to 12 p.m., they'll provide Sidewalk CPR training at Parkway Plaza in El Cajon, Grossmont Shopping Center in La Mesa, and at Albertsons, located at 7090 Broadway in Lemon Grove. This life-saving effort is sponsored in conjunction with San Diego County Health and Human Services, the American Red Cross, the American Heart Association and San Diego Project Heart-

Trained personnel will educate the citizens on when to call 9-1-1, when to use CPR, and how to provide Hands Only Sidewalk CPR, showing them where to place their hands, how deep to push and the rate

of compressions. Educational material about Sidewalk CPR will be distributed at each event with a request to pass this life-saving information onto family and friends. Thanks to support from the City Managers in El Cajon, La Mesa and Lemon Grove, Heartland Fire & Rescue will provide this training to City staff on June 5.

Six-Time NASCAR Champion Jimmie Johnson returns to his hometown of El Cajon for a special tribute

Jimmie Johnson will be in El Cajon, weather permitting, on Tuesday, June 17! On that day, the El Cajon City Council will hold a special celebration to recognize the El Cajon native for his racing accomplishments and philanthropic contributions to the community. The City is encouraging everyone to attend and show their support for one of NASCAR's biggest stars.

El Cajon Mayor Bill Wells, the City Council, Senator Joel Anderson, and other local dignitaries will be honoring Johnson during a special ceremony beginning promptly at 11 a.m. local time. Due to Jimmie's time constraints, this is not an autograph event. His #48 show car will be on display at this event and special #48 Hero cards will be available, while supplies last. Additionally, portions of the event will be broadcast live on 101.5 KGB.

Johnson continues to make his hometown proud. In 2013, he won his sixth NASCAR Sprint Cup Series championship, adding to a NASCAR record five championships in a row (2006-2010). At just 38, he is the youngest driver

to win six titles. His 68 wins since 2002 puts him eighth on the all-time wins list. Just over the past two weeks, Johnson won back-to-back races, the Autism Speaks 400 and the Coca Cola 600.


It's Bluegrass Music at the next Friday night "Dinner & a Concert"

Men at risk for the silent killers — many haven't seen a doctor in the past year

any fathers, husbands, sons, brothers, and boyfriends share a common ailment called "Doctor-itis" – avoidance of a trip to the doctor. Whether it's a "macho" thing as some research suggests, or simply fear or lack of time, the scary fact is that men don't take time out of their day to see a doctor.

In honor of Father's Day (June 15) and Men's Health Week (June 9-15), local doctors at AFC/Doctors Express centers in our area urge men to come in for a checkup. Urgent care centers are ideal for the man on the go – no appointments are necessary and later hours offer convenience. The time is right for a doctor's visit since survey information by the American Academy of Family Physicians and the Men's Health Network (MNH) reveals:

- •55 percent of U.S. men haven't seen their M.D. in the past year, and men make half as many doctor visits for prevention as women. (AAFP, National Institutes of Health)

"While many men have the attitude that 'nothing's wrong,' or 'I'm fine,' there are several medical problems that don't present symptoms and can lead to trouble down the road if they aren't addressed," says Dr. D. Bruce Irwin, founder of American Family Care. "Most men are guilty of 'doctor avoidance,' and we're urging men to step up and take charge of their health, just as they do with other aspects of their lives."

Men's hidden health risks

Doctors and experts at the American Osteopathic Association recommend physicals to rule out common problems or identify health risks that often don't show obvious signs including:

- More men are involved in suicides and car accidents, linked to depression and "risky" youthful behaviors.

"A routine checkup, paired with screenings and lifestyle changes, if necessary, can reduce the risk of chronic illness for men, as well as the chances of needing surgery later in life," Dr. Irwin says. "We want men to embrace a healthy lifestyle and visit the doctor to get the care they need and deserve."

Men's checkup checklist

Viewing the doctor as an ally rather than an adversary can lead to a longer, healthier life for men. AFC/Doctors Express physicians recommend men follow a Checkup Checklist with a medical professional to address issues that impact men's health the most. According to the NIH that includes:

- •Blood pressure: Normal blood pressure is 120/80. If your numbers are higher, your doctor may recommend lifestyle changes, medication or monitoring.
- Cholesterol: Men ages 34 and over should be checked every five years.
- •Colon cancer: Men over age 50 should get regular

screenings for colorectal cancer.

- •Heart disease: According to the CDC, high blood pressure, high LDL cholesterol, and smoking are key risk factors for heart disease. About half of Americans (49 percent) have at least one of these three risk factors.
- Immunizations: Men should get a flu shot every year. Other vaccinations may be needed if you have other medical conditions
- Osteoporosis: Men ages 50-70 who smoke, drink alcohol or are sedentary, should be screened for osteoporosis.
- Prostate cancer: Men over 50 should get a prostate cancer screening annually. Those with a history of prostate

cancer and black men should start screening at 45.



Representative D-Day "invasion striped" P-51 Mustang and P-47 Thunderbolt fighter aircraft plus C-47 "Dakota" will join D-Day Doll and others at AirShow San Diego and in the flying performance period from 11 am to 2 pm both Saturday and Sunday.

The AIRBORNE ASSAULT into Normandy as part of the D-Day Allied invasion of Europe was the largest use of airborne troops up to that time. Paratroopers of the U.S. 82d and 101st Airborne divisions, the British 6th Airborne Division, the 1st Canadian Parachute Battalion, and other attached Allied units

took part in the assault. Numbering more than 13,000 men, the paratroopers were flown from bases in southern England to the Cotentin Peninsula in approximately 925 C-47 and C-53 airplanes, including the now named "D-Day Doll." An additional 4,000 men, consisting of glider infantry with supporting weapons and medical and signal units, were to arrive in 500 gliders later on D-Day to reinforce the paratroopers. The parachute troops were assigned what was probably the most difficult task of the initial operation -- a night jump behind enemy lines five hours before the coastal landings.



Portrait of a dedicated gadfly is a must see

is father both had an affair with Amelia Earhart and designed a plane so safe that even his 10-year-old son could fly it – and he is shown doing so in Gore Vidal: The United States of Amnesia.

Vidal spent three years in World War II, where he "never heard a patriotic word said about anything." After an early discharge for crippling arthritis, he became a successful writer at 21 with his first book, Williwaw, a sea story based on his Alaskan Harbor detachment during the war.

In 1948, the publication of *The City And The Pillar* caused a furor with its explicit depiction of homosexuality – and so offended New York Times book critic Orville Prescott that he refused to review it, nor allow reviews of his next five novels.

Vidal turned to Hollywood for work and doctored the screenplay for *Ben Hur*. He drove through Italy with Tennessee Williams and bought a fabulous home on the hills of the Amalfi Coast.

But he was probably best known for debating anyone and everyone – most notably William F. Buckley, when they were both hired to provide political commentary for the Democratic and Republican national conventions in 1968.

Gore Vidal: The United States of Amnesia uses largely archival footage and interview snippets to illustrate the life of this gadfly extraordinaire. He spent 38 years with Howard Auster in a nonsexual friendship. "Sex ruins relationships," he said, "though he also claims to be a dedicated libertine.

Filmmaker Nicholas Wrathall calls him "the last lion of the age of American liberalism." Vidal was certainly one of the most vocal – and possibly the most entertaining. He was a sound bite machine, a fact Wrathall takes advantage of by flashing some of his most famous quotes on the screen. Here are a few of my favorites:

"You don't decide to write. You are one or you aren't." "The war on terror is abstract. It's like a war on dandruff."

"The U.S. was founded by the brightest people in the country – and we haven't seen them since."

Vidal hobnobs with Hollywood celebrities like Paul Newman and pols like Mikhail Gorbachev (at the glasnost summit in 1986), rails about American adventurism and stolen elections that he says indicate the loss of the American republic.

"The lies are based on the most advanced techniques of advertising, the only art form my country has ever created," he said. "We sell presidents and soap in the same fashion."

Gore Vidal: The United States of Amnesia is a fascinating (if partisan) portrait of a dedicated gadfly. It's a must-see for every American.

Pet seat belts save lives

No matter what type of pet seat belt you choose, you must always use a harness - never a collar. A collar can easily choke or strangle your pet if you stop fast or are in an accident. In addition, pet's should never ride in the front seat. Deployed airbags can seriously injure pets.
