

Independence Day celebrations



Independence Day celebrations are taking place all over San Diego county next Thursday and Friday, July 3 & 4. Shown above are photos from last year's Kennedy Park celebration in El Cajon. See page 3 for a full list of celebrations and firework displays. Remember fireworks are dangerous and illegal in all of San Diego and San Diego County. That includes sparklers, firecrackers, cherry bombs, bottle rockets and even poppers. The National Fire Protection Association (NFPA) says there is no safe way to use consumer fireworks. According to NFPA research, there are far more U.S. fires reported on a typical Independence Day than on any other day, and fireworks account for more than half of those fires, more than any other cause of fires. Each year, fireworks cause thousands of fires, including outside fires, structure fires and vehicle fires. These fires result in millions of direct property damage each year. There are also thousands of fireworks-related injuries that are treated in hospital emergency rooms. The highest injury rates are for teenagers 15-19-year-olds and children aged 5-9-year-olds. Antique or collectible?

n purist terms, and according to the U.S. Customs Service, an antique is an item with at least 100 years of age under its belt. That means that genuine Victorian pieces are now true antiques.

However, the term antique is used rather loosely among the masses, and often ends up reflecting the age of the person using it. 

'C' your way to stronger bones: Seven surprising benefits of Vitamin C

ost Americans be-lieve that the best way to strengthen bones and stave off osteoporosis is to ingest as much calcium as possible. No wonder: We constantly hear advice like "Drink your milk!" and (especially if we're women of a certain age) "It's soooo important to take your calcium supplements." But Thomas E. Levy, MD, JD, begs to differ. He insists that an excess of calcium won't improve bone strength or help fight osteoporosis—and that the best way to

achieve those is to load up on vitamin C.

Yep. Vitamin C.

"While many supplements can strengthen bones and help slow (or even reverse!) osteoporosis, vitamin C is one of the most effective," says Dr. Levy, author of Death by Calcium: Proof of the Toxic Effects of Dairy and Calcium Supplements (MedFox Publishing, 2013, www.deathbycalcium. com). "But to understand why, it's first necessary to clear up a few widespread—and dangerous-myths about calcium and osteoporosis.

"The problem with osteoporosis is that the body is unable to synthesize a new structural bone matrix and integrate calcium into it-an issue that more calcium doesn't even begin to fix!" he explains. "The steady loss of calcium from osteoporotic bone is a symptom of the disease, not the cause. Actually, much of the calcium leached from the bones simply moves to other parts of the body, where it does you harm.³

That's right. Despite the good PR calcium tends to enjoy, Dr. Levy says too much of it reliably promotes heart disease, high blood pressure, strokes, cancer, and other degenerative diseases. In fact, in a large study, all-cause mortality increased by 250 percent in women with the highest dietary and supplemental intake of calcium

But back to osteoporosis. If loss of calcium from osteoporotic bones isn't the cause of the disease, what is? The answer may surprise you.

"Osteoporosis is focal scurvy of the bones," Dr. Levy says. "In a nutshell, your bones contain bone-building cells (osteoblasts) and bone-dissolving cells (osteoclasts). Focal scurvu of the bones causes an imbalance characterized by too many osteoclasts and results in a detrimental breakdown of the bone integrity, along with calcium loss. And since scurvy is a severe vitamin C deficiency, these symptoms can be prevented, cured, and reversed with appropriate dosing and administration of vitamin C and other important nutrients.'

In Death by Calcium, Dr. Levy presents compelling scientific evidence that systematically debunks much of what Western society believes about calcium and osteoporosis. Here, he shares seven ways in which vitamin C helps build strong bones and improve overall health:

Vitamin C defends against oxidative stress. First, a little background: When a toxin enters the body, it starts a molecular "fire" that grows and spreads like a blaze through a forest. Scientists call these "fires" oxidative stress. Oxidative stress is combated by antioxidants: molecules that extinguish oxidative stress and neutralize the original toxins without becoming toxic themselves. Interestingly, chronically elevated calcium levels appear to be a common denominator for most, if not all, forms of oxidative stress

"Here's the vitamin C connection: As an antioxidant, it is a frontline defender against oxidative stress, which greatly impairs the production of healthy bone matrix and plays a role in the cause and development of osteoporosis," explains Dr. Levy. "In other words, vitamin C supplementation can result in a healthier bone structure. Furthermore, as an antioxidant, vitamin C can help prevent and address all degenerative diseases including cancer, since oxidative stress is a well-known causal factor.'

It increases bone density. Research demonstrates the strong relationship between vitamin C supplementation and bone density. In one study, postmenopausal women with a high dietary intake of vitamin C had greater bone mineral density, but only in the lumbar region of the spine.

"However, individuals who supplemented with vitamin C saw significantly higher bone mineral density at all sites tested," says Dr. Levy. "The increased density was particularly evident at the femoral neck, which is the typical site for most hip fractures.'

Vitamin C supplementation

have suffered an osteoporotic fracture have been found to have significantly lower blood levels of vitamin C as compared to their fracture-free peers.

"Multiple studies mirror these results and support the conclusion that supplemental vitamin C lowers the risk of osteoporotic fractures," Dr. Levy comments. "It's worth noting that the relatively small amounts of vitamin C that are tupically ingested via any dietary regimen are not sufficient to impact fracture risk.'

It accelerates and improves the quality of bone healing. In addition to accelerating the bone healing process per se, vitamin C is also important to the 1) formation of non-collagen bone matrix proteins, 2) differentiation of mesenchymal stem cells into bone cells, and 3) the regulation of cartilage-forming cells in the bone.


Collectively, this means that

vitamin C contributes substantially to both the speed and the quality of healing in fractured bones," explains Dr. Levy. "And, in fact, a sufficient deficit of it can result in the failure of a fracture to heal.

Supplementation protects against dangerous calcifications. In osteoporotic patients. calcium leaches from the bones into non-bone tissues. These abnormal calcifications directly contribute to heart disease, stroke, cancer, and more.

"Not only does vitamin C help to reincorporate calcium back into the bones; it also prevents calcification and calcium depositions elsewhere in the body by keeping calcium in a dissolved state," Dr. Levy asserts.

Vitamin C protects against calcium-laden kidney stones. One particular (and particularly painful) manifestation of abnormal calcification in the See VITAMIN C page 10

body is seen in the formation of kidney stones. While the popular press and uninformed physicians have accused vitamin C of initiating kidney stones, nothing could be farther from the truth.

"When adequately dosed, vitamin C can be expected to inhibit or even prevent the oxidative stress that causes kidney stones," Dr. Levy states. "Anecdotal evidence (which is consistent with the calciumdissolving properties of vitamin C) even indicates that vitamin C can dissolve and/or resolve preexisting stones in humans and animals!"

the huge race track outside of Las Vegas and partied for three days. Oh, the hangovers and tired leg muscles!

The movie is shot in the realistic depth process of 3D, although it neither enhances nor distracts from the show. Occasionally there will be a shot that thoroughly uses the 3D effect, but most of the wide looks at the crowds make no difference.

What does make a difference, however, is Cinematographer Reed Smoot's brilliant use of the Technicolor process to brighten banners, colored lights, dazzling costumes, and the carnival itself . The colors are so vibrant, so startling they

They won two Emmy's for *Top Chef* in 2010 and 2013. They won a Peabody Award for Project Runway. In 2011 they produced Justin Beiber: Never Say Never, which became the third highest-grossing documentary of all time. They went on the direct their first motion picture, Katy Perry: Part of Me for Paramount in 2012.

Under the Electric Sky is going to appeal more to the college set and those young people who have an unquenchable thirst for loud music, wild dancing, hard-drinking, and just plain fun. Mom and Dad? You can go, too. But bring your earplugs!



Only the Good...

THE CLASS (2006-07) Comedy kings David Crane (Friends) & Jeffrey Klarik (Mad About You) bring you the tale of an overeager romantic (Jason Ritter) who hosts the ultimate surprise party for his fiancée: a reunion of their third-grade classmates to celebrate the 20th anniversary of the day they met. Unfortunately, things do not go as planned as we are plunged into the dark comic world of this ahead-of-its-time sitcom serial that plays like the mutant spawn of Friends and Melrose Place. Extra-marital affairs, suicidal tendencies, friendship and other lies all provide ample fodder. Classmates of note include The Walking Dead's Jon Bernthal, Modern Family's Jesse Tyler Ferguson, Mr. Sunshine's Andrea Anders, Once Upon a Time's Sean Maguire and Party Down's Lizzy Caplan. Notable guest stints from David Keith, Sara Gilbert, and Sam Harris. Directed by James Burrows (Frasier). 19-Episode, 2-Disc Collection.

THE LAST OF MS. SHEARER?

THE LAST OF MRS. CHEYNEY (1929) This first film adaptation of the stage play - and Norma Shearer's second sound film - embodies the same froth and frill as the later Joan Crawford/William Powell version while providing a fascinating glimpse at how the story must have played on-stage. Shearer plays the eponymous Mrs. Cheyney, an Australian arriviste to the socialite circle who employs a valet of most particular resources (George Barraud) who is more than what she seems. Basil Rathbone plays Lord

Dilling, the aristocrat who gets a lesson in morals from the criminal class.

HER CARDBOARD LOV-ER (1942) George Sanders plays the romantic rogue that Norma Shearer's socialite can't say no to, driving her to the desperation play of hiring Robert Taylor's muse-blocked songsmith to play her faux amour. Unfortunately for the socialite, this is one song and dance man that isn't playing around. Norma Shearer's cinema swan-song finds her in fine form ably supported by the dashing pair of Taylor and Sanders. Sanders depiction of romantic conceit flummoxed is a particular delight. FIRST COUSIN ONCE REMOVED (2012) A distinguished poet, translator, critic and teacher, Edwin Honig

His seminal translations awakened English-speaking readers to previously overlooked literary giants, resulting in honorary knighthoods from the king of Spain and the President of Portugal. The film reflects Honig's life steeped in tragedy, love, loss, irony and literary daring with the same raw honesty that resonates in his poetry.

LIFE ACCORDING TO SAM (2014)







ORDINANCE NO. 5009

AN ORDINANCE TO EXTEND AN INTERIM ORDINANCE ADOPTED AS AN URGENCY MEASURE PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 65858

TO ESTABLISH A MORATORIUM ON THE APPROVAL OF ANY NEW HOOKAH AND ELECTRONIC/VAPOR

SUBSTANCE INHALATION SHOPS AND LOUNGES IN THE CITY OF EL CAJON

THE CITY COUNCIL OF THE CITY OF EL CAJON DOES ORDAIN AS FOLLOWS:

SECTION 1: Findings and Declaration of

That the City of El Cajon has an overriding interest in planning and regulating the use of property within the City. Implicit in any plan or regulation is the City's interest in maintaining the quality of urban life and the character of the City's neighborhoods. Without stable, well-planned neighborhoods, sections of the City can quickly deteriorate, with tragic consequences to social, environmental, and economic values.

On January 14, 2014, and March 11, 2014, the City Council heard testimony from the public requesting amendments to the El Cajon Municipal Code ("ECMC") to regulate, through the City's Zoning Code ("Title 17" or the "Zoning Code"), the establishment of locations of businesses that sell electronic/ vapor inhalation products (commonly referred to as "electronic cigarettes," "e-cigarettes, "hookahs," "water pipes," "hookah pipes," and other similar devices, as well as such cartridges, substances, and additives used to experience the sensation of smoking vapors, tobacco and non-tobacco substances) (collectively. "Electronic/Vapor Inhalation Products"). and as well as to consider amendments to the ECMC to regulate the sales of Electronic/Vapor Inhalation Products in the City of El Cajon.

The City Council recognizes the dramatic increase in the use of Electronic/Vapor Inhala-tion Products within the community, and the commensurate increase in businesses offering Electronic/Vapor Inhalation Products for sale to the public and businesses providing areas where customers can smoke or inhale vapor from hookahs, electronic vapor devices, or electronic hookahs often referred to as lounges or bars ("Lounges"); and that the problems associated with the unregulated sale of Electronic/Vapor Inhalation Products and the use of properties for Lounges, will lead to increased consumption of such products by the youth of the community, thereby likely leading to unhealthy behavior on the part of youth, with concerns related to the harmful effects Electronic/Vapor Inhalation Products could have on our youth. The City Council has also become concerned with the unregulated use of commercial property for Lounges, which might create unwanted and undesirable activities in and around the properties where Lounges are established, and has determined that local control through land use regula-tory authority is necessary to ensure public health, safety and welfare by addressing the effects and impacts Lounges might have to the community.

Accordingly, the City Council has an interest in modifying the City's land use regulations to adopt a legally enforceable method to regulate the establishment of vendors of Electronic/ Vapor Inhalation Products and businesses erating Lounges in the community.

Amendments are needed in Title 17 of ECMC to accommodate this change. Pursuant to ECMC Section 17.20.020, amendments to

Title 17 can be initiated by adoption of a resolution of intention by the City Council or the Planning Commission. Resolution No. 020-14 was adopted by City Council on March 11, 2014.

SECTION 2: Purpose.

The purpose of this ordinance is to extend the existing moratorium on additional Electronic/Vapor Substance Inhalation Shops and Lounges from doing business in the City of El Cajon, which was established by urgency ordinance (Ordinance No. 5008) for an initial period of 45 days, for an additional period of 10 months and 15 days. Such an extension is necessary to allow such reasonable time for a detailed study of the possible adverse impacts such establishments might have on commercial uses, may be made, and for such reasonable amount of time that any changes to the Zoning Code can be reviewed and considered for approval by the Planning Com mission and the City Council as contemplated by Resolution No. 020-14.

"Electronic/Vapor Substance Inhalation Shops and Lounges" are defined as those businesses that sell electronic/vapor substance inhalation products (commonly referred to as "elec-tronic cigarettes," "e-cigarettes," "hookahs," "water pipes," "hookah pipes," and other similar devices, as well as such cartridges, substances and additives used to experience the sensation of smoking vapors, tobacco and non-tobacco substances) (collectively, "Electronic/Vapor Inhalation Products"), both for off-site uses, and on-site uses by providing areas where customers can smoke or inhale vapor from hookahs, electronic vapor devices. electronic hookahs, often referred to as lounges or bars ("Lounges").

SECTION 3: Urgency.

This ordinance is an interim ordinance adopted as an urgency measure pursuant to Govern-ment Code Section 65858 and is for the immediate preservation of the public peace health and welfare. The facts constituting the urgency are these:

Unregulated locating of such establishments may be in conflict with contemplated zoning and other regulations to limit the number, location, and activities of such establishments; to deter the increased use of Electronic Vapor Inhalation Products and resulting health problems from such activities within the City's zones. Thus, in view of the facts set forth in Section 1 of this ordinance, it is necessary to immediately study, hold public hearings, and consider an amendment of the City's Zoning Ordinance and other applicable ordinances, and the adoption of restrictions or regulations as they may be recommended to the City Council by the Planning Commission. A comprehensive set of restrictions and regulations cannot be enacted without due deliberation, and it will take an indeterminate length of time to work out the details of such comprehensive restrictions. It would be destructive of the proposed restrictions if, during the period they are being studied and are the subject of public hearings, parties seeking to evade the operation of these restrictions in the form which may be adopted should be permitted to operate in a manner which might progress so as to defeat in whole or in part the ultimate objective of those restrictions.

SECTION 4: Condition.

That no persons, partnerships, corporations, or other entities shall commence doing busi-ness as, nor shall a business license be issued to owners or operators of. Electronic/Vapor Substance Inhalation Shops and Lounges, as defined herein, except those establishments specifically excluded herein, until such reasor able time as a detailed study may be made and the zoning and/or any necessary specific plan amendment, and public hearing processes pertaining to these matters is completed, or for ten (10) months and fifteen (15) days from and after June 28, 2014, whichever occurs sooner, except as may be extended as provided by Government Code Section 65858

SECTION 5: Regulation.

(A) Notwithstanding any provision of ECMC to the contrary, no persons, partnerships, corpo rations, or other entities, shall be issued busi ness licenses, or special operation licenses to operate businesses as Electronic/Vapor Substance Inhalation Shops and Lounges as defined herein, within the City of El Cajon.

(B) Establishments excluded from this ordinance are those establishments already in operation at the time of the enactment of this Urgency Ordinance.

SECTION 6: Taking Effect.

This ordinance shall take effect immediately upon passage by a 4/5ths vote of the City Council, and in accordance with Government Code Section 65858 and El Caion Municipal Code Section 17.15.100 and is of no further force or effect on the date that the abovementioned zoning ordinance becomes opera-tive, or until ten (10) months and fifteen (15) days from and after June 28, 2014, whichever is sooner, except as may be extended as provided by said sections.

2.Yogurt. This provides a great source of protein for dogs (especially Greek yogurt). Make sure to avoid the brands high in sugar and preservatives.

3.Lean proteins (like chicken, turkey and beef). Most of these meats are found in your pet's dry and wet foods anyway and are filled with healthy fats and proteins dogs need to maintain a healthy weight and energy level. Just be sure to feed them lean proteins that have not been cooked with strange vegetables, oils or wines.

4.Salmon. The omega-3 fatty acids are good for your

What's not safe

Unless you live under a rock, you know that chocolate and cocoa are completely off limits. However, that's not the only favorite snack of yours that could poison your dog. Other everyday items, like onions and grapes could also really sicken, or kill, your best friend. Check out this list of the most poisonous foods, provided by Web MD for pets, for dogs and be sure you keep them far away from your pup's curious snout! These poisonous foods are bad for all dogs, but are even more extreme for smaller breeds, like shih tzus, Yorkies, chihuahuas and tea cup breeds.

1.Chocolate and cocoa. The reason behind the toxicity in this sweet treat lies in the theobromine, or toxic agent. Just one bite can cause a dog to vomit or have diarrhea. It can also cause abnormal heart rhythm, tremors, seizures and death. **2.Grapes.** These popular fruits need to kept away from your pup, especially if your dog is older or sick. Something in the grapes is known to cause kidney disease in most breeds.

3.Avocados. This healthy fruit contains persin, which is known to give dogs vomiting and diarrhea.

4.Onions and garlic. These flavor enhancers need to be kept far away from your dog. Large volumes of these vegetables and herbs can cause gastrointestinal irritation and red blood cell damage, which can lead to anemia.

5.Alcohol. Feeding your pet beer or wine isn't funny, it could be deadly. Just a drop can lead to vomiting, diarrhea, central nervous system depression, difficulty breathing and even death. The effects are even worse in smaller breeds.

6.Milk and dairy products. Just one slice of cheese won't kill your pet, but excessive dairy will likely negatively disrupt their digestive system, since dogs don't have as much of the lactose breaking enzyme that humans do.

7.Coffee. Just a sip of coffee or caffeine can lead to restlessness, heart palpitations and bleeding, while a large dosage can be fatal.

8.Gum. Xylitol, or the sweetener found in gum and candy, can lead to liver failure and hypoglycemia. In addition, a dog's digestive system cannot break down gum the way humans do and the sticky substance can block up their system, which can quickly lead to death.

View human food as a treat to your pet, not as something you give them in place of their own dog food. Although the foods listed in the healthy category are good for pets, too much can upset their digestion or make it harder for them to eat their own food. A few pieces of chicken or salmon can be a great incentive if your pup is behaving or does a trick.
