## El Cajon Host Lions Clubs deliver Christmas Baskets

The El Cajon Valley Host Lions Club will deliver 100 Christmas food baskets on December 20 starting at 7 a.m.

Each year, for the past 27 years, the Lions Club has delivered food baskets to the needy of East County. This year's chairman, Roy Collura, will collect all the food at, 215 W. Lexington El Cajon, where it will be divided up into identical baskets (boxes) for delivery by the Lions and Leo's Club of El Cajon High School.

Each basket will contain a 15 lb Turkey, various canned goods, milk, bread, cereal, noodles, rice, apples, eggs, cheese, cookies, soup, celery, stuffing mix and much more. Last year the San Diego Food bank sold the Lions various food items at a steep discount enabling them to deliver the much needed food to additional families. That relationship will continue this year.

This annual tradition began in 1967 when the Lions delivered food to 25 families. That number grew to 33 by 1998

and last year they delivered to 100 families and 15 more were picked up.

The Lions will pack their own boxes and make the deliveries in their private vehicles with the help of the Leo's. The Salvation Army provides the list of families in need based on criteria that they have used for years.

## Holidays hazardous to your health? Tips for staying healthy

**I**t's a sad statistical fact: The holidays, from Christmas to New Year's, are a treacherous time when it comes to our health.

"There's a spike in heart attacks and other cardiac issues," says Dr. John Young, a physician specializing in the treatment of chronic illnesses through biochemical, physiological and nutraceutical technologies, and the author of "Beyond Treatment: Discover how to build a cellular foundation to achieve optimal health," [www.YoungHealth.com](http://www.YoungHealth.com).

"The incidence of pneumonia cases spikes – in both cold and warm climates. And deaths from natural causes spike. In fact, more people die of natural causes on Christmas Day than any other day of the year!"

While those numbers are well-documented, the cause(s) are not.

"Stress plays a role, particularly if your immune system is weakened," Dr. Young says. "If you look at how most of us eat from Halloween through New Year's, it's easy to see how the immune system takes a beating and otherwise healthy people become more susceptible to illness during the holidays."

It's basic biochemistry, he says.

"We eat a lot more refined

sugar, for instance, which is a carbohydrate that's been stripped of all the vitamins, minerals and proteins that make up a complete carbohydrate," he says. "Our bodies can't use that, so the cells in our digestive organs work overtime, burning up a lot of energy, vitamins and minerals to digest it, and they get nothing back. So, eventually, they grow weak."

So – can we have a little sugar, and good health, too? Dr. Young says we can.

"The occasional slice of pumpkin pie is fine as long as you're also feeding your cells with the nutrients they need – the minerals, vitamins, good quality protein, amino acids, essential fatty acids – to stay healthy."

He offers these tips for staying healthy through the holidays and throughout the year.

### Get your vitamin D!

Vitamin D is actually a hormone, not a vitamin, and one of our best sources for it is sunshine. Unfortunately, many people work indoors all day, so they get little sun exposure. When they do go outside, they wear long sleeves and sunblock to protect against skin cancer. And, of course, in the wintertime, people in cold climates tend to stay inside. As a result, many of us are vitamin D deficient, and should be taking supplements.

"Vitamin D is crucial to many physiological systems, including our immune defenses," Dr. Young says. "It helps fight bacterial and viral infections, including the flu. It supports our cardiovascular system; optimal vitamin D levels can reduce hypertension, heart attacks and stroke."

"If I feel I'm coming down with a cold, I'll take 40,000 units of vitamin D at bedtime," he says. "The next morning, I usually feel like a new person."

**Eat your protein** – 1 gram for every 2.2 pounds of body weight daily.

In this country, we think a healthy diet means eating a lot of fruits and vegetables. We've forgotten protein, Dr. Young says.

"Our immune system is made up of proteins – our bones are 40 percent protein," he says. "We need protein."

When calculating your protein intake, consider: an egg has about 8 grams, and 8 ounces of fish, chicken, beef or pork have about 30 grams.

Dr. Young does not give any of his patients more than 100 grams of protein a day.

**Get a good night's sleep, exercise, and manage your stress.**

Yes, some doctors' orders never change. Rest, exercise and finding effective, healthy ways to cope with stress are simple ways to pamper your cells.

"One of the many cellular benefits of exercise is that it increases the oxygen in our bloodstream. Every cell in our body requires oxygen, so consider exercise another means of feeding your cells."

It's also important to manage stress during the holidays. With unchecked stress, our body releases large amounts of cortisol which, among other things, suppresses the immune system.

"Take time out to meditate, listen to music, or take a walk in the woods," Dr. Young says. "It feels good – and it's good for you!"

# At the Movies

## 'The Homesman' — home on the range with a shocking twist

**R**ough, gruff actor/director Tommy Lee Jones has single-handedly brought the American open plains in the 1850s Midwest back to the widescreen. Nothing is better suited to the grand widescreen than the old America west of the Mississippi, as captured beautifully by Cinematographer Rodrigo Prieto in *The Homesman*.

Novelist Glendon Swarthout wrote the book in 1988 and Jones turned it into a screenplay with buddies Kieran

Fitzgerald and Wesley Oliver. Swarthout intended the title to convey the meaning of when immigrants were taken back home, typically by a man, or a "homesman."

Oscar-winning actress Hilary Swank plays a well-situated single woman named Mary Bee Cuddy who owns a large piece of land which she farms. She was formerly a school teacher in the East but felt the western territories would offer her more opportunities. She settled in Nebraska, but suffers from depression after having been alone for so long. She's not exactly an old hag,

nor is she a raving beauty, but is simply referred to as "plain."

Swank plays Mary Bee as a frisky, no-nonsense kind of a woman who goes after what she wants. And what she wants is a husband to share her farm and life with and raise a family. Although she is only 30 -- an ancient age in those days -- she doesn't give up in her quest to find happiness. She pursues and proposes marriage to several young men who reject her for being too unattractive or too old. This throws her into another blue funk. She's a desperate woman but, by golly, Swank plays her as an undefeated woman with verve.

This prompts her to seek some adventure to brighten her dreary life. When three pioneer women lose their sanity because of varying degrees of tragedy, the local Reverend asks for a man to escort the insane women to Iowa where they will be taken care of by a church that caters to the mentally ill. No man volunteers, so Mary Bee gleefully takes it upon herself to

drive the women in a covered and locked coach to satisfy her need for some excitement and a change of scenery.

As she makes her journey she runs into ruffian George Briggs (Jones). He is a claim jumper and has been lynched, so he begs Mary Bee to take

him on and save his life. He's an uncontrollable sort and just the perfect type of character for Jones' craggy face and uncivilized manner. Even so, Mary Bee sees he is breathing and is a male, so she makes a desperate attempt to have him agree to hook up with her. It doesn't turn out as she expected and there is a shocking twist.

Swank does a first-rate job of acting like a desperate spinster, and Jones is usually a curmudgeon on screen, so he's perfect for Briggs. Meryl Streep comes in for a ten-minute cameo as a preacher's wife and commands the screen. She makes everything look as though we could all act ourselves, but you know in your heart you cannot touch the hem of her skirt. Viva Meryl!

## Chargers beat Rams in a nail-biter 27-24

On a picture perfect 72° sunny day in Mission Valley, the San Diego Chargers played a hot St. Louis Rams team fresh off a beat down of the Denver Broncos, earlier victors over the world champion Seattle Seahawks. Both teams were desperate for a win. This game was a thriller going down to the final minute on a game-changing play.

Improving their record to (7-4), three games over .500 keeping their playoff hopes alive, the Chargers snatched a victory from the jaws of possible defeat after it appeared the Bolts were giving the contest away to a now floundering (4-7) St. Louis Rams team. But persevered hanging on at the end for a big win with some kind of finish. In a wild and crazy game with more ups and downs than a roller coaster there were mixed emotions with plays both good and bad. The good outweighed the bad for San Diego thanks to a game saving interception by Chargers defender Marcus Gilchrist.

Redemption was seen on the face of the Chargers strong safety as he iced the win playing the hole as a "robber" stepping in front of 37-year old, 13-year veteran QB Shaun Hills' unwise second-and-goal pass. Intercepting it and smartly falling to the ground at the two-yard line securing the ball and the three-point win in the final minute of the game. #38 thanked God for the opportunity to play the game he loves stating, "It's truly a blessing and a dream. When you got to fight and scratch as a team to get these wins, these are the type you build off of," said Gilchrist.

"We were in a coverage

where I didn't have too much responsibility. I was able to get my eyes back on the quarterback (thanks to tight coverage of Rams WR Kenny Britt by Bolts cornerback Shareece Wright). Somebody had to make a big play on defense for us to win. I saw the crossing route coming. As soon as he let go of the ball I was able to step in front of it," said the former Clemson alumnus getting his first interception of the season. Gilchrist a blue-collared worker with five career interceptions redeemed himself with his first pick in 16-games. This came one year after dropping a sure interception playing against head coach Jeff Fisher with his former team the Tennessee Titans.

"Games like this, someone has to step up and make the play and end it. That's exactly what he did. It was an outstanding team win. Going out there and playing together, just believing in one another, that's what this game is all about," joyously declared Bolts Head Coach Mike McCoy.

Redemption was not only on the mind of the Chargers defense, but also on the mind of second-year wide receiver Keenan Allen who had a rough game Sunday, but didn't let it deter him from catching the game winning pass in the fourth quarter, a 29-yard strike from Chargers quarterback Philip Rivers.

Philip Rivers threw a lot of underneath stuff getting what the Titans were giving him. Missing on only six passes, the future Hall-of-Famer connected on 29-of-35 attempts for 291-yards. He got hurt early not in the chest but on a Janoris Jenkins ill advised pass interception which the Rams corner took to the house on a 99-yard pick six in the second

quarter giving the Rams a 7-3 lead.

Chargers running back Ryan Mathews just a few games back from the injured list solidified a Chargers running attack leading all rushers with 105-yards on just 12 carries. Showing power, cutting ability and speed from 'fresh legs', Mathews exhibited the first round pick talent we have all have seen and expected, needed now as the team pushes for the 2014 playoffs.

This said, the Bolts offensive lines kept Rivers standing for the most part during the game and, blew open holes for the former Fresno State running back.

In his first professional start 24-year old Chris Watt picked by the Chargers in the third round of the draft from Notre Dame did an outstanding job as the O-line captain playing center against the Rams stingy highly ranked defense.

"We're still continuing to improve every week in the running game and that starts in practice," said the 311 lb center/guard. On his quarterback and his fellow linemen, Watt said, "He (Rivers) does a great job of making the transition easier & the rest of my line-mates too helping me out. It's a good team effort out there."

Team effort on the O-line all season has been spearheaded by the two monsters who inhabit the left and right tackle positions. King Dunlap and D.J. Fluker. Keeping Rivers back and front side intact these two giants have played solid and exceptionally well all season, blowing smaller defensive linemen on their backside.

As read earlier, this was a crazy game. Chargers were down early on the Rivers 99-yard pick six interception. Down 10-6 at the half San Diego came back to control the game on the Mathews 32-yard touchdown run, changing the momentum, only to lose it again after the Keenan Allen 29-yard touchdown catch in the fourth. When the Rams tightened the score 27-24 on a Hill to Steadman 7-yard TD pass. Driving the ball downfield on their last possession with under a minute left is when Gilchrist iced the contest with his interception.

The Chargers are in charge of their own destiny with five games left in the schedule, four of them against winning Super Bowl quarterbacks. Two of the remaining five are at home at Qualcomm Stadium where their record is 5-1.

Baltimore Ravens (7-4) with an identical record as the Chargers are hosting San Diego Sunday. Kickoff is scheduled for 10 a.m.

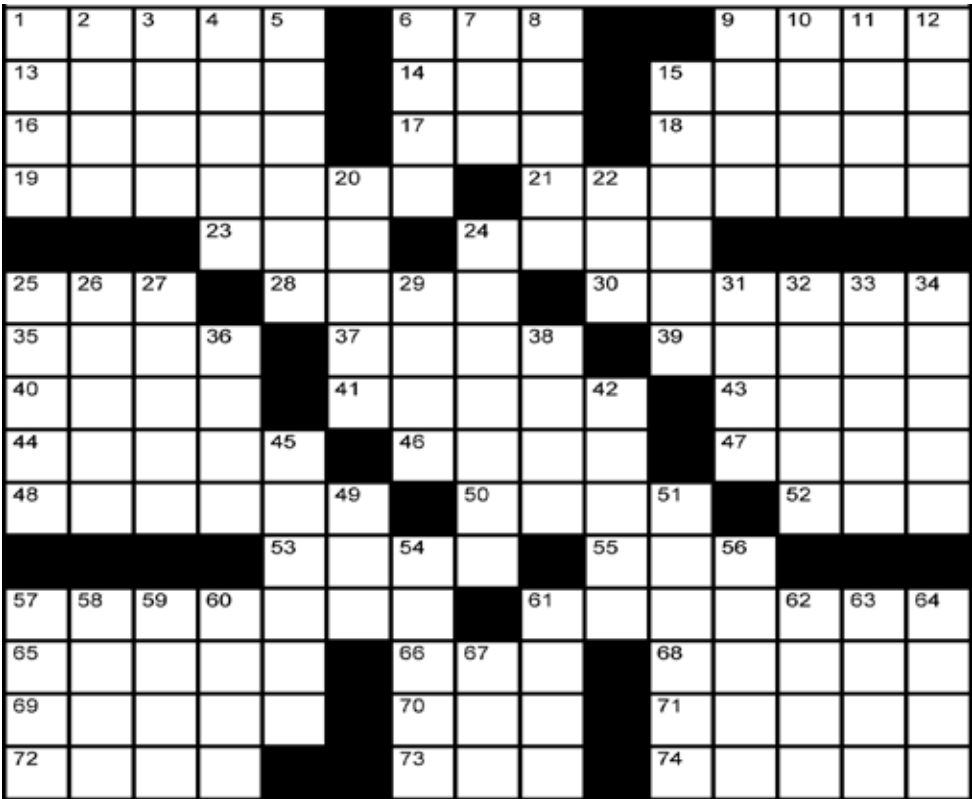

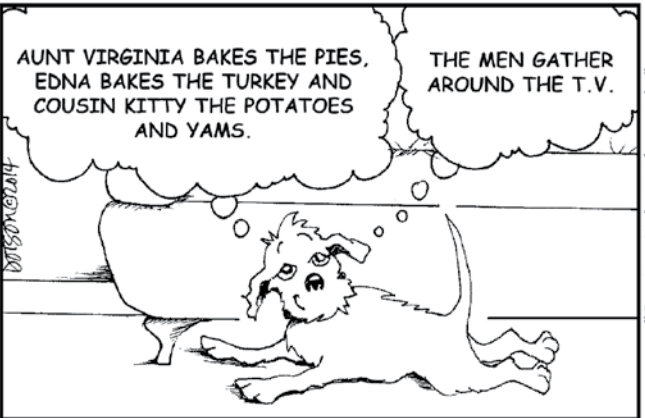

- 3-4 c chicken stock
- 2 medium onions (diced)
- 1-2 tbsp dried sage

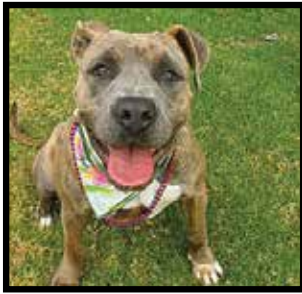
