Heartland Fire & Rescue receives highest rating possible for Fire Protection Services

Several months ago, the Heartland Fire & Rescue Department, which provides fire and emergency medical services to the cities of El Cajon, La Mesa, and Lemon Grove, voluntarily requested an external evaluation of the de-



partment's services and capabilities by the Insurance Services Office (ISO). As a result, Heartland Fire & Rescue received a Class 1 rating from the ISO, which is the <u>highest</u> score a fire protection community can receive. The agency was previously at Class 2.

The Insurance Services Office evaluates fire protection efforts in cities and districts throughout the country. They rate agencies on a scale of 1–10, with 1 being the best. The ratings are calculated on multiple factors, such as the Fire Department itself, the water supply system, and the dispatch center.

"There are only two Class 1 ratings in San Diego County and Heartland Fire & Rescue is one of them," said Chief Rick Sitta. "As a matter of fact, there just 97 Class 1 ratings out of 47,000 fire agencies in the United States. So, it is extremely rare for a fire agency to receive this kind of recognition." Moreover, Heartland Fire & Rescue is now one of ten fire agencies with a Class 1 rating in the entire State of California.

Chief Rick Sitta noted that this rating is a result of a team effort. "It's not just the Fire Department receiving the rating," he said, "it's a reflection of the teamwork between us, the 9-1-1 Heartland Fire Dispatch Center, the water utility company, and the Cities of El Cajon, La Mesa and Lemon Grove."

This rating is also good news for homeowners in El Cajon, La Mesa and Lemon Grove. Residents could start saving money on fire insurance premium rates once this rating goes into effect on September $1,\,2015.$

Sitta added, "This rating demonstrates to the citizens we serve that their Fire Department is able to provide the highest level of fire suppression and community risk reduction for protection in our communities, and according to ISO, may also save our citizens some money on insurance premiums."

Chief Sitta and a representative from ISO proudly announced the new Class 1 rating during a special presentation to the City Councils of El Cajon and La Mesa at their June 9, 2015, meetings. It will also be presented to the Lemon Grove City Council at their meeting on June 16, 2015.

"We have an agency full of proud firefighters who are dedicated to providing the best Fire and Emergency Medical services to their communities. This Class 1 recognition is a badge of honor that they worked hard to achieve and they will undoubtedly strive to maintain the Class 1 rating for years to come," Chief Sitta stated.

Where have all the Fathers gone?

round this time of the year, my thoughts wander back to my father. He has been gone quite a spell but his memory lingers. I often wonder what he would think of what is happening in our world today if he were to come back.

I grew up with a father who believed in being the father. I confess he was not always right all the time, but what he said was law in our house. That is, of course, unless his wife contradicted him. Then it was time for us kids to seek sanctuary outside where we could not hear what was going on.

I cannot help but believe that some of the problems we are having in our society today would not be such a problem if we had fathers. How many families are there where children grow up not knowing their father? No wonder they have no respect for authority.

Although my father was not a very well educated person, he knew how to use the Board of Education on the Seat of Learning for all of us children.

Some of the stuff he did back in "the day," would bring him some real legal problems today.

For example. My father believed he had the right to be judge, jury and executioner concerning the things in his children's life, with no appeal to a higher authority.

In the kitchen hanging next to the door to go outside was a very interesting parenting tool, at least in my father's eyes. It was a paddle with a religious inscription, "I Need Thee Every Hour." The inscription was quite true to the reality of life in our home.

Spanking was a routine exercise in our home. My father had the idea that if you were in trouble in school you were also in trouble at home. He had this fantastic idea that the teacher was right and I was wrong. I guess he knew me and that I could take a little bit of truth and spin it into a lie. I wonder who I learned that from?

Several times I got in trouble at school, which involved a spanking down at the principal's office. The first time this happened, I well remember walking into the kitchen and saw my father standing there holding in his hand that infamous paddle. Within a few moments, the paddle was doing its duty and I was doing the "paddle dance."

After the paddling, my father sat down with me and said, "Okay, what trouble did you get into at school requiring the principal to paddle you?"

I wished he had asked me before the paddling, because now I had no incentive whatsoever to lie. Looking back, maybe that was the whole purpose of the paddling.

I well remember one time out in the backyard, I did something requiring parental action. My father looked at me and said, "Go get me a switch. You need to be taught a lesson."

At the time, I thought it was funny, however, after the fact I could see no humor whatsoever in it. I went to get the "switch," according to my father's instructions and came back with a twig. I thought it was funny, but my father had no sense of humor about this. In a few moments, my sense of humor evaporated because

my father went and got a switch, which is a whole lot different from a twig, just ask my backside.

Ruminating over these things, I tried to figure out how many spankings I actually got during my lifetime. Let me just say, it was significant. It taught me respect for authority.

I wonder if some of these young people getting into trouble today ever had a spanking? Of course, today that is completely against PC. My father did not believe in PC, but he did believe emphatically in BS (Back Side). I think if parents today would focus more on BS than PC, things might be a lot different.

Today, people think those old-fashioned spankings represent cruel and unusual punishment. However, if you look at this generation that has not had an old-fashioned spanking, I think the evidence speaks for itself.

I must say that my father was not too much interested in what we call "love" today. He was more interested in respecting authority. In fact, as I think about this, when you are respecting authority you are exhibiting love. People today do not know how to love because they do not know how to respect authority.

I think if some of these youngsters could spend a week with my father and his infamous "paddle" they would grow to respect authority. Unfortunately, there is no authority figure in most homes today. Even those homes that have fathers are coerced into believing the father has no real significance in the family.


All I can do is to quote a famous psychologist, "How's that working?"

Skin Cancer Foundation shares summer sun protection tips

ummer is right around the corner, and families will spend more time outdoors. Exposure to the sun's harmful ultraviolet (UV) rays increases the risk of skin cancer, which is why proper sun protection is essential. In fact, the sun's UV rays are responsible for about 90 percent of nonmelanoma skin cancers and 86 percent of melanomas.

"Exposure to UV radiation is directly linked to all three forms of skin cancer," said Perry Robins, MD, president of The Skin Cancer Foundation. "By adopting good sun safety habits families can enjoy summer outdoor activities without increasing their skin cancer risk."

At the beach

- Use a broad spectrum sunscreen daily. For extended outdoor activity, use a water-resistant broad spectrum (UVA/UVB) sunscreen with an SPF of 30 or higher. Reapply every two hours or after swimming or excessive sweating.
- •Cover up with clothing. Look for high-UPF (Ultraviolet Protection Factor) swim shirts or rash guards, and choose bathing suits that cover more skin, like one-piece suits and long trunks. Make sure to apply and reapply sunscreen to exposed areas of the skin not covered by fabric. To help avoid missing spots apply sunscreen before putting on your bathing suit. When shopping for high-UPF clothing, look for The Skin Cancer Foundation's Seal of Recommendation.
- Avoid tanning. There is no such thing as a safe tan, because tanning itself is caused by DNA damage to the skin. In addition to increasing skin cancer risk, tanning also leads to premature skin aging, including wrinkles, leathery skin and age spots.

At summer camp

•Remind kids to seek the shade. Advise kids to play in

shaded areas to limit UV exposure. Check with counselors to see if there are adequate places for campers to seek shade during outdoor activities taking place between 10 AM and 4 PM, when UV rays are most intense.

- Dress kids in sun-protective clothing. For optimal protection from the sun, send kids to camp in sun-protective clothing. Look for tightly woven or knit, dark- or brightcolored fabrics, which offer the best protection. Don't forget wide-brimmed hats and wraparound, UV-blocking sunglasses.
- Practice sunscreen application beforehand. Teach children to apply 1 ounce (2 tablespoons, or about the size of a golf ball) of sunscreen to all exposed areas 30 minutes before outdoor activities. Remind them to cover easily missed areas such as the back of the neck and tops of the ears. If camp rules allow, ask counselors to help children reapply sunscreen every two hours, or after swimming or excessive sweating.

On the road

•Treat your vehicle to window film. Car windows don't provide complete sun protection. Though UVB radiation is effectively blocked by glass, more than 60 percent of UVA radiation can pass through windows. UV-protective film,



also known as window film, blocks out up to 99.9 percent of UV radiation. If you have window film installed, remember that it protects you only when the windows are closed. When shopping for window film, check to see if the product has The Skin Cancer Foundation's Seal of Recommendation.

• Drivers beware. Nearly 53 percent of skin cancers in the US occur on the left, or drivers' side of the body. Don't forget to apply sunscreen, particularly when spending extended time in a car that has no window film.

Additional skin cancer prevention tips

- •Do not burn. At any age, a person's risk for melanoma doubles if he or she has ever had five or more sunburns.
- Keep newborns out of the sun. Sunscreen should be used on babies over the age of six months.







'Jurassic World' loaded with scary thrills and excitement

ow! Is this film exciting and scary? You bet! It seems the fourth film in the Jurassic Park series is the best of the lot. After seeing dinosaurs galore in all the other films, one would think boredom might set in, but that is not the case. Director Colin Trevorrow (Safety Not Guaranteed) has written a slam-bang script with longtime partner Derek Connolly, Rick Jaffa and Amanda Silver. Together they have injected humor, fright, breath-taking adventure, and science fiction into a ball-of-fire movie.

Chris Pratt, the most likeable and funny actor in films, brings charm and laughs to his role as Owen Grady, the Velociraptor trainer for the Jurassic World adventure park. Muscled up like a Navy SEAL (which he played in Zero Dark Thirty) with a sense of humor. Pratt has shot to overnight fame to become a mega star with his appearance in the world-wide smash film Guardians of the Galaxy. So he is up to playing the leading man and tough guy in Jurassic World.

The plot serves as the connecting bolts between action scenes. The action merges with

the frights, and the frights lead to laughs. So it all works to the audience's advantage. Director Trevorrow never lets a minute lapse without scaring the pants off the audience or giving them a thrilling, take-your-breathaway encounter with the bad, really bad, dinosaurs. This time the Godzilla of all Dinosaurs is one that has been cooked up by the park's geneticists and has the new designation of Indominus rex. He/ she / it /? is a real badass to end all such designations.

So what is the purpose of all the genetic engineering going on at the park? It's merely to

draw in more customers to the Costa Rican island that now houses Jurassic World. Big dinosaur means big box office according to Claire Dearing (the stunning Bryce Dallas Howard, real-life daughter of director Ron Howard) who is the park operations manager. With her two nephews visiting the park (Nick Robinson and Ty Simpkins) she feels confident they will get a thrill out of the attractions. The new park is owned by Simon Masrani (Irrfan Khan), and an on-site member of the staff is Grady (Pratt). They all pitch in with Barry (Omar Sy) and Dr. Henry Wu (B.D. Wong, the only actor to return to the series) to overlook the animals.

There always has to be a bad guy for us to hate and that onerous task falls to actor Vincent D' Onofrio as Hoskins, head of security operations of an outside firm. His intentions are definitely not ideas that win the Nobel Peace Prize, and he is certainly a fly in the ointment who serves to give Grady something to do in the pugilistic arena.

We can't give enough praise to Industrial Light and Magic and Legacy Effects (formerly Stan Winston Studios) for all of the special effects in creating the animatronic dinosaurs. Cinematographer John Schwartzman has beautifully captured all the nuances of the 3D cameras. It is some of the best 3D and most effective seen this year.

All the plot manipulations are not what audiences really go to see the movie for, and that is action, action, action! All of the whiz-bang scenes are tolerable because they are relieved by Pratt's winning personality and humorous take on just about every disaster one can imagine. Move over Stallone and Schwarzenegger-- your replacement is al-

ready here! It's humor, fright, breath-taking adventure, and science fiction creates a ballof-fire movie.

Pe and Earl and The Dying Girl hit theaters this weekend already boasting accolades having won the Audience Award and the Grand Jury Prize at this year's Sundance Film Festival. The film is yet another story of a teen afflicted with a disease and the response of those around her.

What could be a ho-hum reaction to this movie instead captures some true emotions and reactions that are credited because the filmmakers – director Alfonso Gomez-Rejon and screenwriter, Jesse Andrews (adaptation of his novel) – took a different approach to this story.

Greg (Thomas Mann) is a high school senior definitely walking through life to his own

blows apart when his mom (Connie Britton) lets him know that his classmate, Rachel (Olivia Cooke), has been diagnosed with leukemia. She thinks it would be a nice idea if he spent some time with her. Having nothing in common with Rachael, Greg objects but soon is okaying a visit with Rachael's mother (Molly Shannon), a sassy, energetic over-the-top female who thinks it's fine.

Rachael stands at the top of the stairs looking down at Greg telling him she does not need his "stupid" pity. When Greg explains it's not pity but what his mom suggested, Rachael lets him come to her room. Greg keeps up the visits, helping Rachael with homework and slowly watches

her begin to fade away. He's as self-deprecating as she is so they create a bond mostly around pillows (have to see it to understand.) When things get tough Greg and Earl bring their home parity movies for her to see, which delights her.

The parents in the film are just as quirky as the teens. Greg's dad is a professor who at home wears his bathrobe all the time and carries around a cat. Finally, the idea to make a film for Rachael surfaces, although throughout the film the narrator (Greg) reminds the audience that Rachael does not die. Greg gets so frustrated in trying to make something special for her; it falls apart at every endeavor.

The films' comedy and real raw emotion comes across fine,

we not had the narrator telling us things. Professional writers preach that you "show a story" you don't "tell" a story. Every time I heard Greg trying to explain something to the audience it took away my focus. He did very well in other scenes; I got it, the silliness overshadowing his insecurity.

I can't say I really enjoyed Me and Earl and The Dying Girl or that I disliked it. I appreciated the acting by teen leads Mann, Cooke and Cyler, but wouldn't recommend this for anyone under 12. Seriously


Queasiness in the car is not just a human problem. Dogs and puppies do sometimes experience motion sickness on car rides. Unfortunately, car sickness can make any kind of pet travel a distressing ordeal for both dogs and their families.

There are several causes of car sickness in dogs and puppies. The most common

- 2. Reconditioning For dogs who have negative associations with riding in cars, reconditioning could be the answer. Reconditioning does take time and patience, but it really can help relax your dog.
- Drive in a different vehicle. Your dog might associate a specific vehicle with unpleasant memories.
- Take short car trips to places your dog enjoys. This will replace negative associations with positive ones.
- Gradually acclimate your dog to the car. Start by sitting with your dog in the car while the engine is off each day for a few days. When he seems

comfortable, let it idle. Once he is used to that, drive slowly around the block. Gradually progress to longer and longer trips until your dog seems comfortable driving anywhere.



- 3. Medication While motion sickness can be helped in natural ways for some dogs, there are cases in which medications is the only option. There are both over-the-counter and prescription medications available, including:
- •Anti-nausea drugs: reduce nausea and vomiting.
- Antihistamines: lessen motion sickness, reduce drooling, and calm nerves.
- Phenothiazine: reduces vomiting and helps sedate

Caution: Always discuss any medications you plan to give your pet with your veterinarian to ensure that your dog is healthy enough to take them, will be given the correct dosage, and won't suffer any adverse effects.

4. Holistic Approach Holistic treatments are another way to go for dog parents. They really can be effective, and are worth trying. Some common

holistic choices include:

- •Ginger. Ginger is used to treat nausea. Try giving your dog ginger snap cookies or ginger pills at least 30 minutes before travel.
- Peppermint, chamomile and horehound naturally help calm the stomach and nerves of your dog. These are available in pills and teas.
- •Massage can help sooth and relax your pet before you travel.

As with other medications, always discuss any holistic remedies you plan to give your pet with your vet to ensure that it's appropriate and the dosage is correct.

In short, with some patience, training, or the right medications or holistic treatments, you and your dog will be able to ride safely and happily together anywhere you need
