Spring Valley youth gives back by cutting two feet of hair

nring Valley resident Gabriella Martinez, 7, who goes by Ella, recently received a special haircut and found a way to give back to children needing hair replacement.

Ella has thalassemia, a form

of anemia that requires blood transfusions every two-to-three weeks for the rest of her life. The blood is provided by the San Diego Blood Bank. The transfusion process, which began when she was nine months old, typically lasts about eight hours over two days at Rady

Children's Hospital – San Di-

According to Erica Martinez, Ella's mom, a hospital nurse responded when Ella asked about small children she saw with no hair. "Ella wanted to help those kids, so the nurse suggested donating her hair so other children could have hair." said Erica. "Ella loved the idea. She realizes that generous people are helping her by donating blood to the San Diego Blood Bank, and giving up her hair was her way to give back.'

On Monday, June 29, Erin Doumert, owner of Salon Elle in La Jolla, cut Ella's hair that stretched about two feet long. The hair was donated to Wigs For Kids, a nonprofit that provides hair to children who have lost their hair due to chemotherapy, radiation therapy, burns or other medical issues. "We have relationships with

many people who have re-ceived blood, and they find all kinds of ways to give back to the community, but Ella's story was compelling and heartwarming," said David Wellis, CEO, San Diego Blood Bank. "Not many kids would be selfless enough to give up their own hair, and Ella provides us an excellent example of how gratitude for a life saving blood donation can be further perpetuated through the community, even beyond blood

The San Diego Blood Bank (SDBB), the primary supplier of blood to the majority of hospitals in San Diego County, is an independent, 501(c)(3) non-profit that serves hospitals in San Diego, Orange, Imperial and Los Angeles counties with blood transfusion products and reference laboratory services. Founded in 1950 with the support of the San Diego County Medical Society, SDBB cur-

Assemblyman Jones Reflects on Freedom as America celebrates Independence Day Californians have less freedom, "Are You Kidding Me?"

ssemblyman Jones (R-Santee) released an "Are You Kid-Ading Me?" segment reflecting on the freedoms we have as Americans as Independence Day approaches.

According to the First in Freedom Index, based on state fiscal policy, education, regulations, and health care, California ranks 48th, making it one of the least free states in the country.

Assemblyman Jones says, "We are supposed to be the land of the free, yet our state regulates our economy more than other states; taking money out of our pockets, telling us how to raise our kids, and even restricting the fireworks that we use to celebrate the 4th of July.'

July 4th History: 6 facts about America's Independence Day

- 1. The flag we know and love today with 50 stars and 13 alternating red and white stripes — is not the original flag adopted in 1777. The original flag, which was created in 1777 by Betsy Ross, only had 13 stars. The American flag was altered, making the United States the only nation who has willingly altered their flag.
- 2. The American flag has a name, which was given by Captain William Driver, a shipmaster from Massachusetts. The flag is named Old Glory.
- 3. The Declaration of Independence was not signed on the first Independence Day on July 4, 1776. That was simply the day that the delegates of the Continental Congress approved the wording of the Declaration of Independence.
- 4. The original sheet of parchment the Declaration of Independence was written on measured 24-1/4 inches by 29-3/4

inches. John Hancock's signature is almost five inches long. As the President of the Congress, Hancock was the first to sign the Declaration of Independence and it is said that he said he signed his name large so King George III could read his signature without his glasses.

5. We all celebrate on the 4th of July, but the July 2 just might have been the original Independence Day and the more fitting one, reveals author Kenneth C. Davis.

"The fact is that John Adams wrote home to Abigail on the 3rd that this day, July 2 will go down in history," said Davis in an appearance on "CBS This Morning." "We'll celebrate it with parades and pomp and bells ringing and fireworks, and it was because Congress actually ruled it in favor of independence on July 2. But it was two days later, of course, that Congress then accepted Jefferson's declaration, explaining the vote two days before that really got fixed in the America's imagination as our birthday. July 2nd should be Independence Day.

6. "Americans began observing the Fourth of July as early as 1777, when the first-ever major celebration in Philadelphia included a parade, a 13-shot cannon salute and fireworks, but Congress didn't make it official until 1870, when it was part of a bill passed to recognize major state holidays at a federal level like Independence Day, Christmas and New Year's Day," reports TIME magazine.

Statistics indicate that 8,500 fireworks-related injuries are reported every year in the U.S. And of these, about 2,000 include eye injuries. One-third of all firework-related injuries to children under the age of 5 are due to sparklers, and 16 percent of all firework injuries are due to sparklers.

"Some of the more dangerous kinds of firework include bottle rockets because they fly erratically, and can cause bystander injuries. Additionally, the bottles and cans used to launch bottle rockets can explode, showering fragments of glass and metal," says Ross Tobleman, M.D., medical director of Emergency Medicine at Scott & White Hospital – Round Rock.

"The most common firework injury for younger kids can involve sparklers and burns. While most adults view sparklers as one of the more harmless types of fireworks, in reality they can burn as hot as 1,800 degrees," warns Dr Tobleman. "Fireworks are really best enjoyed at a community display, not in your backyard."

Additional tips from Dr. Tobleman:

- Do not let children play with exploding fireworks and rockets
- View public fireworks displays from at least 500 feet away or up to a quarter of a mile
- Leave the lighting of fireworks to trained professionals.
- If you find unexploded fireworks, don't touch them.

Contact your local fire or police department.

• Obey laws. If fireworks are illegal where you live, do not use them. In Southern California, watch for burn bans, and be aware that in dry conditions, a "run-away" bottle rocket can start a very damaging fire.

Do not use homemade fire-

works or illegal explosives: Report illegal explosives to the fire or police department in your community.

"Remember, fireworks injuries are preventable. Make it a safe Independence Day for everyone by enjoying fireworks set up by professionals," said Dr. Tobleman. As always, have fun, but stay safe and healthy."

Consumer Fireworks illegal in San Diego County

here's really only one thing you need to know about consumer fireworks: ALL CONSUMER FIRE-WORKS ARE ILLEGAL IN THE CITY AND COUNTY OF SAN DIEGO. That includes sparklers, firecrackers, cherry bombs, bottle rockets and even poppers.

The National Fire Protection Association (NFPA) says there is no safe way to use consumer fireworks. According to NFPA research, there are far more U.S. fires reported on a typical Independence Day than on any other day, and fireworks account for more than half of those fires, more than any other cause of fires. In 2008, fireworks caused an estimated 22,500 reported fires, including 1,400 structure fires, 500 vehicle fires, and 20,600 outside and other fires. These fires resulted in an estimated \$42 million in direct property damage.

In 2008, 7,000 fireworks-related injuries were treated in U.S. hospital emergency rooms. The highest injury rates were for teenagers 15 to 19 and children aged 5 to 9.

The San Diego Fire-Rescue Department Bomb Squad urges you to obey the law and leave fireworks to professionals.





'Max' — one of the best animal pictures in years

ho doesn't love a movie about a dog? There have been many stories made in the past about dogs, but none catches the warmth, affection, and loyalty between Marine Working Dog Max (MWD) and his caretaker Kyle Wincott, (played by Canadian newcomer Robbie Amell) as does this film from MGM/ Warner Bros.

Nature has provided a primal bond between animals and humans. Dogs have especially been closely connected to human mates throughout history. Max is just such a dog. He got his training through the Marine program and, as such, was attached to Kyle. Accompanying the Marines into battle in Afghanistan, Max saved many lives by using his odor-sniffing nose to helped avoid danger.

When a traumatic incident causes Max to suffer an animal form of PTSD, (Post Traumatic Stress Disorder), he is automatically shipped out of the service and retired. Many such dogs mourn their handlers just as do humans. When Max is returned to Kyle's family, he is hurt, angry, scared, and dangerous to be around. It will take a lot of adjusting for him to trust anybody again.

Kyle's younger brother Justin (Josh Wiggins) inherits the Belgian Malinois upon the dog's return from the Middle East. The two have an uneasy truce between them. Justin's friends Carmen (Mia Xitlali) and Chuy (Dejon La Quake) are instrumental in helping to cement the bonding between Max and his new family.

There is plenty of action when Justin and Max accidentally get involved with a nefarious friend of Kyle's (Luke Kleintank) and gun-runner Emilio (Joseph Julian Soria). Excitingly staged dog fights between Max and some vicious Rottweiler's keep one on the edge of the seat. Races on bicycles through the woods of South Carolina are effectively staged for maximum thrills and rival some big-budget special effects. The teens must outsmart the bad guys and Max must show how effective his combat raining was in the face of new battles. The breathtaking climax will have you gasping and cheering.

Justin's mom and dad are played warmly by TV's Lau-



Specifically, Plaintiffs claimed that Defendants circumvented landlord-tenant law by treating its quests as transient occupants. Defendants have denied all liability in the case. 

Keeping your pets safe on the Fourth of July

t's the Fourth of July - do you know where your pet is? This may not be the first question that comes to mind on this day of barbecues. picnics, family gatherings and

Yet to the American cat and dog, the Fourth of July is a scary holiday - a day of sudden flashes and explosions. Pets don't realize this is a national holiday. Dogs and cats, who tend be sensitive to noise, become confused and frightened. Often their first instinct is to run and hide.

Many pet owners, unaware of how their pets will react, bring their dogs along to fireworks events or leave their cats outside for the evening. Some owners simply leave a window ajar, not realizing that terrified kitties might think this opening will allow them to escape the noise.

Here are some simple ways to prepare for the holiday, increase your pets' safety, drastically reduce their stress and lower their risk of running away.

Create a quiet place. Firecrackers, loud party voices and booming music can make pets anxious. Even well-socialized

animals are likely to be pushed beyond their limits. Whether you go out or entertain at home, make sure your pets have a restful room or area to which they can retreat.

Don't take your pets to a fireworks display. Though you might prefer to have your pets' company, they'll be happier at home. Secure all potential escape hatches. If you can, leave them in a quiet, sheltered area. To reassure them, you may want to keep a television or radio playing at a normal volume while you're away.

Keep a harness and leash ready for each dog. If you must be outside with your dogs during fireworks, make sure each one is secure on a leash and harness. Frightened dogs commonly manage to slip out of their collars, and harnesses allow you to fully control your

Don't leave your dogs outside unattended. Even tethered pups will struggle to get away if startled by noise. Dogs who aren't tethered may try to dig out of an enclosed yard. Generally, if dogs are afraid and stressed, they will look for a way out.

Be sure your pets wear current ID tags. Clear identification can be a pet's ticket back home. An ID tag means anyone who finds your pet can get in touch with you right away. Even an indoor cat should wear a breakaway collar with ID in case he slips out. If you don't have time to get a tag before the holiday, write your pet's name and your phone number in indelible ink on the collar itself for each of vour pets.

Shoot a roll of photographs. It's a good idea to have upto-date photos of your pets in case they ever get lost. Take a side shot of each pet and one looking directly at the camera. Hang up a gray sheet as a backdrop so your pets' images stand out clearly.

Keep all fireworks away from pets. People often don't realize how unpredictable and dangerous fireworks can be. Bottle rockets and firecrackers. in particular, can fly off in any direction. If one explodes near a pet, it could severely burn or

Hire a pet-sitter. If you go out for the day or evening, hire a pet-sitter to stop by or ask a friend who knows your pets to pay a visit. The loving touch and soothing tones of an animal-lover can calm your pets during the pyrotechnics.
