



# Prayer memorial by local tribes for their ancestors



Memorial singing and praying for ancestors

ecently several San Diego tribal Indian bands gathered together at the San Diego Mission to protest the pending sainthood of Father Sera, but most importantly to pray for their ancestors and healing of all people.

The protest was in remembrance of all the ancestors of the tribes who had been killed and buried on the Mission grounds in earlier years. As the evening light began to darken, more people arrived

and singers began their chants and songs. It was a serene atmosphere as the Memorial was dedicated with lit candles surrounding a cross.


Anthony Pico, former Chairman of the Viejas Band of Kumeyaay Indians, addressed the crowd.

"They knew this entire place was sacred ground but they started digging in this spot to make a building," Pico said. 'The lower they dug they started hitting human remains. By the time we found out about it, they were about eight feet deeper than a grave."

"Those present that day looked over the holes and discovered skeletons were buried there. Anthropologist Florence Peck took the bones

to have them checked out," Pico said. "Florence told me that on the bones of the ones they took out, she saw marks on their forearms from being shackled and that they had to be on a long time to leave marks on their bones.

In 1989 Pico remembers coming with other tribal members and for 18 hours singing and then 10 hours of digging to finally give those buried a

cestors and for healing for our people," he said. "The mission to all levels of our society that it's time for us to start healing at this spot, an Indian cemetery

"We did everything by hand with shovels and it was brutal," Pico said. "I was so exhausted and dirty with filth, but when I got home I laid down in the bed and collapsed."

Angela Elliott Santos, Tribal Chairperson for the Manzanita Band of Mission Indians arrived with many of their band.

"We are here because of the canonizing of a man who treated our people bad and to show everyone we still exist. This matters to us. The Manzanita were oppressed in the 80s. Even though some were younger people, we knew the history and what happened here. Our people were forced to build the mission and they were civilized people with their own religion. It's very sad that they're going to canonize a man who has cost so much

heartache for us to get over. Today on this sad day, we are here to pray for the ancestors and for ourselves to find a way to get through another atrocity



that is sacred ground to us and where we want to come and recognize them. They're the ones that had to live under this oppressive system and their energy will be energized if we stand up and start healing our own people."

As the group surrounded the cross circled with candles, two signs under a tree expressed the message all were here to share. One read "Serra isn't a Saint, God knows and so do we, genocide is wrong; and the other "Native Lives Matter."



Cancer Task Force recommends that women continue to follow the same screening mammography guidelines supported by the American Cancer Society (ACS), with added consideration of individual patient risk factors and preferences.

The ACS recommends annual screening mammography beginning at age 40 and continuing as long as a woman is in reasonably good health and a candidate for treatment. The debate is whether to begin mammograms at age 40 or 50, and at what frequency. In general, women younger than 50 are at a lower risk for breast cancer. There is an increased risk of breast cancer as women get older.

The Scripps Breast Cancer Task Force's expanded guidelines for breast cancer screening for average risk patients are as follows:

- Monthly breast self-exams beginning at age 20
- · Annual clinical breast exams with a physician or other health care practitioner
- · Baseline mammogram and risk assessment at age 40, followed by the opportunity for annual screening mammograms
- 70 to 80 percent of newly diagnosed breast cancer cases have no significant family history

Discussion of an individual patient's situation, needs and concerns with a physician can help assess if a woman is at greater risk of developing cancer, where different guidelines may apply.

A screening mammogram is a first step to breast health. After a patient's risk is determined, next steps include developing an individualized screening program based on a patient's risk and their feelings and preferences in regard to their risk level and screening

One of the tools available to assess risk levels is the National Cancer Institute (NCI)'s Breast Cancer Risk Assessment Tool at: http://www.cancer.gov/ bcrisktool/.

"The debate continues across the health care industry about appropriate screening. Our approach at Scripps is one where we apply appropriate guidelines, but recognize that individual patient needs and preferences must also be considered and respected," said William Stanton, M.D., chair of the Scripps Integrated Network Cancer Program.





# La Cage Aux Folles

orget Las Vegas! Anyone who wants to see a high anxiety, won-

derful production and superb entertainment should see the San Diego Musical Theater's (SDMT) La Cage Aux Folles at the Spreckels Theatre running through October 11, 2015.

The 1973 play by Jean Poriet has entertained millions around the world. SDMT's pro-

duction is so exquisitely done its one not to miss whether you have seen it before or not.

The story – as seen in the

movie *The Birdcage* (starring Robin Williams and Nathan Lane) – takes place in St. Tropez. Nightclub owner George (Robert J. Townsend) loves

his work and his chorus line of dancers. After some really spicy numbers, some observations and laughs from George, we discover someone is missing. That would be Albin (David Engel), also known as Zaza, a drag queen and star performer of the company.

Albin is not just a performer to George, but his partner ever since George divorced Sybil, mother to their son Jean-Michel (Bren Thor Johnson).

Life is good for George and the company. It gets even better when Jean-Michel announces he found the woman he wants to marry. But although Albin has actually been his mother, he feels it's vital to invite his real mother, who has not really been there for him most of his life. This causes a huge storm between George and Albin.

A good thing is while they work out their problems, the audience continues to see wonderful showbiz entertainment from the company which includes amazing dance numbers, songs and snippets of the continuing saga. Through several songs Bren Thor Johnson shows he's grown up to be his own man. At times he's agitated, but others reasonable in his discussions with his dad and Albin.

As do most of this cast, Robert J. Townsend and David Engel have amazing theatrical resumes. Both men have Broadway credits and they shine on stage. Their voices are terrific, and they totally inhabit their characters. While George is entertaining and charms the audience with several popular songs, he doesn't quite understand how deeply Albin is damaged by Sybil's invitation to the wedding.

Before long it's time for the bride's family to show up. Anne's mother and father have no clue what kind of club George runs, or that he and Albin are partners. When they put two and two together that Jean-Michel's father is gay, it becomes an explosive situation








SW: The first time I saw Aladdin as a work in progress was in this theater. I was 17 and saw it here. Everything about being the voice of Aladdin has been a wonderful experience. The most surreal thing is that today, my son Mischa is seeing it for the first time. To be here with him and my wife Rina, also with my Disney family, is a huge honor. Now every day I work here as a writer and walk by this stage, I see my life has become full circle I thank Ron Clements and John Musker for writing and making such an incredible movie.

**DS:** Watching this film again

was so fun. I can't imagine how it felt for you to see it with your son. Did you watch his face the

SW: Absolutely. I spent more time staring at my son and his buddies than at the screen. Mischa will be six in November. and he is such a sweet kid. He knew that I was Aladdin but he didn't really understand what that meant, and now I think he fully gets it.

JH: You were the speaking voice of Aladdin; what was that like to do as a young teen?

SW: I didn't get to meet Brad Kane, who did the singing, until after the film was made. When I went to the initial audition I had learned as a child actor you say yes to everything, roller skate yes, juggle fire, yes, can you sing, and I said absolutely. So they gave me some sheet music, and I couldn't read it. I did my best, but knew it was not on par. But. they liked my speaking voice and gave me the job.

**DS:** Do you have a favorite scene?

SW: Yes. It's a scene that reminds me of when I was a kid. It's the one of the Genie telling Aladdin about Jasmine; "there's this girl, and she's so beautiful, and she's got these eyes,"... and I could really see my teenage self saying those words. I also love the scene on the balcony with the Genie and the bee whispering in my ear because I got to record that with Robin Williams. He did so much improvising and was so funny and made me laugh.

DS: I've interviewed Robin, and you couldn't\_get anything done because he spent the

entire time making you laugh hysterically, and I loved it. So how did you handle it?

SW: He was calm and meticulous when planning the storyboards together. It wasn't until we were recording when he would really turn it on. I was laughing so hard I knew I was going to be on the recording so I just fell down to the floor laughing. It appeared on the extras on the DVD.


JH: You've worked on some other shows also, correct?

# 'The Martian' — laughs and thrills in space

hat a terrifically entertaining film director Ridley Scott has fashioned out of Andy Weir's science novel *The Martian* for 20th Century Fox! The book was bought by the studio after it rose to the top of the best-seller list in the "NY Times." Using Weir's sarcastic humor, screenwriter Drew Goddard captured the essence of the novel and brought it the big screen.

Astronaut Mark Watney (Matt Damon) and the crew of his interstellar spaceship go on a mission to Mars. They set up a space camp and have exploratory machinery to find out what makes Mars tick. The extraordinary scenes filmed with deeper than deep 3D lenses of the cameras of cinematographer Dariusz Wolski, the landscape of Mars is truly remarkable. How did they create a Mars-scape that approximates what may be the scorched ground of the 140 million-miles-away planet? Scott took his crew to the Wadi Rum desert area of Jordan and voila! A mars-scape drier than a parched steer bone in the Sahara! Both beautiful and scary at the same time, the Wadi Rum landscape seems to capture what humans think of as the contours of Mars.

Just walking around Mars would be boring, so Ridley Scott has conjured up a terrific

storm to come up suddenly while the crew is out doing their experiments. The camp is nearly destroyed and Watney is blown away a distance from the rest of the crew. He is presumed dead when there is no communication from him. The crew has only minutes to get off the planet before being destroyed by the raging winds and flying debris. Assuming Watney is gone, Captain Melissa Lewis (Jessica Chastain) must save the rest of the crew and take off.

Surprisingly, Watney is still alive and must now go into severe survival mode by using his ingenuity and scientific

education to save his own life. This is when the picture becomes the most fascinating. Damon must command the screen alone for many long scenes as he explains to a video recorder (and us) what he is doing and how he is doing it. Damon is brilliant in his lonely scenes, but he uses his sense of humor to explain complex scientific jargon in simple terms. It's fun, informative, and enlightening in an entertaining way. It's probably the best work Damon has done in a long time, and he may be in contention for an Oscar® nod. Damon's Libra qualities show in his solo scenes as he is such a likeable fellow.

Meanwhile, back at headquarters in Houston, Teddy Sanders (Jeff Daniels), head of NASA, has gathered up his forces to mount a rescue plan to go get Watney. What he doesn't realize is that the spacecraft's crew has also conjured up a risky, but brilliant scheme to go back and get Watney themselves. The crew, consisting of Rick Martinez (Michael Pena), Alex Vogel (Aksel Hennie). Chris Beck (Sebastian Stan), Captain Melissa Lewis (Chastain) and others, know that it's a dangerous mission and that they could all die.



# Bolts beat Browns on a second chance field goal

ust win the games you're supposed to win. That's exactly what the Chargers did last Sunday at home snapping a two-game slide against the visiting Cleveland Browns, a team, they were favored to beat.

Improving their record to

(2-2) on the young season the Bolts were given a second chance to kick a game winning field goal as time expired. This after a 39-yard attempt sailed wide right by kicker Josh Lambo after going 2-of-2 (45 and 46-yards) in the second quarter.

The last one, the game winner from 34-yards was a free-

bie, given to Lambo and the team after Browns outside rusher 9-year veteran DB Tramon Williams was flagged for an off-sides' penalty. Giving the Bolts rookie another chance for redemption. Redeem himself he did nailing the game winner as the game clock expired to the comfort of the team and the home town fans.

This culminated after Chargers quarterback Philip Rivers orchestrated an eight-play 57-yard drive with 2:09 left in the game giving the Bolts a second opportunity for a victory after the Browns tied the score at 27 apiece following a 36-year old QB McCown touchdown pass and successful two-point conversion.

Rivers working behind an offensive line minus three of their starters, the one starter working on a hobbled leg (D.J. Fluker). The Chargers allowed their quarterback to be sacked just twice as Rivers completed 23-of-38 passes for 356-yards, two touchdowns and no fumbles or interceptions. This was the

team's first no turnover game of the season, hence the win.

Throwing passes to eight different receivers, Rivers was spot on in his decision making, especially when a receiver was covered or when the pocket collapsed. Throwing the ball away for incompletions, rather than to the other team when pressured. The Bolts had only two healthy wide-outs at the games end.

Leading the Chargers in receptions was 'little-big-man' Danny Woodhead catching 4 for 84-yards (longest 62-yd) followed by Keenan Allen 4-72 TD, Ladarius Green 4-53, Stevie Johnson 4-32, Dontrelle Inman 3-88, Melvin Gordon 2-8, Malcolm Floyd 1-20, and John Phillips 1-1 TD.

WR Dontrelle Inman was called to duty as the 'next man up' when Malcolm Floyd (concussion) and Stevie Johnson (hamstring) left the game and did not return. Johnson performed magnificently on special teams, blocking on offense. Most notably running in an open field after catching a short Rivers pass galloping for a 68-yard gain.


After the game Inman said, "It feels awesome getting a team win. It's chemistry you want on the field. Rivers says he always trusts me on the field. We can only learn from our mistakes. Try to get better and know that when the time comes we need to persevere and go get a win. We can do it. It always brings us together."

The RB tandem of D. Woodhead and M. Gordon gained 90-yards collectively for over 4.0 yards a carry, just enough to take some of the pressure off their quarterback.

The Chargers defensively don't have much to brag about in a game where their starting cornerbacks were injured. Team captain FS Eric Weddle all with 10 tackles. They did allow McCown to complete 32-of 41 passes for 356-yards and two scoresled . However, in crunch time when it really mattered the defense gave the Chargers a chance to win it on the last possession of the contest which Rivers and Josh Lambo did."

"It was a huge win for this team," commented Chargers Head Coach Mike McCoy.

He continued by saying, "Just kept on fighting, kept on battling. The message all week





"You got to do whatever


you do to get a win. The fans were good. Looking forward to another to play in front of our fans. Just keep rolling," concluded McCoy.


