Landmark victory for Digital Privacy with SB 178

for the electronic privacy rights of all Californians, Governor Jerry Brown today signed Senator Mark Leno's California Electronic Communications Privacy Act (CalEC-PA, SB 178). The bill, jointly authored by Senator Joel Anderson, R-Alpine, protects Californians against warrantless law enforcement access to private electronic communications such as emails, text messages and GPS data that are stored in the cloud and on smart phones, tablets, laptops and other digital devices. Legislature earlier this year with strong, bipartisan support.

"For too long, California's digital privacy laws have been stuck in the Dark Ages, leaving our personal emails, text messages, photos and smartphones increasingly vulnerable to warrantless searches," said Senator Leno. "That ends today with the Governor's signature of CalECPA, a carefully crafted law that protects personal information of all Californians. The bill also ensures that law enforcement

need to continue to fight crime in the digital age."

SB 178 requires law enforcement to get a warrant before accessing an individual's electronic information and includes thoughtful exceptions for law enforcement to use in the event of emergencies and other public safety needs. A diverse coalition of the state's leading technology companies and civil rights organizations supported the bill, and California's statewide law enforcement groups helped ensure the bill provided important public safety protections. The bill is co-sponsored by the American Civil Liberties Union of California, the Electronic Frontier Foundation and the California Newspaper Publishers As-

"Senator Leno and I helped bridge the gap between progressives and conservatives to make the privacy of Californians a top priority this year," said Senator Anderson. "This bipartisan bill protects Califorthe Fourth Amendment and the California Constitution intended.

According to recent statewide polling, voters across all age groups, geographic regions and party affiliation are overwhelmingly concerned about their digital privacy. More than 80 percent of voters support requiring a warrant from authorities before they can access e-mail and Internet activity.

"Governor Brown just signed a law that says 'no' to warrantless government snooping of our digital information. This is a landmark win for digital privacy," said Nicole Ozer, Technology & Civil Liberties Policy Director at the ACLU of California. "We hope this is a model for the rest of the nation in protecting our digital privacy

With Governor Brown's signature, California now joins states as diverse as Texas, Virginia, Maine, and Utah that

have already updated their privacy laws for the digital age.

"California has led the nation in technological innovation for decades, and it's finally time for its digital privacy laws to catch up," said Lee Tien, Senior Staff Attorney at the Electronic Frontier Foundation. "Californians deserve warrant protection for their sensitive electronic communications."

CalECPA has support from Silicon Valley's major tech companies, including Google, Apple, Facebook and Twitter. Many of these companies have seen a dramatic rise in requests from law enforcement for consumer data in recent years. Google has seen a 180

percent jump in law enforcement demands for consumer data in the past five years. Last year, AT&T received 64,000 demands - a 70 percent increase in a single year. Verizon reports that only one-third of its requests had a warrant, and last year Twitter and Tumblr received more demands from California than any other state.

'This legislation has important privacy implications for all Californians," said Nikki Moore, Staff Attorney for the California Newspaper Publishers Association. "We are pleased CalECPA appropriately safeguards a newspaper's ability to gather and report news by protecting journalists and their sources from unwarranted surveillance.'



San Diego County continues water-saving streak in September

he San Diego region recorded its fourth consecutive month of significant water-use reductions since state mandates started in June, decreasing urban potable water use by 26 percent in September compared to September 2013, according to preliminary numbers released today by the San Diego County Water Authority.

From June through September, regional water consumption dropped by 27 percent compared to the state's baseline period in 2013, beating the regional aggregate target of 20 percent. Conservation has allowed the Water Authority to store water locally for future use - a valuable asset should drought conditions continue into 2016 or beyond - and reduce purchases of imported water supplies.

September temperatures were about 7 degrees above average for the month, and water year 2015 - which ended Sept. 30 - was the warmest ever for California, according to the state Department of Water Resources. Current projections

are for temperatures to remain above average statewide during the fall and winter, potentially making it harder to conserve water and making it harder to accumulate snowpack.

Climatologists also say there is a strong likelihood – 95 percent - that El Niño conditions will continue through the winter. El Niños often, but not always, deliver above-average rainfall to Southern California. Even if California gets substantial precipitation, it almost certainly will take more than one wet winter for California to emerge from the current drought, which is among the most severe in recorded history.

"The San Diego community keeps rising to the water exceptionally hot weather," said Mark Weston, chair of the Water Authority's Board of Directors. "It's critical for our region to maintain a leadership role in conservation as we enter the fifth year of drought. While we all hope that El Niño will produce more rain and snow in coming months, there's no guarantee that will happen where we need it most - in the Sierra Nevada and Rocky Mountains."

The State Water Resources Control Board has set mandatory conservation targets for Water Authority member agencies between 12 and 36 percent below 2013 levels. Those targets are scheduled to remain in place through February.

class in SDSU history

he numbers are in and The numbers are the new crop of freshmen at San Diego State University is again the highestachieving in the history of the

university.

Classes began on Aug. 24, but a complete census could not be taken until after the final add/drop deadline. Final numbers show that among the 5,142 first-time freshmen at the San Diego Campus, the average high school GPA remained steady at 3.69 with an average SAT score of 1118, up from 1115 the year before.

The incoming class is also highly diverse, 52.9 percent of first-time freshmen on the SDSU campus are students of color and 54.8 percent are

"Each year the academic strength of SDSU's incoming students is more impressive than the year before." said SDSU Provost and Senior Vice President Chukuka S. Enwemeka. "It's exciting to see all of the hard work that has gone into the university's strategic plan coming to fruition as we continue to advance student success, diversity and

academic quality."

SDSU's one-year continuation rates also continue to climb with 89.8 percent of full-time freshmen from the 2014/15 academic year returning to campus, up from 88.2 percent for the 2013/2014 academic year.

The application pool was more competitive than ever before, with a record 82,000 undergraduate applications received for the 2015/16 academic year.

This semester, SDSU also welcomes 2,096 new graduate students, including 373 post baccalaureate students, 1,586 master's students and 137 doctoral students. The class includes three National Science Foundation Fellows, four international Fulbright Fellows. five campus Fulbright Fellows and 20 Presidential Graduate Research Fellows

n a difficult loss for the (2-3) San Diego Chargers, the Pittsburgh Steelers improved their record to (3-2) winning on the last play of the game on the stage of Monday Night Football at Qualcomm Stadium.

To the delight of the largely populated orange towel waving Steelers fans and to the chagrin of the blue and gold clad Chargers fans, Steelers running back Le'Veon Bell scored the game winning touchdown on a strong second effort from a half-yard out as time expired on the game clock giving Pittsburgh a 24-20 victory.

Steelers QB Michael Vick subbing for the injured Ben Roethlisberger made some key plays using his legs and throwing arm to help secure the win in a back and forth pivotal fourth quarter.

Completing a 72-yard touch-down to WR Markus Wheaton at the expense of CB Brandon Flowers. It took the Steelers only 20 seconds to tie the score at 17 apiece after Chargers quarterback Philip Rivers threw his second TD pass in the game to Antonio Gates (101 career) in an eight-play 60-yard drive that consumed 5:50 of the fourth quarter.

The winning drive orchestrated by Vick came after a key Heyward-Bey 15-yard third down pass completion, a 24-yard Vick third down quarter-

back run, and a 16-yard pass to TE Heath Miller putting the ball at the one-yard line with five seconds left on the clock.

"He's (Vick) a talented player. We had a game plan going in there but didn't make enough plays," confided Bolts head coach Mike McCoy.

Gaining 155-yards rushing the ball, 111-yards of them to De'Veon Bell, McCoy said this about the Steelers star runner,

"He's an explosive great player that has great patience week in, week out."

The Chargers run defense continues to be their Achilles heel. Monday night it came back to bite them.

Starting out explosively San Diego's offense led by their ace starter QB Philip Rivers scored on their first possession. Tossing a 12-yard pass to his favorite target Antonio Gates caught the 100'th touchdown pass of his career in the first game played for him of the regular season after completing a four-game suspension. He later caught his 101'st in the fourth quarter. He led all Chargers receivers with nine catches.

"If you would have seen him in practice running around, he came back in phenomenal shape which is what you expect of a great player like that," quipped McCoy.

'The Walk' — a solid hair-raising thrill

t's not exactly a walk in the park, but it is a stroll you'll never forget. Director Robert Zemeckis has taken a real-life incident in The Walk who has been waiting in the and turned it into a spinewings for a star-making film. tingling adventure and thriller of an unconventional kind. It's also a career-making role for

French aerialist Philippe Petit Gordon-Levitt is a man who has had his dreams come true. A high-wire star in Europe, Petit had one great dream, and that was to walk a wire between the two World Trade Center towers in 1974. Naturally, it was illegal and he knew he would never get a permit to do it. He had to resort to skullduggery and nefarious schemes to pull off the biggest high-wire coup in history.

Turning to his mentor Papa Rudy (Oscar® winner Ben Kingsley), once King of the High Wire himself, Petit seeks advice and the old man's wisdom. Kingsley exudes authority in his usual take-charge way, and gives a convincing performance. When Kingsley is on the screen, nobody else seems to matter.

Petit gathered up friends and fellow plotters to overcome enormous odds and road blocks. His pal, Albert (Ben Schwartz), is terrified of heights but pitches in anyway. He's quite funny in his portrayal of a character who shrinks from heights but is compelled to help his friend -- by covering his eyes.

Gordon-Levitt must, of course, feign a French accent and, for the most part, accomplishes it with such a likeable demeanor we don't realize the off-kilter tones. He grasps his role and dives right in, metaphorically speaking. He has the taught, muscular build required and the grace to appear like a ballet swan on the wire. He is completely believable as a high-wire artist and draws us in with his humor and style.


Director Zemekis is a master film-maker and story-teller (Forest Gump, Back to the Future, Cast Away). He has taken what is essentially a one-trick pony of a story and fleshed it out to make it compelling and gripping. Planning the walk, getting the equipment ready, throwing a line across from one tower to the other, and tightening "the screws" make for a fascinating narrative. Not once will your attention be diverted.

The ground breaking special effects and the use of the 3D and IMAX cameras by brilliant cinematographer Dariusz Wolski make it all seem so real I could swear that Gordon-Levitt is actually 1,300 feet in the air walking the wire between the two towers. That's what makes it so real and scary and gives us goosebumps.

Zemeckis has created another hit in his repertoire by creating a fascinating and never dull film about an historic event that held the world captive. Joseph Gordon-Levitt emerges as a major leading man with

What You Need

3/4 c butter, softened

1 1/2 c brown sugar, lightly packed 2 eggs

2 c unbleached white flour 1/2 tsp baking soda

- 1/2 tsp baking powder
- 1 pinch salt
- 1 tsp vanilla
- 1 jar raspberry jam

Directions

- Preheat oven to 350.
- In your stand mixer, cream butter and sugar.
- Once creamed, add eggs. Continue to beat until smooth and very creamy.
- In a separate bowl, sift

- together flour, baking soda, baking powder, and salt.
- Once combined, gradually add into the cream mixture. Mix well. Add in vanilla.
- Roll dough into small balls, place on prepared cookie sheet (parchment paper lined). Then flatten with the bottom of a cup coated in powdered sugar.
- Bake for about 10-12 min. You want them to be a light golden brown. If you prefer a crispier cookie, bake for 13-14 min.
- Spread raspberry jam over cookies while they are still warm. Press another cookie on top.
- Nana wrote in her original recipe to hide 5 if you want any for yourself. They go quick!
