Sycuan donates over \$75,000 to Charities

Thirty local charities received monetary donations from Sycuan this morning. A total over \$75,000 was donated amongst the organization's Gift Giving Ceremony, an event that started back in 2006. Each member of Sycuan's leadership team, comprised of elected tribal council members, the casino executive management team and the casino directors, had the opportunity to each select a charity of their choice to donate to.

All 30 charities were present at the event that took place this morning in Paipa's buffet where they had the opportunity to speak to the group about their cause and receive their monetary donation.

"The Gift Giving Ceremony is one of the biggest highlights of the year here at Sycuan. We are proud to empower the leaders of the tribe, resort and the casino to make a difference in the community," said Cody J. Martinez, Chairman of the Sycuan Band of the Kumeyaay Nation. "Many of the charities invited to the Gift Giving Ceremony are big partners of ours throughout the year. Others are charities that Sycuan will help for the first time which enables us to broaden our reach in terms of charitable involvement within the San Diego community."

The Gift Giving Ceremony began back in 2006 as another

way to give back to important causes during the holiday season. The tribe and the casino are philanthropic leaders in the community year around, contributing monetary or in-kind donations to over 700 organizations in the last year alone. In 2015, the group celebrated a milestone partnership with Susan G. Komen by providing the largest team in history to participate in the annual Race for the Cure.

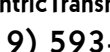
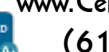

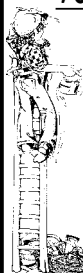

Alternative cold and flu remedies

While flu and cold are common to every region of the world, different cultures have developed their own solutions to tackle the all-too-familiar and dreadful symptoms.

Today it's thought that 70 percent of your immune system lies in your digestive tract, so many of these alternative healing methods rely on food for its curative properties. While some alternative treatments have not been evaluated by the Food and Drug

- In Japan: Hot green tea is poured over a crushed ume, which is an alkaline-rich Japanese pickled plum. Drinking this "umeboshi tea," full of iron and potassium, is said to help ease fever associated with the flu.

lic: A paste of honey, finely chopped onion and garlic, and the juice of at least half of a lime, is taken before bedtime. The garlic and lime juice, rich in vitamin C, boosts immunity.

- In France: For those with the flu, a homeopathic approach is taken using Oscillococcinum. This unusually named medicine has been a favorite flu fighter of the French for more than 70 years. Clinical studies show that it reduces the duration and the severity of fever, chills, fatigue, headache and body aches. It is recommended that you take it at the first sign of flu symptoms.

- In China: A restorative dish is made from healing fritillaria bulbs (Chuan bei mu) and an Asian pear. The center of the pear is scooped out to form a bowl. A teaspoon of honey is mixed with fritillaria extract, which is then poured into the pear. The covered dish is

steamed for 45 minutes to create a warm elixir to soothe the throat. For maximum effect, a honeysuckle and licorice root tea chaser provides added immune support.

- In South America: A plate of sliced onions is placed on a nightstand overnight. The scent from a freshly chopped onion helps break up mucus and congestion, just as it causes the eyes to water and nose to run while cooking. Loaded with sulphur compounds, onions also improve circulation.

My Christmas 'Miss-Her-Toe' celebration

Making mistakes is not in the resume of the Gracious Mistress of the Parsonage. That was, up until now.

I am not known as Mr. Perfect by any stretch of the imagination. If there is a mistake to be made, I have already made it or it is on my "Bucket List." I have made a lifetime profession of making mistakes.

Sooner or later, I am going to come to the end of this and stop making mistakes. I suppose I will have to live as long as Methuselah to achieve that goal, and believe me, I do not plan to live that long, only long enough to come to the end of all of my mistakes.

I must say I was making progress until this past week. Actually, it was not my mistake that highlighted the week, which made it remarkable.

My wife does not make mistakes, but this past week she made a blunder of all blunders. Believe me; I am not smiling except on the inside where I am actually laughing hysterically.

It is that time of the year

when Christmas decorations magically appear in our very gracious and merry domicile. The procedure along this line is that I am to just stay out of her way. It is amazing what she can do when I am out of her way!

'Victor Frankenstein' is marvelously entertaining

In what turns out to be a marvelously droll and often funny film, *Victor Frankenstein* takes another look at the classic story as written in Mary Shelley's 1818 novel. The tale of life being created by young mad scientist Victor Frankenstein while at the University of Ingolstadt has captivated movie audiences since 1931 when the first *Frankenstein* film was made by Universal Pictures.

Starring the unforgettable Boris Karloff as the monster, make-up genius Jack Pierce created the iconic look of the flat-top head and the electrode bolts in neck. The creature in the new *Victor Frankenstein* film has a different look, but is patched together with spare body parts that don't quite fit and are haphazardly sewn together with what looks to have been baling wire. Scary, none the less, but a nod to the original with the inclusion of newly styled lightening rods.

Screenwriter Max Landis has

fashioned the story to be told from Igor's point of view. Igor, you might remember, was the twisted, hunch-backed assistant to Dr. Frankenstein. In the original movie, he was called Fritz, as played by Dwight Frye. This time out, we have a much better looking Igor, played by Daniel Radcliffe in a role that takes him far beyond his youthful *Harry Potter* days. Discovered at the circus by Dr. Frankenstein, Igor is miracu-

lously cured of his hunchback, gets his hair styled, is fitted for some fancy Edwardian suits, and voila!, he is turned into a sexy young medical genius. He's now ready to help out the far-thinking doctor in his quest to create life from scratch.

Director McGuigan has skewed the story to a more "youthful" feeling as both McAvoy as Victor and Radcliffe as Igor are much younger than

actors Colin Clive, Boris Karloff, and Dwight Frye were in the original 1931 film. The film is more accessible to today's young audiences and should play well with them. With Radcliffe's millions of fans, they should be delighted to see him in a more grownup role.

Everybody knows the story, much like we all knew the ending of *Titanic*. It's great fun to see just exactly how to tell the same familiar story but make it seem new all over again. By inserting some comic scenes and snappy dialogue, it becomes more fun when the chills are dished out by the gross medical procedures taking place. Black humor, you say? Yes, plenty of that. McAvoy stops just short of parlaying his version of Dr. Frankenstein from going over the top. But he has plenty of histrionics for us to figure out he has only one oar in the wa-

ter. Hapless Igor doesn't have much luck in trying to reign in the scientific experiments. He reluctantly goes along with all the outrageous lab hijinks.

A beautifully mounted film, the look is lush and lavish and catnip to cinematographer Fabian Wagner's eye. Wagner makes even the gory scenes look like an exquisite painting. This is helped, of course, by the production design by Eve

Stewart and the stylish costumes by Jany Temime. Craig Armstrong's music lends the appropriate chills at the proper times and warms us during the ballroom scenes.

Victor Frankenstein is a marvelously entertaining film and should be a winner for 20th Century Fox. It's not exactly a holiday-type film, but it adds fun and diversity to the already crowded holiday film releases.

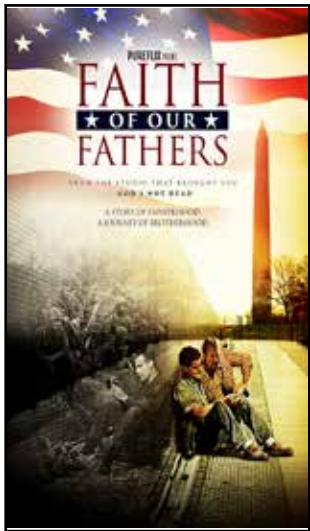

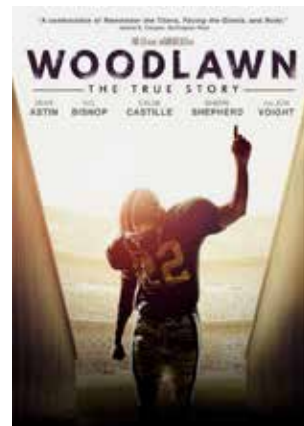
When Elizabeth meets Miss

Kevin Downes talks about his connection to 'Faith of Our Fathers'

The film *Faith of Our Fathers* has recently been released on DVD. Kevin Downes — writer, producer, actor along with his friend producer, writer David White, script writer Harold Uhl and writer and director Carey Scott — was anxious to talk about his involvement in *Faith of Our Fathers* and other Christian films.

Q. When did you become a Christian?

KD: When I was 8-years-old, a friend invited me to an Awana's group so I started going to church. Then I went to high school and college. I moved to LA and was cast in my first Christian film at 23, produced my first film at 27, and now am now 44.

Q. Did you have a desire to make films early on, and was filmmaking easy to get into?

KD: Not until I was cast in *End of The Harvest* with David White in 1997. It was the second Christian movie I acted in and the director Rich Christiano said, "You two guys should produce and make your own movies." So we did. We wrote a script and went out and started shooting. I didn't really think I could do it, but here we are.

Q. How did you come to team up with David White?

KD: He had a bible study in LA in 1992 at a church we were both going to. We became good friends first, and began doing movies together after that, like *The Crossing*. We talk to each other every week and are still working on projects today. It's a great friendship.

Q. Your and David are, actors, producers and writers on *Faith of Our Fathers*. How does that workout?

KD: Dave and I started on it about 10 years ago. The

concept was interesting; two guys whose fathers served in the Vietnam War made a great father-son story. We didn't think it would take us this long to make, but I'm glad we went on the journey that we did. When I started developing films, Christian movies weren't in theaters, the marketplace wasn't there. Today and it is and it was wonderful to release *Faith of Our Fathers* in July. Many veterans came out to see it, and we let them know how important they are. It was like a love letter to them. I'm really proud of this film, and from the standpoint of filmmakers, that we got to thank those guys then.

Q. How did the writing between the three of you?

KD: David and I started together with a father/son story. We market it as a love letter to them. It's not just about names; every name represents a story. It's not only about what happens to them, but what happens to their families left

behind. That's something we touch on big-time in the movie which is about two fathers who left their sons and families behind what happened to the families, and the sacrifices soldiers make.

Q. *Faith of Our Fathers* has received some rough reviews. How do you as a filmmaker / actor react to some of the criticism?

KD: We had a small budget that's what some of the criticism was about. Also it's evangelistic so some people don't like that. I let it roll off my back.

Q. What's the best reason for you to make Christian films?

KD: So many people don't realize that when a Christian film is in the theater, we can really rally and get support to further the cause we need today, for sure. I was very proud of *Woodlawn* and we would've liked to market it more, but it takes big dollars to get it out there.

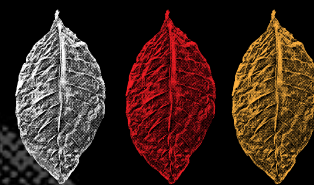

Bolts drop the ball at K.C.

For the second week in a row against a divisional opponent, the San Diego Chargers defense gave up only 10 points. Trouble is, for the second week in a row the Bolts offense could not get into the end zone. Dropped passes, costly penalties, and a vehement pass rush on their quarterback (Rivers) kept the Chargers quagmire of a season intact.

On a rainy, blustery Kansas City afternoon where the rain at Arrowhead Stadium pelts from the side. The (3-10) San Diego Chargers plummeting season continued as they were unable to score a touchdown in the last eight quarters.
