#### East County Letter Carriers help 'Stamp Out Hunger!'

n Saturday, May 9, join East County Letter Carriers, the National Association of Letter Carriers (NALC), United States Postal Service, AFL - CIO, United Way of America, Campbell Soup Company and Feeding America San Diego to help Stamp Out Hunger! in San Diego County. Stamp Out Hunger!, the annual National Association of Letter Carriers food drive is the nation's largest single-day food drive.

Residents throughout East County can leave a sturdy bag containing non-perishable food such as canned soup, canned vegetables, pasta, rice or cereal next to their mailbox prior to the time of regular delivery on May 9. Food items should be in non-breakable containers such as boxes and cans. Letter carriers will collect the food donation that day and deliver it to San Diego County's hungry. For residents who would prefer not to leave the food out or who have a post office box, food donations may be taken to your local post office.

"This is the largest one day food drive in the nation," said Gary McDonald, president and CEO of Feeding America San Diego. "Not only do letter carriers deliver our mail rain or shine - they play an incredibly active role in partnering with Feeding America food banks across the United States to end hunger."

Last year, letter carriers across the country collected a record total of more than 73.1 million pounds of food. However. during these hard economic times, more people than ever are relying on food banks to provide food for their table. A recent survey of Feeding America food bank members reported a 30 percent increase in requests for emergency food assistance. The reason cited for this dramatic increase in demand included rising cost of food, increasing unemployment and underemployment, cost of fuel and the burden of mortgage or rent costs.

"In these difficult economic times, hunger is an issue that must be addressed in every community across our country," said William H. Young, NALC president. "We see it daily out on our routes. That's why now more than ever before we need

everybody's help to make a real difference."



Cajon Police Chief Pat Sprecco as the 2009 inductee into the Grossmont College Walk of Fame. Sheriff Bill Kolender will be making the presentation to Chief Sprecco. The Walk of Fame, located on campus in the Main Quad area, is a display of several bronze plaques embedded in concrete that feature the names of previous distinguished alumni. The Grossmont College Foundation began the Walk of Fame program in 1989, the 18 previous Walk of Fame recipients have included medical researchers, political advocates, artists, athletes and community leaders. Chief Sprecco was a 1976 graduate of Grossmont College with an associate degree in criminal justice administration. He was named Chief of Police in March of 2008.

Newly certified participants that pass the yearly renewal Crime Prevention, Crime Prevention Through Environmental Design (CPTED) inspection for the CFMH program, will now be recognized at El Cajon City Council meetings. The Crime Free Multi-Housing Program consists of three training phases that are completed under the supervision of the El Cajon Police Department. The benefits of this program are reduced calls for service, a more stable tenant base, and it creates a sense of community for tenants living in an apartment environment. 

### Swine Influenza — know the facts

Swine Influenza (swine flu) is a respiratory disease of pigs caused by type A influenza viruses. Outbreaks of swine flu happen regularly in pigs. People do not normally get swine flu, but human infections can and do happen. Most commonly, human cases of swine flu happen in people who are around pigs but it's possible for swine flu viruses to spread from person to person also.

### Are there human infections with swine flu in the U.S.?

In late March and early April 2009, cases of human infection with swine influenza A (H1N1) viruses were first reported in Southern California and near San Antonio, Texas. CDC and local and state health agencies are working together to investigate this situation.

#### Is this swine flu virus contagious?

CDC has determined that this virus is contagious and is spreading from human to human. However, at this time, it not known how easily the virus spreads between people.

### What are the signs and symptoms of swine flu in people?

The symptoms of swine flu in people are similar to the symptoms of regular human flu and include fever, cough, sore throat, body aches, headache, chills and fatigue. Some people have reported diarrhea and vomiting associated with swine flu. In the past, severe illness (pneumonia and respiratory failure) and deaths have been reported with swine flu infection in people. Like seasonal flu, swine flu may cause a worsening of underlying chronic medical conditions.

#### How serious is swine flu infection?

Like seasonal flu, swine flu in humans can vary in severity from mild to severe. Between 2005 until January 2009, 12 human cases of swine flu were detected in the U.S. with no deaths occurring. However, swine flu infection can be serious. In September 1988, a previously healthy 32-year-old pregnant woman in Wisconsin was hospitalized for pneumonia after being infected with swine flu and died 8 days later. A swine flu outbreak in Fort Dix, New Jersey occurred in 1976 that caused more than 200

cases with serious illness in several people and one death.

#### How do you catch swine flu?

Spread of swine flu can occur in two ways:

- Through contact with infected pigs or environments contaminated with swine flu viruses.
- Through contact with a person with swine flu. Human-to-human spread of swine flu has been documented also and is thought to occur in the same way as seasonal flu. Influenza is thought to spread mainly person-to-person through coughing or sneezing of infected people.

#### Are there medicines to treat swine flu?

Yes. CDC recommends the use of oseltamivir or zanamivir for the treatment and/or prevention of infection with these swine influenza viruses. Antiviral drugs are prescription medicines (pills, liquid or an inhaler) that fight against the flu by keeping flu viruses from reproducing in your body. If you get sick, antiviral drugs can make your illness milder and make you feel better faster. They may also prevent serious flu complications. For treatment, antiviral drugs work best if started soon after getting sick (within 2 days of symptoms).

### How long can an infected person spread swine flu to others?

People with swine influenza virus infection should be considered potentially contagious as long as they are symptomatic and possible for up to 7 days following illness onset. Children, especially younger children, might potentially

be contagious for longer periods.

#### What can I do to protect myself from getting sick?

There is no vaccine available right now to protect against swine flu. There are everyday actions that can help prevent the spread of germs that cause respiratory illnesses like influenza. Take these everyday steps to protect your health:

- Coveryour nose and mouth with a tissue when you cough or sneeze. Throw the tissue in the trash after you use it.
- Wash your hands often with soap and water, especially after you cough or sneeze. Alcohol-based hand cleaners are also effective.
- Try to avoid close contact with sick people.
- If you get sick with influenza, CDC recommends that you stay home from work or school and limit contact with others to keep from infecting them. Avoid touching your eyes, nose or mouth. Germs spread this way.

#### What should I do if I get sick?

If you live in San Diego County or Imperial County California or Guadalupe County, Texas and become ill with influenza-like symptoms, including fever, body aches, runny nose, sore throat, nausea, or vomiting or diarrhea, you may want to contact your health care provider, particularly if you are worried about your symptoms. Your health care provider will determine whether influenza testing or treatment is needed.

If you are sick, you should stay home and avoid contact with other people as much as possible to keep from spreading your illness to others.

If you become ill and experience any of the following warning signs, seek emergency medical care.

In children emergency warning signs that need urgent medical attention include:

- Fast breathing or trouble breathing
- Bluish skin color
- Not drinking enough fluids
- Not waking up or not interacting
- Being so irritable that the child does not want to be held
- Flu-like symptoms improve but then return with fever and worse cough
  - Fever with a rash

In adults, emergency warning signs that need urgent medical attention include:

- Difficulty breathing or shortness of breath
- Pain or pressure in the chest or abdomen
- Sudden dizziness
- Confusion
- Severe or persistent vomiting

### Can I get swine influenza from eating or preparing pork?

No. Swine influenza viruses are not spread by food. You cannot get swine influenza from eating pork or pork products. Eating properly handled and cooked pork products is safe.

### Health...Just Common

Who is coughing his lung out in 2?" That is not a particularly good way to start a new patient relationship but it happens. And, on a busy day without any students to gather even more information to develop the best diagnostic tool, your history. But, we persevered.

The patient is actually rather important in a challenged world by our new leadership, so, performance standards were on alert. However, his infectious laugh and yet desperate questions soon put all appearance strategies away and off we went. (Already behind, a quick silent prayer for clarity went up.)

It turns out that stressors as a young child in school and in a nation that we abandoned and hence lost it's freedom led to trips to Geneva and adult medications to adjust gastritis when he had not yet entered puberty. An escape to our nation led to less stress but damage or scar tissue was in place. As medications failed and adult stressors entered the picture, breathing difficulties and infections became a constant. You would not believe the number of famous physicians and systems that have been accessed. Rescue medications abound and are changed often and a partial lung lobectomy almost was accomplished. "But, that was too much and when I went back a few months later they discovered that did not work anyway." His intermittent cough was certainly disruptive. Occasional mold exposures and reflux pictures kept sneaking in the story of how the coughing could not be stopped and that the secretions are now thick and firm. Trips to other areas of the world had sometimes diminished the cough but never did it entirely go away. He is not an old man but fears he can no longer function at his present famous pace.

"Hey, when do I get to talk?" "Oh, am I acting like a doctor." (Ouch!) With the lead now sort of in place, we went back to his childhood. It was pointed out that his GI tract and hence his immune system were not built and encouraged to function properly. To change the ph of the GI tract so dramatically alters critical digestion, limits the building blocks for your body and over challenges and under prepares your immune system for just daily function. So, it is all about your GI tract and not your lung. The lung is the secondary presentation although much more apparent. We will never repair anything unless the GI tract is balanced, non-inflammed and absorbing the good stuff. "You have spent years turning off the warning signals and not finding the cause." The subsequent silence was deafening. "And, as a final observation, your adrenal activity is probably pretty much done." That lead to a powerful coughing sequence.

It was not as difficult to send him home with a test list and net homework assignment. He fully understands the importance of knowledge and research before he implements a plan in his profession and was appreciative that there was no "hip shooting" after are first meeting. Everything stays the same until more is explained. Hey, kind of catchy. Stay tuned.

### Negativities aside 'The Soloist' is memorable

uch like the reporter played by Russell Crowe in State of Play, Robert Downey Jr.'s Los Angeles Times columnist, Steve Lopez, also makes a difference in people's lives through his coverage in The Soloist. However, State of Play is fiction while The Soloist tells a real-life story and is based on a 2005 column and a 2008 book written by Lopez about a disturbed homeless man on the streets of L.A.

While questioning Nathaniel Anthony Ayres (Jamie Foxx) and watching him play a violin, Steve (Downey) discovers Nathaniel is a dropout from Juilliard. Steve stumbles through a conversation that has Nathaniel taking frequent breaks to vent about a statue of Beethoven in his space. Over the next few weeks, Steve will learn through their disjointed friendship that Nathaniel is mesmerized by

both Beethoven the man and his music.

Steve, facing a stalemate with his job and his marriage, welcomes the intrigue of finding out what makes the obviously mentally-ill Nathaniel tick and trying to help him get off the streets. This becomes an arduous task as Nathaniel is very happy with his life and where he's at "making music in the under-freeway tunnel."

The story of one man helping a less fortunate man is inspirational, especially when Steve's columns start an avalanche of support for Nathaniel with contributions flowing into the newspaper office. Even a cello, the instrument that Nathaniel was well on his way to becoming a success with at Juilliard, shows up. Steve then finds him a tutor to help reacquaint Nathaniel with the instrument.

The two leads in this film are

superb. The pure essence of *The Soloist* is that while trying to help Nathaniel pursue his passion of music and reconnect with his life, Steve rediscovers his own passion to live life to the fullest.

Susannah Grant (Catch and Release, Frin Brockvich) was excited to watch Foxx and Downey bring her screenplay to life. "For me, it was almost unnerving how completely Jamie embodied the experience of being Nathaniel without ever being an imitation. The way he captured the vulnerability Nathaniel carries out into the world each day was amazing to watch," Grant said. "And I loved the assuredness Robert brought to the character. The way you see Steve's heart open up bit by bit is really beautiful."

Downey is one of today's most gifted actors. There are moments in *The Soloist* when Steve is interacting with Na-

thaniel and he stops talking and just stares. There's an assumption that Steve doesn't quite know what he wants to say. That's when Downey verbalizes a simple line of dialogue that becomes so profound through his magic of subtle emotion, we're transformed.


Foxx is also amazing as a broken man who understands so much yet can't make sense of common things. Foxx is totally immersed in Nathaniel's world. He spent six intensive months learning advanced cello and violin techniques.

"It's so seldom you find a character captured with so many nuances and have everything work so well together on the page," Foxx said. "I thought it was amazing. It's a story about how trying to understand someone else's world can take you a long way in your own, and it's really a beautiful love story. It was tough because I had to try to submerge myself into the mind of a schizophrenic in order to really understand what Nathaniel's journey is all about. You have to kind of slip off the deep end a bit, and the biggest challenge was letting go.

It's too bad some elements of the film keep it from being extraordinary. Wright admitted he felt a passion for the

### Chargers speak English for first pick

ith their 16'th selection, the San Diego Chargers chose outside linebacker Larry English as their first pick in the 2009 NFL Draft.

Who is he and where is he from?

At (6-2, 256) the four-year starter from Northern Illinois University, was a two-time recipient of the Vern Smith Leadership Award given to the top player in the Mid America Conference. Known as a quarterback 'killer' and a backfield 'disruptor', English finished his college career with 31.5 sacks and 63 tackles for loss.

Joining an already talent laden linebacker corps of Shawne Merriman, Shaun Phillips, Jyles Tucker and Antwan Applewhite the Chargers now have three quality designated pass rushers on the same squad, something not seen in San Diego in quite some time.

"He is a pass rusher (who is) physical, competitive with a nasty streak who runs all over the field," said Chargers General Manager A.J. Smith describing the Chargers number one pick.

The selection of English surprised everyone on draft day. Even the broadcast teams covering the event appeared shocked. English was not on anybody's list of first round draft eligible rookies... except A.J. Smith's.

Like pulling a rabbit out of his hat, the Chargers General Manager has a knack of finding talent where others can't.

Explaining his reasoning for his first draft choice selection A.J. responded. "The decision was defense. We need to do a better job and stop these passing assaults or we're not going to go where we need to go. We got to bring the heat. It makes the back end better (secondary)."

"We need to put Shawne Merriman on one side, Larry English on the other side, and Shaun Phillips. We got all these things we are thinking about and it would be absolutely wonderful if it takes place."

With an emphasis on the future A.J. spoke, "I'm a big worry wart. I worry about everything. I don't know if people are going to be here or not. I don't know if they are going to get hurt. We have somebody behind Shawne Merriman. If it doesn't work out with Shawne (last year of current contract), we can turn to this guy, so there is a B plan. It just works that way. I'm hoping that everyone is healthy, excited, and ready to go. We have to go to those backup scenarios. We have another pass rusher."

Larry English is a likeable guy who worked his way up to the top in a smaller program.

Describing himself and his current situation he said, "I grew up in a normal middleclass family. My father worked on computers and my mother worked in sales. I had a supportive family that made me the kind of person I am today. There was no silver spoon in my mouth. I was blessed, but at the same time my family had to work for everything we got. I think it instilled a lot of characteristics in me to look at life in the same light. If you put in the time and commitment, then it will pay off the best for you.

"I had committed to Northern Illinois. At that point it was a team on the rise and had come off a great season. I thought it was a good fit for me just from the standpoint of the players and coaches. I'm happy with the decision (to play there). It worked out great for me.

"I've watched plenty of tape of the Chargers defense. It couldn't have been a better fit. I'm so happy with them making a decision to go with me. It's a blessing and I'm excited to get started. I'm not exactly sure how everything is going to play out. All I know is I'm here to work hard.

"One of the things I am most excited about is getting to come in with two experienced guys, (Merriman and Phillips) and getting to learn all the things they can pass on to me. I'm here to help the team any way I'm asked.

"I think going through this process (getting drafted, contract negotiations), the money obviously is a plus, but the thing that is more important to me is to be a successful football player, winning football games, and being a monster on the field. That's what makes me happy."

Only time will tell if this dominant player in the lower level of college will be a success in the NFL.

But wait, the Fusion Hubrid is in showrooms as I write this review. The only problem is that there are none in the showrooms! It seems

80 percent of all 2010 Fusions ordered from the dealers are Hybrid and they can't keep them in the dealerships.

So no one will think I'm on Ford's payroll because of the positive response to the Fusion Hubrid. I have been involved in alternative fuel vehicles for years. Thirty days in an EV-1, plus many hours in every kind of hybrid built. But I have to admit, Ford hit the bull's eye with the 2010 Ford Fusion. I feel what Ford did right was listen to the consumer and built a car we could all use.

Ford has tried to address all the negative feeling hybrids have set in our minds, sluggish, rattle, clunk and bump on the road, very harsh ride and what we call in the industry, "motor boating" which is on acceleration the engine revs

and the car moves out slowly then the engine drops down when the car gets up to speed, very annoying!. By building an Electronically Controlled Continuously Variable Transmission the acceleration and deceleration is spot on with regenerative braking system to help in the fuel mileage, stopping and the results is less wear on your brake pads.

The Fusion is a mid-size four door sedan able to handle five full size adults and still gets fuel mileage in the upper 40's. One feature that is pretty cool is the ability to run up to 47 miles per hour on the electric motor and if one lets off the gas pedal, it will maintain that speed with out pushing on the pedal, which is why you get better mileage in town than on the open road. EPA numbers are 41 city and 36 highway. The gas engine is unique as it was built as a partner to the hybrid system, a 2.5-liter Atkinson inline 4-cylinder engine that doesn't need oil changes until 10,000 miles.

Into cool gauges that will tell what is going on under the hood? Well Ford has listened again and put in four different dash clusters, Inform, Enlighten, Engage and Empower. A different source of information at the touch of a finger from a little information to more than is needed. If there is a bush or small tree on the dash that is a good thing, drive smart and the tree flourishes, stand on the gas pedal and the leaves will drop and lets the driver know he/she is killing the environment. The gauge packages are called SmartGauge and EcoGuide and because it is a Hubrid that has a 110-volt receptacle at the base of the dash.

How did it drive? Like a regular Fusion but with the ability to go over 700 miles on a tank of fuel. Last week a team of engineers at Ford Motor Company took a Fusion Hybrid and drove it 1,000 miles on one tank of gas! Talk about raising the bar for the competition. This test was done in Washington DC on city streets, of course no A/C even though the Fusion system is an electric A/C system which cuts down on fuel consumption. The Fusion Hybrid is based on the Fusion SE model so you get a lot for your money; \$27,270 plus tax and license is your starting price for a very well equipped four door sedan.

I was very impressed with my test drive and the technical advances Ford has made in this segment, the competition should take a closer look at the 2010 Ford Fusion Hybrid, and I think they are!

CDBG and HOME grants are funded by the U.S. Department of Housing and Urban Development (HUD)

HUD requires that any jurisdiction receiving CDBG and HOME funds to complete a five-year document outlining the needs of the community and establishing goals to meet those needs. The Five-Year Consolidated Plan satisfies the statutory requirements for these programs. The City is required to update this plan for Fiscal Years 2009 - 2014. Additionally, the City is required to prepare a one-year action plan describing the activities that will be completed during Fiscal Year 2009-10 to meet a portion of the goals established in the five-year plan.

The primary purpose of the Consolidated Plan is to develop a plan for addressing the needs for lower income groups who are the intended beneficiaries of the HUD formula programs. The CDBG funds must be utilized to meet one of three national objectives to qualify for funding: 1) benefit 70% low and moderate income persons in the community; 2) aid in the elimination of slume and blight; or 3) meet other community development needs having a particular urgency because existing conditions pose a serious threat. HOME funds may be used "to provide incentives to develop and support affordable rental housing and homeownership affordability through the acquisition, new construction, reconstruction, or rehabilitation with suitable amenities, including real property acquisition, site improvement, conversion, demolition and other expenses." It may also be used to provide for the payment of reasonable administrative and planning costs, and to provide for the payment of operating expenses of community housing development organizations (CHDO's) – 24 CFR 92.205(a). Each participating jurisdiction must set aside 15% of their HOME entitlement for CHDO's. The El Cajon City Council took these tentative actions at the February 24, 2009, public hearing: allocated \$1,234,525 of anticipated CDBG funds, and \$759,051 of anticipated HOME funds. In addition the City Council also allocated \$902,547 of unallocated prior year CDBG and \$477,271 of HOME funds. Preliminary allocations were made and are subject to public review. The projects and programs below reflect those allocations made at the April 14, 2009, public hearing.

The Five-Year Consolidated Plan outlines programs anticipated for 2009-14 and the One-Year Action Plan 2009-10 is the document that provides details of the projects and programs funded through CDBG and HOME funds for Fiscal Year 2009-10. 

### Dog hates me ... ask a trainer

Dear Trainer.

have a 3 month old Min Pin that, well let's just say I've scared the "you know what" out of him due to my frustration. And as one would expect, he is very scared of me. I've recognized the err of my ways and am striving to make things right. I'm completely ashamed that I've made my little buddy this way and who right now wants little to do with me. When I pick him up, he shivers, and when I take him for a walk, he only tries to get away from me and I have to drag him to get him to follow. My question is, is there hope for me to regain any semblance of forgiveness or trust from my dog? He is quite content around my wife and kids and tolerates me when they're around. Thanks for your help and insight. Please forgive me for my wrong doing. I love my little buddy. I just hope that at some point he might love me back.

Signed, Hang Dog, Dog Owner

#### Dear Hang Dog,

Thank you for your honesty and candor: it's not easy to admit one's wrong doing, and I'm glad you are looking to make amends and set things right with your puppy.

First, make sure your dog is eating a high-end food without grains, if you are not already doing this. This helps dogs calm down from the inside. This will go for all treats as

Next. I would recommend that you back off a bit on trying to hold, pet and walk your dog. Right now, he really doesn't have any reason to enjoy being with you—as evidenced by his shaking and having to "drag" him on walks. What is happening is that you are confirming to your dog that you really "don't get it." even though he is "telling" you with his actions that he is not comfortable.

So, what you really need to do is teach him that you are really very important in his life and that he really shouldn't be fearful of you.

#### What to work on

The first thing you will need is to build trust between you and your dog. You can do this via classical conditioning, which means pairing good things with your presence.

You will want to start with enough distance between and the dog where your dog isn't going to growl or shake when you walk in the room. As soon as you walk into the area where the dog is, begin giving your dog several really good food rewards such as tiny pieces of chicken, just for looking at you when you enter, tossing the treats if needed. Do that a

number of times until you can see that your dog is anticipating the reward when walk in. Your dog will be learning that when you are around, wonderful things happen, but when you leaves the treats go away.

After 10-20 sessions at this level, (take a few days) move a little closer to your dog and give your dog several highvalue rewards again. It's important to avoid making direct eye contact with your dog so your dog doesn't feel any pressure to acknowledge your presence. Stay at this level a number of sessions, moving a tiny bit closer each round that you train. Strive to move close enough to your dog (without any growling, so go slow) that you are able to start handing your dog the food rewards. This might take a few weeks since this has been traumatic, so be patient. Once you are able to hand treats to your dog, begin to make brief eye contact as you hand the treats. This will help him learn that eye contact is part of this.

When you are able to get close enough to your dog to sit down near him, it should be without any pressure to interact with you. It will be important that your dog learns that you are not going to talk, lean over, pet or interact with him, just sit near and give him food rewards. This allows your dog the opportunity to initiate the interaction and with that, feel

more confident that nothing bad is going to happen. As he becomes more comfortable with you near, you can then begin to reach out to him, but still offering him a food treat after he allows a tiny bit of contact with vou. Don't over do. just look for one small touch, and then remove your hand and reward him for that.

Be sure to take lots of little breaks in-between training so your dog can process all of this, however, if you see that your dog is concerned at any point, go back to an easier level and do that part until your dog has a stronger association.

I would also recommend

that you hand feed your dog his meals. Sit in a chair and place his bowl on the floor near you, and drop his food in, one piece at a time. Don't talk to him or try to touch him, just allow him to eat one piece of food at a time. The more you control the things that are really important to him, the more he will realize that you are not so bad after all.

Per walks, I would recommend that your wife takes the leash and you come along with really good food treats (very high value, such as chicken) and any time your dog is not pulling you drop a treat on the ground for him to find. This will teach him that walking near you

is okay and results in rewards. I hope this helps with your problem, but if you are still having trouble after working on this, please contact a good positive reinforcement behavior trainer to help you work through all the steps and figure out what else your dog might need.
