# City officials break ground on Public Safety Center

# City of El Cajon breaks ground on \$40 million Public Safety Center

afcon Inc., a leading San Diego-based construction management and consulting firm, announced that construction is now underway on a new \$40 million Public Safety Building for the City of El Cajon. An official groundbreaking ceremony was held Tuesday at the 5.7-acre site adjacent to City Hall at 100 Civic Center Way.

The project is being funded by Proposition O, a half-cent sales tax which was approved by El Cajon residents in November 2004. The 119,400square-foot Public Safety Building will be a five-story structure with 212,750 square feet of parking integrated on three levels. The stateof-the-art facility will include administrative and operational space for all divisions, a joint police and fire emergency operations center, community meeting room, modern communications center, indoor firing range, crime laboratory, property processing and storage area, short-term custody facility and central data center. The project is scheduled for completion in June 2011.

Participating in the groundbreaking ceremony were El Cajon's Honorable Mayor Mark Lewis, City Manager Kathi Henry, Police Chief Pat Sprecco, Retired Police Chief James Davis, and Public Safety Facility Finance Planning Oversight Committee Chair Rodgers Smith.

Gafcon was retained by the City in early 2006 to provide program management for the Public Safety Building. KMA Architecture & Engineering was selected as the primary architect and design began in summer 2006. The design and full Environmental Impact Report became finalized in late 2008. Ledcor Construction

was awarded the construction contract in March 2009.

The construction team includes KMA Architecture & Engineering, in partnership with McClaren, Wilson & Lawrie, architect, space planner, interior designer and mechanical engineer; Burkett & Wong Engineers, structural and civilengineers; Helix Environmental, environmental engineer; Geocon Inc., soils engineer; Wimmer, Yamada & Caughey, landscape architect; VSA & Associates, acoustical consultant; Brummitt Energy Associates, Title 24 consultant; IT Pathworx, IT consultant; and Rolf Jensen & Associates, fire protection engineer.

#### Landlords agree to pay \$18,000 to settle discrimination complaint

When Kanita Brawley tried to rent a Milwaukee area apartment for herself and her two children in April 2007, the property manager turned her down because the building's owners did not accept tenants with children.

Brawley had spent about two months searching for an apartment for herself and her daughters, who were 10 and 11 at the time. "When I finally found a decent place and then was told I couldn't get it because of my children, it was like a blow to my face," she said

Brawley fought back, and she is very glad she did.

The Metropolitan Milwaukee Fair Housing Council sent a fair housing "tester" to the apartments. The tester was told the landlords didn't rent to families with children anymore.

Federal and Wisconsin state laws prohibit housing discrimination based on the presence of minor children, so the Metropolitan Milwaukee Fair Housing Council helped Brawley file complaints with government agencies. Because she filed and pursued these discrimination complaints, building owners Arnold and Rebecca Peltz must pay Brawley \$18,000 as settlement for refusing to rent an apartment to her family. The Peltzes and their property manager, Crystal Sahr, also agreed to undergo fair housing training to prevent future discrimination.

In California, it is illegal to refuse to rent or sell a home to someone based on the person's race, color, religion, sex, sexual preference, age, marital status, national origin, ancestry, physical or mental disability, familial status, or any other unreasonable or arbitrary category. When you seek to rent or buy an apartment, condominium or house, the owner (or the owner's agent) cannot refuse to deal with you solely because you are a woman, divorced or separated, living with someone to whom you are not married, or gay. With respect to housing agreements, a single person with children is entitled to the same treatment as a married couple with children.

The Center for Social Advocacy offers assistance with housing discrimination, harassment, and other tenant/landlord disputes, as well as information on immigration rights, and support and assistance to victims of discrimination in schools, hate crimes, labor exploitation, human trafficking, and immigration raids.

#### City of El Cajon 4th of July **Fireworks**

# Lakeside Round Up of events

joint effort spearheaded by the Sheriff's Department in conjunction with Cal Trans and the Lakeside Fire Department cleared approximately 30 acres of land off Old Hwy 80 near Amelia Dr. in unincorporated

The Sheriff's Department has received complaints from neighbors that transients had set up illegal camp sites on a mesa above a hill overlooking Lakeside and El Cajon. The eight camp sites, which were located within close proximity to homes and a mobile home park, had fire pits used to burn a variety of items. Lakeside Fire Marshall Greg Schreiner said there were all the ingredients for a fire disaster. The fire pits could have easily ignited brush fires which would have spread to nearby homes.

Corporal Tim Johnson and Corporal Amber Leavitt, who have taken the lead, have chosen to be pro-active by being problem solvers instead of waiting for an incident. The Corporals are working hard with the community to address problems before they get out of hand. Johnson and I eavitt notified the transients the area was to be cleared out on Wednesday, June 17. Caltrans (who now has the area posted "No Trespassing or Dumping"), County inmates and Sheriffs all descended on the area early in the morn-

ing and found the camp sites vacant. Truck load after truck load of trash and brush was hauled down the steep hill. The camp sites which were little more than natural habitat forts for one or two people stood empty of litter which had included old rugs, a baker's rack, step stools, liquor bottles and some evidence of drug use. For over seven hours inmates and sheriff's worked side by side to clear out what had become a dangerous situation.

Sergeant Chris May with the community policing unit said he is proud of the work Corporal Johnson and Leavitt have done in the community. As Sergeant May headed toward another camp site he said this is one of the largest areas we have cleaned out but it won't be the last.

The Sheriff's Department patrols from unincorporated El Cajon, to the base of Alpine, Lakeside and up Wild-Cat Canyon to Barona.

#### **Annual Living Museum**

Lakeside Historical Society hosted the 3rd Annual Living Museum June 16, 17 &18. Event Organizer, Barbara DeYoung said 200 students from

the Lakeside school District attended the three day event. The hands on living museum allowed students to milk a wooden cow which simulated a real cow with a working utter, type on an old fashioned typewriter, and braid cloth for a braided rug.

Students in third grade learn about their own local history as part of their curriculum. Lakeside students are fortunate to have the Lakeside Living Museum to reinforce what they have learned in school.

There were 11 stations showing different aspects of life in Lakeside many years ago. The Living Museum is a community

effort with many local residents taking part in the three day event. Lifelong resident Cliff Northcote brought farm equipment which had been in his family for many years. Other exhibits included: a chicken plucker, hand wringer, washing machine and sewing machines form the early 1900's.

Members of the Lakeside Historical Society helped make the event such a big success.

# Pfeiffer perfect at ageless beauty in 'Cheri'

t's been some time since a truly seductive romance has appeared on the big screen, so the arrival of Chéri, starring Michelle Pfeiffer and Rupert Friend, has much to live up to. Director Stephen Frears re-teamed with screenwriter Christopher Hampton, his partner on Dangerous Liaisons, for this adaptation of two novels by Colette de l'Académie Goncourt. While the story seems somewhat dry and occasionally plods along, Pfeiffer and Friend make up for those flaws by creating a passionate sexual chemistry on screen.

Pfeiffer plays Léa de Lonval, a Parisian courtesan in the early 20th century. A short opening vignette reveals that courtesans were women who used their potent combination of sex and politics to influence powerful men and advance their own places in society. Today they would be referred to as high-priced call girls.

Léa, who has done very well for herself with this lifestyle, begins thinking of retiring when her friend and noted gossip, Charlotte Peloux (Kathy Bates), presents her with a challenge. Charlotte is annoyed because her son, lovingly nicknamed Chéri, has become irritable and restless, and may be in need of an exciting older woman's charms.

What begins as a one-onone flirtatious conversation in the garden between Léa and Chéri turns into a ravenous six-year affair with Léa not only supporting her new lover but equating his skills to a Masters in Lovemaking. They shut the world out around them and satisfy their own needs – he to mature, she to stay young.

Just when life seems perfect, Léa learns that Charlotte now wants more for her son – marriage and children. She pairs him off with Edmee (Felicity Jones), a youthful and innocent girl from a prominent family.

Surprised to discover she had fallen in love with Chéri, Léa feels devastated when he gets married. She boards up her house and heads for the seashore in hopes of finding a new lover. Ultimately, she and Chéri discover their affair was unrivaled, and they long to be together again. A craving that surely would come with great turmoil, but has that ever stood in the way of an obsessive attraction?

The fact that the plots of Co-

lette's books, *Chéri*, published in 1920 and *The Last of Chéri* in 1926, can still hold their charm in today's world speaks volumes about the obsessive power of sex, beauty and youth. Pfeiffer's (*Stardust*) ability to still bring grown men to their knees with adoration -- and make 20-year-olds envious of her beauty – proves she's the perfect choice for this role.

Because Frears had previously worked with Pfeiffer on Dangerous Liaisons (1988), he knew she would "fill the shoes of an actress who could deftly hit notes of humor, intelligence and pathos all in one fell swoop." According to Frears, Pfeiffer "was upsetting in Dangerous Liaisons and she's upsetting in a different way as Léa. She's unnerving, as though being that beautiful contains its own tragic quality, and that is what I wanted...a beautiful woman facing the reality of aging and Michelle is one of the most beautiful women in the world.'

While the story seems to flounder when Léa and Chéri are apart, that's the time which provides insight into Léa's realization about her own life.

"It's only when this young beautiful boy Chéri comes into her life that she completely loses her perspective and falls prey to her heart for the first time in her life," Pfeiffer said. "Love has never happened for her and she's always accepted that, yet now she's grappling with the aging process and she feels that this is her one last chance."

At first, Friend comes off a tad sheepish as Chéri, but eventually he fills the shoes of this character well. He certainly broadens the range of his talents, having more recently played Prince Albert in the historical romance of *The Young Victoria* and the intriguing Lieutenant Kotler in *The Boy in the Striped Pajamas*.

Bates (Revolutionary Road) fits the role of the scheming Charlotte as if it were written for her. Jones continues the innocence of the era she exhibited in *Brideshead Revisited*, but as Edmee in *Chéri*, she also demonstrates a calculated maturity in patience as she waits for the her new husband to recognize her worth.

Chéri is enhanced by gorgeous costumes by Consolata Boyle and beautiful cinematography by Darius Khondji (The Interrupter, Wimbledon), but it's the tension and vulnerability of the love affair that fuels the film.

# 'Year One' — please, no year two

Year One reminded me of two other comedies. The History of the World, Part 1 directed by Mel Brooks and Monty Python's Life of Brian, directed by Terry Jones. The big difference between those films is that Year One is not funny. It tries to be a Mel Brooks knock off mixed with Monty Python humor set behind two inept sexually frustrated cavemen, Zed (Jack Black) and Oh (Michael Cera).

Zed is the worst hunter of the tribe. Oh is not allowed to hunt and is forced to be a fruit gatherer with the women. The two are the least popular in the tribe and are desperate to impress two women they admire - Maya (June Raphael) and Eema (Juno Temple). Zed decides to take a bite of the forbidden fruit from the tree of knowledge of good and evil to gain godly power to become more popular. This results in his expulsion from the tribe for not understanding the word forbidden. Oh, joins him and together they set out to discover a variety of new people and places, "supposedly" biblical in nature.

They meet Cain (David Cross) and Abel (Paul Rudd), the first and second sons of Adam (Harold Ramis - who

also directs) and Eve (Rhoda Griffis). Cain murders Abel and tries to blame it on Zed and Oh. They meet both Abraham (Hank Azaria), patriarch of Jews, Christians, and Muslims, and his son Issac (Christopher Mintz-Plasse). Maya and Eema get captured by Roman soldiers and Zed and Oh must somehow rescue them and not die in the process.

Jack Black overacts every scene as usual, and it's a shame that such a talented comedic actor agrees to star in such dribble as this. Cera is the same character as in his previous roles in Superbad and Extreme Movie, a timid man

who gets tongue tied whenever women are around.

The least funniest character in the entire movie is Oliver Platt (Kinsey, Casanova) as the High Priest who does a scene involving a picture of oil and the Priest hairy chest. Again another wasted great talent. Olivia Wilde as Princess Inanna is obviously only here to provide visual stimulus.

Year One focuses most of its time on visual sight gags, toilet humor and ridiculing the Bible, and is unfunny, degrading, repulsive and not worth seeing even it they paid you to go see it.



# 2010 Toyota Prius Hybrid V Model

Honda Insight and now the 2010 Toyota Prius. So, which one would I choose to put in my garage? Before I answer that let's talk about the Prius.

My model was your typical five door hatch back with a 1.8-liter dual overhead camshaft, 16 valve variable valve timing intelligence (VVT-i), four cylinder engine that burns gasoline. With the help of the Hybrid Synergy Drive System one could expect 51 miles per

gallon in the city and 48 miles to the gallon on the open road. That is probably the most important part of this car review, but wait there is more.

Yes, one can put four adults in the Prius with no problem, there is a lot of storage space for all the grocery getters and it keeps up with traffic and is easy on the eyes.

But I had a few issues that come with driving a hybrid,. Some are hybrid characteristics and others are Toyotas own design. For example, the power is low unless one really stands on the gas, which should not be done — no problem with doing it, just isn't environmentally correct. Then there is the, "Is the engine running or not?" Look for the ready light on the dash. Next is the hesitation at freeway speeds, as if the Prius is looking for the correct speed to be in. The Honda did this as well.

Toyota has loaded this car up with more bells and whistles than Honda — that is good and bad. The good is if one likes bells and whistles great, if not, it is a down side.

For example Toyota has this safety system that only works when the cruise control is engaged. What happens is when the cruise control is engaged a screen pops up and it shows three bars on the dash. The bars relate to the distance between the vehicle and the vehicle in front of you. The distance can be adjusted, but can not be turned off as long as the cruise control is on. This is great for tailgaters, it will not let the driver tailgate, the car actually slows down, but my question is, if it slows down as

quickly as it did for me did the brake lights come on? I decided to call Toyota and spoke with a product consultant who stated yes the brake lights will come on if the Dynamic Radar Cruise Control System detects a potential collision or if the Prius de-accelerates at a rate of speed that could cause a rear end accident. I'm not fond of this feature but I feel it is necessary and the driver needs to accept this system to help save lives and keep accidents to a minimum.

The only other complaint I had is it rained last week and the rear wiper only cleaned the top glass of a two-tier-glass hatch, which left the bottom glass dirty, not a big deal but a little annoying.

So, to answer the question I posed at the beginning of this road test, which one would I want in my garage? Even though it is more technical than I like, I would take the Toyota over the Honda. I feel Toyota is ahead of Honda by a year or two, but hey make your own choice.

One last complaint, and this is to the State Government. Issue HOV stickers to all Hybrid vehicles!

**Dave:** My husband is 89 and has always loved our cars, they have never been to a car wash and our 1998 Passat looks brand new, even though he is unable to drive anymore, he has taught me how to wash and put air in the tires. It has 64,000 miles on it and I hope I will have it forever.... I love it. Do you have any suggestions as to how to get tire marks off our driveway, I know it isn't really a car question, but thought you would perhaps have an idea. AJ.

**AJ:** Go down to your nearest Parts Store, (NAPA, Kragen, etc) they will have a driveway cleaner you can purchase. A home remedy is little Clorox and water and a strong scrub brush. You can always go to my website and see all the information I have to offer, <a href="https://www.davestall.com">www.davestall.com</a>.

**Dave:** Question, I have a 2003 Toyota Camry and want to have my windows tinted. What is legal and will it interfere with the antenna in the rear window and will it create a problem for night driving? Any drawbacks at all? Elaine.

**Elaine:** Window tinting is legal on all windows except the driver and passenger door glass. Most tint shops will still do the driver and passenger glass but you take full responsibility for any tickets you may incur. I have heard a doctor can give you a prescription if you have difficulties driving in bright sunlight but I wouldn't try it unless you have a medical issue. If installed properly the radio antenna will work just fine. Drawbacks: Depending on the shade of tint you choose will depend on night vision, the other drawback is if you leave your rear window defroster on to long it will burn through the tint. I had bought a car with illegal tint on the driver and passenger window and I hated to drive it at night, I removed the tint and it made a big difference.

Following is a summary of an Ordinance adopted at the Joint Meeting of the City Council/Redevelopment Agency of the City of El Cajon on June 23, 2009. Full text is available in the City Clerk's Office, 200 East Main Street, El Cajón, California.

#### ORDINANCE NO. 4930

AN ORDINANCE REPEALING CHAPTERS 13.16, 13.20, 13.24, AND 13.28 OF THE EL CAJON MUNICIPAL CODE AND ADDING NEW CHAPTERS 13.16, 13.20, 13.24, 13.28, 13.37, AND 13.38 TO THE EL CAJON MUNICIPAL CODE RELATED TO SEWERS AND SEWAGE DISPOSAL

ordinance amends chapters of the El Cajon Municipal Code regarding the operation, maintenance, and use of the City's sanitary sewer system. The chapters being amended provide regulations for connection to the sanitary sewer system, and regulates the use of the system by the public. This ordinance is to update those regulations contained in the El Caion Municipal Code as required by the State Water Resources Control Board, San Diego Region, Order #2206-0003-DQW.

This ordinance would implement regulatory authority to accomplish the following: (1) control infiltration and connections from inflow sources, including satellite systems; (2) require that sewers and connections be properly designed and constructed: (3) ensure proper installation, testing, and inspection of new and rehabilitated sewers (such as new or rehabilitated collector sewers and new or rehabilitated service laterals): (4) limit fats, oils and greases and other debris that may cause blockages in the sewage collection system; and (5) implement the general and specific prohibitions of the national pretreatment program under 40 CFR

This ordinance would also (1) further regulate food-serving establishments to minimize the release of fats, oils and grease into the sanitary sewer and storm water runoff. (2) further restrict substances that are discharged into the sewer systems and building sewers (3) require video inspection and repair of private sewer systems and building sewers. and (4) make it a crime for the citizens of El Cajon to fail to report a sewer spill.



# Should dog go through the door last ... ask a trainer

Dear Trainer:

) friend, who thinks he knows everything about dogs, says that letting my dog go out the door before me is allowing my dog to dominate me by being her "doorwoman." My friend also tells me I should no longer play tug-a-war with my dog for the same reason, since my dog "wins" a lot when we play. I consider my dog a nice, well adjusted dog that enjoys playing tug and I just don't see her turning into some crazed dog because we play together. My dog is 2 years old and a pit bull/lab mix. She is spayed and I have had her since she was 8 weeks old. What do you think; are these myths or should I change how I treat

my dog? Signed, Myth Buster

#### Dear Myth,

Within any blanket statement about dogs, there seems to be some truth, and the two situations you bring up are both good topics to look at and discover where, exactly the truth lies. Let's look at these common concerns and a few more from a behavior standpoint so you can discover just where your own dog falls on the continuum.

# A dog that pushes through the door first is being dominant

Many dogs are allowed to go through a door before their humans and the majority of them are normal and well

adjusted dogs. However, dogs that push through the door first, slamming past people or other dogs in the process are often overly excited dogs that have not been trained to wait! Alone, this is rude behavior and is considered a training deficit, and for some dogs even bully-like behavior. For dogs that are lacking basic manners, the best solution is to teach them that waiting until released (whether the person goes out first or not) will result in rewards and keep the dog calmer and more focused overall.

#### You can never play tugof-war with a dog because it will make your dog dominant

There are a bunch of agility dog trainers, not to mention Customs and Bomb Dog

trainers that would be sorely disappointed if that were true! Playing tug with their dogs is their dog's paycheck for a job well done! It is fine to play tug-of-war with a dog that is trained to stop playing when you ask. Teaching dogs the tug-of-war rules early in their puppyhood, insures a good habit when they reach adulthood. Dogs that are allowed to escalate the play to the point of over-the-top arousal can be dangerous for dogs that have little impulse control that sometimes leads to dogs biting due to the arousal.

To learn how to play properly with your dog there are several books and DVD's that explain the process. Play with Your Dog, by Pat Miller, Play Together, Stay Together, by Patricia McConnell and Karen London, are two new titles that, among others, can be found at: <a href="https://www.dogwise.com">www.dogwise.com</a> and include fun ways to play with your dog while building a good relationship, not a confrontation.

Other behaviors that are often sited as dominance are usually very normal dog behaviors and should be considered as that. If a behavior is unwanted, training and behavior modification should be the first step to eliminating unwanted behaviors. Let's look at some of the others that are common myths:

# A dog that urinates in the house in front of the owner is trying to show his or her dominance.

A dog that urinates in the house, in front of the owner is not housetrained, has a medical condition or is suffering from undue stress and feels a need to mark. Each of these areas should be carefully looked at, and sometimes require professional help if prevention and management are not helping. Talking to your veterinarian about conducting a urinalysis is the first step to any house training issue. If that is all clear, re-house training and possibly behavior modification are the next steps.

You should never let dogs sleep in your bed or they will feel equal or higher than you in rank

You can allow dogs to sleep with you if your dog understands he/she will have to get off the bed if you ask. Training your dog, using positive reinforcement methods, will teach your dog to happily give up his space when asked. Many people create problems with their dogs by pushing or forcing them from the bed or furniture. Not only is that rude, it can make dogs defensive if they are constantly pushed around, when a simple training game that teaches them to get on and off things would be so much simpler.

You should never feed your dog before you eat, or if it is an intra-dog issue, always feed the "dominate" dog first

These are two of the silliest myths out there if you really think about what is being said

in these statements. Dogs are unable to figure out the time schedule of human meals in relationship to their meals, and it would be impossible to always feed them after you ate and have it make any sense to the dog. A good example is, if you eat lunch first, and then feed your dog, would she then think she ate first because you later have dinner? Dogs just don't think this way.

The same goes for feeding what people call their "high-ranking" dog first when there is more than one dog in the home. This is also misguided as many people identify one of their dogs as the "Alpha" dog, when in fact, many of those dogs are usually just spoiled and bossy and feeding them first supports them being rude and pushy with other dogs.

Teaching dogs to wait their

turn, no matter which dog, or human is going to eat first makes more sense to the dog and teaches polite behavior that all dogs should learn.


So there you have it; some of the more common myths dispelled. Dogs are just dogs being dogs. Plain and simple, it is our job as their companions to help them with things like understanding household boundaries and teaching them what we do want from them.
