## Bits and pieces around East County

### Three cities to provide cooperative fire services

The cities of El Cajon, La Mesa, and Lemon Grove have agreed to enter into a Joint Exercise of Powers Agreement (JPA) that will create a shared management team to coordinate fire and emergency medical services, firefighter training, fire prevention, emergency planning, and community preparedness.

Goals of the JPA are creating additional staffing capacity and containing costs, while maintaining a high level of fire and emergency medical services and preserving local control. By sharing management functions, a savings of \$560,000 is projected for the first year.

These three cities have a long history of cooperative efforts in training and dispatch facilities. This shared management approach will further improve service and flexibility by coordinating resources and

enhancing training through standardized policies, procedures, and practices.

### Exciting changes planned for The East County Performing Arts Center

Positive changes continue in the revitalization of downtown El Cajon. The agreement between the City of El Cajon and Art Beat Management for management services of the East County Performing Arts Center will terminate effective January 1, 2010. Given the difficulty in successful fundraising on behalf of Art Beat and the economic constraints of the City during this recessionary period, it has become financially impossible to continue to operate the theater.

Art Beat Management has been the theater manager since January 2006. They have brought numerous patrons to the theater and have greatly contributed to the educational enrichment of thousands of

school children in theater arts through the productions they have booked. The most popular must see event is the annual *Traditions of Christmas*. This will be the last performance at this theater until the reopening, currently anticipated in late 2011.

The City has been working on a master plan for the Civic Center area that will include substantial renovations to the theater itself. Funding for this plan will be provided by the City of El Cajon Redevelopment Agency. In addition to replacing the roof, upgrading the interior and improving handicapped access, a goal is to change the orientation of the theater so that it is accessed from Main Street. This has been a long time dream of theater patrons, the City Council and downtown merchants. In addition, the Public Safety Center is currently under construction and adjacent landscaping will be reconfigured to allow more extended use for theater events and fund raisers. It will also tie together pedestrian access

from the Promenade to the theater and on through the Civic Center to both Magnolia and Park Avenues.

Since parking in the area will be difficult during the two year construction of the Public Safety Facility, this appears to be a perfect time to make some much needed changes and renovations to greatly enhance the theater going experience in El Cajon. Once

the changes are made to the theater, the surrounding plaza and the Public Safety Center is complete, expect a Grand Opening Celebration!

### County hoping new bill will spur home solar, wind energy

Owners of home solar and wind energy systems that generate extra kilowatts can soon

turn those surplus electrons into compensation thanks to new legislation signed by the Governor this week.

Assembly Bill 920, which earned strong backing from Chairwoman Dianne Jacob and the San Diego County Board of Supervisors, allows electric utility customers who install solar or wind generation systems on their properties to

ny School (San Diego County Office of Education)

The five teachers will go on to represent San Diego County in the California Teacher of the Year program, which will be announced later this year. Nominees for San Diego County Teacher of the Year were selected by their school districts based on student achievement, teaching philosophy, familiarity with current issues in education and community involvement.

### East County Winners

Donna Farquar is an English language development teacher at the Santee Elementary School District Educational Resource Center. Farquar works toward getting her students reclassified as Fluent English Proficient students. She can be found working with the district's nine schools and students from kindergarten through 8th grade whose first language ranges from Spanish and Russian to Kurdish and Arabic. Farquar uses her own second-language learner experience she had as an adult teaching abroad in Brazil and Hong Kong to help her stu-

dents overcome their anxiety and apprehension of not being English proficient.

Mike Love has been a math teacher at Mount Miguel High School in Spring Valley for 15 years. Much of his career there has been spent preparing under-served and under-represented students for college through the AVID program. Love was instrumental in Mount Miguel becoming the first high school in the nation to have a chapter of the Student African-American Brotherhood, a naturally chartered program that promotes leadership, self-discipline and intellectual development in young men of all backgrounds. Love says that he is not just a math teacher. He is a life skills teacher, a philosopher, a psychologist, a father figure, and a stand-up comedian in his classroom because all of those roles play an important part in his ability to connect with his students.

Eric Mabrey is a 20-year teaching veteran at Olympian High School. He is an instrumental and choral music teacher in the same district where he attended school. He draws on his experiences as a student in a diverse cultural

community to connect and relate to his students. Well known in the music educational community for consistently having performing groups that score at the top during festivals and competitions, Mabrey used his musical talents to compose the alma mater and fight song for Olympian High School.

Rounding out the 10 finalists are: Jennifer Eckle, Vista Magnet Middle School (Vista Unified School District); Bill Freeman, Walter J Porter Elementary (San Diego Unified School District); Arlene Gapusan, Black Mountain Middle School (Poway Unified School District); Yvonne Fojtasek, San Elijo Elementary School (San Marcos Unified School District); and Diana Souther, Valley Center Primary School (Valley Center-Pauma Unified School District).





be paid by their electric utility for the surplus electricity they produce.

"The Governor is to be commended for giving green-minded San Diegans a fair return on their investment," said Chairwoman Jacob, who brought the matter to the Board of Supervisors in November 2008. "The utilities have been allowed to profit from the investments of home solar and wind customers for long enough," she said.

In the past, for generation systems of up to one megawatt, the surplus was carried forward on a customer's bill for 12 months. Any yearly excess went to the utility. Jacob said California's new legislation has the potential to drive many more homeowners to invest in home solar and home wind.

"If you couple the benefits of AB 920 with the County efforts to roll out a program to help San Diegans afford the upfront costs of home solar and wind systems, you've got all the ingredients necessary for a residential renewable boom," said Chairwoman Jacob. "The benefits of that boom will be

far-reaching. We can clean the air, create jobs, stimulate the economy and lessen the nation's dependence on imported fossil fuels," she said.

Colorado, Connecticut, Maryland, New Jersey, Min-

nesota and many other states compensate residential PV customers for surplus power. In Oregon, credit from some surplus solar is granted to customers enrolled in the state's low income assistance programs

## Computer sense saves cents: Episode 1 Attack of the Dust Demons-

This new article will take you into problems that face PCs every day that can make for poor performance. One may tell themselves "My PC seemed to be so fast when I bought it. Now I can't get it to do anything that it used to do." These are the all too familiar words that most of us have said at least once throughout our computing history. My hope for this article is to help people embrace these problems and find what is plaguing their computer. I will start with the most basic of issues and work my way up to more advanced over the next few months.

The most basic but of upmost importance with problematic computers is dust. Over a few months, sometimes days depending on where one lives, dust and pet dander is blown into the computer and will cake itself around computer components and cooling fans. Enough dust build up will clog the fans which limit or stop the intake of air causing the PC to overheat. Which in turn will cause crashes, very slow performance and eventually short circuit the components (Motherboard, Video Card, ECT). To prevent these costly issues it's recommended to keep the PC where air can flow freely, by making sure not to place anything on the sides or back of your computer and to let the fans do their work by removing the hot air from inside the computer. Next is to buy a can of compressed air (\$5-\$10) and to blow out any fans that may be on ones computer. Also to make sure to blow out the power supply fan which should be on the back of your pc, directly next to the power plug. Don't be afraid to remove the side panel of your PC and blow out all components inside. Just try not to touch the components with the nozzle or hands as to avoid static discharge. Hold a metal part of the PC case while blowing out just to make sure. Make sure to do this in an open space where dust can flow away from ones face as it is surprising how much dirt, pet hair and dander can blow out. Do this every few weeks to insure that the computer stays clean and to avoid possible costly repairs.





## 2010 Aston Martin DBS Volante

Aston Martin, talk about heritage in racing and just driving. I had the privilege to slip behind the wheel of a 2010 Aston Martin DBS Volante. This V12 is pumping out 510 horsepower backed by a six speed paddle shifting transmission that when the driver blipped the down shifting paddle (located on the left side of the leather wrapped steering wheel) he/she gets a high rev sound not unlike a Formula One race car, but it will make the hair stand up on one's arm (that's if one has racing oil in their veins).

Of course the first thing noticed is the styling when one walks up to the DBS. One look and buyers would think it was doing 200 miles per hour just sitting there, low sleek and ready to romp.

To start the Aston the driver slips a crystal key fob in the center of the well appointed dash, push a little harder, two clicks to be exact and the starter grabs the flywheel and gives it a massive tug and the 5.9-liter V12 wakes up with a growl. Next release the hand brake located on the left side of the driver seat. Note: check the hand brake light on the dash before leaving. The way Aston Martin

designed the hand brake system is once the handle is lifted and engaged it drops freely along side the driver seat. If one just jumps in, starts the car, drops it into gear the V12 will destroy the emergency brake system and I would imagine within a few miles and minutes.

Now that the Aston is purring at idle waiting for the driver to take it out for a spin there are a row of buttons on either side of the key fob in the enter of the dash, P for park, N for neutral and D for drive. If the driver is not interested in paddle shifting just push the D button and Aston will do the rest. Now if one is cruising down the freeway and wants to check out the paddle shifter, just either up shift or down shift and the paddles system cancels out the D mode and off one goes!

The Volante is a convertible model with a very smooth acting top, but if anyone looks at the colored pictures on my website [www.davestall.com](http://www.davestall.com) lookers will see that the body is painted Lighting Silver and the top is red with Chancellor

Red leather interior. Aston is a four seater, but forget about the back seats they will be good for storage or very small kids.

The Aston is really all about driving, yes it has all the safety gear one would want, but driving is what it is really all about with rear wheel drive, 3.46:1 rear gear ratio, and 4-wheel ventilated brakes with Carbon Ceramic disc brakes, ABS, Adaptive Damping System, Electronic Brake Force Damping, Dynamic Stability Control and Traction Control. Speaking of brakes, this Aston really stops on a dime, I mean really stops!

One of my favorite parts of the car is the sound system and hey how could one go wrong with a Bang & Olufsen BeoSound DBS Audio System with trip computer, top up or down and the sound system rocks! Oh and one of the photo's shown at my website shows a little round unit on top of the right side of the dash, that is a speaker that rises from the dash when the sound system is engaged, cool!

Aston had a rule no more than 200 miles could be put on the car during its visit to a journalist. I forgot to set the trip meter, but so far no phone calls, this car just likes to run. This car is not insane horsepower, but it is more like power on demand and when applied it is controllable and will give you a sense of accomplishment, funny but true.

Now the price of the car could buy you a real nice house in San Diego, just under \$300,000, but if you add tax and license your up over \$300,000 so who buys this car and why? Once you drive it you will understand why you would pay the price and

if you had that kind of money why not, just look at this car.

Downsides, yes there are major downsides to the Aston; the front lip is about 2 inches off the ground, Ouch! The 10 spoke Diamond Turned Graphite rims are mounted on low profile tires which make these really cool rims exposed to curbs and pot holes not to mention the tires. Fuel mileage is OK, 12 mpg in the city and 18 on the open road running on Premium gas.

Very few get a chance to drive an Aston Martin, but the lucky few who do will have a big grin on their face, trust me!

# For Health's Sake

## Summer end — begin healthy habits

When sizzling summer temperatures start mellowing into cooler autumn days and back-to-school bells command attention, a new season of adventure and learning begins. A fresh start can also dawn for a

healthy lifestyle through TOPS Club, Inc. (Take Off Pounds Sensibly).

Many times, a renewed commitment to an exercise routine and weight-loss program is bolstered by encour-

agement. As summer begins to give way to fall, TOPS experts provide guidance to boost back-to-program resolve.

Amy Goldwater, M.S., educator, former body-building champion, and physical fitness expert for TOPS, offers advice to get exercisers motivated as brisk days provide a comfortable outdoor environment. She points out that TOPS has long promoted walking as a way to get in shape and has encouraged the use of pedometers to help walkers track their progress.

Goldwater suggests that, using a pedometer, walkers are motivated by being able to see their progress right away, and that helps encourage them to not only stay committed, but to go further, too. "The pedometer can help people set goals and gives them instant feedback about how they're doing in reaching those goals," she adds.

Goldwater teaches that walking three times per week is a good goal for beginners. Follow a schedule that eventually leads to walking 30 minutes per day most days of the week at a pace of about 3.5 miles an hour, she advises.

### Strategies for Change

Patricia M. Amborn, M.S.M., educator and wellness author and expert for TOPS, offers some suggestions on attaining goals. "I think sometimes we fail because we think we have to wait for the right person to come into our life at the right time to inspire us, but it's really a lot of little steps," she says.

Amborn outlines a four-step process to effect change. She starts with George Bernard Shaw's quote, "Life is not about finding yourself. Life is about creating yourself." She advises keeping in mind that each of us creates his or her own self.

Her second point is that self-improvement is a personal choice. Whether good habits or bad habits prevail, it's a choice. "Remembering this prevents excuses," Amborn notes. "It puts the onus back on the person because it's his or her choice to change or not."

Amborn believes that no one actually has to be motivated in order to get moving. "You can start something, and you'll become motivated," she

says. She gives the example of someone who knows he or she should get outside and go for a walk, but can't find the willpower to do it. If that person simply puts on sneakers and starts putting one foot in front of the other, the action will create the resulting motivation to do it.

She also says that everyone needs to practice self-reflection in order to set goals. "How do you know what to move toward if you don't know what's important to you?" Amborn asks. "September, when school starts, could be a time to learn more about ourselves."

### Self-Work Tools

To promote self-reflection, Amborn suggests the following methods:

- Use self-talk with affirmations such as, "I can achieve this." Negative self-talk is a defeating drain on energy.

- Positive thinking is another tool. "We would be surprised to find how often we sabotage ourselves with negative thinking," she observes. "An example is: 'I'm too overweight already so why bother?' We often pick on ourselves. Recognize it for what it is and tell yourself to stop."

- "Create a vision board; cut out pictures from magazines of how you'd like to look and keep them in a prominent spot to view. Have some fun with it. You could also journal to record your dreams and success stories, along with failures, because you learn from failures," Amborn adds.

With practice, the self-work tools get easier. "It can be hard to master some of these techniques but, once you do, it's powerful," Amborn says.

Along the way, she emphasizes, practice patience. Visualize enjoying a life that is newly created. "Practice stopping the negative self-talk; use the other tools, and be patient," she advises. "Start and end with self-love. Starting with that will help you create the life you desire in the first place. And, end with self-love, because you are worth it."

# Our Best Friends

## Exercise and rest, how much for my dog... ask a trainer

**Dear Trainer,**  
**M**y dog is really hyper and never seems to relax. I exercise her at least three times a day and take her to the dog park 2-3 times a week to help her burn off energy. She is a spayed shepherd mix and is about 2 years old. I have had her for a year now, and nothing I do seems to slow her down. I'm going crazy trying to keep up with her. Do you have some suggestions?

**Dear Overdone,**

Of course dogs need exercise, just like we do to maintain and condition our bodies. It's the type and amount of exercise that becomes the question. Since my focus is about dogs that have a difficult time relaxing and those that drive their owners crazy with their "busy work," day in and day out, I tend to look at exercise a little differently.

My first question is how much rest and sleep is your dog getting each day? The authors of the book *Stress in Dogs* found that the most well-adjusted dogs were those that were getting at least 17 or more hours of rest and sleep each day. When we consider how short a life span our dogs have, it really makes sense that they require a lot of recovery time from just everyday activities. So if your dog is not getting that kind of rest and sleep, you need

to consider something different in her life.

When dogs, like kids, don't get the recovery time their bodies need, there is a likelihood that they may be more cranky, more irrational and not as cognitive as need be for working on behavior issues, and in fact, not getting enough down time might have created many of the issues in the first place. This study points to the fact that, at least in mice, they are dummed down by too much exercise, and by withholding that same exercise for a short time, they return to normal. There have also been some recent studies down on humans that pointed to the same conclusion, and dogs as we know them, are not good at dissipating heat and so risk overheating and adding to stressors that can be linked to over-exercised bodies.

Another concern is that you might be training your dogs to become out of control because every time she acts bored and becomes annoying or destructive, you find ways to exercise. It doesn't take long for a dog to figure out that her annoying behaviors results in fun activities with you. I worked with a dog that was given up to the shelter where I worked at the time because she was too active. She was a young (1-2 years) chocolate lab that never seemed to slow down. She was beautiful and was adopted

quickly and we didn't spend much time with her. Well, she was back about a month later with the same complaint—too active. In fact the adopters gave up on ways to exercise her to "get her energy out," when having her job along side their jeep didn't work!

She was so stressed when she came back and there was some real concern about her health. She was overly muscled (a sign of stress in the body), too thin and didn't seem connected to humans at all. This was a frantic dog that could no longer think about anything other than running and that is a very sad state for a dog. We worked on everything calm for her and she had to earn short sessions of ball playing, via focus and attention work, such as the Relax on a Mat and Auto Eye Contact that are in my book *Chill Out Fido* ([www.dogwise.com](http://www.dogwise.com)). She slowly came back around to being a normal dog (normal for a young lab) and was adopted to her forever home after a few weeks of the calmness work.

Second, the risk of taking a dog for an infrequent run, playing an intermittent game of fetch, visiting a dog park occasionally, or injuring a dog that is less than a year old and still developing bone and muscle, all have the potential to stress a dog's body with these types of infrequent, but high-energy activities. Stay within a dog's normal limits or beginning a more rigorous exercise program that slowly builds endurance and muscle,

is the only way to increase the intensity of exercise for a dog, or a human.

Also, it has been found that domesticated dogs living in the wild or natural states without humans, exercise much less than most would imagine, and it's not hard to envision how it wouldn't serve those dogs to run, play or fight, (such as we see in our pet dogs), for fear of burning precious reserves of energy, or becoming injured. Survival and safety are the first order of importance for dogs living in their natural habitats, just as it is on some level for our dogs.

The dog that shares your home is still a canine with many of the same natural drives as their untamed counterparts, and it is those genetic components that hold the answers in terms of how much exercise is

really needed for the dog living with you.

The balance that many experts are trying to find with exercise includes a good deal of mental exercise and leads right back to the information in the *Stress in Dogs* book about rest and sleep. Dogs that use their minds a good portion of the day doing things like chewing on bones, working on Kongs or other food puzzles, training with their owner, are dogs that get that balance and as such, need much less intense physical exercise to help them be more quiet and less problematic. I believe when this balance is met, it serves to satisfy some deep innate behaviors that we see in wild dogs, such as hunting for small prey, and scavenging for food. Many of my clients now feed their dogs from Kongs, paper bags, or boxes, have them scavenge

the grass for their kibble, or train with their meals to help satisfy that need to forage and look for their meals. (Be sure you are feeding a high end diet that is low or no carbohydrates, and without corn, wheat or soy products.)

I also find that dogs that are engaged in high level physical activities every time they leave the house, in order to "tire them out," often miss just enjoying "smelling the pee on the roses," as someone recently stated. Dogs have those finely turned snouts and it's a sad waste if they never get the opportunity to enjoy exploring the world with their noses because they are moving all the time. At the very least, exploring scent games for dogs can help them in that area.

So, when looking at exercise, look for balance!
