# County set to break ground on new library

hovels were poised for the groundbreaking of the newest branch of the San Diego County Library in the East County community of Ramona on Monday, Nov. 16 at 1349 Main Street.

When completed, the 20,894 square-foot building will be more than four times larger than the existing library on Montecito Road and is the cornerstone of a larger inter-

generational campus planned for the site.

Chairwoman Dianne Jacob, who represents Ramona on the Board of Supervisors, said construction would not have been possible without tremendous support from the people of Ramona.

"The Friends of the Ramona Library and all of Ramona are about to watch their library dreams rise before their eyes," Chairwoman Jacob said. "The library is blazing new trails because it will be the centerpiece for the future intergenerational campus," Jacob said.

"This project shatters the myth that libraries are quiet places for books," said Library Director Jose Aponte. "It will be a true community gathering place, alive with people, ideas and multimedia," Aponte said.

The \$11.6 million library is being funded mostly by the County with more than \$1 million coming from the Friends of the Ramona Library for fixtures and furniture.

The building's architecture is Southwest Tuscan-style and includes a spacious community room, study rooms, a space for teens, a larger children's area with a homework center, public computers and a Friends of the Library bookstore.

The project will meet LEED Gold criteria and include water-efficient landscaping, water-conserving fixtures, photovoltaic panels and parking spaces for fuel-efficient vehicles.

The project's design-build team is C.W. Driver, Ferguson Pape Baldwin Architects and Manuel Oncina Architects.

The library is targeted to

open December 2010. The larger, intergenerational campus will eventually include a senior center, childcare and teen facilities. The campus will connect to the Santa Maria Greenway Park.

Library services will continue in the current facility at 1406 Montecito Rd until the new branch opens.


### **Holiday Car Show**



### Computer sense saves cents: Chapter 6 PC buying guide

Purchasing a new computer can be stressful; especially to those unfamiliar with PC hardware. Between brand names such as Dell, Gateway, HP, Acer, Sony and retailers offering big sales items such as Bestbuy, Office Depot, Fry's Electronics and Walmart (to name a few), its difficult to pick the right PC and which location would have the best deals. After years of experience I have learned a few tips that should help relieve some of the headaches.

I would avoid buying a computer from stores that don't dedicate its own portion of the store to PC's and accessories. I've found the stores that do this have a more knowledgeable staff and offer excellent assistant that help make solid decisions.

Always buy a PC from a location that has its own warranty system. I've found Best Buy one of the best for quick service. If any problems arise on setup or while using the computer, the user can take the PC back to the purchasing location to get it diagnosed and fixed free of charge instead of sending the PC back to the manufacturer – which can take weeks if not months and cost the user shipping charges and possible damage fees. I recommend always going for the longer warranty. It doesn't cost that much more for an added six months up to two years of parts and service.

For anyone who uses a PC for standard features such as Internet browsing, word processing, or general office tasks, it's not necessary to spend \$700-\$1000 for a new PC. For less than \$400 it's easy to find a PC that has more than enough speed, space and features to fit users' computing habits. Just make sure that the PC has at least 1.5 gigabytes of ram and a dual-core CPU. For the more advanced users who want to do graphic editing, studio recording, play video games or use system heavy programs, I suggest a PC that has four to eight gigabytes of ram, a quad core CPU and a PCI-E video card. A PCI-E video card will reduce the load on the CPU and ram when graphic heavy applications are running (PC games, graphic studio software etc).

# Counting (and eating) your blessings

uring the month of November, many families are eagerly awaiting what is perhaps the most anticipated meal of the year. If you're the parent of a toddler, your thoughts of Thanksgiving dinner might be very similar to how the Pilgrims and Indians felt as they shared their favorite foods with each other. Not only was the first Thanksgiving a lesson in friendship, it was a lesson in food preparation and new tastes. As these worlds merged together 'round the table, there were probably a few picky little Pilgrim or Indian dinner guests who had to taste something new that day. It was a learning opportunity on both sides, as will be serving up new foods to your little Pilgrim this Thanksgiving.

As a parent, of course you know there are so many things to be thankful for at Thanksgiving. One thing that parents—of picky eaters especially—should count as a blessing is the opportunity that this meal presents to festively share new foods with children. While Thanksgiving dinner is great for helping your child experience the foods of fall, remember that these foods

are meant to be experienced throughout the season and be thankful for that.

"As a nutritionist, I am thankful for the bounty of healthy foods the fall season brings and for the opportunity to share how they can be prepared and enjoyed with my family and others," says Christina Schmidt, M.S., Nutritionist and Author of The Toddler Bistro: Child-Approved Recipes and Expert Nutrition Advice for the Toddler Years (Bull Publishing Company, 2009, ISBN: 978-1-933503-19-6, \$16.95). "The traditional Thanksgiving meal is really quite nutritious, and the occasion offers a wonderful opportunity to introduce new foods to your toddler."

The opportunities to share nutritional lessons with your child really are bountiful this time of year. Let her know that she can be a great helper in the food preparation process. She can help you pick a healthy recipe, shop for ingredients, and even play a role in cooking that winning dish. Helping your little chef identify with her own special role in the holiday meal preparation can really go a long way in your quest to

make her a healthy eater. This will increase her awareness and comfort level with new foods, and as an added bonus, she'll be more inclined to eat some of the meal that she helped prepare too!.

As you're reveling in the festivities of fall, remember that this season is loaded with so many fantastic, tasty, and healthy foods that you can be introducing to your toddler. "These foods store a rich supply of vitamins, minerals, and phytonutrients that fortify and support our body health," adds Schmidt. "They will also help expand her list of favorite dishes—and hopefully move some of those food items that tend to be on heavy rotation (can you say chicken nuggets?) further down that list."

Looking for a little more help in the kitchen this Thanksgiving? Here's a Turkey Day dining guide and a list of kitchen tasks to tempt your toddler into adopting some new food favorites. Many of these can be prepared ahead of time to avoid tiring out your little helper.

**Appetizers** (Serve these with some fun fall cocktail napkins. Even the table decorations encourage trying different foods.)

Sliced hard boiled eggs: Your toddler can help arrange them on the trav.

Raw veggie bites with hummus and yogurt dips: Let your toddler create a dip with yogurt, a little honey, or vanilla spice.

Cheese, olives, and whole grain cracker tray: Include

some black olives for some holiday finger food fun. (Not too many! These are high in sodium.)

Soup: Butternut, sweet potato, or pumpkin soups are winners! Use milk instead of cream and low sodium broth. Have your toddler help spoon soup into mugs and his own special cup. (Make sure it has cooled first.)

### Sides

Cranberry relish: This dish is loaded with antioxidant power and was designed with toddlers in mind. They can measure cranberries and help grind and taste. Grind or mix in a food processor 2 cups fresh cranberries with 2 small oranges (rind and all) and ½ cup sugar or to taste.

Jell-O salad: Abandon the sugary-sweet ambrosia salad for a Jell-O mold with fresh fruits or avocado whipped with light cream cheese.

Gravy: Throw in some ice cubes to separate the fat from the juice and skim the fat off the top. Older children who are cautious around hot burners can stir the gravy while it thickens

Sautéed veggies: Try carrot "coins" with ginger and honey, snow peas, sliced turnips with maple syrup and raisins, or green beans. Your toddler can design the veggies into fun shapes, such as trees, stars, and faces on the serving plate.

Whipped sweet potatoes: Whip steamed sweet potatoes with some plain yogurt.

Potato parsnip mash: Your toddler will love the "white carrot."

### Main course

Turkey, Tofurky or your meat of choice. Your toddler can help out by telling you when the timer goes off for basting or baking.

Stuffing: Forgo the packaged breadcrumbs and have your toddler tear up small pieces of dry, whole grain bread into a big bowl for stuffing mix. This is a great activity while watching the floats and balloons in the Macy's Thanksgiving Day Parade. Sneak in some extra veggies and fruit by mixing in some chopped sautéed celery, onion, parsnips, apples, raisins, kale or chard before baking or stuffing.

**Dessert** (These choices are low in fat and contain natural sweetness, so not much sugar is needed. They are also loaded with vitamins!)

Pumpkin Pie: Use fresh pumpkin or canned, organic pumpkin, skim evaporated milk, and brown sugar. You can make a custard-style, crust-less pie too; just bake the filling in a nonstick or oiled pie pan. Have your toddler help you scoop a little frozen vanilla yogurt, ice cream, or soy dessert for some à la mode action!

Fruit crisps: Try a pear or apple crisp with some cranberries thrown in and have your toddler help sprinkle on the crumble topping. (Watch that they don't eat it all!)

Sliced pomegranate halves: Make sure to have plenty of napkins to pick out edible seeds from these fun, polyphenol-packed, finger-staining fruits.

"Whether or not your toddler gobbles down every bite of each lovingly composed dish this Thanksgiving," concludes Schmidt, "by allowing her to take part in the preparation of your Thanksgiving dinner, you have nonetheless done your best as a parent by exposing her to new foods, cooking in the kitchen, and in sharing a family meal with her." Research shows that when children help out in the kitchen, try new foods, and get to experience meals with their families, they are likely to have healthy eating habits throughout life. Now that's something to be very thankful for.

# 'The Blind Side' — is engaging and heartwarming

eel good movies are ■ making their way into the theaters, and The Blind Side definitely fits the category. Based on the book The Blind Side: Evolution of a Game by Michael Lewis, the story of a homeless man taken in by an affluent family is the life changing event that tuned Michael Oher into an All-American football star.

Leigh Ann Tuohy (Sandra Bullock) is a lively Memphis socialite who has her and her family member's lives under control. Leigh Ann is a successful interior decorator, and the family owns a fast-food restaurant chain run by her husband, Sean (Tim McGraw). Naturally, the Tuohy kids, Collins (Lily Collins) and S.J. (Jae Head), want for nothing, but they're studious kids who have learned some valuable lessons from their parents – mainly not to discriminate.

As the Tuohys are driving one evening in the pouring rain. Leigh Ann tells Sean to stop the car when she notices a big African American man walking in the freezing rain without a coat. The kids tell her Michael (Quinton Aaron) goes to their school, but hardly talks. She insists on taking Michael home for the evening and letting him sleep on the couch. When Sean checks into how this uneducated boy got into a private school, he learns Coach Cotton (Ray McKinnon) saw Michael's skills with a basketball and hoped to use him on their ailing football team.

Michael is soon accepted with open arms as one the Tuohy family members, even getting his own bed which he has never had. Each Tuohy has his own amazing hand in Michael's new life. Leigh Ann tries to find out about his real situation; Collins sticking up for him at school when others make fun of him, and Sean making sure he remains current with school requirements. The biggest outreach, and one of the funnier scenes in the movie is when S. J., about one fourth of Michael's size, becomes his football coach helping him to workout, timing his play speeds and pushing him to excel. Leigh Ann hires Mrs. Boswell (Kathy Bates) to tutor Michael so they can get him into a college on a football scholarship.

John Lee Hancock (The Rookie), directs and wrote the heart-warming screenplay. Michael Oher's real life story is amazing, but it still takes skill to turn it into a compelling movie that's not too sappy. Hancock delivers on that point with no problem and is aided by a

Quinton Aaron carries his first lead role well. Even though he has little dialogue, his character is very emotional, and Aaron has no problem making us believe Michael's ups and downs. Bullock is in full form as the dominate but likeable Leigh Ann. We cringed at Bullock's role in All About Steve, and sighed at The Proposal. he Kia automotive manufacturers may be on a winning streak. First, the Kia Soul, now the Kia Forte Koup, is my test vehicle this week. Being a big fan of two door coupes I was pleased to see Kia looking to the past to forge to the future. Yes getting into the backseat of a coupe can be a pain, but the styling is everything. Just look at the Kia Forte 4-door sedan sitting next to the Koup. I know most folks. prefer the four door which is more practical, but the Koup is outstanding.

The second thing I notice when I slipped behind the steering wheel was the audio and cruise control right at the driver's finger tips. That's a nice touch for a car that costs less than \$20,000. The seats are sporty and very comfortable with manual controls for the seat. The instrumentation has a sports feel to it, and is very informative without a lot of confusion. The center console has two storage compartments, satellite radio, a CD player and plug-in for all the new techno gear that is out there. The back seat was surprisingly comfortable even though it took this old coot awhile to get back.

Performance was the third thing I noticed when I stepped on the gas pedal thanks to the peppy little 2.0-liter 4-cylinder, 16-valve dual overhead camshafts. The constant variable valve timing engine backed by a four speed automatic transmission gives plenty of power with 25 miles per gallon in the city and 34 on the open road with a potential of getting into the 40s. They do offer a 6-speed manual transmission which readers know would be my choice.

This is a great first car for the kids; it's safe, stylish, has good fuel mileage and a warranty that can't be beat - 10 year 100,000

a five year 60,000 mile bumper to bumper warranty. Opt for the Kia Extended warranty and the car is completely covered bumper to bumper for 100,000 miles all for under \$20,000. Hard to beat that deal.

This car is built for fun with sport suspension and great outside styling with black accented grill, body colored door handles, rear diffuser (so it cuts through the air for maximum fuel mileage and stability at high speeds). The chrome dual exhaust instead of the 2.5 mile per hour bumpers has increased that impact number up five miles per hour. As far as safety, as of this printing the NHTSA

has not posted the frontal and side impact numbers but it is for sale so it has met the basic standards of safety.

Safety is a main concern of Kia, and this car comes standard with the following safety items, anti lock brakes at all four corners, brake assist, electronic brake force distribution. electronic stability control, and traction control. Inside safety comes with front airbags, front seat mounted side airbags, full length side curtain airbags, front active headrests, tire pressure monitoring system.

Being a Koup, the back seat folds down at a 60/40 split to add to the storage needed from

# Chargers roar

laying solid defense, displaying a few surprises on offense (wild-frog formation) and good special teams play, the Bolts outscored and limited the high-flying Donovan McNabb led Eagle offense not on the stat sheet, but on the scoreboard in the end when it counted.

Chargers quarterback Philip Rivers started the scoring first, finding fullback Mike Tolbert over the middle for a touchdown (his first of the season) giving San Diego a 7-0 lead.

The Chargers scored again this time in the second quarter. This 82-yard drive culminated with LaDainian Tomlinson scoring his first touchdown of the day, setup by a Rivers to Malcolm Floyd pass to the 3yard line, giving the Chargers a 14-0 lead.

The Eagles were held to two Aker field goals (18, 25) before the half. Both teams went to the locker room with the Chargers on top 14-6.

Picking up where they left off, San Diego's L.T. scored his second touchdown of the day, this on an explosive 20yard run midway through the third quarter. Sandwiched in between another Chargers touchdown was an Aker field goal (25-yards). Following that field goal Philip Rivers connected with Legedu Naanee on a 20-yard touchdown pass, (also his first of the season.)

Going into the fourth quar-

ter with a commanding 28-9 lead, it appeared the Chargers would coast to victory. That was not to be.

Philadelphia quarterback Donovan McNabb was not finished. Going into the final stanza McNabb already with 329-yards passing, threw two touchdown passes in the fourth quarter to get the Eagles to within five points at 28-23 San Diego

Putting together an important 12-play, 66-yard time consuming drive. Chargers kicker Nate Kaeding converted on a 29-yard field goal to make the score 31-23, with just 30 ticks remaining on the game clock.

McNabb drove his Eagles to the San Diego 34-yard line with the game ending with an Antonio Cromartie interception (his team leading third INT of the season).

Living legend and future Hall-of-Fame running back LaDainian Tomlinson finished the day just shy of 100-yards rushing (96) moving him into 12th place in the NFL's alltime rushing list (12,145) past Thurman Thomas and Franco Harris. L.T. is now only 98yards behind the great local Lincoln High alumnus Marcus Allen (12,243).

LaDainian also took sole possession of third place in the NFL's all-time touchdown list with 146.

"He breaks off the run in the red-zone. It's a 20-yard run. He looked explosive. He

hit a crease. He was patient. He did the things he does. I think he's getting into a good rhythm, and we're getting into a better rhythm blocking for him, commented the Chargers Head Coach.

After the game at the Chargers podium LaDainian Tomlinson happily revealed to the media the recent pregnancy of his wife. He was quoted saying, "God works in mysterious ways. It's a special thing about having a child."

Norv Turner has this to say about the Tomlinson's' pregnancy, "I don't know who was aware. I was aware. L.T. was emotional when he found out. I went over about 15 or 20 minutes later and told him. This is going to be a special day."

Quarterback Philip Rivers once again at the top of his game completed 20-of-25 passes in the game for a career high 80% completion ratio, and no interceptions. He also finished the day with a season high passer rating of 131.8.

Antonio Gates was his favorite receiver in the game catching a team-leading 7 passes, 4 of them in the first quarter.

This win also should be credited to the Chargers defense. With two sacks in the game by Brandon Siler and Paul Oliver, the Bolts 'D' held the Eagles to three field goals after Philly had first and goal on each possession. Although giving up 450-yards passing to McNabb, the Chargers kept the Eagles out of the end-zone on those three critical drives.

Also credit the Chargers coaching staff. Chargers skipper Norv Turner out coached the Eagles Andy Reid.

"I think this is the most complete game we played as a team," summarized Head Coach Norv Turner.

"Offensively we got done what we needed to get done. We protected Philip. He was

"Defensively, I was very pleased with what we did. They were able to get a lot of vards, but their style of offense is based on getting the ball up the field. I thought we contained that pretty well."

Regarding the Chargers running game he said, "I like the mix. I think we were 50/50run-pass. I liked getting the explosive plays. I thought we gave L.T. a chance to get going. I thought Philip did a good job getting us in and out of the best plays.

"In a game like that when you get 27 rushes and end up with 120-yards I thought that was good."

This coming Sunday, the season is on the line for both teams. This is a must win game for both franchises. The winner will sit alone on top of the AFC West. The Chargers are looking to exact revenge for their earlier home loss to Denver. This could get ugly, but a win is a win. A loss would be devastating. Kickoff time is slated for 1:15 p.m.







# Bicycle rider wants dog safety tips... ask a trainer

Dear Trainer

"m a bike rider and have had some close encounters with loose dogs and was wondering how to handle these scary surprises? Luckily, the owners of the dogs have been around and were able to get their dogs before the dogs got me, but I'm afraid that might not be the case in the future. Do you have any ideas or suggestions about what to do if I come across dogs that want to chase me? I would rather not do anything that provokes or injures a dog since it seems to me that might things worse.

### Dear Wheeling,

Thank you for the great question and I'm so happy that you are looking for ways to solve this problem without violence. You are correct that confronting a dog might make matters worse, since a dog that is chasing something is a pretty aroused animal and capable of much more damage to a human in that heightened state.

### What you can do

Always carry a cell phone

with your local Animal Control's number stored. A cell phone is also important if you need emergency help. Loose dogs, no matter what the intention of people allowing their dogs to roam, are illegal unless the dog is in a designated offleash area. It's important to report loose dogs, since dogs on the run are not only a danger to the likes of people, but are also in danger of being hit by cars, teased by kids, or attacked by covotes in those areas where wild canines thrive. Try to get a photo or video if you have time (of course be safe) so you have a record of the dog in case Animal Control is unable to get to the area right away.

Next try to avoid any loose dog, whether you think he/she is friendly or not. Change directions, take a wide birth, and don't make eye contact. Try not to move too quickly as this can cause the dog to chase and build up more adrenaline.

Carry protection, but do so with caution. Using products such as "Direct Stop" can buy you a short time to get away from a roaming dog, but you will need to be within the range

of about 10-feet to spay the product at the dog's face. If the dog is not in a completely aroused state of mind, these products can work well, but they can also backfire if the dog is not "thinking" clearly and can often make matters worse.

A can of club soda also can work. Shake it and throw it as a way to startle the dog. When you shake the can, the carbonation should get the contents flowing hard enough to spay out, thereby causing the dog to take his/her attention from you and allowing you to move away. This won't buy you a lot of time, but sometimes just a little can be helpful.

There is another product called Pet Corrector that "hisses" and shoots out a strong spray of compressed air. In their advertising, they show a person on a bicycle using the spray on a chasing dog. This product is sold at many outlets. Please note however, that we don't recommend this product for many of the suggested things like aggression, place avoidance or barking.

Another idea is to carry a collapsible umbrella with you. Most Southern California dogs are not used to seeing open umbrellas, so if a dog approaches you, you can pop open the umbrella in the direction of the dog. Not only can this startle the dog, but also gives you something to use to protect yourself if needed. It's far better to have a stray dog take the umbrella in his/her mouth rather than your body parts. One trainer I know painted a really scary face on her open umbrella, so if she has to pop it open, there are big eyes, and a full set of teeth showing, which might be enough to cause the dog

Carry food treats with you. You can always throw food at the on-coming dog to get

his/her attention, but you will need to throw a lot to keep the dog searching rather than following you as a good food resource. I have tossed my treat bag full of treats toward a dog that was moving too fast for my comfort. I lost a treat bag, but the dog forgot about me when he got a whiff of the cut up turkey in my bag. The downfall is that you might reinforce the dog for chasing people on bikes, but if you report the dog and then avoid the area, your local Animal Control should take action if you are able to identify the dog and the dog isn't likely to put two and two together—people on bikes throw treats when I chase them.

The other risk with loose dogs is falling from your bike and becoming injured, so do

always wear your safety equipment to minimize this risk.

Finally, your bicycle can be a form or protection if a dog gets really close to you—get off of your bike and use it to block the dog from getting to you.

Overall, loose dogs are a problem and not only are bike riders at risk, but children, and others that might be accosted by them. Most dogs are friendly, but that should never be assumed, and aside from the above suggestions, reporting the offenders is the best way to avoid what might result in a tragedy for you or others.




