San Diego's 'Best Moms' honored

Three local students earned the prize for Top Essays through this year's San Diego's 50 Best Moms essay contest hosted by Time Warner Cable. The contest, now in its eighth year, asks students in grades four through 12 a very simple question: "Why do you think your mom is one of San Diego's 50 Best?" More than 3,000 entries were received from San Diego County students, but only 50 rose to the top. These finalists, and their Best Moms, were invited to a luncheon on Saturday, May 9 at the Hyatt La Jolla at Aventine. More than 200 people attended.

Santee resident Jesse Vargas received top prize for the high school category. Vargas is in the eleventh grade and attends Santana High School.

Journalists, politicians and teachers evaluated each essay. These students received a new Sony VAIO laptop computer. In addition, the winning students' teachers will also each receive a \$250 gift card for supplies for their classrooms, plus a \$50 gift card to Anthony's for a well-deserved night out. The Best Mom finalists each received their time in the spotlight, walking down a red carpet as an excerpt from the essay was read. The Best Moms also each received an en-

Cox Conserves Heroes awards \$17,000 to environmental heroes

Thanks to San Diegans' 3,457 online votes, the first, second- and third-place youth and adult winners of the Cox Conserves Heroes awards program were selected. In February, Cox Communications and The Trust for Public Land, launched the Cox Conserves Heroes program and solicited input from the public to nominate their favorite volunteer environmental heroes who continue to make great strides in ensuring a greener tomorrow. Ninety-eight nominations were received.

Sponsored by Think Blue San Diego and Stand for Less, the Heroes program featured an online nomination process for the public to identify San

Diego's everyday conservationists. A judging panel from The Trust for Public Land, the San Diego Foundation and Think Blue San Diego selected the three youth and three adult finalists from thousands of votes and profiled them on San Diego Insider Magazine on Channel 4 San Diego.

At a ceremony last week Cox Conserves Heroes in each category received \$5,000 to donate to their favorite environmental non-profit organization. First- and second-place finalists in each category received \$2,500 and \$1,000, respectively, for the environmental non-profit of their choice. All finalists will be recognized on the field at the Padres game on August 22, 2009.

Cox Conserves Heroes:
\$5,000 – (Youth) Sonya Vargas was one of two youths who served on the steering committee for the Wetland Avengers/ Campeones de los Canones, a community-based habitat education and restoration event. Her strong leadership and communication skills mobilized and inspired more than 950 volunteers to participate in planting 2,500 native plants, restoring two acres of canyon and wetland habitat, creating a school garden at the adjacent elementary school, and designing an outdoor classroom. Vargas will donate her prize to Aquatic Adventures Science Education Foundation.

\$5,000 – (Adult) John Willett was nominated for his efforts

with Reclaiming the Otay River Valley in the Otay Valley Regional Park (OVRP), a 13-mile unique urban river parkway in the South Bay. Willett, a World War II veteran who will turn 88 in June, has volunteered in the park for more than two decades, dedicating countless hours in the planning, clean up and restoration of the park. Thanks to Willett's efforts, the Otay Valley is now a valuable community resource for outdoor recreation and enjoyment of nature for all South Bay families. Willett will donate his prize money to Wildcoast.

Youth Finalists:

\$2,500 - Jennifer Gold is the founder and president of Valhalla High School's Recycling Club. Through Gold's leadership the club placed recycling bins throughout the campus and now sorts and sends the recyclable materials to a recycling center, instead of sending these items to a public dump site. Valhalla's Recycling Club donates half of its recycling proceeds to Outreach International, a charity that works in 12 underdeveloped countries throughout the world to help those that live there overcome the devastating effects of poverty and hunger. Gold will donate her prize to Surfrider Foundation of San Diego.

Gold said she picked her project because, "the empty bottles kept overflowing the trash bins, and I decided that something needed to be done to change that. I feel extremely honored to have even been nominated, let alone win second place. I'm very thankful for

Molly Cartmill who nominated me, and everyone that voted for me."

\$1,000 - Jose Mendoza, is a student at Hoover High School and the president of the Hoover Eco Club. Through his involvement with the Hoover Eco Club and other environmental organizations, Mendoza became an organizer of the Friends of Swan Canyon. Volunteer efforts including the removal of trash and non-native plants have reduced gang activity and the homeless population in the canyon. As one of Hoover Eco Club's most active members, he was recognized by the school for his participation in several school clean ups. Mendoza will donate his prize to San Diego Canyonlands.

Adult Finalists:

\$2,500 - Josie Hamada is an exemplary member of the San Ysidro Women's Club through the 9-11 One Hundred Cherry Tree Peace Grove project, Hamada's small community garden project was transformed into a county-wide attraction. The Beyer Elementary school playground, once a barren dirt, was transformed by Hamada into a peaceful grove consisting of 100 cherry trees where students and community members alike can walk and sit to remember those who died in our tragic 911 attacks. Hamada will donate her prize money to Tijuana River National Estuarine Research Reserve.

\$1,000 - Diane Nygaard formed Preserve Calavera, which has protected, preserved and added land to this beautiful watershed area in northern San Diego County. She was instrumental in the purchase of a 134-acre parcel in the Buena Vista Creek Valley located in Carlsbad known as the Sherman Acquisition. The land is strategically important for water quality, wildlife movement, Native American culture and early California history. Nygaard organized several successful public events to showcase this little valley and raised approximately \$150,000. She has organized community clean-ups, held Wildlife Appreciation events, birding walks, and hosted cultural lectures about the valley. She will donate her prize money to Preserve Calavera.

The Cox Conserves Heroes program was created through a partnership between The Trust for Public Land (TPL), a national nonprofit land conservation organization that conserves land for people to enjoy as parks, gardens and natural areas, and Cox Enterprises, a leading communications, media and automotive services company. The award money was provided by the Cox Kids Foundation, the philanthropic arm of Cox Communications in San Diego. The foundation is funded by Cox employees, who donate money directly from their paychecks and is then matched 100 percent by the company.

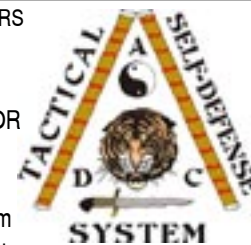

Lindo Lake boathouse

In 1886 when subdividing land for the 3,000 acre Lakeside town site, the El Cajon Valley Land Company dedicated 45 acres to a public park. The park was landscaped and a boat house was built. The boathouse became a social and recreational destination for the community where visitors were able to launch rowboats into Lindo Lake.

The boathouse remains one of the oldest buildings in Lakeside. Recently the boathouse was given a place on the list of California Points of Historical Interest.

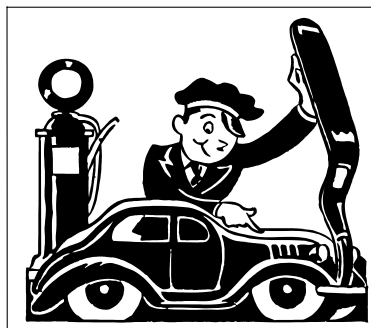

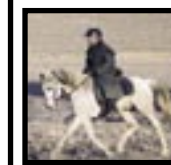

'Star Trek' — a successful reboot

After the last disappointing Star Trek film, *Nemesis* (2002) and the cancelled television series *Enterprise* in 2005, it looked like the 40-year old *Star Trek* universe was about to collapse into obscurity. Several months after the cancellation announcement of the *Enterprise*, Paramount announced it was in pre-production on the 11th *Star Trek* film. I, like many *Star Trek* fans, shuddered at the thought of a prequel with younger versions of the original cast. Chat rooms were full of those who assumed it was doomed to fail.

Good news! The filmmakers pulled it off and gave the *Star Trek* universe a fighting chance into becoming a potential new series for the old and new generations to enjoy.

When the U. S. S. Kelvin crew investigates a lightning storm in space, they discover it's a hostile Romulan mining ship, The Narada, emerging from an artificial black hole. The Kelvin is hopelessly outmatched by the Narada's

advanced weapon technology and is crippled in the battle.

Captain Richard Robau (Faran Tahir) is summoned by Narada's Captain Nero (Eric Bana), and is killed for not answering his questions correctly. First officer George Kirk (Chris Hemsworth) takes command and fights off the Narada so that his wife and newborn child, James T. Kirk, can escape and survive.

Fast forward 22 years and James (Chris Pine) meets Uhura (Zoë Saldana) and Christopher Pike (Bruce Greenwood) at a local Iowa bar. Pike convinces him to join Starfleet. There, he meets Dr. Leonard "Bones" McCoy (Karl Urban) and strikes up an immediate friendship.

At Starfleet, Kirk is caught cheating against an unwinnable Starfleet training test designed by half-human, half-Vulcan, Spock (Zachary Quinto). Kirk is suspended from active duty. When the Vulcan comes under attack, the entire United Federation fleet is dispatched to investigate and provide help. Kirk is horrified

at the thought of being left behind until McCoy smuggles him onboard the newly built USS Enterprise commanded by Pike.

Kirk is alerted that the same lightning storm has reappeared near Vulcan and convinces Commander Pike they are heading towards a trap; just like his father did 22 years earlier. Despite being tipped off about the Narada, they are overwhelmed by the ship's firepower, and Pike travels over to negotiate a surrender. Spock is commissioned as Captain and Kirk as his first commander. Together they must overcome their differences and stop the Narada.

Acting is surprisingly good in *Star Trek*, especially from Chris Pine (*Bottle Shock*, *Smoking Aces*) as Kirk and Zachary Quinto (*Heroes*) as Spock who is tested several times to see if he has human emotions. There are more surprises ahead when Spock Prime (Leonard Nimoy) shows up in the story.

One of the biggest assets of the new film is the realistic

computer graphics, which draws the audience into the action. Compared to the original series, the sets have been dramatically altered to give it a more futuristic look based on today's technology.

Director J. J. Abrams, who directs, writes, and produces great entertainment, is the genius behind *Alias*, *Mission Impossible*, *Fringe* and *Lost*. In *Star Trek* he successfully balances the action with the dialogue so that neither overpowers each other. There are some genuinely funny scenes that honor the original characters such as when 'Bones' calls Spock a hobgoblin; Chekov's (Anton Yelchin) inability to pronounce the letter "v"; Sulu's (John Cho) fencing and

Chief Engineer Montgomery "Scotty" Scott's (Simon Pegg) Scottish accent and infamous quotes.

Overall this is an enjoyable movie that should please a majority of *Star Trek* fans, but

those who aren't will also be entertained. It's disheartening that DeForest Kelly, James Doohan, and series creator Gene Roddenberry won't be able to see their legacy beam back to life and continue at warp speed.

'Ghosts of Girlfriends Past' — above my expectations

Let's face it; Matthew McConaughey doesn't always choose the best films. Remember *Surfer Dude*, *Sahara* and *Fools Gold*? Some scenes in those films even solicited moans from his fans; but they're still fans. Why? Because McConaughey is charismatic in person and on screen, and that loveable bad boy smile grabs your attention faster than a mouse in a trap. While not expecting much from *Ghosts of Girlfriends Past*, I was surprised to find the film entertaining. It's not over the top, and a competent cast makes the story plausible.

McConaughey plays Connor Mead, a famous photographer who gets more satisfaction from seducing as many girls in one week than in creating good photographs. One by one the girls learn they're a paint-by-numbers plan on his photographic tripod of conquests. Connor handles their annoyance by moving on to the next victim.

When Connor gets an invite to his brother Paul's (Brecken Meyer) wedding, the thought of anyone getting married repulses him. However, he's the only family member left, so he feels obligated to attend. Connor is also not looking forward to running into Jenny (Jennifer Garner), his childhood friend and possibly the only female he ever had real feelings about.

Within hours when back home, Connor has upset his brother and his fiancée Sandra (Lacey Chabert) so severely she calls off the wedding. That's after Connor destroys the cake, tries to pick up her mother (Anne Archer), makes her father, Sergeant Volkom (Robert Forster), practically order him in front of a firing squad and convinces Jenny she was smart not to get involved with him.

It would take magic to fix this mega-mess — so it's time for Connor's ghosts of girlfriends past. Uncle Wayne (Michael Douglas), who raised Connor and Paul after their parents died, shows up as a ghost to lay out the strategy. He's the

appropriate one for this job because Connor inherited his uncle's promiscuous genes. Wayne warns Connor he's heading for serious trouble, and — like Jacob Marley with Scrooge — takes Connor on a trip to the past. Ghost of the Past is Allison (Emma Stone), who was in the right place to make Connor feel better when Jenny ignored him in his youth. Ghost of the Present is Connor's own assistant (Noureen DeWulf), who shows him a little of the present he's missing out on. Finally there's Ghost of the Future (Olga Maliouk), who gives Connor a bird's eye view of his funeral.

Complaints I've heard about this film include the following:

It's predictable — but what romantic comedy isn't?

It steals the idea of the ghosts from Dickens — just Google that idea and see how many movies come up.

It lacks originality — hmm, doesn't that sum up about half the movies opening every year?

It's tasteless — were we ex-

pecting McConaughey to appear in an Oscar-nominated movie?

Connor is loathsome — characters in films are supposed to start at zero so their characters can grow.

Those complaints actually fit in with the reactions I expected to have before seeing this film. However, I was entertained all the way through instead.

I particularly enjoyed the way the movie works for several demographics. Garner and McConaughey serve the middle age audience well. No wonder McConaughey has six films in development. Emma Stone, the bridesmaids and groomsmen appeal to a younger crowd. Archer, Douglas and Forster are well thought of by more mature moviegoers. I also appreciated how so many clever scenes mix with the ho-hum ones, such as when Connor is in a shower and the water comes from the tears of all the women who have cried over him.

Yes, the ending does a big

'Daddy Diaries' returns to the REP

Hollywood scribe, professional actor, and one of the most produced Latino playwrights in the country, Rick Najera, brings his one-man show *Daddy Diaries* back to the San Diego REPeritory Theatre May 15 -17 and May 22 - 24. The comedy about a man looking at life through a father's viewpoint is at times poignant but contains the comedy aspects Najera is known for throughout Hollywood and Broadway.

Named twice by Hispanic Business Magazine's as one of the "100 Most Influential Latinos in America" and also named "50 Most Creative in Hollywood" by Variety, the La Mesa native began his career as a middle-schooler when he enrolled in San Diego Jr. Theatre, and worked on the San Diego REP and Old Globe's educational tours. He's the writer, executive producer and co-star of Broadway's *Latinologues* that has played in theaters across the country.

Najera is known for his award-winning comedic writing on *MAD TV*, *In Living Color* and *BBQ Bill*.

San Diego REP Artistic Director Sam Woodhouse, who worked with Najera on both *Latinologues* and *Sweet 15 (Quinceañera)*, said about Najera, "He's endlessly creative and one of the most fluid, facile, and funniest writers I've ever worked with."

Najera took time from his busy schedule to be interviewed for the Gazette about *Daddy Diaries*, directed by Gary Blumsack and written and performed by Najera.

Q. Where Did This Idea Come From?

Rick N: I basically went from a Hollywood guy who never expected to get married, to a daddy guy. My daughters are four and 18 months and my son is six; and they have changed my life. I think it's also ironic that I had my first date with my wife Susie at Horton Plaza, the same place

my parents had their first date. I never thought I would be a good father; mothers are geared for it. But I was the birth coach, I have fun with the kids, I'm a good provider and I change diapers. Once you have kids you look at the world differently. But as a writer I'm always looking for a good story. What better one than the one right in my own home where funny things happen on a daily basis.

Q. What Lessons Have You Learned About Fatherhood From Your Father, Eduardo?

Rick N: He went to Vietnam as a civil servant and sometimes I think it was to avoid diapers, but he taught me many lessons in life. He was a great storyteller that really inspired me. Men in his day were the hunters, and women the caregivers. Now days it's different, and I'm so grateful to be part of my kids' everyday life.

Q. How Difficult Is It To Do A One-Man Show?

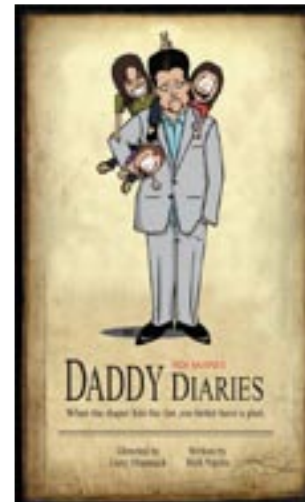
Rick N: Once it gets started, it's a hard gymnastic move. Once in the air – you're committed. It can be an hour filled with pain or a joyous time where the audience has fun with you. In shows like *Latinologues* it's like a prize fighter, someone else goes in the ring after you. The stamina is different in this show. I'm memorizing, concentrating and constantly re-thinking the lines I wrote. It's really the intimacy of a dialogue where the audience becomes like a friend and you're speaking just to him. Honda brings back the redesigned Insight



Honda Insight.

Hybrids, hybrids everywhere one looks there are new hybrids trying to make their way into our garages and our lives. Honda is bringing back one of the first hybrids the Insight. Remember the insight back in 2000? A space age looking car with big rear fender skirts and capacity for a driver and one passenger. The car rode heavy and when it hit bumps one would think they weren't liked.

Fast forward to today and there is the all new and redesigned 2010 Honda Insight. Now there is room for three more passengers and the ride has smoothed out to the point it does not feel like a hybrid, until the stop at a gas station. Forty miles per gallon in the city and 43 on the open road. Powered by a 1.3-liter 98 horsepower single over head camshaft eight-valve i-VTEC four cylinder gas engine with Integrated Motor Assist with idle stop features and backed by a Continuously Variable

Transmission, what a mouthful but it works. In fact, it works better than I expected.

The interior is wonderful — I just loved the instrumentation with a very bright blue lighting and enough information to keep just about any techno-geek happy. Steering wheel has controls as well and it is big and comfortable. Looking at the dash, everything is round. Everywhere you look you see round vents, gauges — get my drift? This is a five door hatchback with room for groceries, sports gear even a couple of golf bags with grocery hangers on the backs of the fold down second row seats for added storage space. When the second row seats are in the up right position there is the option to flip down the head rest when there is no one in the backseat. This gives a better vision out the back. Remember the clear glass panel on the old Insight rear hatch? Well Honda integrated it back into the 2010 Insight. It seemed to work but there is still

a good size bar running side to side through the middle of the hatch and that was a blind spot — but I'm sure one could get used to it.

Safety is high on the Insight list, with dual front airbags, driver and front passenger side airbags, side curtain airbags, anti lock brakes, vehicle stability assist, brake assist and electronic brake distribution. Then there is tire pressure monitoring system, active front head restraint, side impact door beams, front and rear crumple zones, rigid body

construction daytime running lights and child restraint latches — all for safety.

The fun stuff is great too; 160-watt AM/FM/CD audio system with six speakers, a MP3/WMA Playback a USB audio interface and a MP3/auxiliary input jack (The kids love this stuff).

The Insight is \$21,300 plus tax and license and they will throw in a tank of fuel at no extra charge. Another point worth mentioning, in the event the hybrid battery

system fails and it is covered under the warranty there is no recycle fee charged to the customer.

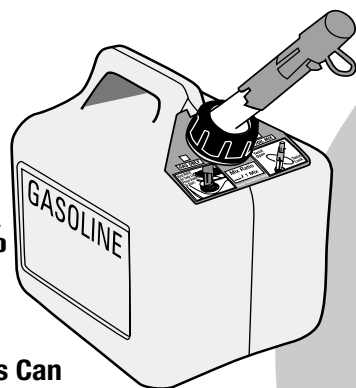

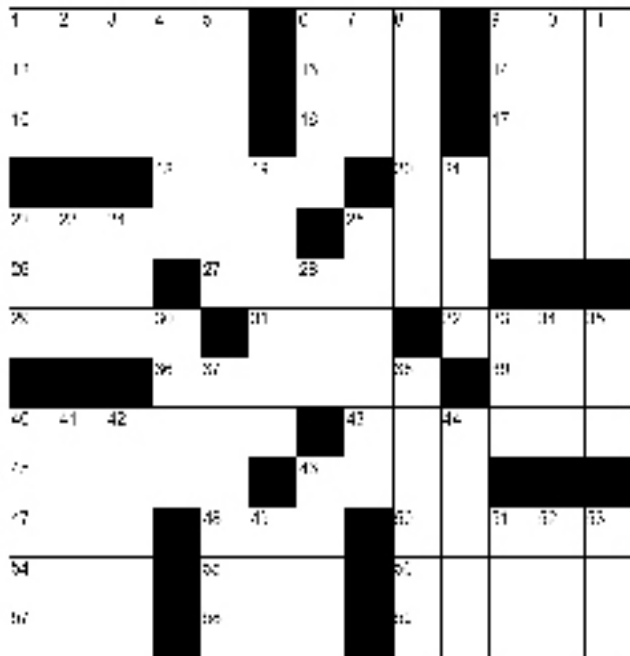

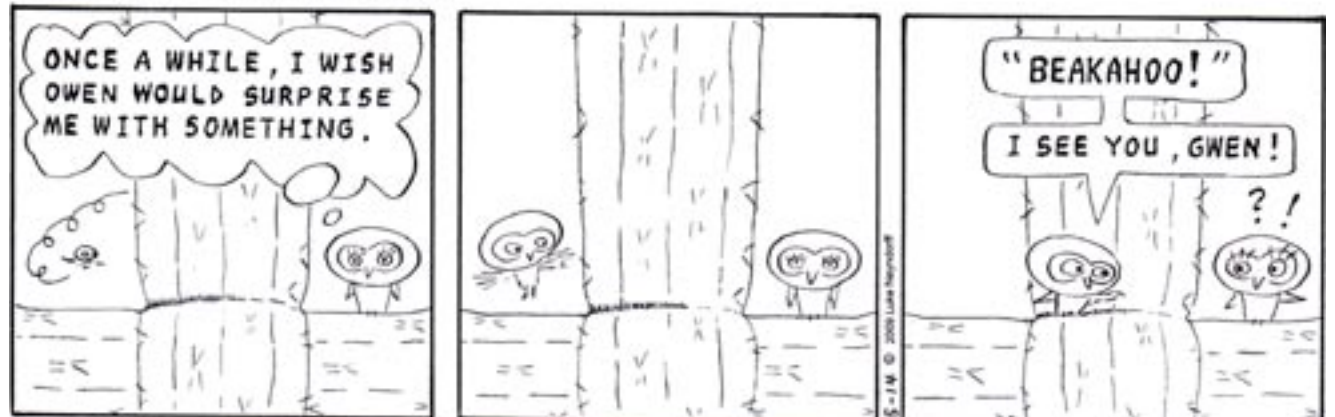

Good dogs don't bite children, do they? ... ask a trainer

Ever marveled at how good your dog is with children? Great! This article is for you and your wonderful dog!

Historical bite statistics project that more than 50 percent of our children will be bitten by dogs before age 12, most often by a dog they know. Even though dog bites rarely cause serious injury, families are distraught and the dogs often lose their homes.

You may be thinking, "Sure, that's because of all those 'bad dogs.' Lucky for me, I have a good dog and don't have to worry about that."

Think again.

Most of the cases I see involve a dog no one expected to bite. When was the last time you heard a parent say, "Oh yeah, I totally knew my dog was dangerous and I let the kids play with him anyway"?

Instead, a call usually begins with: "The bite came out of the blue! He was always so good with the baby," followed by a list of all the various things that the dog has put up with without apparent complaint.

This is a clear case of 'The Curse of a Good Dog.'

Most dogs known to be uncomfortable with small children are protected and treated with

caution. It's the "good dogs" that are generally left to fend for themselves.

It's easy to see how this happens. A small child does something with the dog and the dog does not object. Parents think, "What a good dog!" and are lulled into a false sense of security and a resultant lack of vigilance in guiding dog and child interactions.

What we forget is that all dogs, even good dogs, have limits to their tolerance. Every action by a child that surprises, frightens, annoys, hurts or otherwise bothers a dog is, essentially, a withdrawal from that "bank account" of goodwill. At some point, this balance dips low, maybe on a bad day or maybe after a longer history of incursions, and that's when you see the growl or snap or bite.

Consider, too, that 'The Curse of a Good Dog' has implications for the child, as well. The child is acquiring unsafe habits of behavior around all dogs, not just this particular dog. Most dogs actively dislike hugs, kisses, kids pushing them or reaching for their toys, pulling their fur or disturbing them while sleeping — even if your own good dog has never objected. What your child does with your dog is what he will do with other dogs.

Instead of expecting more and more of our good dogs, let's honor their forbearance

with our protection. Keep your good dog good!

- Look for opportunities to turn withdrawals into deposits. Sure, all kids do some things that are annoying to dogs. Your job is to make it worth your dog's while. Look at your dog, praise him and give him a treat. Every time. This builds your dog's goodwill balance and prompts him to look to you for guidance when disturbed or startled.

- Learn the body language of a worried dog and contrast with how your dog looks when happy or relaxed. Unless you have a suggestion box for your dog to use, body language is all he has got. If you miss the subtle signs, your dog has no

choice but to make it more obvious. Luckily, once you know what to look for, you can't miss what your dog is telling you.

- Teach your children true respect and empathy for animals by clearly supporting the animal's likes and dislikes. If your child loves your dog, it's important to learn to show that love in a way the animal truly appreciates. Dogs love children they can feel safe around. Save the hugs and kisses for Grandma.

Oddly enough, we get to have our happily ever after with dogs and children when we stop assuming that a good dog is the most important part of the equation.

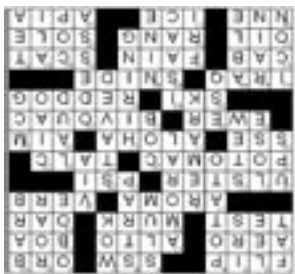
