Wings Over Gillespie Air Show

On June 5, 6 and 7 Air Group One, the San Diego wing of the Commemorative Air Force will present their (almost) annual Wings Over Gillespie Air Show at Gillespie Field in El Cajon.

The Commemorative Air Force has the largest airworthy collection of former military aircraft in the world. It has over 150 flyable combat aircraft, making it the world's seventh largest air force! The CAF's members number over 10,000 worldwide, composing 80 wings in 30 states and 4 countries. The CAF's purpose is to acquire, maintain and operate vintage military aircraft, ground vehicles and associated artifacts for the education and enjoyment of present and future generations.

The CAF is a living, flying

history lesson, giving tribute to America's great military aviation heritage. It proudly displays some examples of the only flying aircraft of its type, such as the B-29 Superfortress and Curtiss SB2C Helldiver. Scores of its aircraft have been used in movies for decades, including the recent version of Pearl Harbor.

Come be part of history at the Wings Over Gillespie Air Show on June 5-7. Each day will feature re-enactments of WWII and Vietnam War aerial battles complete with pyrotechnic displays, "bombing" runs and strafing attacks. This year John Collver will once again demonstrate his famous aerobatic skills in his SNJ "War Dog". You'll be able to get up close to famous combat aircraft from World War II and see classic warbirds and other interesting aircraft take to the sky!

Friday, June 5 will be a day for students and children from across San Diego county to

come and learn about aviation and aviation history. Experts will be on hand to talk to students about the aircraft on static display, and the roles they played. (The actual flying part of the airshow will occur on Saturday, May 6 and Sunday, May 7.)

Approximately 40 aircraft, both flying and in static displays, will be on hand that you can see up close. This unique air show will have live entertainment throughout the day, interviews with aces and veterans from WWII to present day, a large Kidz Zone, and free shaded seating for over 400 people. As always, more than two dozen food and merchandise vendors will be on hand.

The air show runs Friday, June 5 through Sunday, June 7. The gates are open from 8 a.m. to 5 p.m. Admission \$10 for adults (18 and over); kids 10-17 and military in uniform \$5; under 10 are free.

Flag Day Parade

Saturday, May 30, 9 a.m.,

downtown La Mesa will dress up in red, white and blue for the Annual Flag Day Parade, "A Salute to Old Glory!" Two pre-parade concerts will begin the festivities from 9 - 10 a.m.: La Mesa Middle School performs at Palm and La Mesa Blvd., and Granger Junior High School at Date and La Mesa Blvd. At 10 a.m. the parade will march through downtown La Mesa Village.

Spectators will enjoy over 75 entries, including 6 marching bands led by the Marine Corps ensemble, floats, military vehicles, active and retired war heroes, equestrian units, service clubs and youth groups, along with a 20-foot wide 'living flag' carried by community volunteers.

Seventy-plus La Mesa businesses and residents contributed over \$10,000 to fund the parade this year after the city council was forced by budget constraints to withdraw municipal support.

Spectators are encouraged to dress in patriotic attire and cheer on the participants in this annual parade. La Mesa welcomes all San Diegans and their families to share in this free and fun event!

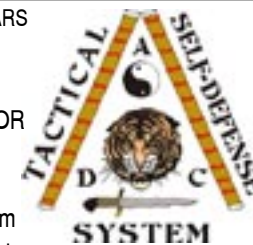

**Lighting ceremony for new
landmark in El Cajon**

The public is invited to the first lighting of downtown El Cajon's new official archway planned at the closing of the weekly Classic Car Show on Wednesday evening, June 10. The location is

on West Main Street, just west of Magnolia Avenue. The decorative arch, selected last year by a vote of the public, will be held aloft by two iron standards, one bearing the name of the mayor, current city council members, city manager, designer and contractor. The second standard will carry the name and likeness of town founder, New Englander Amariah Lord Knox. Knox who arrived in the newly opened-for-settlement El Cajon Valley in 1869 – the same year gold was discovered in what would become Julian. The El Cajon Historical Society and the El Cajon Community Development Corporation are hosting the lighting ceremony.

Community Center hours change

On May 12 the County of San Diego Board of Supervisors was presented a proposed budget that reduces funds available for the operation of County Services including Department of Parks and Recreation (DPR).

Reductions include Lakeside. The proposed reduction for Lakeside would affect the Lakeside Community Center reducing the hours: Monday through Friday 12 to 8 p.m., closed Saturday and Sunday.

Several community members have expressed concerns and suggest letters to the supervisors in opposition.

Optimist Club Fishing Derby

The Lakeside Optimist Club will host its sixth annual Fishing Derby on June 6 for the youth of Lakeside. The event is co-sponsored by the Barona Band of Mission Indians, El Cajon Ford and many local community organizations and businesses.

The Derby will take place at Lindo Lake from 7 a.m. to 1 p.m. The Optimist will stock the lake with 1,500 pounds of catfish. The Optimists Club loaner program will have over 250 rods and reels for Lakeside children to participate even if they don't have their own equipment. The San Diego Rod & Reel club will serve a free hot dog lunch. There will be raffle prizes for the kids such as bikes, fishing poles and tackle boxes. Last year over 500 children ages 3 to 16 years took part in the Lakeside Optimist Fishing Derby.

Boathouse ribbon cutting

Several hundred people attended the Lindo Lake Boathouse Ribbon Cutting on a sunny May 21 afternoon. County Chairwoman Dianne Jacob cut the ribbon assisted by Project Manager Nick Martinez, members of Parks and Recreation Department, members of the Lakeside Historical Society and Lakeside Chamber of Commerce.

Chairwoman Jacob told the crowd the newly restored boathouse was restored to depict its original form, features and character. The boathouse remains one of the oldest buildings in Lakeside and has recently been given a place on the list of California's Point of Historical Interest.

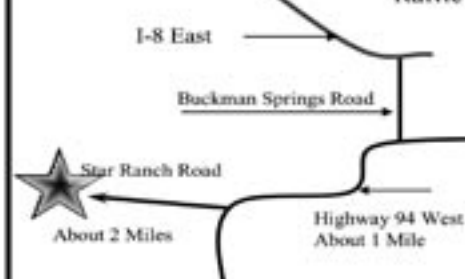

'Terminator Salvation' — a futile attempt

Since the release of *The Terminator* in 1984, fans of the franchise have craved for episodes of the future where humans and machines are at war. *Terminator Salvation* finally fulfills that vision, in fact, with an entire movie about war. The

only problem is that director Joseph McGinty Nichol (McG) has sacrificed a believable storyline for meaningless action sequences.

The movie jumps into full throttle as Marcus Wright (Sam Worthington) is on death row and moments from being executed for his crimes. Just

before the needles are injected into his arm, Dr. Serena Kogan (Helena Bonham Carter), a Cyberdyne scientist, pleads with him to sign a document allowing permission to use his organs to save lives in the name of science. He signs and is executed.

Jumping 15 years into the future, the war between man and machine has begun. John Conner (Christian Bale) leads an expedition force to a Skynet base suspected of holding vital information about a new type of terminator model. He discovers Skynet has developed a new model, the T-800. Their objective is to capture humans for unknown experiments and they start hunting them down.

In a burned out and destroyed Los Angeles, Marcus — supposedly who was formerly killed — wakes up and finds Kyle Reese (Anton

Yelchin) and his mute friend, Star (Jadagrace Berry), fighting terminators. In prior films, Reese was a Resistance fighter who went back in time to battle the Terminator (Arnold Schwarzenegger) and become Conner's father. Together Kyle, Star and Marcus set out to find the resistance headquarters only to be hunted down by Skynet, and Kyle is captured.

Christian Bale and Sam Worthington are excellent assets to the terminator series. Other actors include Bryce Dallas Howard as Conner's seven-month pregnant wife, Moon Bloodgood as Resistance fighter Blair Williams who becomes Marcus's close friend, and Michael Ironside as General Ashdown. The high caliber of their performances and excellent computer graphics are great in this movie. But the impressiveness abruptly stops there because McG concentrates on pointless action sequences that do

nothing for the plot and insults hardcore fans.

One example is the chase scenes involving Skynet robot motorcycles used for pointless fillers to draw out the action sequences another five minutes. Skynet has theoretically an unlimited number of flying robots yet they resort to obso-

lete motorcycles to chase down a tow truck? That doesn't make sense to me.

Terminator Salvation is a futile popcorn flick that fails to live up to the franchise standards. Dedicated *Terminator* fans continually crave to see humans and machines slug it out.

Anyone who likes comedies that are not too funny with poor acting, awful dialogue, and inappropriate scenes, will find *Dance Flick* the right movie to see. Directed by Damien Wayans, written by Keenan Ivory, Shawn, Craig, Marlon and Damien Wayans and starring several of the Wayans' clan, this spoof should probably have been a family reunion rather than a movie.

Megan (Shoshana Bush) — a take-off on the Julia Stiles

character in *Save the Last Dance* — gave up dancing after her mother died and decides to take up the form again. Her first step is to a poor neighborhood school for dance lessons and a hope to pursue her dreams.

When Megan befriends Charity (Essence Atkins), the two soon have to help Charity's brother, Thomas (Damon Wayans Jr.). He and his friend, A-Con (Affion Crockett, *Soul Men*), are in a bit of trouble with Sugar Bear (David Alan Grier). The guys owe him money, and Sugar Bear is more than eager to get it back. So

Megan decides to put together a dance team to compete in the ultimate dance off of all time. They hope to win the \$5,000 prize money and give it to Thomas to pay off his debt. This sounds a lot like *Over the Hedge* (2006) — which was far more entertaining.

Bush (*Lie To Me*) is okay in the film, but Atkins (*Love For Sale*) gives the best performance in the movie. The Wayans brothers do what they're known for — a wild brand of irreverent humor.

Dance Flick is really a spoof of movies such as *Ray Charles*, *High School Musical*, *Step It Up*, *Save the Last Dance* and more. But like other movies made to mock other films such as *Disaster Movie*, *Scary Movie*, and *Meet the Spartans*, there is little plot and moviegoers are left with the same old boring antics of the cast members.

Substituting anything close to a real plot with attention-seeking and inappropriate scenes with attractive females results in a doomed movie and lack of filmmaking skills. *Dance Flick* isn't worth the price of a movie ticket.



'Battle of the Smithsonian' — delivers laughs and a good message

Night at the Museum: *Battle of the Smithsonian*, a sequel to *Night at the Museum*, is funny, fast moving and a great choice for families. Some of the favorite characters from the first film return for a crazy adventure in Washington D. C.

Larry (Ben Stiller), once the night guard at the museum, returns to visit his friends only to discover the museum is due for a remodel so everything is being moved to storage in the Smithsonian Museum. Worried about the magic tablet that brings the characters to life, he tries to stop the transfer, but is too late.

With the help of this son, Nick (Jake Cherry), Larry hurries to the Smithsonian and sneaks into the basement

where he's met by Brundon (Jonah Hill), a young museum guard. The two of them have an interesting meeting that left us smiling. Larry is happy to discover that Dexter, the mischievous Capuchin monkey, stole the tablet and brought it along on the move.

There is a tense moment when the villain Kahmunrah (Hank Azaria), brother of Egyptian King Ahkmenrah from the first movie, wants the tablet to bring his army from the ancient underworld back to life to take over the world. Thankfully, General George Custer (Bill Hader) steps in to save Larry from harm. In no time at all the characters and their exhibits are brought to life and up to their old antics. Jedidiah (Owen Wilson), Octavius (Steve Coogan), Sacagawea (Mizuo Peck) and, of course, the nice T-Rex, make us laugh again with crazy adventures.

While escaping from Kahmunrah, Larry runs into Amelia Earhart (Amy Adams), a perky and enthusiastic character who insists she come along because she "smells" adventure. Unable to turn down the first woman to

There are lots of historical characters that add exciting moments in the movie such as Einstein (Eugene Levy),

Ivan the Terrible (Christopher Guest), Napoleon (Alain Chabat), Al Capone (Jon Brenthal), Darth Vader (Thomas Morley), and Oscar the Grouch.

And it's not just a giant Abraham Lincoln statue or three dimensional figures that come to life, characters pop in and out of famous paintings and are really comical. The animation of the characters is fantastic, especially the dinosaur, the sea monster, and the balloon dog.

"My favorite part of the movie is when Kahmunrah and Larry argue over the tablet because their dialogue is fast and really silly," Casey Lind said. "Overall, I thought the movie was a great adventure, although I would have liked some new music in the film."

Haley Price said, "My favorite part is when The Thinker (Hank Azaria) comes to life and wants to impress a girl statue nearby. He turns out to be a big dummy instead of a clever guy. This is apparent when he tries to show off for the girl statue and flexes his muscles as he shouts, 'Boom, Boom, Fire Power!'"

There is comic fighting but no scary scenes so kids aged seven and older are fine to see this movie. *Battle of the Smithsonian* shows bravery and has a good message that friends are far more important than money.

Hyundai goes luxury with the Genesis Coupe

I was a little surprised and quite a bit concerned when I heard Hyundai was coming out with a high end luxury car, the Genesis. I thought, "what are they thinking? They have the inexpensive car market all but sewn up and they decided to travel where no Hyundai has traveled, luxury!"

Well to my surprise it worked and when they decided to bring out the Genesis Coupe

I decided to wait and see the finished product before I put my foot in my mouth.

The Coupe is in the showroom floors as of this writing and let me say that when one slides behind the wheel of this 3.8-liter dual overhead camshaft 24-valve V6, one will be pleasantly surprised. My tester from Drew Hyundai had the six-speed manual transmission, which I loved, smooth and very direct. The driver seat was more than supportive. I had to remove my wallet from my

left rear pocket due to excessive pressure I don't want to discuss! The dash layout is simple but functional. There is a performance suspension, which includes a five link rear suspension, a front tower brace for rigidity, 18-inch alloy wheels, and the coupe is front engine and rear wheel drive.

The inside, as I mentioned before, is basic but there is leather seating, auto temperature controls, keyless entry with an alarm, driver lumbar support, leather steering wheel with audio and cruise controls on the wheel. Then my favorite area — the sound system. Hyundai didn't skimp a bit, AM/FM/XM/CD/MP3 audio system with six speakers and the ability to hook up an iPod, there is a USB port as well. There is also a Bluetooth standard along with fog lights.

The safety features are the best out there; electronic stability control, traction control (that can be turned off), six air bags standard, front air bags, side air bags and curtain air bags plus beams in the doors, crumple zones surrounding the occupants and active head restraint.

There are engine choices with the Genesis Coupe. Buyers can pick the 2.0-liter inline four cylinder that delivers 210 horsepower and 223 pound foot of torque with fuel mileage of 21 city and 30 miles per gallon on the open road with a manual transmission.

One mile per gallon will be lost with a five or six speed automatic transmission, but with the 3.8-liter V6, 306 horsepower and 266 pound foot of torque will be had. Mileage drops a little with the 3.8 V6, city ranges from 17 to 20 miles per gallon and on the open road 26 to 30, again this depends on transmission choices.

Car & Driver pitched the 2010 Camaro against the Genesis together on a race track and the Camaro beat out the Genesis just slightly but the Hyundai did turn some heads with its styling and great looks. Pricing is very comparable starting out at a low \$22,000 and pushing upwards to around \$31,000 plus tax and license.

There is a car for the "car enthusiast," the Track Version. It comes with a 3.8-liter V6, choice of transmissions Brembo brakes, 19-inch alloy wheels, track-tuned suspension, Torsen Limited Slip Differential, Aluminum Pedals, Aero Wipers, Rear Spoiler and they delete the Chrome lower fascia and the back up warning system.

Check this sleeper out at the local Hyundai dealership today and don't forget their great 10 year 100,000 mile warranty and five year 60,000 bumper to bumper warranty. One can't beat a company that believes in their product and the proof is their warranty.

Streaky Padres — how 'sweep' it is

The San Diego Padres winners, sweepers of nine-straight games at home (nothing like home-cooking), took their show on the road to Arizona and snapped an 11-game road losing streak, in a game that was one of their best comeback efforts of the year.

As of Tuesday of this week the Padres were riding a 10-game winning streak, one game above .500 (23-22) in second place in the National League West. (Who would have believed 2 weeks ago they would be above .500?)

Chicago White Sox. Adding to more drama, Tony Gwynn Jr. was traded from the Milwaukee Brewers to his home-town San Diego. He entered the lineup just in time to draw a late inning walk and subsequently score a game winning run.

This came on a weekend series in which the 1984 Padres were honored, celebrating a miracle season with team members, family, and friends of that World Series team last Saturday evening.

The week before, the Chicago Cubs had embarrassingly crushed the Padres in three games in Chicago. This time however, it was payback as your Padres swept Chicago at Petco.

Padres fans came out in large multitudes last weekend. Crowds of 35,000 to 40,000 came to the Park to cheer on their home team. At the very least, this years Padres are playing entertaining, fundamentally sound baseball, the same brand they played to begin the 2009 season with a 9-3 record.

Remembering and trying to forget the miserable 4-19 stretch that followed, fingers were beginning to point, questions were being asked (rebuilding year)? In Chicago, Padres skipper Bud Black had a closed door talk with his troops. What he said to the players is not known, but since then, the chemistry on the club is being evidenced by their inspired play and back-to-back home sweeps.

This is what Bud Black did say to the media following the

clubs 10th straight victory on Monday.

"The first thing is we're pitching", (2.11 E.R.A) he said, then further elaborated "Starting pitching through this has been outstanding and the bullpen work is just as solid. Overall with the pitching and the defense, fundamental play, and enough hitting to get it done, yesterday was a good sign to see them open it up offensively. (Padres scored 9 runs Monday).

On the trade acquisition of Anthony Gwynn Jr., the Padres manager commented, "The players and the organization were excited about it. Tony has been on the radar for a number of years by us and other teams. We feel he brings a different caliber than what Jody (Gerut) brought. He (Gw-

ynn) was hitting well in Triple A and was stealing bases, the element and type of player we didn't have. We're going to see if it works."

After a 9-0 home stand and an incredible come-from-behind win on Monday, Padres skipper Bud Black closed with this statement, "The guys are playing well and keeping their focus. Ultimately you got to keep winning and that's what we're doing."

They will attempt to keep their winning ways intact on the road at Arizona this early week. An off-day is scheduled for Thursday. Then it's the rarified air in Colorado with Jeff Geer towing the rubber on Friday for the Padres beginning a 3-game weekend series against the Rockies.

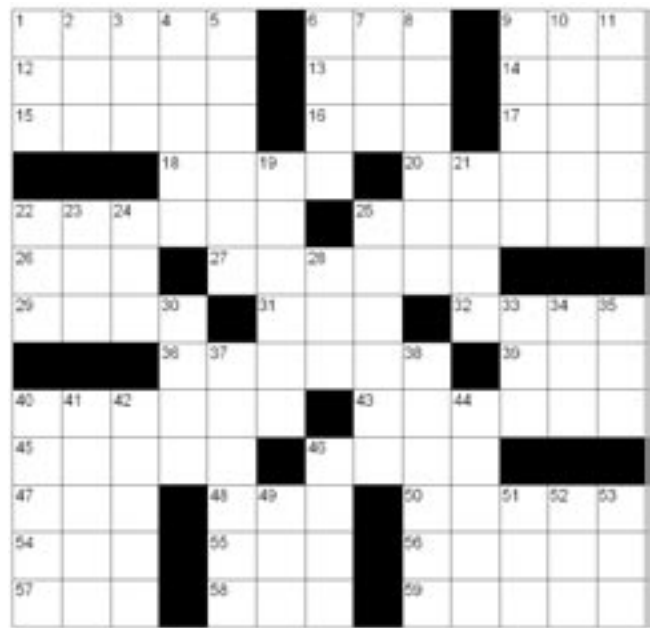



Our Best Friends

Dog is afraid of stairs ... ask a trainer

Dear Trainer:

In our house before this one, my dog Tucker went up and down the stairs to and from the 2nd to 1st floors with no problems whatsoever. But NEVER in the basement. In this house, he will NOT go up the stairs to the 2nd floor, and if I carry him up there, which I have done, he does his coyote *slink* to the stairs and rushes back down. Only thing we can think of is the loft just has a railing and he can see out over the living room from the loft. Maybe too scary for a dog? What can I do?

Dear Stair,

Dogs always present interesting quandaries for us humans, and since we can't ask them what the problem might be, we can only observe behavior and work within those parameters. Your dog may be frightened by the open space as you say, so you can experiment by blocking the view with some newspaper or cardboard to see if that makes things better for him. If so, you can then begin to desensitize him so you can gradually remove the paper or cardboard.

In case that is not the problem, let's take a look at other things that might also be suspect for Tucker's fear.

Other possible reasons a dog doesn't want to go up the stairs:

- Open stairs—being able to see through each stair bothers

some dogs.

- Medical issues—it hurts to go up and the stairs become associated with that (always good to check hips, knees and elbows for any problems).

- Something happened to frighten a dog once he got to the top of the stairs (a sudden loud noise, someone yelled at the dog, someone came around a corner and wasn't expected, etc.)

- Strange smells that humans might not be able to smell, (a previous dog or cat that marked somewhere, someone that is ill, someone died in the house, etc.) but the dog can. Remember that dogs can detect things like cancer, so it's not such a stretch. You might be able to tell if this is the case is your dog does a lot of air sniffing when you take him up there.

Those are some ideas, but for the most part, the solution will be similar. Your choices are to help Tucker become more comfortable with the stairs or just let him be downstairs and not worry about it. However, since you may have to encounter stairs with Tucker during the course of his life, and carrying a dog up flights of stairs seems pretty inconvenient, I would vote to desensitize him to the stairs.

How to begin

Start at the bottom of the stairs with a stash of really wonderful food rewards. Since this is so scary for Tucker, think about really exceptional treats such as cooked chicken, beef or even fish. If you are familiar with clicker training, I would recommend that, but if not,

you can easily use a marker word to inform Tucker when he gets the right answer. Begin to move toward the stairs, keeping enough distance from them so Tucker doesn't feel like he has to go up them. In other words, keep his fear below the tipping point so he is able to focus and learn.

You are going to build the final behavior of going up the stairs in small steps—no pun intended—so he never feels forced to overcome this issue, so go slow.

Begin training

You will stand near the stairs where Tucker is comfortable and when Tucker looks at the stairs, you will click or say a marker word, such as, "Yip," and then toss a small treat slightly toward the stairs so he has to move a tiny bit closer to get the treat. It doesn't have to be a long look, just a fleeting glance is okay at first. Stay at this level until you see that Tucker is offering to look at the stairs on his own to get the marker word or the click and treat.

Tucker is allowed to stop training at any time, but don't give him any treats if he walks away at any point. Simply say, all done, take a short break and try again. Be sure that as you train you do take breaks, working for no more than 10 minutes at a time to avoid boredom or filling him up, and training only once or twice a day to keep it fresh for Tucker.

After Tucker is readily looking at the stairs, move a little closer and repeat, tossing the food

closer to the stairs for each session. You are showing Tucker that if he faces his fears, he will be rewarded.

Keep progressing until you are right next to the stairs (this could several days, so be patient) you will then begin to toss or place his reward on the very first step. You may have to move back a little after you put the treat on the step so he doesn't feel like you might ambush him. Keep a happy voice and praise each time he gets his treat from the step. Stay at this level until you can see that Tucker is easily retrieving the treat after your marker word or the click. Keep the sessions short, even if you are making great progress, as you want Tucker to be a little disappointed that you are not going

to train for awhile. This way, when you go back to train, he will be more excited about it.

If he is doing well, start the next section with tossing or placing the treat on the 2nd step and stay there until he seems relaxed at that level. Work all the way up the stairs, doing one stair at a time until you reach the top.

You should be able to convince him that going up the stairs is not all that scary after all, and he is highly rewarded for doing so. This makes a fun game for dogs, and you can eventually teach Tucker a verbal cue, such as, "Up the stairs," once you see he is able to go all the way to the top.

Once you have Tucker to

that point, you can also toss a favorite toy up the stairs where he has to run up and retrieve it in order to play fetch again.

If you find that Tucker is unable to process through this, you should then consider bringing in a professional behavior expert that can help you, one-on-one, to problem solve this issue.
